2008

Barbara L. Wilkins, MSW (LCSW 735)

Stipulated Final Order Assessing Costs (May 13, 2008). Violation of OAR 877-030-0090(2) related to failure to cooperate with a Board investigation. Board assessed a cost of \$500.

Jeanette C. Chardon, MSW (CSWA 1914)

Stipulation for Voluntary Surrender and Final Order (May 2, 2008). Violation of OAR 877-02-0009(2), 877-020-0012, and 877-020-0013 related to failure to have a current Plan of Supervision with a Board approved supervisor and failure to submit required six month supervision evaluation reports.

Stephen R. Beck, MSW (LCSW 1320)

Stipulated Final Order of Probation and Assessing Civil Penalties (April 8, 2008). Violation of OAR 877-030-0040(1) related to failure to separate his private life from his professional work; OAR 877-030-0070(1)(a, b, c, and d) related to dual relationships; OAR 877-030-0070(3) related to providing inappropriate or unnecessary treatment to clients; OAR 877-030-0070(4) related to failure to provide clients with explicit information regarding the extent and nature of services provided; OAR 877-030-0070(5) related to failure to seek timely consultation or make referral when it was in the client's best interest; and OAR 877-030-0070(7) related to failure to terminate services when appropriate. The Board imposed 3 years of probation that includes supervision twice a month, the completion of 12 hours of continuing education above the normal amount needed to maintain licensure, and a \$4,050 civil penalty.

Michael V. Stevens, MSW (LCSW 2581)

Stipulated Final Order Assessing Civil Penalty (February 16, 2008). Violation of OAR 877-030-0070(11) related to breach of client confidentiality. Board imposed a \$1,000 civil penalty.

Dennis C. Florendo, MSW (LCSW 676)

Stipulated Final Order Assessing Civil Penalty (January 8, 2008). Violation of OAR 877-030-0040(3) related to failure to notify the Board within 30 days of receiving a DUII citation. Board imposed a \$500 civil penalty.

Samuel Tallman, MSW (LCSW 2057)

Stipulated Final Order of Probation and Assessing Civil Penalty (January 8, 2008). Violation of OAR 877-030-0070(11) related to breach of client confidentiality; OAR 877-030-0070(1)(a) related to violation of the therapeutic relationship of power and trust; and OAR 877-030-0070(3) related to provision of inappropriate treatment. Board imposed 3 years of probation with specific supervision and continuing education requirements, and a \$1,000 civil penalty.

Alice J. Rothschild, MSW (LCSW 1989)

Stipulation for Voluntary Surrender in Lieu of Revocation and Final Order on Reconsideration and Assessment of Costs (July 28, 2006). Violation of OAR 877-035-0015(2)(b) related to refusing to enter a rehabilitation program recognized by the Board; OAR 877-035-0015(2)(d) related to refusing to complete a rehabilitation program recognized by the Board; and OAR 877-030-0090(2) related to failure to cooperate with the Board's investigation.

Marcia I. Hageman, MSW (CSWA 1238)

Stipulated Order Assessing Civil Penalty, (June 13, 2006). Violation of OAR 877-030-0070(1) & (3) [2003] related to engaging in a dual relationship with a client. Board imposed a \$500 civil penalty.

Lynn E. Johnson, MSW (LCSW 2571)

Stipulated Order of Reprimand (April 11, 2006). Violation of OAR 877-030-0070(13)(b) related to refusal to conduct business with a legally authorized person, and OAR 877-030-0070(14)(c) related to failure to provide client with reasonable access to records.

Schailar V. Gionson, MSW (LCSW 3298)

Stipulation for Voluntary Surrender of Clinical Social Worker License in Lieu of Revocation, Assessment of Costs and Final Order (January 17, 2006). Violation of ORS 675.540(1)(a) related to being convicted of a crime (Class B Felony/sexual contact with a minor) in the State of Washington that would be considered a felony in Oregon.

Kathleen L. Prieto, MSW (LCSW #2391)

Amended Stipulated Final Order, Probation and Assessment of Costs (December 16, 2005). Violation of OAR 877-030-0070(3) related to dual relationships with agency client.

Craig W. Schreiter, MSW (LCSW #999)

Stipulation for Voluntary Surrender of Clinical Social Worker License in Lieu of Revocation and Final Order (December 13, 2005). Violation of OAR 877-030-0070(4) related to sexual conduct with a former client, and OAR 877-030-0070(14) related to breach of client confidentiality.

Robert A. F. White, MSW (LCSW #1098)

Stipulation for Voluntary Permanent Surrender of License in Lieu of Revocation and Final Order (July 20, 2005). Violation of ORS 675.510(2) related to submitting false claims for health care payment for mental health services he did not render. White paid the full restitution of \$169,620.59, and permanently surrendered his Clinical Social Worker License.

Kathleen R. Boeve, MSW (LCSW #1460)

Final Stipulated Order, Letter of Reprimand for Additional Continuing Education and Assessment of Costs (April 27, 2005). Violation of OAR 877-030-0070(3) related to dual relationships with clients.

Donald L. Mann, MSW (LCSW #943)

Stipulated Order of Reprimand (February 8, 2005). Violation of OAR 877-030-0070(14)(c) related to failure to provide reasonable access to client files by custodial parent.

Stanley J. Marcus, MSW (LCSW #3349)

Final Order by Default, Letter of Reprimand and Assessment of Costs (January 20, 2005). Violation of OAR 877-030-0070(14) related to disclosure of confidential information (one instance) and OAR 877-030-0070(17) related to soliciting clients from agency for private practice (one instance).

M. Diane Wade, MSW (LCSW #2778)

Stipulation for Voluntary Surrender of License in Lieu of Revocation and Final Order (November 6, 2004). Violation of OAR 877-030-0070(4) related to sexual relationship with a client within three years of providing clinical services.

Polly A. Morrow, MSW (CSWA #A1451)

Final Order Accepting Stipulation for Voluntary Surrender of Clinical Social Work Associate Certificate in Lieu of Revocation (June 16, 2004). Violation of OAR 877-030-0040(2) related to dishonesty, fraud, deceit, or misrepresentation, and OAR 877-030-0070(4) sexual conduct and related behavior with a former client.

Robert M. Clark, MSW (LCSW 751)

Stipulated Order of Probation (February 13, 2004). Violation of OAR 877-030-0070(14) related to disclosure of confidential client information. One year of probation under supervision of a Board-approved LCSW supervisor, and 15 hours of continuing education on client confidentiality.

Homer Samuel Adams III, MSW (LCSW 1724)

License Revocation (September 9, 2003). Violation of OAR 877-030-0040(2) related to dishonesty, fraud, deceit, or misrepresentation, and OAR 877-030-0070(4) regarding sexual conduct and related behavior with a client. This Order affirmed the Emergency Suspension which the Board issued against the same licensee on August 23, 2002.

Hugh McCauley, MSW (LCSW 2803)

Final Order Imposing Discipline, License Suspension (March 5, 2002). Violation of ORS 675.540(1)(d) related to unprofessional conduct in the practice of clinical social work, and OAR 877-030-0070(4) sexual contact with a client. Six months suspension of license beginning March 5, 2002, and three years probation under ORS 675.540(2)(b) with supervision by a Board-approved LCSW for the first year of probation.

2001

Lawrence Gradek, MSW (LCSW 1826)

Final Order by Default, License Suspension and Probation (December 4, 2001). Violation of ORS 675.540(1)(d) related to unprofessional conduct, OAR 877-030-0070(1) dual relationship, and OAR 877-030-0070(4) soliciting sexual acts. One year suspension followed by one year probation under ORS 675.540(2)(b).

Kim A. Lee, MSSA (LCSW 2705)

Emergency Suspension (June 14, 2001). Violation of ORS 675.510(6) related to unprofessional conduct constituting a danger to the health or safety of a client or the public and 675.540(1)(d) gross negligence in the practice of clinical social work. (Deceased March 2, 2002)

Leo Munter, MSW (LCSW 0167)

Final Order, Revocation of License (November 28, 2000). Violation of ORS 675.540(1)(d) related to unprofessional conduct, OAR 877-030-0070(1) dual relationship, and OAR 877-030-0070(4) sexual relationship.

Frederick Karnes, MSW (LCSW 2169)

Stipulated Agreement/Final Order (November 20, 2000). Violation of ORS 675.540(1)(d) related to unprofessional conduct. Karnes allowed license to lapse. Disposition and settlement of the matter without contested case hearing.

Elwyn Wenger, MSW (LCSW 0684)

Final Order by Default, Revocation of License (October 16, 2000). Violation of ORS 675.510(6) related to unprofessional conduct, OAR 877-030-0070(1) dual relationship, and OAR 877-030-0070(4) sexual relationship.

Charles Jeff Manley, MSW (LCSW 1612)

Letter of Reprimand (July 25, 2000). Violation of ORS 675.540(1)(d) related to unprofessional conduct. Manley allowed license to lapse. Disposition and settlement of the matter without contested case hearing.

Eleanor Park, MSW (LCSW 0531)

Final Order by Default, Letter of Reprimand (July 25, 2000). Violation of OAR 877-030-0070(6) inappropriate treatment, and ORS 675.540(1)(d) unprofessional conduct.

Wolfgang L. W. Kuettner, MSW (LCSW 0905)

Proposed Revocation resolved with a Stipulated Agreement (March 28, 2000). Violation of ORS 675.540(1)(d) related to unprofessional conduct, OAR 877-030-0070(1) dual relationship, and OAR 877-030-0070(4) sexual relationship with a client. Six-month suspension of license, probation for two-years with supervision throughout the probation, and additional continuing education.

Linda K. Fritz, MSW (LCSW 0208)

Final Order by Default, Revocation of License (February 1, 2000). Violation of ORS 675.540(1)(d) related to unprofessional conduct, OAR 877-030-0070(1) dual relationship, and OAR 877-030-0070(4) sexual relationship with a client.

David C. Medlin, MSW (LCSW 2176)

Final Order by Default, Revocation of License (December 1, 1999). Violation of ORS 675.540(1)(d) related to unprofessional conduct, OAR 877-030-0070(1) dual relationship, and OAR 877-030-0070(4) sexual relationship with a client.

Robin Longnight, MSW (LCSW 0962)

Final Order by Default, Suspension of license (October 26, 1999). Violation of ORS 675.540(3) related to unprofessional conduct, OAR 877-030-0040(2) dishonesty, and ORS 675.589 and OAR 877-030-0070(14) breach of confidentiality. 30-day suspension of license, requiring 12 hours of continuing education in the area of confidentiality and ethics.

Chari Chauvin, MSW (LCSW 2250)

Final Order, Revocation of License (July 1, 1999). Violation of ORS 675.540(1)(d) related to unprofessional conduct, OAR 877-030-040(2) dishonesty, fraud and deceit, and OAR 877-030-0070 dual relationship by committing acts detrimental to clients and exploiting clients for financial gain.

Janice A. Elliott, MSW (LCSW 1126)

Stipulated Agreement, Letter of Reprimand (June 17, 1999). Violation of 877-030-0070(1) related to dual relationship, and 877-030-0080 ethical responsibility as a supervisor.

Dawn W. Mesenburg, MSW (CSWA 0442)

Final Order by Default, Letter of Reprimand (May 11, 1999). Violation of OAR 877-030-0070(3) related to dual relationship with client. Reprimand to include additional supervision and continuing education.

V. Jason Hilton, MSW (LCSW 1289)

Final Order, Suspension of License (June 18, 1998). Violation of OAR 877-030-0070(3) related to dual relationship, and OAR 877-030-0070(4) and ORS 675.650(1)(e) sex with a former client. License suspended for six months and placed on three years probation, requires two years of supervision and specific continuing education.

Stipulated Agreement, Letter of Reprimand (January 9, 1998). Violation of OAR 877-030-0070 and 877-030-0070(6) related to unnecessary and inappropriate treatment or therapy with a client.

Final Order, Revocation of License (November 5, 1997). Violation of ORS 675.540(1)(a) and OAR 877-030-0070(1)(4)(6) related to conviction on two counts of first degree sexual abuse of minors.

Stipulated Agreement, Three-year Probation of License and two years of supervision (June 3, 1997). Violation of OAR 877-030-0070(6) related to unnecessary and inappropriate treatment or therapy with a client.

Stipulated Agreement, Letter of Reprimand (March 16, 1996). Violation of OAR 877-030-0070(1), (15), (17) related to accepting commissions for soliciting and making client placements while under contract with an agency.

Stipulated Final Order (July 11, 1995) with a 90-day License Suspension, two-year plan of supervision, and probation for five years (7-11-2000). Violation of ORS 675.540(e), OAR 877-030-0070(1), (7), and (15) related to dual relationship with a client.

Kathleen Boeve', MSW (LCSW 1460)

Letter of Reprimand issued (June 12, 1995). Violation of OAR 877-030-0070(1), related to dual relationship.

Kenneth E. Pierce, MSW (LCSW 1849)

Stipulated Agreement, Surrender of License in Lieu of Revocation (March 25, 1995). Violation of OAR 877-030-0070(1) related to unprofessional conduct and incompetence, 877-030-0070(1) dual relationship, and 877-030-0070 (4), sex with a client.

Letter of Reprimand issued (July 11, 1994). Violation of OAR 877-30-005(2)(a) and (e) related to providing a written report with a recommendation based on inadequate information, and OAR 877-30-000(1)(b) misrepresentation of facts in both a written report and statement of fees.

License surrendered in lieu of a Contested Case Hearing scheduled for July 11, 1995. Violation of ORS 675.540(1)(e), OAR 877-30-005(2)(d) related to dual relationship, and OAR 877-30-080(2) sexual acts with client.

Revocation of license (March 31, 1994). Violation of OAR 877-30-005(2)(c) related to dual relationship, and (2)(d) engaging in sexual acts with a client.

Stipulated Agreement, Supervision (July 6, 1993). Violation of OAR 877-030-000(1)(b) related to prescribing and dispensing homeopathic remedies; and 877-030-005(2)(g) billing inaccuracies.

Stipulated Agreement, Three-year Probation, Two years of Supervision, Civil Penalty, and specific Continuing Education (June 6, 1993). Violation of OAR 877-030-0005(2)(a) related to dual relationship, and (d) inappropriate billing to insurance company.

Stipulated Agreement to not renew license in lieu of proposed disciplinary action (March 9, 1993). Violation of OAR 877-30-005(2)(d) related to dual relationship.

Stipulated Agreement, Two years of Supervision (November 17, 1992). Violation of OAR 877-030-0005 (2)(a)(e), related to service to clients to the maximum of competency level. Terms of Agreement completed February 1994.

David A. Olson, MSW (LCSW 1129)

Letter of Reprimand, Civil Penalty (June 9, 1992). Violation of OAR 877-030-000(1)(b) related to dishonesty, fraud, deceit or misrepresentation.

Michael Slover, MSW (LCSW 0014)

Stipulated Agreement, Probation with two-years of Supervision, Practice limited to adults, (May 12, 1992). Violation of OAR 877-030-0005(2)(a) and (e), related to service to clients to the maximum of competency level.

Stipulated Agreement, Psychotherapy, Supervision, (November, 12, 1991). Violation of OAR 877-030-0005(2)(d) related to dual relationship and (2)(c) engaging in sexual acts with clients.

Revocation of License (October 10, 1991). Violation of OAR 877-030-0005(2)(d) related to dual relationship (second violation).

Carol J. (Carly) Doster, MSW (LCSW 0941)

Stipulated Agreement, Psychotherapy, Supervision, (August, 13, 1991). Violation of OAR 877-030-0005(2) (d) related to dual relationship, and OAR 877-030-0005(4) and ORS 675.580 (1) breach of confidentiality.

License Revocation (December 11, 1990). Violation of OAR 877-030-0005(2)(c) related to engaging in sexual acts with clients. Convicted of felonies of sexual abuse in the second degree, contributing to the sexual delinquency of a minor, sodomy in the first degree, second degree, and third degree, and attempted sodomy in the first degree.

License Revocation (July 23, 1990). Violation of ORS 675.540(1)(c)(d)(e) related to dual relationships, and 13 counts of OAR 877-30-000(1)(b)(c), 877-030-0005 (2)(b)(c)(d) (f)(g), and 877-030-0005(4)(b) engaging in sexual acts with clients.

David B. Hawkins, MSW, Ph.D., (LCSW #0622)

Stipulated Agreement, withdrawal of Licensure application for 1989 and 1990 (May 8, 1990). Violation of ORS 675.540 and OAR 877-030-0005(2)(a)(b)(c)(d) related to dual relationship, and 877-030-020 sexual act with a client.

Stipulated Agreement, Letter of Reprimand, Supervision, (December 15, 1989). Violation of OAR 877-030-0005(2)(a)(c), related to dual relationship.

License Revocation (August 3, 1989). Violation of ORS 675.540 and OAR 877-030-0005(2)(a)(b)(c)(d) and 877-030-020, related to dual relationship with clients, sexual act with a client.

Letter of Reprimand (November 10, 1988). Violation of ORS 675.540(f); OAR 877-030-0005(3) and 877-030-0020 related to breach of confidentiality.
