This CBIC Pro Bono site shows that the number of Oregon CCB registered contractors between 2004 and 2005 increased by 5,937, from 39,520 in 2004 to 45,457 contractors in 2005.

This CBIC Pro Bono site also shows that the number of insurance companies writing these contractors' liability insurance policies increased to 356 in 2005 from 294 in 2004, a net increase of 62 insurance companies.

This site compares the average annual cost of CBIC contractors liability insurance policies for Oregon, Washington, California, Arizona, Nevada, Idaho, Montana, Wyoming and New Mexico for the 16,710 CBIC insurance policies in these states with Oregon's 4,037 policies having the lowest CBIC average rate of all states - \$1,290.
