



## Sanitation Inspection Agency List

Sanitation inspections are required annually for child care licensing. It is the responsibility of all child care facilities to pay any fee involved in obtaining the inspection. Contact the agency in your county for their fee schedule then mail your check and the inspection forms (contact your local post office for amount of postage stamps required). Allow Environmental Health Specialists five weeks advance notice.
