The following list indicates updates to Permit Maps and Attachments that are not yet reflected on the respective Map or Attachment. The information provided herein takes precedence over the information provided on the Maps and Attachments listed.

PERMIT MAPS

Group Map 1 – Revision Date 01/2008

1. OR202 between MP23.7 and MP29.20 is authorized for Truck & Trailer combinations up to 75' overall length with a 48' trailer maximum.
2. Territorial Hwy#200 between MP37.86 and MP42.08 (Douglas Co line) is authorized for Log Truck/Pole Trailer and Log Truck/Full Trailer (40' Trailer maximum) combinations up to 75' overall length.

Route Map 2 – Revision Date 06/01/2005

1. US30 Business (Sandy Blvd) shown in Portland Metro detail box is now under City of Portland jurisdiction. Call Portland Bureau of Transportation at (503) 823-5185 for information.
2. US97 Business south of junction with US20 in Bend is now under city jurisdiction.
3. US30 Bypass (Sandy Blvd) between 162nd Ave and 203rd Ave now belongs to the City of Portland. East of 203rd is under Multnomah Co. jurisdiction.
4. Powell Butte Hwy#371 is now under Crook Co. jurisdiction.

Route Map 5 – Revision Date 10-2006

1. McVay Hwy (#225) is now a Black route (old Red route).
2. OR99 E (#81) From MP46.15 at the junction of Astoria rd to the junction of I-5 is now a Black route (new addition)

Route Map 6 – Revision Date 09/17/2003

1. US30 Business (Sandy Blvd) shown in Portland Metro detail box is now under City of Portland jurisdiction. Call Portland Bureau of Transportation at (503) 823-5185 for information.
2. US97 Business south of junction with US20 in Bend is now under city jurisdiction.

Route Map 7 – Revision Date 10/2006

1. OR86 east of Halfway to Copperfield is now a Purple Route (old Red Route).
2. US20/US26 (Central Oregon Hwy #007) From MP266 to Idaho Border at the Snake River is now a Brown route (old Black route).
3. Territorial Hwy (#200) From MP25.05 (Jct of Crow rd) to MP25.35 (Jct of Wolf Creek rd) is now a Blue route (old Red route).
4. OR42S From MP0.010 at Bandon to MP2 is now a Brown route (old Red route).
5. US197 (#004) From MP67.17 (Jct US97) to MP54.20 is now a Brown route (old Red route).
6. **OR140 (#20) From MP36 (jct Gadowa Springs rd) to MP41 (Jct Sprague River rd) is now a Brown route (old purple route)**

Route Map 8 – Revision Date 10/2006

1. Bridge #11 on I-84 on the front of the map has had all weight restrictions removed.
2. Bridge #31 on OR82 on the front of the map has had all weight restrictions removed.
3. Bridge #51 on US26/OR126 on the front of the map has had all weight restrictions removed.
4. Bridge #96 on I-5 on the front of the map has had all weight restrictions removed.
5. Bridge #114 on OR47 on the front of the map has had all weight restrictions removed.
6. Bridge #93 on I-5 on the front of the map has had all weight restrictions removed.
7. Bridge #90 on Midland Hwy on the front of the map has been replaced and all weight restrictions removed.
8. Bridge #81 on OR234 (Old OR99W) on the front of the map has been improved and will now allow 98,000 lbs. GVW – weight table 3 and extended weights up to 105,500 lbs – weight table 2.
9. Bridge #95 on I-5 on the front of the map has had all weight restrictions removed.

Note: Permit Weight Tables 1 and 2 are also displayed on Group Map 1 and Route Map 7.

1 The loaded weight of any group of axles, vehicle or combination of vehicles shall not exceed that specified in Permit Weight 1 or any of the following:

- the manufacturer's sidewall tire rating, but not to exceed 600 pounds per inch of tire width.
- 20,000 pounds on any one axle, including any one axle of a group of axles.
- 34,000 pounds on any tandem axle.
- the sum of the permissible axle, tandem axle, or groups of axle weights, whichever is less.
