1. Executive Summary

The Drug Takeback Solutions Foundation’s (“Foundation”) Drug Take-Back Program Plan (“Approved Plan”) was approved by the Oregon Department of Environmental Quality (“the Department”) on June 4, 2021 pursuant to ORS 459A.200 to 459A.266 and related rules (the “Drug Take-Back Law”). The Approved Plan requires that the Foundation submit to the Department an Annual Report on the development, implementation and operation of the Drug Take-Back Program (“Program”) for the previous year. This Annual Report describes collection and outreach activity between July 1, 2022 and June 30, 2023 (“Reporting Period”) pursuant to ORS 459A.230.

The Foundation operated 173 Kiosks at Drop-off Sites across the state of Oregon during the Reporting Period. The Foundation grew the network of Drop-off Sites by 20 during the Reporting Period. Additionally, in accordance with an approved Request for Additional Services, the Foundation operated Mail-back Distribution Sites at 475 locations including in 163 population centers where Kiosk Drop-off Sites could not be established. Direct mail service was provided to Lonerock and Antelope where no mail-back distribution locations were able to be established within the population centers.

To promote awareness of these collection methods, the Foundation employed targeted outreach to population centers and Historically Underserved Communities throughout the State. These campaigns included direct mail, print ads, influencer and programmatic media. Promotional materials were made available on the program website and for distribution to Authorized Collectors upon request.

Overall, the Foundation’s program experienced a 135% increase in weight of collected drugs from the previous year. The Foundation continues to explore opportunities to increase the number of Drop-off Sites statewide, improve public awareness and increase collection.

The following information included in the Report is in accordance with ORS 459A.230 and organized to reflect guidance provided by DEQ in the Guide for Oregon Drug Take-Back Program Annual Reports document. Capitalized terms used herein are the same as those used in the Approved Plan and the Drug Take-Back Law.

The Foundation will be following up with DEQ immediately to further

address these notifications and procedures going forward.

The Foundation's Program had a total of 173 Drop-off Sites participating during the program year. Four Drop-off Sites stopped participating during the Reporting Period. They include:

- Pill Box Drugs Inc., 625 Se Miller Ave., Dalles, OR 97338 (Closed 3/27/2023)

The Foundation added 20 Authorized Collectors to the program during the Reporting Period. Each of these 20 new Authorized Collectors will be provided with five auto-injector mail-back packages in accordance with the approved plan.

The Foundation provides prepaid, preaddressed Mailers to all covered entities at no cost. Three types of Mailers including Standard Mail-back Envelopes, Inhaler Mail-back Envelopes and Auto-injector Mail-back Packages are available at 475 Mail-back Distribution Sites or by request to all Covered Entities on the approved Program Website or by calling 1-800-350-0396, option 5.

Covered Entities are able to request up to three Standard Mail-back Envelopes or Inhaler Mail-back Envelopes at a time via the Program Website or Toll-free Phone Number. Covered Entities receive the Envelopes no later than 10 business days from date of request.

Mail-back Service to In-home Hospice Providers

The Foundation added two hospice locations in program year two bringing the total to Eleven Hospice locations established as Mail-back Distribution Sites. During the Reporting Period, 360 Mail-back envelopes were provided to these locations. The Foundation continues to work with Barb Hansen to set up and distribute mail-back envelopes to Hospice facilities across Oregon. Barb continues to reach out to the hospice centers that she works with to gauge interest and understand the feasibility of housing mail-back envelopes in each location. The Foundation intends to add mail-back envelopes to any facility that wants to participate and believes it is a need for their community.

The Foundation made a request for additional services for 166 population centers where the convenience standards were unable to be established or maintained. The request for additional service was approved by DEQ on September 8, 2022. The strategy proposed and approved to reach the underserved population centers included:

- The foundation established 475 Mail-back Service in 163 population centers for Program Year 2 (July 1, 2022 - June 30, 2023).
- The remaining 3 of the 166 population centers needing Additional Services were handled according to the below methods
 - Greenhorn - No need to provide service due to population zero
 - Lonerock - Direct Mail
 - Antelope - Direct Mail

The Foundations Direct Mail efforts resulted in 78 envelopes distributed, 1 envelope returned and .25 lbs collected.

A list of all Mail-back Distribution Sites used during the Program year and the weight of drugs collected at each location is included as Appendix C.

The Foundation’s Service Provider used transporters and disposal facilities that were not previously identified to DEQ. These updated transporters and disposal facilities are the result of availability of resources and a changing landscape across the waste industry including facility closures and waste backups at hazardous waste facilities. The Foundation did not encounter any safety or security problems during the collection, transportation or disposal of drugs in the Reporting Period.

6. Public Awareness and Education

Per ORS 459A.230(1)(k), please provide a summary of the drug take back program's compliance with ORS 459A.227.

Pursuant to ORS 459A.227, The Foundation executed a comprehensive and measurable public awareness and education strategy to drive awareness of the Program and maximize participation. The goal of the Foundation's public awareness and education efforts was to ensure that where and how to return Covered Drugs was widely understood by Oregon Covered Entities and Authorized Collectors.

To accomplish this comprehensive public awareness and education strategy, the Foundation deployed a combination of outreach initiatives including printed materials and media communication. Pursuant to ORS 459A.227(1)(a)-(d), each initiative aimed to instruct Covered Entities by providing at least one, if not all, of the following key messages:

- Promote the safe and secure storage of Covered Drugs by Covered Entities
- Awareness of the inherent risks of improperly storing or disposing of opioids or opiates and other Covered Drugs
- Discourage the disposal of Covered Drugs in the garbage or sewer system
- Promote the disposal of Covered Drugs through the use of the Drug Take-back Program including by publicizing information on Drop-off Sites, hours of operation, Mail-back Services, collection processes and any Collection Events

Additionally, the Foundation established a toll-free telephone number and website that Covered Entities could use to contact the Foundation about the Program. A summary of each of the initiatives deployed as part of the Foundation's public awareness and education strategy is provided below.

Printed Promotional Materials

In accordance with ORS 459A.227(4), the Foundation distributed promotional written materials to Retail Drug Outlets, hospitals with an on-site pharmacy and health care clinics with an on-site pharmacy so that they could, upon request, provide those materials to Covered Entities at the time that a Covered Drug was delivered. These materials were also provided on the Program's website.

These materials:

- Provided instruction on how to safely store Covered Drugs at home
- Informed of the risks of disposing of Covered Drugs in inappropriate waste streams (e.g., solid waste collection, sewer, or septic systems)
- Outlined how to participate in the Drug Take-back Program for safe disposal of Covered Drugs
- Informed Covered Entities about Drop-off Sites, hours of operation and Mail-back Services

Education Materials

In accordance with ORS 459A.227(1)(a)-(d) materials are available to Covered Entities on the Program Website and for distribution to Authorized Collectors upon request. These

Educational Materials promote the safe and secure storage of Covered Drugs while educating Covered Entities on best practices for the disposal of Covered Drugs through the use of the Drug Take-back Program.

Educational materials have been translated into six languages (English, Spanish, Russian, Chinese, Vietnamese, and Somali) to ensure that all Covered Entities have easy and convenient access to the materials.

The Foundation did not receive any requests for printed educational materials within the Reporting Period. However, each of the Foundation's new Drop-off Sites added in the Reporting Period was provided with promotional material in their welcome packet after enrollment as an Authorized Collector. This welcome packet also includes information on how to request additional promotional materials either by 1) requesting materials on the website to be downloaded or 2) contacting the Foundation to request that promotional materials be printed and shipped to the drop-off site at no cost. The retail drug outlets, on-site pharmacies, health care clinics with on-site pharmacies, and law enforcement agencies that received these education materials in the Reporting Period are listed in the table below.

Kiosk Signage

Kiosk Signage was created and implemented to educate and assist Covered Entities in the proper storage and disposal of Covered Drugs. In accordance with ORS 459A.227(1)(g) and in partnership with the other Program Operator, a common mark logo was created to provide a common symbol for Covered Entities to identify Collection Methods and educational materials that are part of the Program.

Direct Mail

In accordance with ORS 459A.227(1)(a)-(d), the Foundation utilized direct mail (5x7 postcard) to promote safe drug disposal and the utilization of the joint neutrally-branded website, medtakebackoregon.org. Direct mailings were translated and sent out in Spanish and English. Direct mail postcards highlighted important statistics, the joint neutrally-branded website and toll-free phone number, a visual of what the Kiosk looks like, and how to operate the Kiosk. Print Advertisements

In accordance with ORS 459A.227(1)(f), the Foundation worked with eleven regional newspapers across the state of Oregon to educate and inform Covered Entities of the joint neutrally-branded website and toll-free phone number, as well as the location of Drop-off Sites, Mail-back Distribution Sites and Collection Events. The newspaper advertisement was included in all print versions of the eleven newspapers and was also included in any online version of the newspaper, for newspapers that have online additions. Programmatic Media

Programmatic Media provides targeted display ads on browser sites on internet capable devices (smart phones, computers, tablets, etc.). Additionally, geo-targeting was used to focus the ads to increase awareness in Historically Underserved Communities, as well as other geographic and demographic groups. The Foundation ran ads across a prequalified list of over 200K domains including a variety of retail websites, Google, and Facebook. Impression metrics are reported directly from the individual websites that the ads are placed on and are reported on a per campaign basis. The Foundation can increase the number of programmatic campaigns utilized if reach and frequency standards are not met. See Appendix D for Programmatic Media examples.

Influencer Marketing

Influencer Marketing is a content creation tactic used to drive awareness and education to a targeted audience through blogs and social media outlets. Influencers create original authentic content around their everyday lives and interests while weaving the story of drug take-back into their content. Influencer content is converted into paid ad units across social platforms and then targeted to community members across Oregon. Paid advertisements for influencer content were run on a variety of platforms including Google, Facebook, and/or Instagram and drove towards a specified impression goal. The Foundation ran quarterly social media influencer campaigns and has now recruited Spanish speaking influencers to create content on safe drug disposal in their native languages. This approach allows for certain demographics to view content that tailors to their specific language needs in an authentic way. The Foundation can increase the number of Influencer campaigns and paid advertisements utilized if impressions and frequency standards are not met. See Appendix D for Influencer Marketing examples.

Website

The website can be translated into six languages including English, Spanish, Russian, Chinese, Vietnamese, and Somali. The website contained a map and list of Drop-off Sites, Mail-back Distribution Sites, and Collection Event locations, dates and times for all Covered Entities in Oregon. Covered Entities were able to request that Mailers including Standard Mail-back Envelopes, Inhaler Mail-back Envelopes, and/or Auto-Injector Mail-back Packages be sent directly to their residence with instructions on how to return the Mailers. The website provided additional information on The Foundation’s Program including a Frequently Asked Questions (FAQ) section.

Collection

The Foundation achieved a 135% increase in collected drugs overall from program year 1. The Foundation’s long-term goal was to increase collection weight by 10% each year. The Foundation recognizes that the overall collection weights have not caught up to the original goal of 20 pounds per month per Drop-off Site, however the trends are positive and collection weight continues to increase, and the Foundation did achieve an increase of over 10% in collection weight. These trends confirm the Foundation’s position that the length of time and duration that a Kiosk exists and the awareness built in the community around the Kiosk over time will result in increased collection. The weight collected from Drop-off Sites increased by 146.11% from the previous program year. Weight collected from mail-back services increased by 126% across all mail-back distribution methods.

The Foundation participated in many activities over the course of the program year in targeted efforts to increase collection and achieve collection goals. Some of these efforts included:

- The Foundation attended the OACP (Oregon Association of Chiefs of Police) Conference on April 5-6, 2022 in Oregon with the intention of engaging the Law Enforcement community and building partnerships to establish more Drop-off Sites across the State. As a result, the Foundation added 15 Drop-off Sites at Law Enforcement Agencies.
- The Foundation continued to engage with Barb Hansen, the CEO of Oregon Hospice and Palliative Care Association to place mail-back service at hospice facilities throughout the state. Two Mail-back Distribution Sites were added in the Reporting Period.

Public Awareness

The Foundation’s long-term public awareness goals include reaching 75% of Covered Entities across Oregon, improving Kiosk use and increasing awareness to Historically Underserved Communities. The Foundation was able to make 15 million impressions via views, readership and home addresses across different tactics of outreach implemented throughout the Reporting Period (see Section 6). The Foundation did not conduct a biennial survey in


Program Year 2, therefore public awareness goals are being measured by the tactics used to as outreach and not by survey responses.

The reach percentages reported for influencer and programmatic campaigns represent results for focused outreach to Historically Underserved Communities.

The Foundation has agreed to conduct an interim year survey to assess the level of program awareness and, as a result, make additional adjustments to the public awareness strategy if needed. The results of that survey
