35	The Board introduced themselves to staff. The Chair announced that a new Board
36	member, Scott Ashford who is the Dean of Engineering for Oregon State, was unable to
37	attend this meeting but should be at the December 2015 Board meeting.

39	7) Board Action: (Board)
40	Luke thanked staff for the time they spent reviewing candidates and the comments they
41	made.

43	Givens stated it was a tough decision. The Board considered staff comments, references
44	and overall the candidates were very qualified and interviewed well. Based on that
45	information they were finally able to come to a decision.
46	
47	Dennis Luke moved that Brad Avy be offered the position as the Director of the
48	Oregon Department of Geology and Mineral Industries. Maffei Seconded. Discussion:
49	Phipps commented that staff should know where the Board was focusing their
50	attention. These were two very different candidates and they were the very best
51	candidates that they had interviewed. For the board, the science background is
52	important but where they really see a need and focus is on the management aspect. The
53	Agency is at a critical juncture and moving forward it needs to have someone with the
54	experience and track record of affecting positive change with agencies that have been
55	transitioning. For her, this was the deciding factor of her vote.

57	Luke stated this was not an easy decision. A lot of discussion took place and he really
58	appreciated the frank comments from staff.
59	
60	Maffei stated that this was tough. The reason why the Board was two hours past the
61	scheduled time was because there was so much discussion that took place to conclude
62	what the Board wanted and what would be good for the Agency. These were two

excellent candidates and she appreciated all the time and effort that staff provided during this process.

Givens stated that both those candidates expressed interest and willingness to work with staff to move the agency forward. Chair Givens called for a vote of the motion of offering the State Geologist and Agency Director position to Brad Avy. All in favor: Givens, Maffei, Phipps and Luke. Motion carried.

Dennis Luke moved to delegate to the Board Chair to act on the behalf of the Board to negotiate final terms of employment. Maffei Seconded.

Discussion:

Givens will be working with DAS on terms of employment. He reminded everyone that he will be leaving the board possibly in February 2016 since it will be the end of his term.

All in favor: Givens, Maffei, Phipps, Luke. Motion carried

Luke asked the Chair to request that DAS recruitment inform staff what lies ahead in the final process. Sama provided a short summary of what to expect in the final process, and stated that timing is contingent on several factors.

Phipps stated that the Board will continue to be closely involved in this process and in helping with the transition of the Agency.

Chair Givens opens the meeting to public comment:

Niewendorp asked the Board what was the estimated state date of the new Director. Chair Givens stated that he would like to see the new Director start as soon as possible. He would hope for a start date of December 1, 2015, but there is no guarantee.

Schueller asked if the Board could share anything about Brad Avy's background. Mercer volunteered to share the chosen candidate's resume with all staff and looked for approval. Sama stated that all personal information needs to be redacted. Phipps provided a quick summary of Avy's academic, work history and other relative involvement to staff.

Mercer personally thanked the members of the staff panel for their time and effort. The Board seconded her comment. Givens thanked Aunan and Sama for their time and support in the process.
