**STATELINE WIND PROJECT:

**I. INTRODUCTION**

1           The Oregon Energy Facility Siting Council (Council) issues this final order in  
2 accordance with ORS 469.405 and OAR 345-027-0070. This order addresses a request by the  
3 current certificate holder, FPL Energy Vansycle, LLC (FPL Vansycle), and FPL Energy  
4 Stateline II, Inc. (FPL Stateline), for amendment of the site certificate for the Stateline Wind  
5 Project (SWP), a wind energy facility in Umatilla County, Oregon.

6           On September 14, 2001, the Council issued a site certificate to FPL Vansycle for the  
7 SWP. FPL Vansycle began construction of the first phase of the SWP on September 17, 2001,  
8 and completed construction on December 20, 2001. The first phase of construction (Stateline  
9 1) consists of 126 Vestas V47-660-kW wind turbines with a combined peak electric  
10 generating capacity of approximately 83 megawatts (MW) and related facilities. The facility  
11 began commercial operation on December 21, 2001.

12           On May 17, 2002, the Council approved a request by FPL Vansycle for an expansion  
13 of the SWP (Amendment #1). Amendment #1 authorized a second phase of construction  
14 (Stateline 2) consisting of 60 Vestas V47-660-kW wind turbines and related facilities. FPL  
15 Vansycle completed construction of these turbines on December 15, 2004. Amendment #1  
16 increased the combined peak generating capacity of the SWP to approximately 123 MW.

17           On June 6, 2003, the Council approved a request by FPL Vansycle for a further  
18 expansion of the SWP (Amendment #2). Amendment #2 authorized a third phase of  
19 construction (Stateline 3) consisting of 279 Vestas V47-660-kW wind turbines and related  
20 facilities. Amendment #2 included a site certificate condition (Condition 106) requiring the  
21 certificate holder to begin construction of Stateline 3 by June 23, 2005.

22           On March 28, 2005, FPL Vansycle requested an extension of the deadline to begin  
23 construction of Stateline 3 (Amendment #3). On June 20, 2005, the Council approved  
24 Amendment #3 and extended the deadline to begin construction to June 23, 2007.<sup>1</sup>

25           On December 22, 2006, FPL Vansycle requested a further extension of the deadline to  
26 begin construction of Stateline 3 (Amendment #4). On April 10, 2007, FPL Vansycle  
27 withdrew its request for Amendment #4 before the Council had taken any action on the  
28 amendment request.<sup>2</sup> The deadline to begin construction of Stateline 3 expired on June 23,  
29 2007. None of the Stateline 3 facilities approved by Amendment #2 have been built.

30           The definitions in ORS 469.300 and OAR 345-001-0010 apply to terms used in this  
31 order.

## II. PROCEDURAL HISTORY AND AMENDMENT PROCESS

1 On October 24, 2008, FPL Vansycle and FPL Stateline (the applicants) submitted their  
2 “Revised Application for a Fourth Amended Site Certificate, Including a Request for Partial  
3 Transfer of the Site Certificate as It Pertains to Stateline 3” (Revised Request for Amendment  
4 #4). On November 6, 2008, the applicants sent copies of the amendment request to a list of  
5 reviewing agencies provided by the Oregon Department of Energy (Department) with a  
6 memorandum from the Department requesting agency comments by December 19, 2008. On  
7 November 12, the Department sent notice of the amendment request to all persons on the  
8 Council’s mailing list, to the special list established for the facility and to updated list of  
9 property owners supplied by the certificate holder, requesting public comments by December  
10 19.

11 By letter dated November 13, the Department notified the applicants that the  
12 amendment request would require “extended review” (OAR 345-027-0070(2)). The  
13 Department advised the applicants that the proposed order would be issued no later than  
14 February 20, 2009.

15 The Department received agency comments from the State Historic Preservation  
16 Office (SHPO)<sup>3</sup>, the Water Resources Department (OWRD)<sup>4</sup>, Oregon Parks and Recreation  
17 Department (OPRD)<sup>5</sup>, Umatilla County<sup>6</sup>, the Oregon Department of Fish and Wildlife  
18 (ODFW)<sup>7</sup> and the Oregon Department of Geology and Mineral Industries (DOGAMI)<sup>8</sup>. The  
19 Department received public comment from Eurus Combine Hills I LLC (Eurus).<sup>9</sup>

20 SHPO requested a copy of the final cultural resources survey report that is referenced  
21 in the amendment request.<sup>10</sup> The applicants sent a copy of the report to SHPO when it became  
22 available on January 15, 2009. OWRD advised the Department of relevant statutes and  
23 administrative rules but otherwise had no substantive comments. OPRD had no substantive  
24 comments. Umatilla County provided the Department with the substantive criteria applicable  
25 to the land use analysis discussed herein. ODFW had general and specific comments and  
26 requested additional information regarding affected habitat, threatened and endangered  
27 species and the applicants’ proposed Wildlife Mitigation Plan and Revegetation Plan  
28 (Appendices P-1 and P-2 of the amendment request). The Department requested that the  
29 applicants respond to the issues raised in the ODFW comment letter.<sup>11</sup> The applicants  
30 responded to the ODFW letter in their supplemental information.<sup>12</sup> DOGAMI requested the  
31 results of future site-specific geotechnical investigation prior to construction of the Stateline 3  
32 components and advised the applicants to prepare reports according the Guidelines for  
33 Engineering Geology Reports and Site-Specific Hazard Report (Open File Report 00-00-4).

1 DOGAMI advised that the facilities should be designed to meet the current Oregon Structural  
2 Specialty Code (OSSC 2007) and the 2006 International Building Code.

3 The comment letter from Eurus asserted that the proposed new Stateline 3  
4 configuration would interfere with Combine Hills I, a 41-MW wind energy project on  
5 adjacent land that is not under Council jurisdiction. Eurus stated: “Because of the prevailing  
6 wind, several of the FPL turbines would create a wake that would interfere with the operation  
7 of certain Combine Hills I turbines.” Eurus asserted that “the economic loss to Combine Hills  
8 I would be significant” due to “decreased energy production and reduced energy sales  
9 revenues.” Eurus requested “that Stateline 3 be modified to eliminate the interference with the  
10 operation of the Combine Hills I wind development.” Eurus advanced numerous legal  
11 arguments in support of its position, which Eurus summarized as follows:

12 Unless EFSC imposes additional site certificate conditions to mitigate the impacts on  
13 Combine Hills I, EFSC cannot find that Stateline 3 as proposed in the Revised Application  
14 meets all siting standards and must therefore deny the site certificate amendment. The  
15 standards that Stateline 3 fail to meet are identified below. In addition, granting the site  
16 certificate amendment is contrary to Oregon state law and Oregon and U.S. Constitutions.  
17 Moreover, without conditions to mitigate the impact on Combine Hills I, the project is  
18 contrary to state energy policy.

19 The Department requested that the applicants respond to the issues raised in the Eurus  
20 comment letter.<sup>13</sup> The applicants provided a detailed response to the legal arguments raised by  
21 Eurus.<sup>14</sup>

22 In 2003, Eurus Oregon Wind Power Development LLC raised identical legal  
23 arguments in a request for a contested case proceeding on the Department’s Proposed Order  
24 on Amendment #2. At that time, the Department advised the Council that there was no legal  
25 authority establishing a common law right to preclude development of competing wind  
26 energy facilities on adjacent property as had been claimed by Eurus.<sup>15</sup> The Department stands  
27 by that advice today and recommended that the Council defer to Oregon statutory law on this  
28 issue.<sup>16</sup> ORS 105.900 defines a “wind energy easement” as “any easement, covenant or  
29 condition designed to insure the undisturbed flow of wind across the real property of another.”  
30 Eurus has not negotiated a wind energy easement with the landowner of the adjacent  
31 properties where the applicants propose to build the new Stateline 3 components. In the  
32 absence of a wind energy easement, Eurus has no right to the “undisturbed flow of wind” on  
33 property they do not own, and the Council should not step in to restrict construction of  
34 Stateline 3 as requested by Eurus.

35 The Department analyzed the Revised Request for Amendment #4 for compliance  
36 with all applicable Council standards. The Department’s recommended findings and  
37 conclusions were discussed in a Proposed Order issued on February 20, 2009. The  
38 Department recommended that the Council approve the amendment request, subject to  
39 revisions of the Site Certificate discussed below at page 128.

1 After issuing the Proposed Order on February 20, the Department issued a public  
2 notice as required under OAR 345-027-0070(5) and posted the notice on the Department's  
3 Internet website. The notice invited public comment and gave a deadline of March 23, 2009,  
4 for comments or contested case requests. The Department did not receive any comments or  
5 contested case requests by the deadline of March 23.

6 At a public meeting in Pendleton, Oregon, on March 27, 2009, the Council held an  
7 informational hearing on the request for partial transfer of the site certificate. The Council  
8 considered the Department's recommendations, and voted to approve the amendment request.

### III. DESCRIPTION OF THE PROPOSED AMENDMENT

9 FPL Vansycle and FPL Stateline request amendments to the Third Amended Site  
10 Certificate for the Stateline Wind Project (Site Certificate) that, if approved, would authorize  
11 a reconfigured third phase of construction (Stateline 3) and would partially transfer the Site  
12 Certificate from the current certificate holder (FPL Vansycle) to FPL Stateline.

13 The applicants propose a "modification of the attributes of Stateline 3."<sup>17</sup> The effect of  
14 the requested "modification" would be authorize construction and operation of the new  
15 Stateline 3 components described in the amendment request and to withdraw authorization to  
16 construct and operate the previously-approved Stateline 3 facilities.<sup>18</sup> The applicants propose  
17 two design options for the new Stateline 3 configuration. The first option would consist of up  
18 to 43 Siemens 2.3-MW wind turbines having a combined peak generating capacity of up to  
19 98.9 MW. The second option would consist of up to 67 GE 1.5-MW turbines having a  
20 combined peak generating capacity of up to 100.5 MW. Under either design option, Stateline  
21 3 would include related or supporting facilities including a substation, new access roads, an  
22 underground 34.5-kW power collection system, an aboveground 230-kV transmission line (to  
23 connect the facility to the regional power grid), a supervisory control and data acquisition  
24 (SCADA) system and an operations and maintenance building.

25 In addition, FPL Vansycle and FPL Stateline request a partial transfer of the Site  
26 Certificate. The current certificate holder is FPL Vansycle. Under Council rules (OAR 345-  
27 027-0100) a transfer of a site certificate is necessary when the person who will have the legal  
28 right to possession and control of the site or facility does not have authority under the site  
29 certificate to construct, operate or retire the facility. In this case, a "partial transfer" is  
30 requested so that FPL Vansycle would retain authority to operate and retire the currently  
31 operating Stateline facility (Stateline 1&2) while FPL Stateline would have authority under  
32 the amended Site Certificate to construct, operate and retire the third phase of construction  
33 (Stateline 3). If the Council approves the amendment request, FPL Stateline would become a  
34 certificate holder and FPL Vansycle would continue to be a certificate holder. The obligations  
35 of the certificate holders as described in the terms and conditions of the site certificate would  
36 be divided between FPL Vansycle and FPL Stateline so that FPL Vansycle would be  
37 responsible for compliance with conditions relating Stateline 1 and 2 and FPL Stateline would  
38 be responsible for compliance with conditions relating to Stateline 3.

## 1. Amendment Procedure

1 Under OAR 345-027-0050(1), a certificate holder must request a site certificate  
2 amendment “to design, construct, operate or retire a facility in a manner different from the  
3 description in the site certificate” if the proposed change:

- 4 (a) Could result in a significant adverse impact that the Council has not addressed in  
5 an earlier order and the impact affects a resource protected by Council standards;
- 6 (b) Could impair the certificate holder’s ability to comply with a site certificate  
7 condition; or
- 8 (c) Could require a new condition or a change to a condition in the site certificate.

9 The proposed changes to the site certificate would authorize construction (Stateline 3)  
10 outside of the site boundary previously approved by the Council. The construction and  
11 operation of Stateline 3 could have adverse impacts that the Council has not addressed in  
12 earlier orders on the SWP and that could affect resources protected by Council standards. The  
13 proposed changes would require new site certificate conditions and changes to current  
14 conditions. For these reasons, amendment of the site certificate is necessary.

15 The proposed amendment would modify the site of the SWP facility and would make  
16 other changes to the construction and operation of the facility allowed under the site  
17 certificate. For areas that would be affected by construction and operation of Stateline 3, the  
18 Council must consider whether the facility complies with all Council standards (OAR 345-  
19 027-0070(10)(a)). In addition, for all site certificate amendments, the Council must consider  
20 whether the amount of the bond or letter of credit required under OAR 345-022-0050 is  
21 adequate (OAR 345-027-0070(10)(d)). We address compliance with these requirements in  
22 Sections IV and V.

23 An amendment that partially transfers the site certificate is subject to the procedures  
24 described in OAR 345-027-0100. To request a transfer, the transferee (in this case, FPL  
25 Stateline) must submit a written request to the Department that includes the information  
26 described in OAR 345-021-0010(1)(a) (information about the applicant), (d) (organizational  
27 expertise) and (m) (financial capability), a certification that the transferee agrees to abide by  
28 all terms and conditions of the site certificate currently in effect and, if known, the date of the  
29 transfer of ownership.<sup>19</sup>

30 The amendment request does not contain an explicit certification that FPL Stateline  
31 agrees to abide by “all terms and conditions of the site certificate currently in effect” and,  
32 instead, proposes a division of responsibility for compliance with the site certificate terms and  
33 conditions as modified upon the Council’s approval of Amendment #4. The modified terms  
34 and conditions of the site certificate, as proposed by the applicants, include a “no-cross-  
35 default provision that would not expose one co-applicant to liability in the event the other co-  
36 applicant experienced a compliance problem regarding its portion of the Facility.”<sup>20</sup>

1 The amendment request does not state the date of the partial transfer of ownership of  
2 the SWP to FPL Stateline. If approved by the Council, Amendment #4 would authorize FPL  
3 Stateline to construct and operate the Stateline 3 portion of the SWP upon the effective date of  
4 the amended site certificate.

5 The Council must hold a public informational hearing before acting on the transfer  
6 request (OAR 345-027-0100(7)). To approve a partial transfer of the site certificate, OAR  
7 345-027-0100(8) requires the Council to find that:

8 (a) The transferee complies with the standards described in OAR 345-022-0010,  
9 OAR 345-022-0050 and, if applicable, OAR 345-024-0710(1); and

10 (b) The transferee is lawfully entitled to possession or control of the site or the  
11 facility described in the site certificate.

12 OAR 345-024-0710(1) pertains to the carbon dioxide emissions standard and is not  
13 applicable in this case. OAR 345-022-0010 is the Organizational Expertise Standard and OAR  
14 345-022-0050 is the Retirement and Financial Assurance Standard. The compliance of FPL  
15 Stateline (the transferee) with these standards is discussed herein at pages 13 and 15.

16 The amendment request indicates that the current certificate holder, FPL Vansycle,  
17 would “transfer all its rights, duties and obligations under the Site Certificate pertaining to  
18 Stateline 3 to its affiliate, FPL Stateline.”<sup>21</sup> Accordingly, FPL Stateline would be lawfully  
19 entitled to possession or control of the site of the facility (Stateline 3) described in the site  
20 certificate. Both FPL Vansycle and FPL Stateline are wholly-owned, indirect subsidiaries of  
21 FPL Energy, LLC. On January 7, 2009, FPL Energy, LLC, announced that it had changed its  
22 name to NextEra Energy Resources, LLC.<sup>22</sup> The applicants state that “the only material  
23 differences between FPL Vansycle and FPL Stateline relate to the differing financing  
24 arrangements and the differing power sale arrangements for the different Stateline phases.”<sup>23</sup>

25 The Council may act concurrently on the requests to reconfigure the third phase of  
26 construction and to partially transfer the site certificate, as described in OAR 345-027-  
27 0100(12). The Department and the Council must follow the procedures of OAR 345-027-0100  
28 and the procedures of OAR 345-027-0070 in reviewing the combined amendment requests.

## 2. Amendments to the Site Certificate as Proposed by the Applicants

29 As an attachment to the Revised Request for Amendment #4, the applicants proposed  
30 specific changes, additions and deletions in the form of a “redline” revision of the Third  
31 Amended Site Certificate. The attachment is incorporated herein by this reference. The  
32 Department recommended that the Council approve the substance of the site certificate  
33 amendments proposed by the applicants with other modifications consistent with the  
34 amendment request. The Department’s recommended revisions are discussed herein  
35 beginning at page 128.

36 In addition to the changes to the language of the Site Certificate, the amendment  
37 request proposes revisions to the *Oregon Wildlife Monitoring Plan* and the *Revegetation*

1 *Plan*.<sup>24</sup> The amendment request proposes adoption of a habitat mitigation plan. Currently  
2 habitat mitigation requirements are included within the *Revegetation Plan*. The Department  
3 supports the applicants' proposal for a separate habitat mitigation plan for Stateline 3.<sup>25</sup> The  
4 *Oregon Wildlife Monitoring Plan* is incorporated in Condition 93 of the current site  
5 certificate; the *Revegetation Plan* (including habitat mitigation requirements for Stateline  
6 1&2) is incorporated in Conditions 65, 66, 67 and 68. The Department's recommended  
7 modifications of the *Oregon Wildlife Monitoring Plan* (renamed the *Wildlife Monitoring and*  
8 *Mitigation Plan*) are addressed in Revision 52, and the Department's recommended revisions  
9 of the *Revegetation Plan* are addressed in Revision 45. Revision 68 would modify Condition  
10 112 to incorporate a new *Stateline 3 Habitat Mitigation Plan* in the Fourth Amended Site  
11 Certificate.

### 3. Description of the Facility as Authorized by Amendment #4

12 If the Council approves Amendment #4, the certificate holders would be authorized to  
13 construct and operate the SWP facility. FPL Vansycle would be authorized to construct and  
14 operate the parts of the facility that the Council approved in the Final Order on the  
15 Application and the Final Order on Amendment #1 (Stateline 1&2). FPL Stateline would be  
16 authorized to construct and operate the parts of the facility authorized by Council action on  
17 Amendment #4 (Stateline 3). These two separate parts of the SWP are described below.

#### (a) Stateline 1&2

##### 18 Turbines

19 Stateline 1&2 consists of 186 Vestas V47-660-kilowatt (kW) wind turbines, each  
20 having a peak generating capacity of 0.66 MW.<sup>26</sup> FPL Vansycle has built and is operating the  
21 Stateline 1&2 turbines. The combined peak generating capacity of the operating turbines is  
22 approximately 123 MW.

##### 23 Power Collection System

24 The wind turbines generate power at 690 volts. A transformer adjacent to each tower  
25 transforms the power to 34.5 kV. From there, power is transmitted via underground 34.5-kV  
26 electric cables buried directly in the soil approximately 3 to 4 feet below the ground surface.  
27 In some cases, trenches run from the end of one turbine string to the end of an adjacent  
28 turbine string to link the turbines via the underground network. The underground collector  
29 system links the facility's turbines to a substation located in Washington. Overhead  
30 transmission lines, located entirely within Washington, connect the substation to the regional  
31 power grid. The substation and aboveground interconnection lines in Washington are not  
32 subject to the Site Certificate.

1 The site certificate application for Stateline 1 described the cumulative length of the  
2 underground collector system as 85,209 linear feet (approximately 16.1 miles).<sup>27</sup> The Request  
3 for Amendment #1 described the cumulative length of the underground collector system for  
4 Stateline 2 as 45,000 linear feet (8.5 miles).<sup>28</sup> Thus, the total cumulative length of the  
5 Stateline 1&2 collector system is approximately 24.6 miles.

#### 6 **Meteorological Towers**

7 The Stateline 1&2 portion of the facility includes six permanent meteorological (met)  
8 towers to measure wind conditions.

#### 9 **Operations and Maintenance Building**

10 The facility includes an operation and maintenance (O&M) facility, which is a satellite  
11 to the primary O&M facility located in Washington.<sup>29</sup> The satellite O&M facility is located  
12 along Butler Grade Road south of Gardena and just south of the state line in Oregon.

#### 13 **Access Roads**

14 County roads that extend south from Highway 12 in Washington (Hatch Grade Road  
15 and Butler Grade Road) and north from Oregon Highway 11 (Vansycle Canyon Road and  
16 Butler Grade Road) are the primary routes of access to the facility site. From the County  
17 roads, a web of private farm roads provides access to most of the ridges upon which the  
18 facility is located. Additional access roads are located along the length of each turbine string  
19 and between strings to connect each turbine string to the next.

20 For Stateline 1, the Council approved construction of approximately 12.2 miles of new  
21 access roads and improvement of approximately 4.3 miles of existing farm roads (widening,  
22 grading and graveling).<sup>30</sup> For Stateline 2, the Council authorized construction of an additional  
23 6.5 miles of new access roads and improvement of approximately 1.5 miles of existing farm  
24 roads.<sup>31</sup> Thus, the total cumulative length of Stateline 1&2 access roads is approximately 18.7  
25 miles of new roads and 5.8 miles of improved farm roads.

#### 26 **Construction Disturbance Areas**

27 In addition to the area occupied by the permanent facility components (approximately  
28 87 acres), construction of Stateline 1&2 affected approximately 196 acres.<sup>32</sup>

1           **Stateline 1&2 Site and Site Boundary**

2           The SWP is located in Umatilla County, north of Helix, Oregon, and south of the  
3 Oregon-Washington border. The Stateline 1&2 turbines and related facilities are located in  
4 Township 6 North, Ranges 32 and 33 East.<sup>33</sup>

5           As defined by OAR 345-001-0010, the “site boundary” is the perimeter of the site the  
6 energy facility, its related or supporting facilities, all temporary laydown and staging areas  
7 and all corridors and micrositing corridors.<sup>34</sup> The Council has recognized the need for wind  
8 energy developers to have flexibility to “microsite” the final location of wind turbines and  
9 related infrastructure after issuance of a site certificate, based on turbine selection,  
10 geotechnical constraints, site-specific wind resource factors, avoidance of high-value wildlife  
11 habitat and the desire to reduce conflict with farming practices. Beginning in 2006, the  
12 Council has approved micrositing areas in site certificates and site certificate amendments for  
13 wind facilities.

14           The original site certificate and the First Amended Site Certificate for the SWP (which  
15 together authorized the construction and operation of Stateline 1&2) predate the Council’s  
16 practice of approving micrositing areas. Nevertheless, the Council specified turbine  
17 “corridors” in the location description for Stateline 1:<sup>35</sup>

18           Specific individual turbine locations would be within 300-foot wide corridors centered on the  
19 turbine locations depicted in Figures B-3 (three maps dated June 15, 2001) of the application  
20 and Figures 1 through 4 (dated July 20, 2001) attached to the letter from Andrew Linehan and  
21 received by the Office of Energy on July 23. A minimum distance of 250 feet would separate  
22 individual turbines. Figures B-2, B-3 and C-1 of the application and Figures 1 through 4  
23 (attached to the letter from Andrew Linehan and received by the Office of Energy on July 23),  
24 incorporated herein by this reference, show the location of the proposed facility.

25           The language specifying 300-foot turbine corridors is incorporated by reference in the  
26 current site certificate.<sup>36</sup> The Final Order on Amendment #1 included a description of the  
27 location of the Stateline 2 wind turbines and related facilities that incorporated by reference  
28 Figures 1 and 2 of the Request to Amend Site Certificate.<sup>37</sup> The Final Order on Amendment  
29 #1 did not modify the description of 300-foot turbine corridors as applied to the Stateline 2  
30 turbines. The “site boundary” for Stateline 1&2 is the perimeter of the wind turbine corridors  
31 and related or supporting facilities described above, together with the laydown areas and  
32 temporary disturbance areas described in the site certificate application and the Request for  
33 Amendment #1.

34           **(b) Stateline 3**

35           **Turbines**

36           In the amendment request, the applicants propose two options for the third phase of  
construction. If approved by the Council, the certificate holders would be authorized to

1 construct and operate up to 67 GE 1.5-MW wind turbines or up to 43 Siemens 2.3-MW wind  
2 turbines. If 1.5-MW turbines are used, Stateline 3 would have a combined peak generating  
3 capacity of up to 100.5 MW. If 2.3-MW turbines are used, Stateline 3 would have a combined  
4 peak generating capacity of up to 98.9 MW. Revision 9 would modify the Site Certificate to  
5 specify the turbine selection options for Stateline 3.

#### 6 **Power Collection System**

7 A transformer adjacent to each tower transforms the power from the wind turbine  
8 generator to 34.5 kV. Up to 24.4 miles of 34.5-kV collector lines would transport the power  
9 from the turbines to the project substation.<sup>38</sup> The entire system of collector lines for Stateline  
10 3 would be installed underground.

#### 11 **Meteorological Towers**

12 The operators of Stateline 3 would rely on data from the existing met towers for  
13 Stateline 1&2.<sup>39</sup> In addition, two new met towers would be built for Stateline 3. The new met  
14 towers would be unguyed towers up to 80 meters in height. The towers would be monopole  
15 structures on concrete foundations.<sup>40</sup>

#### 16 **Substation and Interconnection**

17 A new substation would be constructed within the Stateline 3 site boundary at a  
18 location near Gerking Flat Road.<sup>41</sup> The substation, the O&M building and a temporary  
19 laydown area would occupy an area of not more than 10 acres.<sup>42</sup> Power from the collector  
20 system would be stepped-up to 230 kV at the substation. A new, aboveground 230-kV  
21 transmission line would connect the substation to an existing 230-kV line. The point of  
22 connection would be in Washington between the existing Nine Mile and Wallula substations.  
23 The proposed route of the 230-kV transmission line in Oregon is shown in Exhibits C-2 and  
24 C-3 of the amendment request. Connection with the regional transmission system would be  
25 through the PacifiCorp Wallula Substation. The length of the transmission line would be  
26 approximately 12.89 miles in Oregon and 3.1 miles in Washington.<sup>43</sup>

#### 27 **Operations and Maintenance Building**

28 An O&M building of up to 4,500 square feet would be constructed within the Stateline  
29 3 site boundary, adjacent to the substation. Water would be supplied from a new on-site well.  
30 Wastewater generated at the O&M building would be discharged to a new on-site septic  
31 system. Telephone and electrical service would be supplied from existing service on Gerking  
32 Flat Road along existing County road right-of-way or along project access roads.<sup>44</sup>

1           **Access Roads**

2           Existing farm roads will be used to the extent possible. Up to 23.1 miles of new access  
3 roads would be constructed.<sup>45</sup> During construction, the new access roads would be up to 37  
4 feet wide, including shoulder areas.<sup>46</sup> New access road width would be reduced to 16 feet  
5 upon completion of facility construction. Existing farm roads may be improved with a new  
6 gravel surface, but no improvements that would result in land disturbance would be made to  
7 existing roads.

8           **Construction Disturbance Areas**

9           In addition to the area occupied by the proposed permanent facility components for  
10 Stateline 3, construction would affect laydown and staging areas, parking areas for  
11 construction equipment and parking areas for construction worker’s vehicles. Construction  
12 cranes would travel along turbine access roads and would not cross adjacent land.<sup>47</sup> The total  
13 construction disturbance area would be up to 327.4 acres.<sup>48</sup>

14           Gravel needed for construction purposes would be supplied from an existing quarry  
15 operated under a Conditional Use Permit issued by Umatilla County.<sup>49</sup> Concrete for  
16 construction purposes would be supplied from a temporary batch plant that would be  
17 dismantled and removed when construction of Stateline 3 is complete.<sup>50</sup> The batch plant is  
18 considered a related or supporting facility for which the Council must make land use findings  
19 as discussed herein. Any other permits required for the batch plant operation would be third-  
20 party permits obtained by the applicants’ construction contractor.

21           **Stateline 3 Site and Site Boundary**

22           The proposed Stateline 3 is located in Umatilla County, Oregon, north of the town of  
23 Helix. The Stateline 3 turbines and related facilities are located in Township 5N Range 33E  
24 Sections 1, 2, 3, 4, 10, 11, 12, 13, 14; Township 5N Range 34E Sections 7, 8, 9, 15, 16, 17,  
25 18, 19, 20, 21; Township 6N Range 32E Sections 13, 14, 24; and Township 6N Range 33E  
26 Sections 17, 18, 19, 20, 21, 27, 28, 33, 34, 35.<sup>51</sup> The Stateline 3 facilities would have a  
27 cumulative footprint of up to 56.3 acres (if 1.5-MW turbines are used) or 34.6 acres (if 2.3-  
28 MW turbines are used).<sup>52</sup>

29           As defined by OAR 345-001-0010, the “site boundary” is the perimeter of the site the  
30 energy facility, its related or supporting facilities, all temporary laydown and staging areas  
31 and all corridors and micrositing corridors.<sup>53</sup> The site boundary for Stateline 3 is the perimeter

1 of the micrositing areas for the wind turbines and related or supporting facilities described  
2 above, together with the laydown areas and temporary disturbance areas described in the  
3 amendment request.<sup>54</sup> The proposed Stateline 3 site boundary is shown in Figures C-2 and C-  
4 3.<sup>55</sup> The applicants provided a preliminary legal description that includes a map of the site  
5 boundary and identification of all land affected by the proposed construction of the new  
6 Stateline 3 components.<sup>56</sup>

#### IV. THE COUNCIL'S SITING STANDARDS: FINDINGS AND CONCLUSIONS

7 The Council must decide whether the amendment complies with the facility siting  
8 standards adopted by the Council. In addition, the Council must impose conditions for the  
9 protection of the public health and safety, conditions for the time of commencement and  
10 completion of construction and conditions to ensure compliance with the standards, statutes  
11 and rules addressed in the project order. ORS 469.401(2).

12 The Council is not authorized to determine compliance with regulatory programs that  
13 have been delegated to another state agency by the federal government. ORS 469.503(3).  
14 Nevertheless, the Council may consider these programs in the context of its own standards to  
15 ensure public health and safety, resource efficiency and protection of the environment.

16 The Council has no jurisdiction over design or operational issues that do not relate to  
17 siting, such as matters relating to employee health and safety, building code compliance, wage  
18 and hour or other labor regulations, or local government fees and charges. ORS 469.401(4).

19 In making its decision on an amendment of a site certificate, the Council applies the  
20 applicable State statutes, administrative rules and local government ordinances that are in  
21 effect on the date the Council makes its decision, except when applying the Land Use  
22 Standard. In making findings on the Land Use Standard, the Council applies the applicable  
23 substantive criteria in effect on the date the certificate holder submitted the request for  
24 amendment. OAR 345-027-0070(9).

##### 1. General Standard of Review

###### **OAR 345-022-0000**

25 *(1) To issue a site certificate for a proposed facility or to amend a site certificate,*  
26 *the Council shall determine that the preponderance of evidence on the record*  
27 *supports the following conclusions:*  
28

29 *(a) The facility complies with the requirements of the Oregon Energy Facility*  
30 *Siting statutes, ORS 469.300 to ORS 469.570 and 469.590 to 469.619, and the*  
31 *standards adopted by the Council pursuant to ORS 469.501 or the overall public*  
32 *benefits of the facility outweigh the damage to the resources protected by the*  
33 *standards the facility does not meet as described in section (2);*

34 *(b) Except as provided in OAR 345-022-0030 for land use compliance and*  
35 *except for those statutes and rules for which the decision on compliance has been*

1 *delegated by the federal government to a state agency other than the Council, the*  
2 *facility complies with all other Oregon statutes and administrative rules identified*  
3 *in the project order, as amended, as applicable to the issuance of a site certificate*  
4 *for the proposed facility. If the Council finds that applicable Oregon statutes and*  
5 *rules, other than those involving federally delegated programs, would impose*  
6 *conflicting requirements, the Council shall resolve the conflict consistent with the*  
7 *public interest. In resolving the conflict, the Council cannot waive any applicable*  
8 *state statute.*

9 \* \* \*

10 We address the requirements of OAR 345-022-0000 in the findings of fact, reasoning,  
11 conditions and conclusions of law discussed in the sections that follow. Upon consideration of  
12 all of the evidence in the record, we state our general conclusion regarding the amendment  
13 request in Section VII.

## 2. Standards about the Applicant

### (a) Organizational Expertise

#### OAR 345-022-0010

14 *(1) To issue a site certificate, the Council must find that the applicant has the*  
15 *organizational expertise to construct, operate and retire the proposed facility in*  
16 *compliance with Council standards and conditions of the site certificate. To*  
17 *conclude that the applicant has this expertise, the Council must find that the*  
18 *applicant has demonstrated the ability to design, construct and operate the*  
19 *proposed facility in compliance with site certificate conditions and in a manner*  
20 *that protects public health and safety and has demonstrated the ability to restore*  
21 *the site to a useful, non-hazardous condition. The Council may consider the*  
22 *applicant's experience, the applicant's access to technical expertise and the*  
23 *applicant's past performance in constructing, operating and retiring other*  
24 *facilities, including, but not limited to, the number and severity of regulatory*  
25 *citations issued to the applicant.*

27 *(2) The Council may base its findings under section (1) on a rebuttable*  
28 *presumption that an applicant has organizational, managerial and technical*  
29 *expertise, if the applicant has an ISO 9000 or ISO 14000 certified program and*  
30 *proposes to design, construct and operate the facility according to that program.*

31 *(3) If the applicant does not itself obtain a state or local government permit or*  
32 *approval for which the Council would ordinarily determine compliance but*  
33 *instead relies on a permit or approval issued to a third party, the Council, to issue*  
34 *a site certificate, must find that the third party has, or has a reasonable likelihood*  
35 *of obtaining, the necessary permit or approval, and that the applicant has, or has*  
36 *a reasonable likelihood of entering into, a contractual or other arrangement with*  
37 *the third party for access to the resource or service secured by that permit or*  
38 *approval.*

39 *(4) If the applicant relies on a permit or approval issued to a third party and the*  
40 *third party does not have the necessary permit or approval at the time the Council*

1 *issues the site certificate, the Council may issue the site certificate subject to the*  
2 *condition that the certificate holder shall not commence construction or operation*  
3 *as appropriate until the third party has obtained the necessary permit or approval*  
4 *and the applicant has a contract or other arrangement for access to the resource*  
5 *or service secured by that permit or approval.*

### Findings of Fact

#### A. Organizational Expertise

6 In the Final Order on the Application and in the Final Orders on Amendments #1, #2  
7 and #3, the Council found that FPL Vansycle had the organizational, managerial and technical  
8 expertise to construct and operate the SWP. FPL Vansycle has continued to operate the SWP  
9 facility in compliance with all terms and conditions of the Third Amended Site Certificate and  
10 continues to meet the Organizational Expertise Standard. The amendment request proposes a  
11 partial transfer of the site certificate from FPL Vansycle to FPL Stateline. In particular, the  
12 applicants propose that FPL Stateline would have the authority under the amended site  
13 certificate to construct and operate Stateline 3 (as described in the amendment request).

14 Although FPL Stateline is a new applicant, both FPL Vansycle and FPL Stateline are  
15 wholly-owned, indirect subsidiaries of NextEra Energy Resources LLC (*formerly* FPL Energy  
16 LLC). NextEra Energy Resources LLC owns and operates nearly 5,100 MW of wind  
17 generation at more than 50 wind facilities (7,500 turbines) in 16 states.<sup>57</sup> The organizational  
18 expertise of FPL Stateline is equivalent to the organizational expertise of FPL Vansycle, and  
19 the differences between the entities “relate to the differing financing arrangements and the  
20 differing power sale arrangements for the different Stateline phases.”<sup>58</sup> The qualifications of  
21 the individuals whose expertise would be available to both applicants are described in the  
22 amendment request.<sup>59</sup> The Council finds that FPL Stateline has adequate organizational  
23 expertise to construct, operate and retire the proposed Stateline 3 portion of the SWP.

#### B. Third-Party Permits

24 Up to 8.7 million gallons of water would be needed for dust control, road and  
25 earthwork compaction and concrete mixing during the construction of Stateline 3.<sup>60</sup> The  
26 source of this water would be the City of Helix under an existing municipal water right or a  
27 private landowner in the area under a limited license to withdraw water for construction  
28 purposes.

29 The amendment request includes a copy of the Helix water right as well as a letter  
30 from the mayor of Helix indicating the City’s willingness to supply water at the rate of up to  
31 120,000 gallons per day.<sup>61</sup> Based on this information, the Council finds that the applicants  
32 have a reasonable likelihood of entering into a contractual or other arrangement with the City  
33 of Helix for access to 8 million gallons of water under the City’s existing water right (a third-  
34 party permit).

1           Alternatively, water may be available from a private landowner, under a private water  
2 purchase agreement.<sup>62</sup> The project construction contractor has applied for a Limited Water  
3 Use License. Umatilla County has provided the required land use information, and the local  
4 Watermaster has completed the necessary Water Availability Statement.<sup>63</sup> The Council finds  
5 that the contractor has a reasonable likelihood of getting the necessary permit and that the  
6 certificate holders have a reasonable likelihood of entering into a contractual or other  
7 arrangement with their construction contractor.

8           Concrete mix would be supplied from a temporary batch plant constructed to serve the  
9 construction requirements of Stateline 3.<sup>64</sup> The batch plant would be dismantled when  
10 construction is completed. The batch plant is a related or supporting facility as defined in  
11 OAR 345-001-0010. The project construction contractor would obtain a DEQ permit required  
12 for operation of the batch plant (WPCF-1000), and given the contractor's experience in  
13 obtaining similar permits, the Council finds that the contractor has a reasonable likelihood of  
14 getting the necessary permit and that the certificate holders have a reasonable likelihood of  
15 entering into a contractual or other arrangement with their construction contractor.

#### Conclusions of Law

16           Based on the findings stated above, the Council concludes that FPL Vansycle and FPL  
17 Stateline would meet the Council's Organizational Expertise Standard if Amendment #4 were  
18 approved.

#### **(b) Retirement and Financial Assurance**

##### **OAR 345-022-0050**

19           *To issue a site certificate, the Council must find that:*

20           (1) *The site, taking into account mitigation, can be restored adequately to a useful,*  
21 *non-hazardous condition following permanent cessation of construction or*  
22 *operation of the facility.*

23           (2) *The applicant has a reasonable likelihood of obtaining a bond or letter of*  
24 *credit in a form and amount satisfactory to the Council to restore the site to a*  
25 *useful, non-hazardous condition.*  
26

#### Findings of Fact

##### A. Retirement

27           In the Final Order on the Application and in the Final Order on Amendment #1, the  
28 Council found that the site of the first and second phases of construction of the SWP could be  
29 restored adequately to a useful, non-hazardous condition following permanent cessation of  
30 construction or operation of the facility. The Council found that the certificate holder had  
31 demonstrated a reasonable likelihood of obtaining a bond or letter of credit, satisfactory to the  
32 Council, in an amount adequate to restore the site. The amount of the financial assurance bond  
33 or letter of credit for Stateline 1&2 is determined under Conditions 80 (for Stateline 1) and

1 102 (for Stateline 2). The amount is subject to annual adjustment for inflation. The certificate  
2 holder has provided financial assurance in compliance with these site certificate conditions. In  
3 accordance with OAR 345-27-0070(10)(d), the Council must consider whether the amount of  
4 the bond or letter of credit that is in place for Stateline 1&2 remains adequate to pay the  
5 estimated site restoration costs for the Stateline 1&2 components of the SWP.

6 In the Final Order on Amendment #2, the Council found the site of the third phase of  
7 construction as authorized by that amendment (the old Stateline 3 configuration) could be  
8 adequately restored to a useful, non-hazardous condition. The Council found that the  
9 certificate holder had demonstrated a reasonable likelihood of obtaining financial assurance  
10 satisfactory to the Council. The amount of financial assurance for the old Stateline 3  
11 configuration would be determined under Condition 109, prior to construction. Because  
12 construction of the old Stateline 3 configuration was never begun, the certificate holder has  
13 not provided the additional financial assurance described in Condition 109.

14 In the Request for Amendment #4, the applicants have proposed a new configuration  
15 for the third phase of construction of the SWP. Compared to the old Stateline 3 configuration,  
16 the new configuration would have fewer turbines, and the facility would occupy a smaller  
17 footprint. The components of the new Stateline 3 configuration are the typical components  
18 common to wind energy facilities, including access roads, an O&M building, a substation and  
19 an aboveground 230-kV transmission line. The Council must make a reasonable estimate of  
20 the cost to restore the site of the Stateline 3 components to a useful, non-hazardous condition.

21 OAR 345-022-0050(1) ensures that the facility site can be restored to a useful, non-  
22 hazardous condition at the end of the facility's useful life. For the purpose of the standard, a  
23 "useful, non-hazardous condition" is a condition consistent with the applicable local  
24 comprehensive land use plan and land use regulations. All phases of the SWP are located on  
25 land zoned Exclusive Farm Use. To satisfy the standard, the applicants must show that the site  
26 can be restored to a non-hazardous condition suitable for agricultural use.

27 The certificate holders are obligated to retire the facility upon permanent cessation of  
28 construction or operation of the SWP. Under OAR 345-027-0020(9), before restoring the site,  
29 the certificate holder must submit a final retirement plan for approval by the Council. The  
30 Department's recommended Revision 23, discussed herein at page 140, would conform  
31 Condition 19 to Council rule OAR 345-027-0020(9), which is a mandatory condition. The  
32 retirement plan must describe the activities necessary to restore the site to a useful, non-  
33 hazardous condition. After Council approval of the plan, the certificate holder would obtain  
34 the necessary authorization from the appropriate regulatory agencies to proceed with  
35 restoration of the site. In addition, Condition 15 requires the certificate holder to maintain a  
36 bond or letter of credit to ensure that funds would be available to the Council to restore the  
37 site if the certificate holder does not retire the facility as required by OAR 345-027-0020(9).  
38 The Department's recommended Revision 21 would conform Condition 15 to Council rule  
39 OAR 345-027-0020(8), which is a mandatory condition. The Council confirms that  
40 Conditions 15 and 19 apply to Stateline 3.

41 Restoring the SWP site to a useful, non-hazardous condition upon retirement would  
42 involve dismantling all aboveground structures. Nacelles and rotors would be removed from  
43 the turbine towers, and the towers would be dismantled. Pad-mounted transformers and  
44 related aboveground equipment would be removed. Concrete tower foundations and

1 transformer pads would be removed to a minimum depth of three feet below grade. Gravel or  
2 crushed rock would be removed from adjacent turbine pad areas. The O&M building would  
3 be removed (or, at the request of the landowner, the building might be converted to farm use).  
4 The 230-kV transmission lines and support structures would be removed. Underground  
5 transmission lines and SCADA communication cables that are at least three feet below grade  
6 would be left in place. At a depth of three feet, underground components and foundations are  
7 not expected to interfere with farming practices.

8 All excavated areas would be backfilled with topsoil. The surface would be graded.  
9 The affected areas, including areas temporarily disturbed during site restoration activities,  
10 would be replanted with native plant seed mixes or agricultural crops, as appropriate, based  
11 on the use of surrounding lands. Demolition waste material would be transported for disposal  
12 at authorized sites.

13 For the purposes of the site restoration cost estimate, the Department assumes that  
14 facility access roads would be removed. Road areas would be restored with topsoil, graded  
15 and replanted with native plant seed mixes or agricultural crops, as appropriate. Access roads  
16 might be left in place based on landowner preference.

17 The facility would not have any underground storage tanks or other on-site bulk  
18 storage of hazardous materials. Small quantities of lubricants, vehicle fuel and herbicides  
19 might be transported over and across the site during operation, and leaks, spills and improper  
20 handling of these materials could occur. Given the small amounts of such materials used on  
21 the site, significant soil contamination is unlikely.<sup>65</sup>

22 The Council finds that the actions necessary to restore the site are feasible and that  
23 restoration of the site to a useful, non-hazardous condition could be achieved.

#### B. Site Restoration Costs

24 OAR 345-022-0050(2) addresses the possibility that the certificate holder is unable or  
25 unwilling to restore the site upon permanent cessation of construction or operation of the  
26 facility. For amendments to site certificates, OAR 345-027-0070(10)(d) requires the Council  
27 to consider whether the amount of a bond or letter of credit is adequate to ensure restoration  
28 for the facility with the changes allowed by the amendment. A bond or letter of credit  
29 provides a site restoration remedy to protect the State of Oregon and its citizens if the  
30 certificate holder fails to perform its obligation to restore the site under any circumstances.  
31 The bond or letter of credit must remain in force until the certificate holder has fully restored  
32 the site. To provide a fund that is adequate for the State to pay site restoration costs if the  
33 certificate holder fails to perform its obligation, the Council assumes circumstances under  
34 which the restoration cost would be highest.

#### Site Restoration Cost Estimate for Stateline 1&2

36 The applicants estimated that the current cost of site restoration for the Stateline 1&2  
37 components of the SWP would be \$5,311,946.<sup>66</sup> The applicants assumed that the scrap or

1 salvage value of the turbines would be deducted from the cost of dismantling them.<sup>67</sup> The  
2 applicants' estimate did not identify line items for general costs (such as permits,  
3 mobilization, engineering, overhead and utility disconnects), project management or  
4 contingency, although these items may have been factored into the line item costs listed in the  
5 estimate.

6 The Department obtained an updated cost estimate, following the estimating procedure  
7 outlined in its draft "Facility Retirement Cost Estimating Guide" (Cost Guide). The Cost  
8 Guide was not available when the Council made findings on site restoration costs for Stateline  
9 1 (in 2001) and Stateline 2 (in 2002). The Department's updated estimate is based on the  
10 actual configuration of Stateline 1&2. The assumptions underlying the Department's estimate  
11 are as follows:

- 12 • 186 Vestas 660-KW turbines and associated towers, wiring, blades,  
13 transformers and turnouts<sup>68</sup>
- 14 • 186 concrete foundations<sup>69</sup>
- 15 • 6 meteorological towers
- 16 • 103 junction boxes for the collector system.<sup>70</sup>
- 17 • 19 miles of access roads<sup>71</sup>
- 18 • Restoration of 196 acres of temporary disturbance<sup>72</sup>

19 The Department's updated estimate of the full cost of restoring land occupied by the  
20 Stateline 1&2 components of the SWP site is shown in Table 1.<sup>73</sup>

1           The financial assurance amount currently in place for Stateline 1&2 is \$2,058,472,  
2 based on information available in 2001.<sup>74</sup> As required under OAR 345-027-0070(10)(d), the  
3 Council must determine whether the amount of the financial assurance currently in place is  
4 adequate to ensure restoration of the site of the Stateline 1&2 components. The Department  
5 compared the estimates made in 2001 (for Stateline 1) and 2002 (for Stateline 2) with the  
6 estimate shown in Table 1 and the new estimate provided by the applicants in the amendment  
7 request.<sup>75</sup> The major differences are summarized below in Table 2.<sup>76</sup>

1 The Department's updated estimate does not include any deduction for scrap or  
2 salvage value. The applicants' estimate is the net cost after removing an estimated \$9.3  
3 million salvage value. The 2001/2002 estimate assumed that the salvage value of the turbines  
4 would entirely offset the dismantling costs. This assumption can now be seen as incorrect,  
5 based on current information. The financial assurance amount currently in place is  
6 significantly less than the new estimates by the Department and the applicants. The most  
7 significant difference between the 2001/2002 estimate and the current estimates is the net cost  
8 associated with dismantling and removal of the turbine towers.

9 **Scrap-Value Offset**

10 In 2001, the applicant estimated that the dismantling and removal costs for the  
11 Stateline 1 turbines and turbine towers would be \$17,500 per turbine (December 2000 dollars)  
12 based on a demolition contractor's bid.<sup>78</sup> The contractor estimated that the salvage value of  
13 the turbines and towers would be equal to the cost of dismantling and removing them. Based  
14 on this information (but without considering the future variability in scrap or salvage value),  
15 the Council, at that time, found that it was reasonable to assume that the scrap or salvage  
16 value of the turbines and towers would be equal to, but not more than, the cost of dismantling  
17 and removing them. The Council applied this finding to the site restoration costs for Stateline  
18 1 and Stateline 2.<sup>79</sup>

19 In 2006, as a result of concerns expressed by Council members, the Department  
20 conducted an internal review of the risks involved in allowing a deduction for scrap or salvage  
21 value in calculating the financial assurance amount. The Department concluded that there was  
22 a significant risk that third party creditors or other parties could assert a claim against the  
23 scrap or salvage value that might result in that value being unavailable to the State to offset  
24 site restoration costs. At a public Council meeting on February 2, 2007, the Council discussed  
25 the issue and considered comments from facility developers. During the discussion, several

1 Council members expressed the opinion that there should be no deduction of scrap or salvage  
2 value in calculating the amount of financial assurance required for site restoration. The  
3 Council did not take any formal action on the matter. In subsequent site certificate and  
4 amendment proceedings, however, the Council has not allowed a deduction for the scrap or  
5 salvage value of turbines and towers in its findings on site restoration costs for wind energy  
6 facilities.

7 As shown in Table 2, the applicants estimated that the cost for Stateline 1&2 site  
8 restoration would be approximately \$5.3 million, which is significantly higher than 2001/2002  
9 estimates that are the basis for the value of the financial assurance currently in place under  
10 Conditions 80 and 102. Nevertheless, the applicants are “satisfied with the conditions as they  
11 are now written and imposed” and believe that “higher bond amounts on Stateline 1 and  
12 Stateline 2 are quite onerous because these two phases have already been financed and  
13 constructed.”<sup>80</sup>

14 In a supplemental statement on the issue of financial assurance, the applicants  
15 emphasize that “project lenders advanced the funds necessary for FPL Energy Vansycle,  
16 LLC, to finance and develop each phase based on the site-restoration bond amounts specified  
17 by the Council for each of Phases 1 and 2.”<sup>81</sup> The applicants state that a significant increase in  
18 the financial assurance obligation would create a hardship because “the lenders will not  
19 consent to any retroactive increase in the amount of the site restoration bond required for  
20 project phases already constructed” and the lenders’ consent is required for FPL Stateline to  
21 proceed with development of Stateline 3. Consequently, the cost of the increase in the  
22 financial assurance for Stateline 1&2 would have to be borne by FPL Stateline “as an  
23 additional cost of Stateline 3.”

24 The Department received additional comments from Umatilla County regarding the  
25 financial assurance issue.<sup>82</sup> Tamra Mabbott, the Umatilla County Planning Director, expressed  
26 concern that an increase in the financial assurance amount for the Stateline project “would  
27 create a competitive disadvantage for Stateline and other projects subject to EFSC jurisdiction  
28 in relation to smaller, subjurisdictional projects.” Although the County shares the Council’s  
29 concerns and supports conditions that will ensure site restoration, the Planning Director  
30 commented that it would be “appropriate for EFSC to recognize salvage values in calculating  
31 the amount of the bond required to cover the cost of restoration to offset part of the bond  
32 amount.”

33 In response to these concerns, the Department recommended that the Council allow a  
34 limited offset of the financial assurance amount for Stateline 1&2 as described below. Steel  
35 and other metals in the turbines and turbine towers are reasonably expected to have value in  
36 the future, either as salvage (for re-use at another site) or as scrap metal. To be conservative,  
37 the Council may assume that towers and nacelles would have a lower value as scrap and base  
38 any offset on the estimated scrap value rather than the estimated salvage value. In the absence  
39 of a third-party claim, the scrap value would be available to the Council to offset the  
40 dismantling and removal costs at the time of facility retirement.

1 If there were a third party having a security interest or other legal claim against the  
2 turbines or turbine towers, such party might assert its claim at the time of site restoration. The  
3 orderly procedure for asserting the claim would be for the third party to participate in the  
4 Council process described in OAR 345-027-0110 for the termination of the site certificate.  
5 Assuming the claim were determined to be valid, the final retirement plan for site restoration  
6 could provide for delivery of the scrap to the third party, less the cost of dismantling the  
7 turbines and removing them from the site. The third party would recover the net value after  
8 sale of the scrap, and the costs of dismantling and removing the turbines would be paid.

9 To ensure disclosure of potential third-party claims, the Council adopts new Condition  
10 136, as discussed in Revision 90 at page 173. The condition would require the certificate  
11 holder to notify interested third parties that the turbines and turbine towers are subject to the  
12 requirements of the Site Certificate and Council rules with regard to facility retirement and  
13 would require the certificate holder to provide the Department with names and contact  
14 information for all such third parties.

15 The financial assurance amount for Stateline 1&2 may reasonably allow for an offset  
16 based on the estimated scrap value of the turbines and turbine towers so long as the offset  
17 amount does not exceed the dismantling and removal costs. That limitation would ensure that  
18 the financial assurance amount is sufficient to cover all other estimated costs of site retirement  
19 (as detailed in Table 1). If the actual scrap value at the time of site restoration exceeds the  
20 dismantling and removal costs, the excess amount could potentially be subject to a third party  
21 claim. Accordingly, the Department recommended that the offset be “capped” at the estimated  
22 cost of turbine dismantling and removal (adjusted annually for inflation). The estimated  
23 dismantling and removal costs are the sum of the line items under the “Turbines and Towers”  
24 section of Table 1.

25 The future scrap value of steel can be estimated and adjusted on an annual basis to  
26 account for fluctuations in the commodity market.<sup>83</sup> The Council has previously approved a  
27 method of scrap value estimation and annual adjustment.<sup>84</sup> The Department recommended  
28 that the Council apply a similar methodology for estimating the scrap value of the Stateline  
29 1&2 turbines and turbine towers. The U.S. Bureau of Labor Statistics publishes the Producer  
30 Price Index (PPI) for industrial commodities, including “carbon steel scrap.” The Department  
31 recommended using the annual index values, because month-to-month values vary seasonally.  
32 Annual index values, therefore, provide the best estimate possible, given a highly volatile  
33 commodity market.

34 In 2006, a consultant to the Department surveyed actual scrap steel prices in the  
35 Portland market and found the average price to be \$145 per ton. The Department calculates  
36 that the current value of scrap steel at Portland is approximately \$166 per ton, based on the  
37 market price adjusted by the PPI.<sup>85</sup> There are approximately 13,206 tons of steel in the 186

1 turbine towers and nacelles that are part of the Stateline 1&2 components. The estimated total  
2 scrap value (currently) is \$2,198,599 (rounded to the nearest dollar). This estimated scrap  
3 value does not exceed the estimated turbine dismantling and removal costs (\$2,524,016)  
4 shown under the “Turbines and Towers” section in Table 1. Accordingly, the recommended  
5 offset would be \$2,198,599 and would reduce the updated financial assurance amount for  
6 Stateline 1&2 to \$3,962,000 (1<sup>st</sup> Quarter 2009 dollars, rounded to nearest \$1,000).

7 In Revision 49 at page 153, the Department recommends modification of Condition 80  
8 to consolidate the financial assurance amount for Stateline 1&2. In Alternative A, the  
9 modification incorporates the revised site restoration cost estimate shown in Table 1.  
10 Alternative A includes the recommended offset and the recommended method of annual  
11 adjustment. In Alternative B, the modification incorporates the revised site restoration cost  
12 estimate shown in Table 1 but does not allow an offset. The Council’s decision whether to  
13 adopt Alternative A (concurring with the Department’s recommendation) or Alternative B  
14 (rejecting the recommendation and not allowing an offset) is indicated on page 174 of this  
15 order.

16 The applicants proposed a “retirement sinking fund” as an alternative “practical  
17 solution that moderates the adverse effects of site-restoration bonds on certificate holders.”<sup>86</sup>  
18 The applicants proposed to insert language in Conditions 80, 102 and 109 that would reduce  
19 the financial assurance amount otherwise required by each of these conditions by 25 percent if  
20 the certificate holder “maintains, or has maintained on its behalf, a dedicated Stateline [1, 2 or  
21 3] retirement sinking fund in an amount of at least \$1,000,000.” The applicants did not  
22 explain the “retirement sinking fund” concept in any detail in the amendment request. There is  
23 no discussion in Exhibit M (Applicants’ Financial Capability) or Exhibit W (Facility  
24 Retirement and Site Restoration) describing how the fund would be maintained or how the  
25 fund would provide financial assurance to the Council. Because the form of financial  
26 assurance is limited by OAR 345-027-0020(8) to “a bond or letter of credit,” the Council  
27 declines to modify the financial assurance conditions of the Site Certificate to incorporate a  
28 “retirement sinking fund” as proposed by the applicants.

### 29 **Site Restoration Cost Estimate for Stateline 3**

30 The applicants estimated that the cost of site restoration for the Stateline 3 components  
31 of the SWP would be \$2,943,320 (if 43 2.3-MW turbines are built) or \$3,897,543 (if 67 1.5-  
32 MW turbines are built).<sup>87</sup> The applicants assumed that the scrap or salvage value of the  
33 turbines would be deducted from the cost of dismantling them.<sup>88</sup> The applicants’ estimate did  
34 not identify line items for general costs (such as permits, mobilization, engineering, overhead  
35 and utility disconnects), project management or contingency, although these items may have  
36 been factored into the line item costs listed in the estimate.

37 In Amendment #4, the applicants request the flexibility to build Stateline 3 with either  
38 1.5-MW wind turbines or 2.3-MW wind turbines. The number of turbines and the final layout  
39 of the Stateline 3 components will be determined by the selection of turbine type. The  
40 Department has determined that a configuration that uses the greater number of turbines

would result in the highest cost for site restoration. The cost estimate for Stateline 3 is based on the 67-turbine configuration, consistent with the Council’s practice of assuming circumstances under which the restoration cost would be highest and consistent with the maximum design flexibility requested by the applicants. The assumptions underlying the Department’s estimate are as follows:

- 67 1.5-MW GE turbines and associated towers, wiring, blades, transformers, and turnouts<sup>89</sup>
- 67 concrete foundations<sup>90</sup>
- 16 miles of aboveground single-circuit 230-kV transmission line<sup>91</sup>
- 9 junction boxes for the underground 34.5-kV collector system<sup>92</sup>
- 23 miles of new access roads<sup>93</sup>
- Substation
- O&M facility
- Restoration of 321 acres of temporary disturbance<sup>94</sup>

The Department’s estimate of the full cost of restoring the land occupied by the proposed Stateline 3 components of the SWP is shown Table 3.

1 For the reasons discussed above with respect to Stateline 1&2, the Department  
2 recommended that the Council allow a limited scrap-value offset of the financial assurance  
3 amount for Stateline 3. The Department recommended that the offset not exceed the estimated  
4 cost of dismantling and transportation.

5 There are approximately 15,142 tons of steel in the 67 turbine towers and nacelles that  
6 are part of the Stateline 3 components, based on the assumptions underlying the cost estimate  
7 shown in Table 3. The estimated total scrap value is \$2,520,914.<sup>95</sup> This estimated scrap value  
8 exceeds the estimated turbine dismantling and removal costs (\$1,934,771) shown under the  
9 “Turbines and Towers” section in Table 3. Accordingly, the recommended offset would be  
10 \$1,934,771 and would reduce the financial assurance amount for Stateline 3 to \$3,976,000 (1<sup>st</sup>  
11 Quarter 2009 dollars, rounded to nearest \$1,000).

12 In Revision 66 at page 162, the Department recommends modification of Condition  
13 109, which establishes the financial assurance amount for Stateline 3. In Alternative A, the  
14 modification incorporates the site restoration cost estimate shown in Table 3. Alternative A  
15 includes the recommended offset and the recommended method of annual adjustment. In  
16 Alternative B, the modification incorporates the site restoration cost estimate shown in Table  
17 3 but does not allow an offset. The Council’s decision whether to adopt Alternative A  
18 (concurring with the Department’s recommendation) or Alternative B (rejecting the  
19 recommendation and not allowing an offset) is indicated on page 174 of this order.

C. Ability of the Applicants to Obtain a Bond or Letter of Credit

20 OAR 345-022-0050(2) requires the Council to decide whether the applicant has a  
21 reasonable likelihood of obtaining a bond or letter of credit, in a form and amount satisfactory  
22 to the Council, to restore the site to a useful, non-hazardous condition. The applicants have  
23 proposed dividing the financial assurance requirement for the SWP facility so that FPL  
24 Vansycle would provide a bond or letter of credit for Stateline 1&2 and FPL Stateline would

1 provide a bond or letter of credit for Stateline 3. To accommodate the applicants' request, the  
2 Department has prepared the separate estimates discussed above.

3 The Department recommends financial assurance of \$3.962 million (1<sup>st</sup> Quarter, 2009  
4 dollars) for Stateline 1&2 as reflected in revised Condition 80, Alternative A. The Department  
5 recommends financial assurance of \$3.976 million (1<sup>st</sup> Quarter, 2009 dollars) for Stateline 3,  
6 or an amount based on the final design configuration, as reflected in revised Condition 109,  
7 Alternative A. Based on these recommendations, the combined total for the SWP as a whole  
8 would be \$7.938 million (1<sup>st</sup> Quarter, 2009 dollars). If the Council declines to allow the  
9 limited scrap-value offset, the combined total for the SWP as a whole would be \$12.071  
10 million (1<sup>st</sup> Quarter, 2009 dollars), based on revised Condition 80, Alternative B, and revised  
11 Condition 109, Alternative B.

12 FPL Vansycle has provided a bond in the amount of \$2,058,472 (Bond No. 08954580)  
13 issued by Fidelity and Deposit Company of Maryland to meet the current financial assurance  
14 requirements for Stateline 1 and Stateline 2, prior to this amendment.

15 In the amendment request, FPL Vansycle and FPL Stateline provided information  
16 about their ability to obtain financial assurance for restoration of the SWP site. The applicants  
17 have provided a letter from Fidelity and Deposit Company of Maryland (FDCM) stating that  
18 FDCM agrees "to provide Suretyship on behalf of FPL Energy Vansycle, LLC and FPL  
19 Energy Stateline II, Inc. covering contracts in the amount of \$10,000,000.00 for any single  
20 contract and \$25,000,000.00 in the aggregate of outstanding contracts."<sup>96</sup>

21 It is customary for a performance bond to contain provisions allowing the surety to  
22 complete construction of a project in order to reduce its potential liability. Oregon law and  
23 Council rules require a site certificate to construct or operate an energy facility.<sup>97</sup>  
24 Accordingly, when the certificate holder elects to use a bond to meet the financial assurance  
25 requirements and the surety retains the right to complete construction, operate or retire the  
26 energy facility, the Council requires the certificate holder to ensure that the surety has agreed  
27 to comply with all applicable statutes, Council rules and site certificate conditions. In  
28 addition, the Council requires that the surety seek Council approval before commencing  
29 construction, operation or retirement activities. Revision 37 would modify Condition 41 to  
30 require that any bonds obtained for Stateline 1&2 and Stateline 3, as required under revised  
31 Conditions 80 and 109, are subject to these requirements.

### Conclusions of Law

32 For the reasons discussed above and subject to the recommended conditions and  
33 revisions, the Council finds that the SWP site, taking into account mitigation, can be restored  
34 adequately to a useful, non-hazardous condition following permanent cessation of  
35 construction or operation of the facilities. The Council's findings regarding a reasonable  
36 estimate of the cost to restore Stateline 1&2 to a useful, non-hazardous condition (Condition  
37 80) and a reasonable estimate of the cost to restore Stateline 3 to a useful, non-hazardous  
38 condition (Condition 109) are stated on page 174 of this order. The Council finds that FPL  
39 Vansycle and FPL Stateline have demonstrated a reasonable likelihood of obtaining bonds or  
40 letters or credit, satisfactory to the Council, in combined amounts adequate to restore the site

1 to a useful, non-hazardous condition. Based on these findings and the conditions discussed  
2 herein, the Council concludes that the applicants would meet the Council’s Retirement and  
3 Financial Assurance Standard if Amendment #4 were approved.

### 3. Standards about the Impacts of Construction and Operation

#### (a) Land Use

##### **OAR 345-022-0030**

4 *(1) To issue a site certificate, the Council must find that the proposed facility*  
5 *complies with the statewide planning goals adopted by the Land Conservation and*  
6 *Development Commission.*

7  
8 *(2) The Council shall find that a proposed facility complies with section (1) if:*

9 \*\*\*

10 *(b) The applicant elects to obtain a Council determination under ORS*  
11 *469.504(1)(b) and the Council determines that:*

12 *(A) The proposed facility complies with applicable substantive criteria as*  
13 *described in section (3) and the facility complies with any Land Conservation and*  
14 *Development Commission administrative rules and goals and any land use statutes*  
15 *directly applicable to the facility under ORS 197.646(3);*

16 *(B) For a proposed facility that does not comply with one or more of the*  
17 *applicable substantive criteria as described in section (3), the facility otherwise*  
18 *complies with the statewide planning goals or an exception to any applicable*  
19 *statewide planning goal is justified under section (4); or*

20 *(C) For a proposed facility that the Council decides, under sections (3) or*  
21 *(6), to evaluate against the statewide planning goals, the proposed facility*  
22 *complies with the applicable statewide planning goals or that an exception to any*  
23 *applicable statewide planning goal is justified under section (4).*

24 *(3) As used in this rule, the “applicable substantive criteria” are criteria from the*  
25 *affected local government’s acknowledged comprehensive plan and land use*  
26 *ordinances that are required by the statewide planning goals and that are in effect*  
27 *on the date the applicant submits the application. If the special advisory group*  
28 *recommends applicable substantive criteria, as described under OAR 345-021-*  
29 *0050, the Council shall apply them. If the special advisory group does not*  
30 *recommend applicable substantive criteria, the Council shall decide either to make*  
31 *its own determination of the applicable substantive criteria and apply them or to*  
32 *evaluate the proposed facility against the statewide planning goals.*

33 *(4) The Council may find goal compliance for a proposed facility that does not*  
34 *otherwise comply with one or more statewide planning goals by taking an*  
35 *exception to the applicable goal. Notwithstanding the requirements of ORS*  
36 *197.732, the statewide planning goal pertaining to the exception process or any*  
37 *rules of the Land Conservation and Development Commission pertaining to the*  
38 *exception process, the Council may take an exception to a goal if the Council*  
39 *finds:*



1           (a) *The land subject to the exception is physically developed to the extent that*  
2           *the land is no longer available for uses allowed by the applicable goal;*

3           (b) *The land subject to the exception is irrevocably committed as described by*  
4           *the rules of the Land Conservation and Development Commission to uses not*  
5           *allowed by the applicable goal because existing adjacent uses and other relevant*  
6           *factors make uses allowed by the applicable goal impracticable; or*

7           (c) *The following standards are met:*

8                   (A) *Reasons justify why the state policy embodied in the applicable goal*  
9                   *should not apply;*

10                   (B) *The significant environmental, economic, social and energy*  
11                   *consequences anticipated as a result of the proposed facility have been identified*  
12                   *and adverse impacts will be mitigated in accordance with rules of the Council*  
13                   *applicable to the siting of the proposed facility; and*

14                   (C) *The proposed facility is compatible with other adjacent uses or will be*  
15                   *made compatible through measures designed to reduce adverse impacts.*

16           \* \* \*

#### Findings of Fact

17           In the Final Order on the Application, the Council found that Stateline 1 complied  
18           with the applicable substantive criteria recommended to the Council by Umatilla County. The  
19           criteria included Umatilla County Development Code (UCDC) Sections 152.060, 152.061,  
20           152.616 and 152.615 and Umatilla County Comprehensive Plan (UCCP) elements on Energy  
21           Conservation, on Open Space, Scenic and Historic Areas and on Natural Resources. In  
22           addition to these criteria, the Council applied OAR 660-033-0120 and OAR 660-033-0130  
23           because these State land use regulations were found to be directly applicable.<sup>98</sup> The Council  
24           found that the facility did not comply with OAR 660-033-0130(22) but that an exception to  
25           the applicable statewide planning goal (Goal 3 – Agricultural Lands) was justified.

26           In the Final Order on Amendment #1, the Council found that Stateline 2 complied  
27           with the applicable substantive criteria of Umatilla County and with all directly applicable  
28           provisions of the LCDC administrative rules.<sup>99</sup> In the Final Order on Amendment #2, the

1 Council found that Stateline 3 (as described in the Request for Amendment #2) complied with  
2 the applicable substantive criteria of Umatilla County and with all directly applicable  
3 provisions of the Land Conservation and Development Commission (LCDC) administrative  
4 rules.

5 Under OAR 345-027-0070(10)(a), the Council must consider whether the facility  
6 complies the Land Use Standard for the areas that would be affected by construction and  
7 operation of Stateline 3. The proposed Stateline 3 would lie on land within the land use  
8 jurisdiction of Umatilla County. Like the previous phases of the SWP, the proposed new  
9 Stateline 3 configuration is located on privately owned land zoned Exclusive Farm Use  
10 (EFU).

11 The Council must apply the Land Use Standard in conformance with the requirements  
12 of ORS 469.504. The Oregon Supreme Court recently held “under ORS 469.504(1)(b) and  
13 (5), the council may choose to determine compliance with statewide planning goals by  
14 evaluating a facility under paragraph (A) or (B) or (C), but ... it may not combine elements or  
15 methods from more than one paragraph, except to the extent that the chosen paragraph itself  
16 permits.”<sup>100</sup>

17 The Council may find compliance with statewide planning goals under ORS  
18 469.504(1)(b)(A) if the Council finds that the proposed facility “complies with applicable  
19 substantive criteria from the affected local government’s acknowledged comprehensive plan  
20 and land use regulations that are required by the statewide planning goals and in effect on the  
21 date the application is submitted.” In this case, Umatilla County is the “affected local  
22 government.”

23 The land use analysis begins with identification of the “applicable substantive criteria”  
24 recommended by the Special Advisory Group (SAG). The Council appointed the Board of  
25 Commissioners of Umatilla County as the SAG on July 28, 2000, during the review of the site  
26 certificate application. In its Request for Comments on the Request for Amendment (dated  
27 November 5, 2008), the Department requested that the County identify the applicable  
28 regulations. The Department later clarified that the Department was requesting that the SAG  
29 identify the applicable substantive criteria.<sup>101</sup>

30 Under ORS 469.504(5), “If the special advisory group recommends applicable  
31 substantive criteria for an energy facility described in ORS 469.300 or a related or supporting  
32 facility that does not pass through more than one local government jurisdiction or more than  
33 three zones in any one jurisdiction, the council shall apply the criteria recommended by the  
34 special advisory group.” Carol Johnson of the Umatilla County Planning Department  
35 responded to the Department’s request and identified the applicable substantive criteria.<sup>102</sup>

36 If the Council finds that a proposed facility does not comply with one or more of the  
37 applicable substantive criteria, then the Council must proceed under ORS 469.504(1)(b)(B)  
38 and must determine whether the proposed facility “otherwise [complies] with the applicable  
39 statewide planning goals.” In *Save Our Rural Oregon*, the Court held that “paragraph (B)  
40 necessarily requires an evaluation of the same applicable substantive criteria as paragraph (A)

1 and, to the extent those criteria are not met, directs the council to consider statewide planning  
2 goals.”

3 ORS 469.504(1)(b)(C) is not available to the Council, because subsection (5) of the  
4 statute does not allow the Council to elect to apply the statewide planning goals directly  
5 when, as in this case, the special advisory group has recommended applicable substantive  
6 criteria for a proposed facility.

7 For the reasons discussed below, the Council finds that the proposed expansion of the  
8 SWP (Stateline 3) does not comply with all of the applicable substantive criteria. The Council  
9 finds that Goal 3 (Agricultural Lands) is the applicable statewide planning goal. The Council  
10 finds that Stateline 3 complies with Goal 3 and, if applicable to this review, OAR 666-033-  
11 0130(37), which is an implementing State land use regulation under Goal 3. The Council  
12 finds, if OAR 660-033-0130(37) is inapplicable or if Stateline 3 were found not to comply  
13 with OAR 660-033-0130(37), an exception to Goal 3 is justified for the reasons discussed at  
14 page 77.

#### A. Umatilla County’s Applicable Substantive Criteria

15 Umatilla County Development Code (UCDC) Section 152.060 lists land uses that  
16 “may be permitted conditionally via administrative review” (conditional uses) in the County’s  
17 EFU zone. A “commercial utility facility for the purpose of generating power for public use  
18 by sale” (and specifically a “wind power generation” facility) is an allowable use, subject to  
19 conditional use standards in UCDC Sections 152.610 through 152.617.<sup>103</sup> UCDC Section  
20 152.003 defines a “wind power generation facility” as follows:

21 ***WIND POWER GENERATION FACILITY.*** *An energy facility that consists of*  
22 *one or more wind turbines or other such devices and their related or supporting*  
23 *facilities that produce electric power from wind and are: (a) Connected to a*  
24 *common switching station, or (b) Constructed, maintained, or operated as a*  
25 *contiguous group of devices.*

26 The SWP, including its related or supporting facilities, is a wind power generation  
27 facility under this definition, and Stateline 3 would be an expansion of that facility. UCDC  
28 Section 152.616(HHH) contains specific standards applicable to wind power generation  
29 facilities. In addition, the County identified UCDC Sections 152.061 and 152.063 (C), (E) and  
30 (F), 152.010, 152.011, 152.016, 152.017, 152.018 and 152.545 through 152.562 as applicable  
31 to wind power generation facilities.

32 A transmission line with towers less than 200 feet in height is allowed in the EFU  
33 zone by administrative review. Such a transmission line is a “utility facility necessary for  
34 public service” under UCDC Section 152.059(C). The County identified UCDC Section  
35 152.617(II)(7) as applicable to the transmission line and stated that UCDC Sections 152.010,  
36 152.011, 152.016, 152.017, 152.018 and 152.545 through 152.562 “also may apply.”<sup>104</sup>

37 In addition, the County identified UCDC Sections 152.061, 152.615 and  
38 152.617(I)(K)(2), (8) and (10) as applicable to the proposed temporary concrete batch plant to

1 be located within the disturbed lands of an existing gravel quarry.<sup>105</sup> As an alternative site for  
2 the batch plant, the applicants have proposed locating it within the 30-acre laydown area  
3 where the O&M facility and substation would also be built.<sup>106</sup> If the batch plant is located  
4 there, then UCDC Sections 152.061, 152.615 and 152.617(I)(A) would apply.

5 The County listed policies in the Umatilla County Comprehensive Plan (UCCP) as  
6 applicable local approval standards. Specifically, the County identified the following policies:

7 Citizen Involvement: Policy 1 and Policy 5

8 Agriculture: Policies 1, 8 and 17

9 Open Space, Scenic and Historic Areas, and Natural Resources: Policies 1(a), 5(a and b),  
10 6(a), 8(a), 9(a), 10(c, d and e), 20(a), 20(b)(1-8), 22, 23(a), 24(a), 26, 37, 38(a-c), 39(a)  
11 and 42(a)

12 Air, Land and Water Quality: Policies, 1, 7 and 8

13 Natural Hazards: Policies 1 and 4

14 Recreational Needs: Policy 1

15 Economy of the County: Policies 1, 4 and 8(a-f)

16 Public Facilities and Services: Policies 1(a-d), 2, 9 and 19

17 Transportation: Policy 20

18 Energy Conservation: Policy 1

19 In addition, the County noted that a Zoning Permit is required before construction of  
20 structures in the County.

21 **UCDC Section 152.010**

22 UCDC Section 152.010 addresses access to buildings and structures. The proposed  
23 Stateline 3 O&M building is a “building” and all other aboveground components of the  
24 proposed Stateline 3 expansion are “structures” under the definitions in UCDC Section  
25 152.003. The ordinance requires that buildings be constructed “on a lot that abuts a public  
26 street or a recorded easement” and requires structures to be “located on lots as to provide safe  
27 and convenient access for servicing, fire protection, and required off-street parking.”

28 UCDC Section 152.010 also addresses “private driveways and easements that enter  
29 onto a public or county road or state or federal highway.” The ordinance requires construction  
30 of such driveways and easements to be “of at least similar if not the same material as the  
31 public or county road or state or federal highway to protect the edge of the road from rapid  
32 deterioration” and requires such improvements to extend at least 25 feet back from the edge of  
33 the existing travel lane surface.

34 In UCDC Section 152.010, the County has established facility design requirements  
35 that may be outside the Council’s jurisdiction under ORS 469.401(4). Nevertheless, the  
36 County has identified the ordinance as one of the applicable substantive criteria under ORS  
37 469.504(5) for the wind power generation facility and the transmission line. In Revision 77,  
38 the Department recommends that the Council adopt Condition 123, which would require the  
39 certificate holder to design and construct Stateline 3 in compliance with the County design  
40 requirements as described in this ordinance. In addition, Condition 2 requires the certificate  
41 holder to design and construct the facility “in compliance with the requirements

1 of...ordinances in effect at the time the site certificate is issued.” Condition 2 incorporates the  
2 mandatory condition required by OAR 345-027-0020(3).

3 **UCDC Section 152.011**

4 UCDC Section 152.011 addresses “vision clearance” areas that apply to intersections  
5 of two streets or a street and a railroad and precludes “any planting, wall, structure, or  
6 obstruction of any kind exceeding two and one-half feet in height measured from the grade of  
7 the street centerline” within the vision clearance area. For an agricultural zone, the vision  
8 clearance distance is 30 feet back from the intersection.

9 In UCDC Section 152.011, the County has established a facility design requirement  
10 that may be outside the Council’s jurisdiction under ORS 469.401(4). Nevertheless, the  
11 County has identified the ordinance as one of the applicable substantive criteria under ORS  
12 469.504(5) for the wind power generation facility and the transmission line. In Revision 77,  
13 the Department recommends that the Council adopt Condition 123, which would require the  
14 certificate holder to design and construct Stateline 3 in compliance with the County design  
15 requirements as described in this ordinance. In addition, Condition 2 requires the certificate  
16 holder to design and construct the facility “in compliance with the requirements  
17 of...ordinances in effect at the time the site certificate is issued.” Condition 2 incorporates the  
18 mandatory condition required by OAR 345-027-0020(3).

19 **UCDC Section 152.016**

20 UCDC Section 152.016 addresses standards for maintenance, removal and  
21 replacement of riparian vegetation along streams, lakes and wetlands. In addition, the  
22 ordinance requires minor drainage improvements on surrounding agricultural lands to be  
23 “coordinated with the Oregon Department of Fish and Wildlife and Soil and Water  
24 Conservation District.”

25 The applicants have identified streams and wetlands within the site boundary of the  
26 Stateline 3 expansion in Exhibit J.<sup>107</sup> Potential impacts to State jurisdictional waters and  
27 wetlands are discussed below at page 123. There are approximately 2 acres of riparian habitat  
28 within the Stateline 3 site boundary, none of which would be disturbed by construction of  
29 Stateline 3.<sup>108</sup> Restoration of the temporarily disturbed areas, mitigation for the permanent  
30 habitat impacts and recommended site certificate conditions regarding habitat disturbance are  
31 discussed below, beginning at page 105. Proposed plans for mitigation of temporary and  
32 permanent habitat disturbances were developed in consultation with ODFW.

33 **UCDC Section 152.017**

34 UCDC Section 152.017 addresses the public transportation system and conditions  
35 applicable to development proposals that are likely to generate a significant increase in trip  
36 generation. UCDC Section 152.003 defines a “significant change in trip generation.”  
37 Increased traffic resulting from construction and operation of the proposed Stateline 3  
38 components is discussed below at page 116. Construction of Stateline 3 would result in a  
39 temporary increase in vehicle traffic to and from the facility site that would be considered  
40 significant under the ordinance, but there would be no significant change in trip generation

1 during facility operation.<sup>109</sup> For a development that is likely to generate a significant increase  
2 in trip generation, the ordinance requires “adequate information, such as a traffic impact study  
3 or traffic counts, to demonstrate the level of impact to the surrounding system.” In Exhibit U,  
4 the applicants have provided information on the estimated traffic impact of the proposed  
5 facility. The ordinance provides for mitigation of the traffic impacts attributable to the project.  
6 Condition 45 requires the certificate holder to restore any County roads that are degraded by  
7 construction traffic. Condition 77 requires the certificate holder to implement traffic safety  
8 measures during construction. The Council confirms that Conditions 45 and 77 apply to  
9 Stateline 3.

10 **UCDC Section 152.018**

11 UCDC Section 152.018 addresses measures to “manage access to land development  
12 while preserving the flow of traffic in terms of safety, capacity, functional classification, and  
13 level of service.” The ordinance describes the categorization of roadways in the County’s  
14 Transportation System Plan. The ordinance implements access management policies for  
15 properties that abut “arterials and collectors within the County,” including specific provisions  
16 for corner clearance, joint use driveways and cross access easements and design of driveways  
17 and access connections.

18 In UCDC Section 152.018, the County has established facility design requirements  
19 that may be outside the Council’s jurisdiction under ORS 469.401(4). Nevertheless, the  
20 County has identified the ordinance as one of the applicable substantive criteria under ORS  
21 469.504(5) for the Stateline 3 wind power generation facility and the transmission line. In  
22 Revision 77, the Department recommends that the Council adopt Condition 123, which would  
23 require the certificate holder to design and construct Stateline 3 in compliance with the  
24 County design requirements as described in this ordinance. In addition, Condition 2 requires  
25 the certificate holder to design and construct the facility “in compliance with the requirements  
26 of...ordinances in effect at the time the site certificate is issued.” Condition 2 incorporates the  
27 mandatory condition required by OAR 345-027-0020(3).

28 **UCDC Section 152.061**

29 *The following limitations shall apply to all conditional uses in an EFU zone. Uses*  
30 *may be approved only where such uses:*

31 *(A) Will not force a significant change in accepted farm or forest practices on*  
32 *surrounding lands devoted to farm or forest use; and*

33 *(B) Will not significantly increase the cost of accepted farm or forest practices on*  
34 *lands devoted to farm or forest use.*

35 UCDC Section 152.061 provides for protection of accepted farm and forest practices.  
36 The ordinance applies to conditional uses, including a wind generation facility. This  
37 ordinance also applies to the temporary batch plant, whether it is located within the existing  
38 County-approved quarry site or within the 30-acre laydown area. Provisions similar to UCDC  
39 Section 152.061 are found in the land use ordinances of other counties where the Council has

1 approved site certificates for wind energy facilities and in State land use regulations.<sup>110</sup> The  
2 Council has previously found that wind energy facilities on farm land in other counties do not  
3 force a significant change in accepted farm practices on surrounding lands devoted to farm  
4 use and do not significantly increase the cost of such farm practices.<sup>111</sup>

5 In the Final Order on the Application, the Council found that Stateline 1 would  
6 comply with *former* UCDC Section 152.061, which addressed the same issue of protection of  
7 accepted farm practices as addressed by the current ordinance.<sup>112</sup> In the Final Order on  
8 Amendment #1, the Council made similar findings as to *former* UCDC Section 152.061  
9 regarding Stateline 2, and in the Final Order on Amendment #2, the Council made similar  
10 findings as to *former* UCDC Section 152.061 regarding the old Stateline 3 configuration.<sup>113</sup>

11 The analysis area for Stateline 3 (the area within the site boundary and one-half mile  
12 from the site boundary) contains approximately 21,305 acres in Umatilla County, all of which  
13 is used for agricultural purposes.<sup>114</sup> At most, as shown in Table 8 herein, the Stateline 3 wind  
14 generation facility would occupy approximately 59 acres of this farm-use land, or less than  
15 one percent.

16 Accepted farm practices in the area are those necessary for dryland wheat farming,  
17 which is the predominant agricultural use, but other land is used for grazing and some land is  
18 enrolled in the Conservation Reserve Program (CRP).<sup>115</sup> There is no forest use within the  
19 analysis area. The Council finds that the impact of the proposed Stateline 3 would not force a  
20 significant change in accepted farm practices or significantly increase the cost of farm  
21 practices, for the reasons discussed below.

22 The temporary batch plant would be dismantled and removed when construction of  
23 Stateline 3 is completed. If the batch plant is located within the quarry site, it would have no  
24 new land impacts that were not considered by the County in approving the quarry. If the batch  
25 plant is located within the Stateline 3 laydown area, then it would have a temporary impact on  
26 agricultural land.<sup>116</sup> The land affected by the batch plant would either be restored to  
27 agricultural uses upon completion of construction or it would be part of the permanent 10-acre  
28 site containing the Stateline 3 O&M building and substation. The temporary and permanent  
29 impacts of the laydown area (as a related or supporting component of the wind energy  
30 facility) are addressed by the discussion below.

1 Construction of Stateline 3 would temporarily disturb up to 327 acres within the site  
2 boundary, including approximately 250 acres of cropland.<sup>117</sup> Construction and operation of  
3 the proposed facility could cause changes in the patterns of cultivation, seeding, fertilizing  
4 and harvesting near the turbines and access roads. Ground disturbance during construction  
5 and the creation of margin areas around access roads and turbine pads could increase  
6 opportunities for weeds to spread into cultivated areas. Construction disturbance could  
7 adversely affect soil quality by erosion or compaction.

8 The certificate holder would locate facility components and temporary construction  
9 laydown and staging areas to minimize disturbance with farming operations. Condition 40  
10 requires the certificate holder to make reasonable efforts not to disturb farming and ranching  
11 activities on adjacent land. Condition 44 requires the certificate holder to locate access roads  
12 in consultation with landowners to minimize crop impacts. New facility access roads and  
13 improvements to existing farm roads would be available to farmers and landowners and may  
14 facilitate access to agricultural fields and movement of farm equipment and vehicles. The  
15 Council confirms that Conditions 40 and 44 apply to Stateline 3. In Revision 79, the  
16 Department recommends that the Council adopt Condition 125, which would require the  
17 certificate holder to record a Covenant Not to Sue with regard to generally accepted farming  
18 practices on adjacent farmland in accordance with UCDC Section 152.616(HHH)(2)(E).

19 Condition 68 requires the certificate holder to implement *Revegetation Plan*, which  
20 includes weed control measures and measures to correct for soil compaction. The Department  
21 recommended revisions to the *Revegetation Plan*, as shown in Attachment B to the Proposed  
22 Order. In addition, Condition 68 specifically requires control of noxious weeds in areas  
23 disturbed by construction. Condition 30 requires the certificate holder to implement a weed  
24 control program during the life of the facility. Conditions 60, 61 and 92 require the certificate  
25 holder to implement erosion control measures during construction and operation. The Council  
26 confirms that Conditions 30, 60, 61, 68 and 92 apply to Stateline 3.

27 Construction-related traffic could cause occasional traffic delays when trucks deliver  
28 construction equipment, turbines and other facility components. Condition 77 requires the  
29 certificate holder to implement traffic safety measures during construction to minimize  
30 conflicts with harvest vehicles. During operation, facility staff vehicle traffic and facility  
31 maintenance vehicle traffic is unlikely to have a significant adverse effect on the movement of  
32 agricultural equipment or other farming vehicles as operational staff would consist fewer than  
33 ten employees.<sup>118</sup>

34 **UCDC Sections 152.063 (C), (E) and (F)**

35 UCDC Section 152.063(C) establishes side and rear yard setbacks. UCDC Section  
36 153.003 defines “setback” as “the open yard space on a lot between any building and a lot line  
37 or a line defining an access easement or road right-of-way.” The proposed O&M building is  
38 the only “building” that is part of the proposed Stateline 3 facilities, according to the  
39 definition in UCDC Section 153.003. UCDC Section 152.063(C)(2) establishes a setback  
40 distance of 5 feet for “accessory buildings or structures.” UCDC Section 152.003 defines

1 “structure” more broadly than “building,” and if the setback distance is applied to all  
2 “structures,” then it would apply to all aboveground components of Stateline 3, including the  
3 wind turbines. UCDC Section 152.063(C)(3) provides that “special minimum yard setbacks  
4 may be established for an approved conditional use to protect the public health, safety and  
5 welfare and to mitigate possible adverse impacts to adjacent land uses.”

6 UCDC Section 152.616(HHH)(5)(A) requires a setback for wind power generation  
7 facilities of 3,520 feet from “properties zoned residential use or designated on the  
8 Comprehensive Plan as residential.” The Department proposed safety setback distances  
9 similar to those adopted by the Council in the site certificate for the Shepherds Flat Wind  
10 Farm.<sup>119</sup> Where the 3,520-foot setback that is required under UCDC Section  
11 152.616(HHH)(5) does not apply, the applicants agreed to the following safety setbacks for  
12 wind turbines:<sup>120</sup>

- 13 • 110-percent of maximum blade tip height, measured from the centerline of the turbine  
14 tower to the nearest edge of any public road right-of-way, assuming a minimum right-  
15 of-way width of 60 feet.
- 16 • A minimum distance of 1,320 feet, measured from the centerline of the turbine tower  
17 to the center of the nearest residence existing at the time of tower construction.
- 18 • A minimum distance of 110-percent of maximum blade tip height, measured from the  
19 centerline of the turbine tower to the nearest boundary of the certificate holder’s lease  
20 area.

21 The Department Council adopts Condition 126, which would incorporate the setbacks  
22 described above. Revision 80 addresses the condition.

23 UCDC Section 152.063(E) establishes setback distances from streams, lakes and  
24 wetlands. The ordinance applies to “sewage disposal installations such as septic tanks and  
25 drainfields” and to “all structures, buildings or similar permanent fixtures” and establishes a  
26 setback distance of 100 feet subject to specified exceptions. The applicants propose to  
27 construct an on-site septic system for the disposal of sewage from the O&M building. The  
28 septic system would be located at least 100 feet from any streams, lakes or wetlands.<sup>121</sup> The  
29 Council adopts Condition 123, which would require the certificate holder to design and  
30 construct the facility in compliance with the County design requirements as described in this  
31 ordinance. The condition is described in Revision 77 herein.

32 UCDC Section 152.063(F) provides that “all development shall be subject to the  
33 regulations contained in §§ 152.010 through 152.017, §§ 152.545 through 152.562, and to the  
34 exceptions standards of §§ 152.570 through 152.577.” UCDC Sections 152.010, 152.011,  
35 152.016 and 152.017 are discussed in the sections above.

36 UCDC Section 152.012 addresses outdoor storage in residential zones. This ordinance  
37 does not apply because the proposed facility is not located within a residential zone.

1 UCDC Section 152.013 addresses mobile homes. This ordinance does not apply  
2 because the applicant does not propose any mobile home as a component of the proposed  
3 facility.

4 UCDC Section 152.014 addresses seasonal farm worker housing. This ordinance does  
5 not apply because the applicant does not propose any seasonal farm worker housing as a  
6 component of the proposed facility.

7 UCDC Section 152.015 addresses fences and provides that a zoning permit is not  
8 required for construction of fences. The ordinance provides that there is no height limitation  
9 on fences “except at corners of street intersections and service drives where vision clearance  
10 requirements shall be met.” Vision clearance requirements are addressed by UDCD Section  
11 152.011, discussed above. UCDC Section 152.015 requires that fences meet all Oregon  
12 Uniform Building Code requirements.” Condition 2 requires the certificate holder to design  
13 and construct the proposed facility in compliance with applicable state and local laws, rules  
14 and ordinances in effect at the time the site certificate is issued. Condition 123 would require  
15 the certificate holder to design and construct the facility in compliance with the County design  
16 requirements as described in this ordinance.

17 The other ordinances made applicable to the proposed facility by incorporation in  
18 UCDC Section 152.063(F) are discussed below.

19 **UCDC Sections 152.545 through 152.548**

20 UCDC Sections 152.545 through 152.548 establish requirements for the types of signs  
21 allowed within different County zones and limitations on signs. Other than signs required for  
22 facility safety or required by law, the applicants propose to use only those signs required for  
23 operation and safety or required by federal, state, or local law.<sup>122</sup> The Council modifies  
24 Condition 37, as described in Revision 36, to require the certificate holder to design and  
25 construct the facility in compliance with the County design requirements for signs as  
26 described in these ordinances.

27 **UCDC Sections 152.560 through 152.562**

28 UCDC Sections 152.560 through 152.562 establish requirements for off-street parking  
29 and loading. For industrial uses, UCDC Section 152.560 requires one parking space per 200  
30 square feet of floor space, plus one space per employee. The proposed O&M building would  
31 occupy up to 4,500 square feet and the Stateline 3 operations staff would consist of up to eight  
32 employees.<sup>123</sup> The ordinance, therefore, requires at least 28 off-street parking spaces. The  
33 O&M building would be located within a 10-acre site that would include an area for employee  
34 parking and storage. There would be adequate space for off-street parking.

35 UCDC Section 152.561 establishes a requirement for a loading area for schools and  
36 limits the use of off-street parking areas for loading and unloading of merchandise. The  
37 ordinance does not apply because Stateline 3 is not a school and its operation would not  
38 involve loading or unloading of merchandise.

39 UCDC Section 152.062 contains additional off-street parking and loading  
40 requirements. Subsection (A) addresses a change of use of a lot or building and is not

1 applicable. Subsection (B) allows the Planning Commission or Hearings Officer to determine  
2 requirements for types of buildings and uses not specifically listed. A wind power generation  
3 facility is not specifically listed, and so this ordinance gives the Planning Commission (and in  
4 this case the Council acting in its place) authority to determine off-street parking and loading  
5 requirements for Stateline 3. Subsections (C) and (D) are not applicable because they address  
6 multiple uses of a single structure or parcel and joint use agreements among multiple owners.  
7 Subsection (E) addresses off-street parking for dwellings and is not applicable. Subsection (F)  
8 provides that the required off-street parking spaces must be available for parking and must not  
9 be used for storage. Subsection (G) precludes locating required off-street parking or loading  
10 areas within a required yard. Subsection (H) requires plans to be submitted as provided by  
11 UCDC Section 152.767 and does not apply to the Council’s siting decision because it is an  
12 administrative provision rather than a land use standard. Subsection (I) establishes design  
13 requirements for parking lots and is not applicable because the proposed Stateline 3 facilities  
14 do not include a parking lot. The Council finds that the proposed parking area within the 10-  
15 acre O&M building site would provide adequate parking area for Stateline 3.

16 **UCDC Sections 152.570 through 152.577**

17 UCDC Sections 152.570 through 152.577 provide for exceptions to the requirements  
18 of other County land use ordinances. These ordinances are not applicable because the  
19 applicants are not requesting any of the exceptions in the Request for Amendment #4.

20 **UCDC Sections 152.610 through 152.614**

21 These ordinances apply to conditional uses. UCDC Section 152.610 contains  
22 definitions rather than substantive standards. UCDC Section 152.611 contains procedural  
23 requirements pertaining to new or altered conditional uses. The proposed Stateline 3 facilities  
24 include a conditional use (the wind power generation facility components). The ordinance  
25 provides that the planning authority may impose conditions “considered necessary to protect  
26 the best interests of the surrounding area or the county as a whole.” The ordinance provides  
27 that the County may require an applicant to furnish the County with “a performance bond or  
28 such other form of assurance that the county deems necessary to guarantee development in  
29 accordance with the standards established and conditions attached in granting a conditional  
30 use.” If the Council amends the site certificate to authorize construction and operation of the  
31 reconfigured Stateline 3, the certificate holders would be legally bound by the terms and  
32 conditions of the site certificate and subject to the enforcement authority of the Council, and  
33 therefore the County performance bond described in this ordinance would not be necessary.

34 UCDC Section 152.612 describes the procedure for taking action on a conditional use  
35 application. The applicants have elected to have the Council make the land use decision in  
36 accordance with ORS 469.504(1)(b), and therefore the Council’s procedural requirements  
37 apply. UCDC Section 152.612(C) provides that a conditional use permit “will not be  
38 approved unless the proposed use of the land will be in conformance with the County  
39 Comprehensive Plan.” Applicable policies of the UCCP are discussed below, beginning at  
40 page 53. UCDC Section 152.612(D) provides that an applicant granted a conditional use  
41 permit must obtain a County Zoning Permit before commencing construction. If the Council  
42 approves Amendment #4, then the County must issue a conditional use permit (or amend the  
43 current CUP for the SWP) in accordance with ORS 469.401(3), and this ordinance would

1 require that the certificate holders obtain a Zoning Permit before beginning construction of  
2 Stateline 3. The Zoning Permit requirement is discussed below at page 63.

3 UCDC Section 152.613 establishes a one-year time limit on a conditional use permit  
4 but provides that the Planning Director or the proper planning authority may extend the time  
5 limit for an additional period not to exceed one year. This ordinance is a procedural  
6 requirement and is not a substantive land use criterion.

7 UCDC Section 152.614 precludes consideration of a conditional use application  
8 within one year after the denial of a like request unless there is “new evidence or a change of  
9 circumstances.” This ordinance is a procedural requirement and is not a substantive land use  
10 criterion.

11 **UCDC Section 152.615**

12 *In addition to the requirements and criteria listed in this subchapter, the Hearings*  
13 *Officer, Planning Director or the appropriate planning authority may impose the*  
14 *following conditions upon a finding that circumstances warrant such additional*  
15 *restrictions:*

16 (A) *Limiting the manner in which the use is conducted, including restricting hours*  
17 *of operation and restraints to minimize such a environmental effects as noise,*  
18 *vibration, air pollution, glare or odor;*

19 (B) *Establishing a special yard, other open space or lot area or dimension;*

20 (C) *Limiting the height, size or location of a building or other structure;*

21 (D) *Designating the size, number, location and nature of vehicle access points;*

22 (E) *Increasing the required street dedication, roadway width or improvements*  
23 *within the street right of way;*

24 (F) *Designating the size, location, screening, drainage, surfacing or other*  
25 *improvement of a parking or loading area;*

26 (G) *Limiting or otherwise designating the number, size, location, height and*  
27 *lighting of signs;*

28 (H) *Limiting the location and intensity of outdoor lighting and requiring its*  
29 *shielding;*

30 (I) *Requiring diking, screening, landscaping or other methods to protect adjacent*  
31 *or nearby property and designating standards for installation and maintenance.*

32 (J) *Designating the size, height, location and materials for a fence;*

33 (K) *Protecting and preserving existing trees, vegetation, water resources, wildlife*  
34 *habitat, or other significant natural resources;*

35 (L) *Parking area requirements as listed in §§ 152.560 through 152.562 of this*  
36 *chapter.*

37 UCDC Section 152.615 describes conditions that may be imposed “upon a finding that  
38 circumstances warrant such additional restrictions.” This ordinance applies to the wind energy

1 facility and all related or supporting facilities (including the temporary batch plant). The  
2 ordinance is a list of discretionary conditions and does not contain substantive standards. The  
3 County is bound by ORS 469.401(3) to issue a CUP for the SWP “subject only to conditions  
4 set forth in the site certificate or amended site certificate.” The County has previously  
5 reviewed the site certificate conditions adopted by the Council for the SWP in the orders  
6 issued in 2001, 2002, 2003 and 2005 and has expressed no concerns to the Department. The  
7 County provided a list of conditions for Stateline 3.<sup>124</sup> The Department reviewed and  
8 identified for the County the comparable conditions that are included or proposed to be  
9 included in the Site Certificate.<sup>125</sup> The Department’s recommended Revisions, discussed  
10 below beginning at page 128, include new conditions and modifications of conditions to  
11 accommodate the County’s requests.

12 **UCDC Section 152.616**

13 UCCD Section 152.616 contains standards for the review of specific conditional uses.  
14 UCDC Section 152.616(HHH) contains specific standards applicable to wind power  
15 generation facilities.

16 *(1) The procedure for taking action on the siting of a facility is a request for a*  
17 *conditional use. A public hearing pursuant to Sections 152.750 -755 and 152.771*  
18 *shall be held to determine if the applicant meets the siting requirements for a Wind*  
19 *Power Generation Facility. The requirement for a hearing will not apply to*  
20 *proposed facilities for which EFSC is making the land use decision.*

21 UCDC Section 152.616(HHH)(1) describes the procedure that applies when a  
22 developer requests a CUP from the County for a proposed wind power generation facility.  
23 The applicants have elected to have the Council make the land use decision in accordance  
24 with ORS 469.504(1)(b), and therefore the Council’s procedural requirements apply.

25 *(2) The following information shall be provided as part of the application:*

26 *(A) A general description of the proposed Wind Power Generation Facility, a*  
27 *tentative construction schedule, the legal description of the property on which the*  
28 *facility will be located, and identification of the general area for all components of*  
29 *the proposed Wind Power Generation Facility, including a map showing the*  
30 *location of components.*

31 *(B) Identification of potential conflicts, if any, with: (1) Accepted farming*  
32 *practices as defined in ORS 215.203(2)(c) on adjacent lands devoted to farm uses;*  
33 *(2) Other resource operations and practices on adjacent lands except for wind*  
34 *power generation facilities on such adjacent lands; and (3) Accepted farm or*  
35 *forest practices on surrounding EFU/GF or NR land, including the nature and the*  
36 *extent of the impact of the proposed facility on the cost of such practices.*

37 *(C) A Transportation Plan, with proposed recommendations, if any, reflecting*  
38 *the guidelines provided in the Umatilla County Transportation System Plan (TSP)*  
39 *and the transportation impacts of the proposed Wind Power Generation Facility*  
40 *upon the local and regional road system during and after construction, after*

1           *consultation with Umatilla County Public Works Director. The plan will designate*  
2           *the size, number, location and nature of vehicle access points.*

3           *(D) An avian impact monitoring plan. The avian monitoring plan shall be*  
4           *designed and administered by the applicant=s wildlife professionals. For projects*  
5           *being sited by EFSC, compliance with EFSC=s avian monitoring requirements*  
6           *will be deemed to meet this requirement. The plan shall include the formation of a*  
7           *technical oversight committee to review the plan, and consist of the following*  
8           *persons:*

9                     *(1) The landowners/farm tenants.*

10                    *(2) Facility owner/operator representative. (Chair)*

11                    *(3) Oregon Department of Fish and Wildlife representative, if the agency*  
12           *chooses to participate.*

13                    *(4) Two Umatilla County residents with no direct economic interest in the*  
14           *project and recommended by the applicants for appointment by the Umatilla*  
15           *County Board of Commissioners.*

16                    *(5) U.S. Fish and Wildlife representative, if the agency chooses to*  
17           *participate.*

18                    *(6) Umatilla County Planning Commission member.*

19           *At the request of applicant, this committee requirement may be waived or*  
20           *discontinued by the County.*

21           *(E) A Covenant Not to Sue with regard to generally accepted farming practices*  
22           *shall be recorded with the County. Generally accepted farming practices shall be*  
23           *consistent with the definition of Farming Practices under ORS 30.930. The*  
24           *applicant shall covenant not to sue owners, operators, contractors, employees, or*  
25           *invitees of property zoned for farm use for generally accepted farming practices.*

26           *(F) A fire prevention and emergency response plan for all phases of the life of*  
27           *the facility. The plan shall address the major concern associated with the terrain,*  
28           *dry conditions, and limited access.*

29           *(G) An erosion control plan, developed in consultation with the Umatilla*  
30           *County Public Works Department. The plan should include the seeding of all road*  
31           *cuts or related bare road areas as a result of all construction, demolition and*  
32           *rehabilitation with an appropriate mix of native vegetation or vegetation suited to*  
33           *the area. This requirement will be satisfied if the applicant has an NPDES*  
34           *(National Pollution Discharge Elimination System) permit.*

35           *(H) A weed control plan addressing prevention and control of all Umatilla*  
36           *County identified noxious weeds directly resulting from the Wind Power*  
37           *Generation Facility during preparation, construction, operation and*  
38           *demolition/rehabilitation.*

39           *(I) A socioeconomic impact assessment of the Wind Power Generation Facility,*  
40           *evaluating such factors as, but not limited to, the project's effects upon the social,*

1 *economic, public service, cultural, visual, and recreational aspects of affected*  
2 *communities and/or individuals. These effects can be viewed as either positive or*  
3 *negative. In order to maximize potential benefits and to mitigate outcomes that are*  
4 *viewed as problematic, decision makers need information about the socioeconomic*  
5 *impacts that are likely to occur.*

6 *(J) If the Wind Power Generation Facility exceeds 20 acres in size, a Goal 3*  
7 *exception is required as found in OAR 660-033-0130 (22).*

8 *(K) Information pertaining to the impacts of the Wind Power Generation*  
9 *Facility on: (1) Wetlands; (2) Wildlife (all potential species of reasonable*  
10 *concern); (3) Wildlife Habitat; (4) Criminal Activity (vandalism, theft, trespass,*  
11 *etc.) and proposed actions, if any, to avoid, minimize or mitigate negative impacts.*

12 *(L) A dismantling and decommissioning plan of all components of the Wind*  
13 *Power Generation Facility, as provided in '152.616 (HHH)(7).*

14 UCDC Section 152.616(HHH)(2) describes the content of an application for a CUP  
15 under the County procedure. Because the applicants have elected to have the Council make  
16 the land use decision in accordance with ORS 469.504(1)(b), the applicable application  
17 requirements for the proposed Stateline 3 facilities are described in OAR 345-027-0060,  
18 which describes the requirements for a request to amend a site certificate. The applicants'  
19 amendment request contains exhibits that are analogous to the subsections of UCDC Section  
20 152.616(HHH)(2), as discussed below.

21 A description of the components and location of the proposed Stateline 3 facilities,  
22 required by subsection (A) of the ordinance, is addressed in Exhibits B and C of the  
23 amendment request.

24 Potential adverse effects of Stateline 3 on accepted farming practices, described in  
25 subsection (B) of the ordinance, are addressed in Exhibit K of the amendment request.

26 Transportation impacts of the proposed facility on traffic safety, described in  
27 subsection (C) of the ordinance, are addressed in Exhibit U of the amendment request.

28 Subsection (D) of the ordinance specifically provides that compliance with the  
29 Council's avian monitoring requirements (discussed in Exhibit P of the amendment request)  
30 satisfies the requirements of the ordinance subsection.

31 The applicants have agreed to record a Covenant Not to Sue with regard to generally  
32 accepted farming practices, required by subsection (E) of the ordinance.<sup>126</sup> The Council  
33 adopts Condition 125, which requires the certificate holder to execute a Covenant Not to Sue  
34 that complies with the County requirement.

35 Fire prevention and response measures for Stateline 3, described in subsection (F) of  
36 the ordinance, are addressed in Exhibit U of the amendment request.

37 Subsection (G) of the ordinance addresses erosion control and specifically provides  
38 that having an NPDES permit satisfies the requirements of the ordinance subsection. Exhibit I  
39 of the amendment request addresses soil impacts. Condition 60 requires the certificate holder

1 to have an NPDES 1200-C permit and to conduct all Stateline 3 construction work in  
2 compliance with an Erosion and Sediment Control Plan.<sup>127</sup> Condition 61 requires mitigation  
3 measures during construction to reduce potential adverse impacts to soils from erosion.  
4 Condition 65 requires erosion control as part of the post-construction *Revegetation Plan*.  
5 Condition 92 requires mitigation measures during facility operation to reduce potential  
6 adverse impacts to soils from erosion.

7 A weed control plan, required by subsection (H) of the ordinance, is addressed in  
8 Exhibits K and P of the amendment request. Conditions 65 and 68 require the certificate  
9 holder to implement *Revegetation Plan*, which includes weed control measures. The  
10 Department recommended revisions to the *Revegetation Plan*, as shown in Attachment B to  
11 the Proposed Order. In addition, Condition 68 specifically requires control of noxious weeds  
12 in agricultural areas disturbed by construction. Condition 30 requires the certificate holder to  
13 implement a weed control program during the life of the facility.

14 Assessment of the effects of Stateline 3 upon the social, economic, public service,  
15 cultural, visual and recreational aspects of affected communities, required by subsection (I) of  
16 the ordinance, is addressed in Exhibits S, R, T and U of the amendment request.

17 Subsection (J) of the ordinance is a substantive standard regarding the acres of  
18 farmland that the footprint of the proposed wind power generation facility would occupy. The  
19 standard is addressed in Exhibit K of the amendment request. The ordinance cross-references  
20 OAR 660-033-0130, a State land use regulation that includes a similar 20-acre limitation that  
21 applies to a “power generating facility” located on low-value farmland. In January 2009,  
22 LCDC amended OAR 660-033-0130, removing the 20-acre limitation for wind power  
23 generation facilities but adopting new requirements. The limitation on the use of farmland is  
24 discussed separately below at page 63.

25 Information about the impacts of Stateline 3 on wetlands, wildlife, wildlife habitat and  
26 criminal activity, described in subsection (K) of the ordinance, is addressed in Exhibits J, P, Q  
27 and U of the amendment request.

28 A plan for “decommissioning” the wind power generation facility, described in  
29 subsection (L) of the ordinance, is addressed in Exhibit W of the amendment request.

30 *(3) Umatilla County may impose clear and objective conditions in accordance*  
31 *with the County Comprehensive Plan, County Development Code and state law,*  
32 *which Umatilla County considers necessary to protect the best interests of the*  
33 *surrounding area, or Umatilla County as a whole.*

34 UCDC Section 152.616(HHH)(3) gives the County discretion to impose “clear and  
35 objective conditions...necessary to protect the best interests of the surrounding area, or  
36 Umatilla County as a whole.” The County has reviewed the site certificate conditions that the  
37 Council has previously adopted for the SWP and has proposed new conditions for Stateline 3.

38 *(4) Prior to commencement of any construction, all other necessary permits shall*  
39 *be obtained, e.g. Umatilla County Zoning Permit, road access and other permits*

1           *from the Umatilla County Public Works Department, and from the Oregon*  
2           *Department of Transportation.*

3           Condition 2 requires the certificate holders to obtain all necessary state and local  
4           permits or approvals required for construction of Stateline 3.

5           *(5) The following requirements and restrictions apply to the siting of a facility:*

6           *(A) The Wind Power Generation Facility shall be on property zoned EFU/GF*  
7           *or NR, and no portion of the facility shall be within 3,520 feet of properties zoned*  
8           *residential use or designated on the Comprehensive Plan as residential. (For*  
9           *clarification purposes of this section, EFU/GF/NR zones are not considered zoned*  
10           *for residential use.)*

11           *(B) Reasonable efforts shall be made to blend the wind facility=s towers with*  
12           *the natural surrounding in order to minimize impacts upon open space and the*  
13           *natural landscape.*

14           *(C) Reasonable efforts shall be taken to protect and to preserve existing trees,*  
15           *vegetation, water resources, wildlife habitat or other significant natural resources.*

16           *(D) The turbine towers shall be designed and constructed to discourage bird*  
17           *nesting and wildlife attraction.*

18           *(E) The turbine towers shall be of a size and design to help reduce noise or*  
19           *other detrimental effects.*

20           *(F) Private access roads shall be gated to protect the facility and property*  
21           *owners from illegal or unwarranted trespass, and illegal dumping and hunting.*

22           *(G) Where practicable the electrical cable collector system shall be installed*  
23           *underground, at a minimum depth of 3 feet; elsewhere the cable collector system*  
24           *shall be installed to prevent adverse impacts on agriculture operations.*

25           *(H) Required permanent maintenance/operations buildings shall be located off-*  
26           *site in one of Umatilla County's appropriately zoned areas, except that such a*  
27           *building may be constructed on-site if (1) the building is designed and constructed*  
28           *generally consistent with the character of similar buildings used by commercial*  
29           *farmers or ranchers, and (2) the building will be removed or converted to farm use*  
30           *upon decommissioning of the Wind Power Generation Facility consistent with the*  
31           *provisions of '152.616 (HHH)(7).*

32           *(I) A Wind Power Generation Facility shall comply with the Specific Safety*  
33           *Standards for Wind Facilities delineated in OAR 345-024-0010 (as adopted at*  
34           *time of application).*

35           UCDC Section 152.616(HHH)(5) lists requirements and restrictions applicable to  
36           siting a wind power generating facility in the County. These requirements and restrictions are  
37           addressed by site certificate conditions. Condition 2 requires the certificate holder to construct  
38           the facility substantially as described in the site certificate.

39           Subsection (A) of the ordinance requires that a wind power generating facility be  
40           located on land zoned EFU, GF (Grazing/Farm Zone) or NR (Non-Resource Zone). The

1 proposed Stateline 3 facilities would be located entirely on EFU land. Subsection (A) of the  
2 ordinance also requires that “no portion of the facility shall be within 3,520 feet of properties  
3 zoned residential use or designated on the Comprehensive Plan as residential.” Condition 126  
4 incorporates this County requirement.<sup>128</sup>

5 Subsection (B) requires that “reasonable efforts” be made to blend the wind power  
6 generation facility’s towers with the surrounding landscape. Condition 37 addresses measures  
7 to reduce the visual impact of the proposed Stateline 3 facilities.

8 Subsection (C) requires “reasonable efforts...to protect and to preserve existing trees,  
9 vegetation, water resources, wildlife habitat or other significant natural resources.” A  
10 discussion of the Council’s Fish and Wildlife Habitat Standard begins at page 105 and  
11 addresses the applicants’ efforts to reduce impact on these resources and the Department’s  
12 recommended conditions. The potential impact on water resources is addressed in the  
13 discussion of the Ground Water Act below at page 124. The effect of the facility on wetlands  
14 and other waters of the state protected by the state’s Removal/Fill Law is addressed below at  
15 page 123.

16 Subsection D requires that turbine towers be designed and constructed to discourage  
17 bird nesting and wildlife attraction. Condition 37 requires the certificate holders to use smooth  
18 turbine tower structures that lack perching or nesting opportunities for birds.

19 Subsection E requires that wind turbine towers be designed “to reduce noise or other  
20 detrimental effects.” Condition 2 requires the certificate holder to design and construct the  
21 facility in compliance with State laws and rules. As discussed below, beginning at page 118,  
22 and subject to the site certificate conditions described in that discussion, the proposed  
23 Stateline 3 facilities would comply with the State noise control regulations. Other possible  
24 “detrimental effects” would be reduced by locating turbines away from residences and public  
25 roads, as required by Condition 126.

26 Subsection F is a County design requirement for gates on private access roads. In  
27 Revision 77, the Department recommends that the Council adopt Condition 123, which would  
28 require the certificate holder to design and construct Stateline 3 in compliance with the  
29 County design requirements as described in this ordinance.

30 Subsection G requires that collector lines be installed underground or, if aboveground,  
31 that they be installed to prevent adverse impacts on agriculture operations. The applicants  
32 propose to locate all of the 34.5-kV collector lines underground.<sup>129</sup> Condition 62 requires the  
33 underground collector lines to be buried at least 3 feet below grade.

34 Subsection H requires that any on-site O&M building be designed and constructed  
35 generally consistent with the character of similar buildings used by commercial farmers or  
36 ranchers and that the building be removed or converted to farm use upon “decommissioning”  
37 of the facility. Condition 37 requires the design of the proposed O&M building to be  
38 consistent with farm structures in the area.<sup>130</sup> Site restoration is discussed above, beginning at  
39 page 17. The cost estimate for site restoration assumes that O&M building would be removed

1 and includes the cost of demolition, but the building might be converted to farm use at the  
2 request of the landowner. The Department’s recommended Revision 66 would modify  
3 Condition 109 to incorporate the site restoration cost estimate for the new Stateline 3  
4 configuration.

5 Subsection I requires that a wind power generation facility comply with the Council’s  
6 Public Health and Safety Standards for Wind Facilities as described in OAR 345-024-0010.  
7 Compliance with these standards is discussed below at page 96.

8 *(6) To the extent feasible, the county will accept information presented by an*  
9 *application for an EFSC proceeding in the form and on the schedule required by*  
10 *EFSC.*

11 UCDC Section 152.616(HHH)(6) is a procedural requirement establishing that the  
12 County will accept information presented in a site certificate application in the form and  
13 schedule required by the Council.

14 *(7) The applicants dismantling of uncompleted construction and/or*  
15 *decommissioning plan for the Wind Power Generation Facility shall include the*  
16 *following information:<sup>131</sup>*

17 \* \* \*

18 *(G) For projects sited by EFSC, compliance with EFSC’s financial assurance*  
19 *and decommissioning standards shall be deemed to be in compliance with the*  
20 *dismantling and decommissioning requirements of this Section 152.616 (HHH)(7).*

21 UCDC Section 152.616(HHH)(7) requires that the applicant provide a plan for  
22 “dismantling of uncompleted construction and/or decommissioning plan.” The requirements  
23 of this ordinance are met “for facilities sited by EFSC” if the certificate holder complies with  
24 the Council’s “financial assurance and decommissioning standards.” The Council’s  
25 Retirement and Financial Assurance Standard is discussed above, beginning at page 15. For  
26 the reasons discussed therein and subject to the site certificate conditions, the certificate  
27 holders would comply with this standard.

28 *(8) A bond or letter of credit shall be established for the dismantling of*  
29 *uncompleted construction and/or decommissioning of the facility. (See §152.616*  
30 *(HHH)(7)) For projects being sited by the State of Oregon’s Energy Facility Siting*  
31 *Council (EFSC), the bond or letter of credit required by EFSC will be deemed to*  
32 *meet this requirement.*

33 UCDC Section 152.616(HHH)(8) requires a bond or letter of credit for the cost of  
34 “the dismantling of uncompleted construction and/or decommissioning of the facility.” The  
35 ordinance provides that the bond or letter of credit that the Council requires satisfies the  
36 requirement of the ordinance for “projects being sited by the State of Oregon’s Energy  
37 Facility Siting Council (EFSC).” In Revisions 49 and 66, the Department recommends  
38 modification of Conditions 80 and 109, which require the certificate holders to provide a bond  
39 or letter of credit for site restoration in a form and amount satisfactory to the Council.

1           (9) *The actual latitude and longitude location or Stateplane NAD 83(91)*  
2           *coordinates of each turbine tower, connecting lines, and transmission lines, shall*  
3           *be provided to Umatilla County once commercial electrical production begins.*

4           (10) *A summary of as built changes in the facility from the original plan, if any,*  
5           *shall be provided by the owner/operator.*

6           UCDC Section 152.616(HHH)(9) requires that “actual latitude and longitude  
7           location...of each turbine tower, connecting lines, and transmission lines” be provided when  
8           commercial operation of the wind power generation facility begins, and UCDC Section  
9           152.616(HHH)(10) requires a summary of “as built changes in the facility from the original  
10          plan.” Condition 84, modified as described in Revision 50, requires the certificate holder to  
11          provide the actual location of turbine towers, connecting lines and transmission lines and a  
12          summary of as-built changes as required by the County ordinance.

13          (11) (A) *The Wind Power Generation Facility requirements shall be facility*  
14          *specific, but can be amended as long as the facility does not exceed the boundaries*  
15          *of the Umatilla County conditional use permit where the original facility was*  
16          *constructed.*

17          (B) *An amendment to the conditional use permit shall be required if proposed*  
18          *facility changes would: (1) Increase the land area taken out of agricultural*  
19          *production by an additional 20 acres or more; (2) Increase the land area taken out*  
20          *of agricultural production sufficiently to trigger taking a Goal 3 exception; (3)*  
21          *Require an expansion of the established facility boundaries; (4) Increase the*  
22          *number of towers; (5) Increase generator output by more than 25 percent relative*  
23          *to the generation capacity authorized by the initial permit due to the repowering*  
24          *or upgrading of power generation capacity. Notification by the facility*  
25          *owner/operator to the Umatilla County Planning Department of changes not*  
26          *requiring an amendment are encouraged, but not required. An amendment to a*  
27          *Site Certificate issued by EFSC will be governed by the rules for amendments*  
28          *established by EFSC.*

29          UCDC Section 152.616(HHH)(11) establishes the County procedure for amendment  
30          of a CUP for a wind generation facility. The ordinance is a procedural requirement and is not  
31          a substantive land use standard. The ordinance notes that an amendment to a site certificate is  
32          governed by the Council’s rules.

33          (12) *Within 120 days after the end of each calendar year the facility*  
34          *owner/operator shall provide Umatilla County an annual report including the*  
35          *following information:*

36                (A) *Energy production by month and year.*

37                (B) *Non-proprietary information about wind conditions. (e. g. monthly*  
38                *averages, high wind events, bursts)*

39                (C) *A summary of changes to the facility that do not require facility*  
40                *requirement amendments.*

1 (D) A summary of the avian monitoring program – bird injuries, casualties,  
2 positive impacts on area wildlife and any recommendations for changes in the  
3 monitoring program.

4 (E) Employment impacts to the community and Umatilla County during and  
5 after construction.

6 (F) Success or failures of weed control practices.

7 (G) Status of the decommissioning fund.

8 (H) Summary comments – any problems with the projects, any adjustments  
9 needed, or any suggestions.

10 The annual report requirement may be discontinued or required at a less frequent  
11 schedule by the County. The reporting requirement and/or reporting schedule  
12 shall be reviewed, and possibly altered, at the request of the facility  
13 owner/operator. For facilities under EFSC jurisdiction and for which an annual  
14 report is required, the annual report to EFSC satisfies this requirement.

15 UCDC Section 152.616(HHH)(12) requires an annual report to the County from the  
16 owner or operator of a wind power generating facility. The ordinance is a procedural  
17 requirement and is not a substantive land use standard. The ordinance notes that for facilities  
18 under Council jurisdiction, compliance with the Council’s annual reporting requirement  
19 satisfies the ordinance. Condition 8 requires the certificate holder to report to the Council  
20 every six months during construction and annually after beginning construction.

21 **UCDC Section 152.617**

22 UCDC Section 152.617 describes standards applicable to conditional uses and “land  
23 use decisions” on EFU zoned lands. The ordinance is divided into two sub-parts. Subpart I  
24 applies to “EFU Conditional Uses.” Among these uses are “commercial facilities for the  
25 purposes of generating and distributing power for public use by sale” (UCDC Section  
26 152.617(I)(C)), which include “electrical substations” but not “wind power generating  
27 facilities.” Standards applicable to wind power generating facilities are addressed by UCDC  
28 Section 152.616(HHH), discussed above. Subpart I subsections (A) and (K) apply to the  
29 proposed temporary concrete batch plant.

30 Subpart II applies to “EFU Land Use Decisions” (other than conditional uses). UCDC  
31 Section 152.617(II)(7) lists “utility facilities necessary for public service.” UCDC Section  
32 152.617(II)(8) lists “wind power generating facility” but simply cross-references the standards  
33 in UCDC Section 152.616, discussed above.

34 The criteria that apply to batch plants and to utility facilities necessary for public  
35 service are discussed separately below.

36 **Batch Plant**

37 The County identified UCDC Section 152.617(I)(K)(2), (8) and (10) as applicable to  
38 the proposed temporary concrete batch plant if it is located within the disturbed lands of an  
39 existing gravel quarry.<sup>132</sup> The County identified UCDC Section 152.617(I)(A) as applicable if

1 the batch plant is located within the 30-acre laydown area. The applicants' preferred location  
2 for the batch plant is within the quarry site. The Council finds that the proposed batch plant in  
3 either location would comply with the applicable requirements of UCDC Section 152.617, for  
4 the reasons discussed below.

5 *(K) Mining*

6 *Commercial gravel bits [sic] or extraction, surface mining and processing and the*  
7 *operations conducted for the exploration, mining and processing of geothermal*  
8 *resources, other mineral resources, or other subsurface resources.*

9 \*\*\*

10 *(2) Processing equipment shall comply with the following restrictions and*  
11 *regulations under the following circumstances:*

12 *(a) In an existing pit.*

13 *(1) Equipment shall not be located within 50 feet of a public road, county*  
14 *road or utility right of way or located further away if deemed necessary.*

15 *(2) Equipment shall not be located within 100 feet from any part of a*  
16 *property line, which is adjacent to a residential dwelling or further if deemed*  
17 *necessary.*

18 *(b) In a new pit. Where the use of processing equipment such as crushers,*  
19 *batch plants, and the like, the operator will be required to place such equipment*  
20 *not closer than 500 feet from any part of a property line adjacent to a residential*  
21 *dwelling unless the operator can obtain a written release from the adjacent*  
22 *residential property owner allowing a closer setback.*

23 If the batch plant is located within the existing quarry site, then 152.617(I)(K)(2)(a)  
24 applies. The batch plant processing equipment would not be located within 50 feet of Gerking  
25 Flat Road, which is the nearest public road, county road or utility right of way. In Revision  
26 80, the Department recommends that the Council adopt Condition 126, which would  
27 incorporate the County's setback requirement for batch plant equipment. There are no  
28 residential properties within 100 feet of the quarry.<sup>133</sup>

29 *(8) The operation complies with all applicable air, noise and water quality*  
30 *regulations of all county, state or federal jurisdictions and all applicable state or*  
31 *federal permits are obtained;*

32 Condition 2 requires the certificate holder to obtain all necessary state and local  
33 permits or approvals required for construction of Stateline 3. The certificate holder would be  
34 obligated to comply with all applicable federal laws and regulations, subject to the jurisdiction  
35 of the appropriate federal agencies. The noise generated by the temporary batch plant would  
36 be exempt from the limits on industrial noise under OAR 340-035-0035(5)(g) or (h) as noise  
37 associated with construction.

1           (10) All equipment, refuse, and temporary structures shall be removed from the  
2           project site and the site left free of debris after completion of the project;

3           Condition 20 requires restoration of all areas temporarily disturbed by construction.  
4           The site used for the temporary batch plant would be restored when construction is complete.

5           (A) Asphalt plants.

6           (1) Access roads shall be arranged in such a manner as to minimize traffic danger  
7           and nuisance to surrounding properties;

8           (2) Processing equipment shall not be located or operated within 500 feet from a  
9           residential dwelling;

10          (3) Haul roads shall be constructed to a standard approved by the Public Works  
11          Director to reduce noise, dust and vibration;

12          (4) The operation complies with all applicable air, noise, and dust regulations of  
13          all county, state or federal jurisdictions; and all state and federal permits are  
14          obtained before the activity begins;

15          (5) New plants proposed on EFU zoned lands. Plants that batch and blend mineral  
16          and aggregate into asphalt cement may not be authorized within two miles of a  
17          planted Vineyard totaling 40 acres or more that are planted as of the date the  
18          application for batching and blending is filed.

19          (6) Complies with other conditions deemed necessary.

20          If the batch plant is located within the 30-acre laydown area, then UCDC Section  
21          152.617(I)(A) applies. Subsection (1) requires that access roads be arranged to minimize  
22          traffic danger and nuisance to surrounding properties. The access road to the 30-acre laydown  
23          area would intersect with Gerking Flat Road.<sup>134</sup> The road would not create any significant risk  
24          to surrounding properties or to traffic safety.

25          The proposed location complies with subsection (2) because the nearest residential  
26          dwelling is more than 500 feet from the laydown area.<sup>135</sup> In compliance with subsection (3),  
27          Condition 61 requires that the certificate holder construct access roads in consultation with the  
28          Umatilla County Public Works Director. Under Conditions 2 and 123, the certificate holder  
29          would construct access roads in accordance with applicable design ordinances. The proposed  
30          laydown area is on EFU-zoned land but is not located within two miles of a planted vineyard.  
31          Locating the temporary batch plant within the laydown area therefore complies with  
32          subsection (5).

33          Site certificate conditions would ensure compliance with subsection (4) of the  
34          ordinance. Condition 2 requires the certificate holder to obtain all necessary state and local  
35          permits or approvals required for construction of Stateline 3. The certificate holder would be  
36          obligated to comply with all applicable federal laws and regulations, subject to the jurisdiction  
37          of the appropriate federal agencies. The noise generated by the temporary batch plant would

1 be exempt from the limits on industrial noise under OAR 340-035-0035(5)(g) or (h) as noise  
2 associated with construction.

3 Subsection (6) requires compliance with “other conditions deemed necessary.” The  
4 County recommended conditions for Stateline 3 consistent with applicable County  
5 ordinances.<sup>136</sup> The Department’s recommended Revisions, discussed below beginning at  
6 page 128, include new conditions and modifications of conditions to accommodate the  
7 County’s requests.

8 Utility Facilities Necessary for Public Service

9 The proposed 230-kV transmission line that is part of the proposed Stateline 3  
10 facilities is subject to UCDC Section 152.617(II)(7).<sup>137</sup> For this use, the applicant must meet  
11 the standards discussed below.<sup>138</sup> The County did not separately identify criteria applicable to  
12 the proposed Stateline 3 substation, but the substation would be a “related or supporting  
13 facility” under the County’s definition of a “wind power generating facility,” quoted above at  
14 page 30, and it is therefore included in the analysis of ordinances applicable to the wind  
15 power generating facility herein.<sup>139</sup>

16 *(a) Demonstrate that reasonable alternatives have been considered and that the*  
17 *facility must be sited in an exclusive farm use zone due to one or more of the*  
18 *following factors:*

19 *(1) Information provided in the technical and engineering feasibility;*

20 *(2) The proposed facility is locationally dependent. (It must cross land in one or*  
21 *more areas zoned for exclusive farm use in order to achieve a reasonably direct*  
22 *route or to meet unique geographical needs that cannot be satisfied on other*  
23 *lands.)*

24 *(A) Show a lack of available urban and non-resource lands;*

25 *(B) Due to availability of existing rights of way.*

26 *(C) Due to public health and safety concerns; and*

27 *(D) Show it must meet other requirements of state and federal agencies.*

28 *(b) Costs associated with any of the factors listed above may be considered, but*  
29 *cost alone, including the cost of land, may not be the only consideration in*  
30 *determining that a utility facility is necessary for public service.*

31 *(c) The owner of a utility facility approved under this section shall be responsible*  
32 *for restoring, as nearly as possible, to its former condition any agricultural land*  
33 *and associated improvements that are damaged or otherwise disturbed by the*  
34 *siting, maintenance, repair or reconstruction of the facility.*

1           (d) Mitigate and minimize the impacts of the proposed facility, if any, on  
2           surrounding lands devoted to farm use in order to prevent a significant change in  
3           accepted farm practices or a significant increase in the cost of farm practices on  
4           surrounding farmlands.

5           (e) Any proposed extension of a sewer system as defined by OAR 660-011-  
6           0060(1)(f) in an exclusive farm use zone shall be subject to the provisions of OAR  
7           660-011-0060.

8           (f) The provisions of this section do not apply to interstate natural gas pipelines  
9           and associated facilities authorized by and subject to regulation by the Federal  
10          Energy Regulatory Commission.

11          The amendment request demonstrates that the proposed 230-kV transmission line  
12          must be sited in the EFU zone. There is no non-EFU land between the location of the  
13          proposed wind turbines and the existing Stateline 230-kV line located between the Nine Mile  
14          Substation and Wallula Substation in Washington. The proposed Stateline 3 facilities would  
15          connect to the regional power grid through the existing 230-kV line at the PacifiCorp Wallula  
16          Substation in Walla Walla County, Washington.<sup>140</sup> There are no alternative transmission line  
17          routes for the transmission line that would affect less EFU land. “Technical and engineering  
18          feasibility,” addressed under subsection (a)(1) of the ordinance, requires that there be an  
19          interconnecting transmission line to deliver the deliver the power to the regional transmission  
20          system. The proposed interconnection transmission line is “locationally dependent” as  
21          addressed under subsection (a)(2). It must cross EFU-zoned land to achieve a reasonably  
22          direct route between the wind turbines and the existing regional transmission infrastructure.  
23          There are no “available urban and non-resource lands” on which to locate the transmission  
24          line. There is no existing transmission right-of-way between the proposed Stateline 3 wind  
25          turbine locations and the existing Stateline interconnection with the PacifiCorp regional  
26          transmission system. The proposed route is on privately-owned land where public access is  
27          limited and where the risk to public health and safety is low. Condition 2 requires that the  
28          certificate holder design and construct the transmission line in compliance with all applicable  
29          State laws and rules and with all applicable permit requirements of other State agencies. The  
30          transmission line must meet any applicable federal agency requirements.

31          In accordance with subsection (b) of the ordinance, the Council finds that the proposed  
32          transmission line is a “utility facility necessary for public service” without consideration of  
33          the costs associated with the factors listed in subsection (a).

34          Subsection (c) of the ordinance requires that the owner of a utility facility approved  
35          under UDCD Section 152.617(II)(7) be responsible for restoring agricultural land and  
36          associated improvements to their former condition if they are damaged or disturbed by the  
37          siting, maintenance, repair or reconstruction of the facility. Condition 20 requires the  
38          certificate holder to restore vegetation to the extent practicable and landscape all areas  
39          disturbed by construction in a manner compatible with the surroundings and proposed use.  
40          Conditions 65 and 68 require the certificate holder to restore areas disturbed by facility  
41          construction according to the methods and monitoring procedures described in the

1 *Revegetation Plan* discussed herein. Revision 45 incorporates the Department’s recommended  
2 modifications of the *Revegetation Plan*.

3 Subsection (d) of the ordinance requires the applicant “to mitigate and minimize the  
4 impacts of the proposed facility, if any, on surrounding lands devoted to farm use in order to  
5 prevent a significant change in accepted farm practices or a significant increase in the cost of  
6 farm practices on the surrounding farmlands.” Mitigation and minimization of impacts to  
7 farmland are discussed above in addressing UCDC Section 152.061, beginning at page 33.  
8 For the reasons discussed in reference to that ordinance and subject to the conditions  
9 described herein, the Council finds that the applicant would “mitigate and minimize” the  
10 impacts of the transmission line on surrounding lands devoted to farm use as required under  
11 UDCD Section 152.617(II)(7)(d).

12 Subsections (e) and (f) apply to sewer systems and interstate natural gas pipelines and  
13 do not apply to the proposed transmission line.

14 **Comprehensive Plan Policies**

15 UCDC Section 152.612(C) provides that a CUP “will not be approved unless the  
16 proposed use of the land will be in conformance with the County Comprehensive Plan.” The  
17 County identified the applicable policies of the UCCP.<sup>141</sup> The County indicated that “most, if  
18 not all” of the identified policies are implemented through the UCDC. The Council finds that  
19 the proposed Stateline 3 facilities would be in conformance with the identified applicable  
20 policies of the UCCP for the reasons discussed below.

21 **Citizen Involvement**

22 *Policy 1: Provide information to the public on planning issues and programs,*  
23 *and encourage continuing citizen input to planning efforts.*<sup>142</sup>

24 *Policy 5: Through appropriate media, encourage those County residents’*  
25 *participation during both city and county deliberation proceedings.*<sup>143</sup>

26 The identified Citizen Involvement policies are procedural and do not contain  
27 substantive standards applicable to the siting of the proposed facility. The applicants have  
28 elected to have the Council make the land use decision in accordance with ORS  
29 469.504(1)(b), and therefore the Council’s procedural requirements apply. The Council’s  
30 procedure for amending a site certificate is a public process. The Request for Amendment #4  
31 is a public document that has been made available at libraries in Umatilla County and on the  
32 Department’s Internet website. The Proposed Order is a public document available on the  
33 website. The Department uses direct mailing and the Internet to inform the public about the  
34 proceedings regarding the proposed amendment of the SWP site certificate. There are  
35 opportunities for public comment throughout the amendment process. Before the Council  
36 takes final action on the amendment request, there is opportunity for public comment and for  
37 requesting a contested case proceeding. The Council’s meetings are open to the public.

1           Agriculture

2           *Policy 1: Umatilla County will protect, with Exclusive Farm Use zoning*  
3           *pursuant to ORS 215, lands meeting the definition of farmland in this plan and*  
4           *designated as Agricultural on the Comprehensive Plan Map.*<sup>144</sup>

5           The County has established an EFU zone and has implemented ordinances to protect  
6           farmland. The proposed Stateline 3 facilities are located within the County’s EFU zone. The  
7           applicable ordinances from the UCDC have been addressed in sections above.

8           *Policy 8: The county shall require appropriate procedures/standards/policies be*  
9           *met in the Comprehensive Plan and Development Ordinance when reviewing non-*  
10           *farm uses for compatibility with agriculture.*<sup>145</sup>

11           The County has identified the applicable standards and policies for reviewing the  
12           proposed Stateline 3 facilities.<sup>146</sup> The County has participated in the Council’s amendment  
13           review process in accordance with ORS 469.504.

14           *Policy 17: Maintain continuing liaison with state and federal agencies to insure*  
15           *water supplies for farming and to help coordinate other land use development*  
16           *related to agriculture.*<sup>147</sup>

17           Water use in Oregon is subject to regulation by OWRD. By definition in OAR 345-  
18           001-0010, OWRD is a reviewing agency in the Council’s site certificate amendment process,  
19           and OWRD has received a copy of the Request for Amendment #4. OWRD has reviewed the  
20           application and has not expressed any concerns to the Department regarding the anticipated  
21           water use for construction and operation of Stateline 3.

22           The applicants estimate that up to 120,000 gallons of water per day (and a total of  
23           approximately 8 million gallons) would be needed during construction of the proposed  
24           Stateline 3 facilities.<sup>148</sup> The water would be purchased from the City of Helix under the City’s  
25           existing municipal water right or purchased from a private landowner under a limited license  
26           issued by OWRD. During facility operation, water use at the O&M building is not expected to  
27           exceed 1,000 gallons per day from a new on-site well. Use of water consistent with approved  
28           water rights ensures protection of existing water rights for agricultural uses. Water use is  
29           discussed herein at page 124.

30           Open Space, Scenic and Historic Areas, and Natural Resources

31           *Policy 1: (a) The County shall maintain this resource by limiting development*  
32           *mainly to existing built up areas.*<sup>149</sup>

33           This policy is related to the finding that Umatilla County has a “sparse rural  
34           population” and is “predominantly open space.” The proposed Stateline 3 wind power  
35           generating facility is a use allowed within the EFU zone under UCDC Section 152.060. A  
36           commercial wind energy facility must be located within open space where a sufficient wind

1 resource exists to support economic power generation. Nevertheless, most of the land area  
2 within the site boundary would remain open space because individual wind turbines would be  
3 widely spaced and other facility structures would occupy a limited area. Of the 7,055 acres  
4 within the site boundary, the permanent facility structures would occupy no more than 59  
5 acres, or approximately than one percent of the land.<sup>150</sup>

6 *Policy 5: (a) The County shall maintain rural agricultural lands, Development*  
7 *shall be of low density to assure retention of upland game habitat, (b) Land uses*  
8 *should maintain the vegetation along streambanks, fence rows, woodlots, etc.*  
9 *Research ways to reduce harassment and loss of upland game by free roaming*  
10 *dogs and cats.*<sup>151</sup>

11 This policy is related to the finding that “land use classifications most compatible with  
12 upland game habitat are agriculture, forestry, open space, and floodplain.” The County has  
13 classified all of the land where the proposed Stateline 3 facilities would be located as  
14 agricultural by the EFU zoning designation. The applicants have identified riparian areas  
15 (areas of streambank vegetation) as Category 2 habitat.<sup>152</sup> There are approximately 2 acres of  
16 riparian habitat within the site boundary, none of which would be disturbed by construction of  
17 Stateline 3.<sup>153</sup> There are no woodlots within the site boundary. Condition 65 requires the  
18 certificate holder to restore areas of vegetation disturbed by construction of Stateline 3 in  
19 accordance with the *Revegetation Plan* discussed herein. The Council adopts Condition 131,  
20 which would require the certificate holder to avoid disturbance of Category 2 habitat.

21 *Policy 6: (a) Developments or land uses that require drainage, channelization,*  
22 *filling or excessive removal of riparian vegetation in sensitive waterfowl areas*  
23 *should be identified....*<sup>154</sup>

24 The applicants assessed the habitat within the site boundary in Exhibit P of the  
25 amendment request. There are no waterfowl areas within the site boundary. Approximately 2  
26 acres of riparian habitat exists within the site boundary, and none of this habitat would be  
27 disturbed.<sup>155</sup> Condition 65 requires the certificate holder to restore areas of vegetation  
28 disturbed by construction of Stateline 3 in accordance with the *Revegetation Plan* discussed  
29 herein.

30 *Policy 8: (a) Setbacks shall be established to protect significant and other*  
31 *wetlands.*<sup>156</sup>

32 UCDC Section 152.063(E) establishes setback distances from streams, lakes and  
33 wetlands. The ordinance applies to “sewage disposal installations such as septic tanks and  
34 drainfields” and to “all structures, buildings or similar permanent fixtures” and establishes a  
35 setback distance of 100 feet, subject to specified exceptions. The proposed septic system for  
36 the Stateline 3 O&M building would be located more than 100 feet from any streams, lakes or

1 wetlands.<sup>157</sup> In Revision 77, the Department recommends that the Council adopt Condition  
2 123, which would require the certificate holder to design and construct the septic system in  
3 compliance with the County setback design requirements described in the ordinance.

4 *Policy 9: (a) The County shall encourage land use practices which protect and*  
5 *enhance significant wetlands.*<sup>158</sup>

6 This policy is related to a finding that identifies “significant wetlands” by reference to  
7 Table D-XI(a) of the Technical Report. The proposed facility would be located in Townships  
8 5 and 6 North and Ranges 32, 33 and 34 East.<sup>159</sup> None of the significant wetlands listed in  
9 Table D-XI(a) of the Technical Report are within the proposed site boundary.<sup>160</sup>

10 *Policy 10:*

11 \* \* \*

12 *(c) Compatible land use shall maintain the riparian vegetation along streams in*  
13 *the floodplain. Streambank vegetation shall be maintained along streams outside*  
14 *of the floodplain by utilizing appropriate setbacks.*

15 *(d) Development or land use that requires channelization, excessive removal of*  
16 *streamside vegetation, alteration of stream banks and filling into stream channels*  
17 *shall be restricted in order to maintain stream integrity.*

18 *(e) New roads, bridges and access rights-of-way shall be designed to avoid*  
19 *channel capacity, and minimize removal of shoreline vegetation.*<sup>161</sup>

20 This policy is related to the finding regarding land use classifications “most  
21 compatible with river and stream fish resources” (including the “agriculture” land use  
22 classification). The proposed Stateline 3 facilities are not located within the floodplain of  
23 rivers or streams in Umatilla County.<sup>162</sup> UCDC Section 152.063(E) establishes setback  
24 distances from streams, lakes and wetlands, and the certificate holders would comply with the  
25 ordinance (Condition 123). No riparian vegetation would be affected by construction of the  
26 proposed Stateline 3 facilities. Construction of the proposed Stateline 3 facilities would not  
27 affect any State jurisdictional waters or wetlands, as discussed below at page 123.

28 *Policy 20:*

29 *(a) Developments of potentially high visual impacts shall address and mitigate*  
30 *adverse visual effects in their permit application, as outlined in the Development*  
31 *Ordinance standards,*

32 *(b) It is the position of the County that the Comprehensive Plan designations and*  
33 *zoning already limit scenic and aesthetic conflicts by limiting land uses or by*  
34 *mitigating conflicts through ordinance criteria. However, to address any specific,*

1 potential conflicts, the County shall insure special consideration of the following  
2 when reviewing a proposed change of land use:

- 3 1. Maintaining natural vegetation whenever possible.
- 4 2. Landscaping areas where vegetation is removed and erosion might result.
- 5 3. Screening unsightly land uses, preferably with natural vegetation or  
6 landscaping
- 7 4. Limiting rights-of-way widths and numbers of roads intersecting scenic  
8 roadways to the minimum needed to safely and adequately serve the uses to which  
9 they connect.
- 10 5. Limiting signs in size and design so as not to distract from the  
11 attractiveness of the area.
- 12 6. Siting developments to be compatible with surrounding area development,  
13 and recognizing the natural characteristics of the location.
- 14 7. Limiting excavation and filling only to those areas where alteration of the  
15 natural terrain is necessary, and revegetating such areas as soon as possible.
- 16 8. Protection vistas and other views which are important to be recognized  
17 because of their limited number and importance to the visual attractiveness of the  
18 area.
- 19 9. Concentrating commercial developments in areas where adequate parking  
20 and public services are available and discouraging strip commercial development.

21 \* \* \* <sup>163</sup>

22 The applicants addressed the visual impacts of the proposed facility in Exhibit R of the  
23 amendment request. The Council’s findings and site certificate conditions related to visual  
24 impacts are discussed below beginning at page 88. UCDC Section 152.616(HHH)(5)(B)  
25 requires that “reasonable efforts” be made to blend the wind power generation facility’s  
26 towers with the surrounding landscape. Condition 37 addresses measures to reduce the visual  
27 impact of the proposed Stateline 3 facilities. Revision 36 includes modification of Condition  
28 37 to require compliance with UCDC Sections 152.545 through 152.548, which address  
29 design standards for signs. Condition 65 requires the certificate holder to restore vegetation  
30 disturbed by construction in accordance with the *Revegetation Plan* described herein.

31 *Policy 22: The County shall cooperate with state agencies and other historical*  
32 *organization to preserve historic buildings and sites, cultural areas, and*  
33 *archeological sites and artifacts.*<sup>164</sup>

34 *Policy 23: (a) Umatilla County shall encourage and cooperate in developing a*  
35 *detailed county-wide historic site inventory....*<sup>165</sup>

1 *Policy 24: (a) Umatilla County shall protect significant historical and cultural*  
2 *sites from land use activities which diminish their value as historical*  
3 *resources....*<sup>166</sup>

4 *Policy 26: The County shall cooperate with the Tribe, Oregon State Historic...*  
5 *Preservation Office, and others involved in... identifying and protecting Indian*  
6 *cultural areas and archeological sites.*<sup>167</sup>

7 The applicants addressed the potential impacts of the proposed Stateline 3 facilities on  
8 historic, cultural and archaeological resources in Exhibit S of the amendment request. The site  
9 certificate conditions that are related to the Council’s Historic, Cultural and Archaeological  
10 Resources Standard are discussed below beginning at page 113.

11 Under the definition in OAR 345-001-0010, SHPO is a reviewing agency, and SHPO  
12 has received a copy of the amendment request. SHPO has reviewed the application and has  
13 made no recommendations to the Department regarding Stateline 3.

14 Policy 26 is related to the finding that the Umatilla Tribes are concerned about the  
15 protection of archaeological and cultural sites in the County. The Department identified the  
16 Confederated Tribes of the Umatilla Indian Reservation (CTUIR) as a reviewing agency, and  
17 the CTUIR have received a copy of the amendment request. CTUIR archaeologists conducted  
18 the 2008 on-site survey for historic, cultural and archaeological resources within the Stateline  
19 3 site boundary.<sup>168</sup>

20 *Policy 37: The County shall ensure compatible interim uses provided through*  
21 *Development Ordinance standards, and where applicable consider agriculturally*  
22 *designated land as open space for appropriate and eventual resource or energy*  
23 *facilities use.*

24 This policy is related to a finding that “areas specifically set aside for natural resource  
25 exploitation, future development of reservoirs, energy generation and transmission facilities,  
26 and industry” would “lower the cost of eventual use, as compared to allowing incompatible  
27 development on the same lands before such eventual use.” The County did not identify any  
28 ordinance standards that “ensure compatible interim uses” of lands “set aside” for the  
29 “eventual uses” described in the finding. The policy, nevertheless, provides that the County  
30 “where applicable” considers agriculturally designated land appropriate for “energy facilities  
31 use.”

32 *Policy 38:*

33 *(a) The County shall encourage mapping of future aggregate sites, ensure their*  
34 *protection from conflicting adjacent land uses, and required reclamation plans.*

35 *(b) Aggregate and mineral exploration, extraction, and reclamation shall be*  
36 *conducted in conformance with the regulations of the Department of Geology and*  
37 *Mineral Industries.*

1           (c) *The County Development Ordinance shall include conditional use standards,*  
2           *and other provisions to limit or mitigate conflicting uses between aggregate sites*  
3           *and surrounding land uses.*<sup>169</sup>

4           *Policy 39: (a) The County shall strictly enforce state and county development*  
5           *standards pertaining to gravel extraction/processing uses through appropriate*  
6           *agencies; whether new operations or expansions of existing sites....*<sup>170</sup>

7           Gravel for construction of Stateline 3 would be obtained from an existing County-  
8           permitted quarry. Stateline 3 includes a temporary batch plant (used for “processing”  
9           aggregate) as a related or supporting facility. The County’s substantive criteria applicable to  
10          the batch plant are discussed above at page 48.

11          *Policy 42: (a) Encourage development of alternative sources of energy.*<sup>171</sup>

12          The proposed Stateline 3 is a wind energy facility. Wind is considered an “alternative  
13          source” of energy.

14          Air, Land and Water Quality

15          *Policy 1: Discharges from existing and future developments shall not exceed*  
16          *applicable federal and state environmental quality standards.*<sup>172</sup>

17          The proposed Stateline 3 facilities would have no air or water pollution emissions  
18          during operation. Potential dust emissions during construction would be controlled according  
19          to an Erosion and Sediment Control Plan and the NPDES 1200-C permit (Condition 60).

20          *Policy 7: Consider cumulative noise impacts and compatibility of future*  
21          *developments, including the adoption of appropriate mitigating requirements at*  
22          *plan updates.*<sup>173</sup>

23          The applicants addressed the potential noise impacts of the proposed Stateline 3  
24          facilities in Exhibit X of the amendment request. As discussed below at page 118, State noise  
25          control regulations apply to the facility. Subject to the site certificate conditions, the Stateline  
26          3 facilities would comply with the applicable noise limits.

27          *Policy 8: Recognize that protection of existing wells has priority over*  
28          *development proposals requiring additional subsurface sewage disposal.*<sup>174</sup>

29          The Stateline 3 facilities would include a new on-site septic system located at the  
30          proposed O&M facility. The system would be designed for capacity of less than 2,500 gallons  
31          per day (Condition 129).<sup>175</sup>

1 Natural Hazards

2 *Policy 1: The county will endeavor, through appropriate regulations and*  
3 *cooperation with applicable governmental agencies, to protect life and property*  
4 *from natural hazards and disasters found to exist in Umatilla County.*<sup>176</sup>

5 *Policy 4: Potentially hazardous major developments (e.g. power plants) must*  
6 *address earthquake hazard possibilities.*<sup>177</sup>

7 This policy is related to the finding that “flooding is the major hazard potentially  
8 dangerous to life and property” in the County. The proposed Stateline 3 facilities area not  
9 located in areas likely to flood. The applicants addressed seismic hazards (including  
10 earthquakes) and non-seismic geological hazards in Exhibit H of the amendment request. The  
11 Council’s Structural Standard, which addresses the risk to public safety from such hazards, is  
12 discussed below beginning at page 112.

13 Recreational Needs

14 *Policy 1: Encourage and work with local, state, federal agencies and private*  
15 *enterprise to provide recreational areas and opportunities to citizens and visitors*  
16 *to the County.*<sup>178</sup>

17 The proposed Stateline 3 facilities are located on private land and not within an  
18 established recreational area. The applicants addressed the potential impact of Stateline 3 on  
19 recreational opportunities in Exhibit T of the amendment request. For the reasons discussed  
20 below at page 95, the proposed Stateline 3 facilities would comply with the Council’s  
21 Recreation Standard.

22 Economy of the County

23 *Policy 1: Encourage diversification within existing and potential resource-based*  
24 *industries.*<sup>179</sup>

25 The proposed Stateline 3 wind power generation facility would diversify the County’s  
26 agriculture-based economy.

27 *Policy 4: Participate in selected economic development programs and projects*  
28 *applicable to the County’s desired growth.*<sup>180</sup>

29 This policy is related to the finding that “regional, state and federal programs aid in  
30 the development of local economies.” The County has not identified any “selected economic  
31 development programs” that are applicable. The applicants are private developers, and the  
32 proposed Stateline 3 facilities are not part of a governmental economic development program.  
33 The project may be eligible for federal and State tax credits.

34 *Policy 8: Evaluate economic development proposals upon the following: Will the*  
35 *proposal:*

36 *a. increase or decrease available supplies?*

1                   *b. improve or degrade qualities?*

2                   *c. balance withdrawal with recharge rates?*

3                   *d. be a beneficial use?*

4                   *e. have sufficient quantities available to meet needs of the proposed project*  
5                   *and other existing and reasonably anticipated needs?*

6                   *f. reduce other use opportunities and if so, will the loss be compensated by*  
7                   *other equal opportunities?*

8                   This policy is related to the finding that “water availabilities are a key resource to  
9                   future economic growth.” Water use during construction and operation of the proposed  
10                  facility is discussed below at page 124. Water used during operation of the proposed facility  
11                  would be supplied from a new on-site well and would be limited to no more than 5,000  
12                  gallons per day. Revision 84 addresses Condition 130, which would incorporate this  
13                  restriction. During construction, up to 120,000 gallons per day (a total of up to 8.7 million  
14                  gallons), would be used.<sup>181</sup> The water would be supplied from the City of Helix under an  
15                  existing municipal water right or from an existing private well subject to a new limited  
16                  license. The facility’s water use would not adversely affect existing water rights and would  
17                  not degrade water quality.

18                  Public Facilities and Services

19                  *Policy 1: The county will control land development in a timely, orderly, and*  
20                  *efficient manner by requiring that public facilities and services be consistent with*  
21                  *established levels of rural needs consistent with the level of service requirements*  
22                  *level of service requirements listed on pages J-27 and J-28 of the Technical*  
23                  *Report. Those needs are identified as follows:*

24                  *a. Fire protection shall be provided consistent with Policies 8, 9, 10.*

25                  *b. Police protection shall be provided consistent with Policy 7.*

26                  *c. Surface Water Drainage – Roadside drainage shall be maintained and*  
27                  *plans for drainage shall be required in multiple use areas.*

28                  *d. Roads shall be maintained or improved to standards adopted by the*  
29                  *County Road Department which are consistent with nationally accepted standards*  
30                  *that correlate traffic to desired road conditions.*<sup>182</sup>

31                  The applicants addressed the potential impacts of the proposed Stateline 3 facilities on  
32                  fire response and police protection services in Exhibit U of the amendment request.  
33                  Conditions related to fire and police services are discussed below at pages 114 and 125.  
34                  Policy 8 provides that the County will “encourage the formation or expansion of rural fire  
35                  districts in areas designated for non-resource use.” This policy is not a standard applicable to  
36                  siting the proposed Stateline 3 facilities. Policy 9 requires “adequate water supplies for fire  
37                  fighting as part of significant new developments in rural areas.” Policy 10 states that “the  
38                  County will provide assistance to rural fire districts in their attempts to locate satellite fire

1 stations closer to rural development.” This policy is not a standard applicable to siting the  
2 proposed Stateline 3 facilities. The Department has no information from the County indicating  
3 that any rural fire district is proposing to establish a satellite fire station closer to the proposed  
4 Stateline 3.

5 The applicants propose to improve existing farm roads and to construct new access  
6 roads. Condition 61 includes provisions applicable to road construction and requires that  
7 surface drainage continues along natural drainage patterns with minimal diversions through  
8 ditches and culverts.

9 *Policy 2: Require that domestic water and sewage disposal systems for rural*  
10 *areas be provided and maintained at levels appropriate for rural use only. Rural*  
11 *services are not to be developed to support urban uses.*<sup>183</sup>

12 The applicants propose to construct an on-site water well and an on-site septic system  
13 at the O&M building. These water and sewage systems would be designed to meet the needs  
14 of the operations staff of up to eight employees. The applicants do not propose to develop  
15 rural services to support urban uses.

16 *Policy 9: Require adequate water supplies for fire fighting as part of significant*  
17 *new developments in rural areas in coordination with the appropriate rural fire*  
18 *district.*<sup>184</sup>

19 Conditions related to fire prevention and response are discussed below at page 125.  
20 The applicants have discussed the potential impacts of the facility with the Fire Chief of the  
21 Milton-Freewater Rural Fire Department.<sup>185</sup>

22 *Policy 19: Where feasible, all utility lines and facilities shall be located on or*  
23 *adjacent to existing public or private rights-of-way so as to avoid dividing existing*  
24 *farm or forest units; and transmission lines should be located within existing*  
25 *corridors as much as possible.*<sup>186</sup>

26 The proposed Stateline 3 facilities would include an aboveground 230-kV  
27 interconnection transmission line. All 34.5-kV collector lines would be installed underground.  
28 These transmission lines would be located on private land and would not be located within  
29 existing public right of way. Condition 40 requires the certificate holder to make reasonable  
30 efforts not to disturb the farming and ranching activities on adjacent lands. The proposed  
31 transmission lines would not divide existing farm or forest units.

#### 32 Transportation

33 *Policy 20: The county will review right-of-way acquisitions and proposals for*  
34 *transmission lines and pipelines so as to minimize adverse impacts on the*  
35 *community.*<sup>187</sup>

36 The proposed Stateline 3 facilities would not require acquisition of right-of-way for  
37 the proposed transmission lines. The collector lines and 230-kV interconnection line would be

1 located on private land subject to lease or easement agreements between the certificate  
2 holders and the landowner.

3 Energy Conservation

4 *Policy 1: Encourage rehabilitation/weatherization of older structures and the*  
5 *utilization of locally feasible renewable energy resources through use of tax and*  
6 *permit incentives.*<sup>188</sup>

7 The proposed Stateline 3 wind power generation facility would utilize a “locally  
8 feasible renewable energy resource” (wind). The use of local tax incentives to encourage this  
9 development is not a standard applicable to siting the proposed Stateline 3 facilities.

10 Zoning Permit

11 UCDC Section 152.612(D) provides that an applicant granted a conditional use permit  
12 or land use decision must obtain a County zoning permit before beginning construction.  
13 UCDC Section 152.616(HHH)(4) provides that prior to beginning construction of a wind  
14 power generation facility, the applicant must obtain “all other necessary permits” including a  
15 County zoning permit. The County has defined “zoning permit” in UCDC Section 152.003, as  
16 follows:

17 ***ZONING PERMIT.*** *An official finding that a planned use of a property, as*  
18 *indicted by an application, complies with the requirements of this chapter or meets*  
19 *the special conditions of a variance or conditional use permit (see also*  
20 *DEVELOPMENT PERMIT).*

21 For the reasons discussed herein, the Council finds that the proposed Stateline 3  
22 facilities comply with the requirements of the applicable County ordinances, subject to the  
23 Goal 3 exception discussed below. The applicable ordinances are included in the UCDC,  
24 which is Chapter 152 of the County ordinances.

25 20-Acre Limitation

26 UCDC Section 152.616(HHH)(2)(J) provides that if a wind power generation facility  
27 “exceeds 20 acres in size, a Goal 3 exception is required as found in OAR 660-033-  
28 0130(22).” OAR 660-033-0130 is a State land use regulation that includes a similar 20-acre  
29 limitation that applies to a “power generating facility” located on non-high-value farmland as  
30 well as a 12-acre limitation that applies if the facility is located on high-value farmland. In  
31 January 2009, the Department of Land Conservation and Development amended OAR 660-  
32 033-0130 to exclude “wind power generation facilities” from the 12-acre and 20-acre  
33 limitations.

34 ORS 215.710(1) and OAR 660-033-0020(8) define “High Value Farmland” as land  
35 “in a tract composed predominantly of soils that are...[either irrigated or not irrigated and]  
36 classified prime, unique, Class I or II” by the Natural Resources Conservation Service  
37 (NRCS).<sup>189</sup> “Tract” means one or more contiguous lots or parcels in the same ownership.<sup>190</sup>  
38 OAR 660-033-0020(1)(a)(A) defines “agricultural land” in Eastern Oregon as NRCS Soil

1 Classes I-VI, and so “non-high-value” farmland would be farmland in other than Class I or II.  
 2 Class VII soils have very severe limitations that make them unsuitable for cultivation.<sup>191</sup>

3 The SWP is a wind power generation facility. As defined in UCDC Section 152.003, a  
 4 “wind power generation facility” includes the energy facility (one or more wind turbines) and  
 5 “their related or supporting facilities.” The County has identified the transmission line as a  
 6 separate use.<sup>192</sup> The area occupied by all Stateline 3 components is shown in Table 4.

7 The 20-acre limitation on the “size” of a wind power generation facility under UCCD  
 8 Section 152.616(HHH)(2)(J) does not specify that the limitation applies to farmland and does  
 9 not distinguish between high-value and non-high-value farmland.<sup>196</sup> As shown in Table 4, the  
 10 total size of the proposed Stateline 3 facilities is approximately 59 acres and the impact on  
 11 farmland is approximately 58 acres.

12 The Council approved the Stateline 1&2 facilities before the County’s adoption of  
 13 UCDC Section 152.616(HHH)(2)(J). Although the 20-acre limitation contained in the  
 14 ordinance was not in effect, the Council applied the similar limitations contained in OAR 660-  
 15 033-0130 to both the Stateline 1 and the Stateline 2 phases of construction of the SWP. In the  
 16 Final Order on the Application, the Council found that the Stateline 1 facilities “would  
 17 permanently preclude about 31 acres of current or former cropland from farm use.”<sup>197</sup> In the

1 Final Order on Amendment #1, the Council found that the Stateline 2 facilities would  
2 permanently occupy about 2 acres, excluding the area occupied by facility roads.<sup>198</sup> New  
3 access roads for Stateline 2 were estimated to occupy 24 acres.<sup>199</sup> Based on these earlier  
4 findings, the Stateline 1&2 components (including new access roads) occupy at least 57 acres  
5 of farmland. For both Stateline 1 and Stateline 2, the affected land was assumed to be non-  
6 high-value farmland, and the Council applied the 20-acre limitation contained in OAR 660-  
7 033-0130(22).

8 Based on the Council’s earlier findings for Stateline 1&2 and adding the estimated  
9 area occupied by the new Stateline 3 components, the SWP principal use and access roads  
10 would occupy an estimated 116 acres of farmland. The Council finds that the SWP would  
11 exceed 20 acres in size if Amendment #4 were approved and, therefore, would not comply  
12 with UCDC Section 152.616(HHH)(2)(J).

#### B. Applicable Statewide Planning Goals

13 For the reasons discussed above, the SWP (including the changes proposed by the  
14 amendment request) would comply with the applicable substantive criteria recommended to  
15 the Council by Umatilla County except UCDC Section 152.616(HHH)(2)(J), which limits the  
16 size of a wind power generation facility. Because the proposed Stateline 3 facilities do not  
17 comply with all applicable local land use criteria, the Council must determine, under ORS  
18 469.504(1)(b)(B), whether the proposed facilities “otherwise comply with the applicable  
19 statewide planning goals.” For a use located within an EFU zone, the “applicable statewide  
20 planning goal” is Goal 3, which is the State’s Agricultural Lands goal. As expressed in  
21 *Oregon’s Statewide Planning Goals and Guidelines*, Goal 3 is:

22 ***To preserve and maintain agricultural lands.***

23 *Agricultural lands shall be preserved and maintained for farm use, consistent with*  
24 *existing and future needs for agricultural products, forest and open space and with*  
25 *the state’s agricultural land use policy expressed in ORS 215.243 and 215.700.*

26 Consistent with Goal 3, Umatilla County has designated the EFU zone to preserve  
27 agricultural lands. Under Goal 3, non-farm uses are permitted within a farm use zone as  
28 provided under ORS 215.283. To find compliance with ORS 215.283, the Council must  
29 determine whether the proposed Stateline 3 facilities are uses that fit within the scope of the  
30 uses permitted on EFU land described in ORS 215.283(1), (2) or (3).

31 The Council finds that the Stateline 3 “principal use” is a “commercial utility facility  
32 for the purpose of generating power for public use by sale” that is allowable under ORS  
33 215.283(2)(g). The Council finds that the principal use includes the wind turbines, power

1 collection system, meteorological towers, control system and O&M facility. For the reasons  
2 discussed below at page 74, the Stateline 3 access roads are subject to the standards and  
3 requirements applicable to the principal use. The Council finds that the other Stateline 3  
4 components (substation, 230-kV transmission line and temporary batch plant) are allowable  
5 on EFU land under other sections of ORS 215.283. Specifically, the Council finds that the  
6 substation and the 230-kV transmission line are “utility facilities necessary for public service”  
7 that are allowable under ORS 215.283(1)(d) (see discussion at page 75).<sup>200</sup> The temporary  
8 batch plant is allowable under 215.283(2)(b)(C), which allows “processing...of aggregate  
9 into...portland cement” on EFU land.<sup>201</sup>

10 ORS 215.283(2)(g) authorizes “commercial utility facilities for the purpose of  
11 generating power for public use by sale” on land zoned for exclusive farm use. OAR Chapter  
12 660, Division 33, contains the LCDC administrative rules for implementing the requirements  
13 for agricultural land as defined by Goal 3. OAR 660-033-0120 (Table 1) lists the “commercial  
14 utility facility” use as a type “R” use (“use may be approved, after required review”). Prior to  
15 the effective date of OAR 660-033-0130(37), the standards found in OAR 660-033-0130(5)  
16 and (22) applied to wind power facilities proposed to be located on non-high-value farmland  
17 and OAR 660-033-0130(5) and (17) applied to such a facility proposed to be located on high-  
18 value farmland.

19 OAR 660-033-0130(37) became effective on January 2, 2009.<sup>202</sup> At the same time,  
20 LCDC adopted amendments to OAR 660-033-0120 (Table 1) that added reference to a “wind  
21 power generation facility” as a distinct type “R” use. The amendments provided that OAR  
22 660-033-0130(5) and (37) applied to wind power generation facilities. The effect of these  
23 amendments was to eliminate the 12-acre and 20-acre restrictions on wind energy facilities  
24 that are contained in OAR 660-033-0130(17) and (22) and to impose, instead, new restrictions  
25 on wind energy facilities contained in 660-033-0130(37). The applicability of 660-033-  
26 0130(5) did not change.

27 The Department believes that the January 2, 2009, amendments of OAR 660-033-0120  
28 and OAR 660-033-0130 apply to the review of the proposed new Stateline 3 components.  
29 Nevertheless, for completeness and in case the Department is later found to be incorrect about  
30 the applicability of the amended LCDC rules, an analysis of both the “old” (before the  
31 January 2009 amendments) and “new” rules is presented below.

1        **The Old Rules**

2                OAR 660-033-0130(5)

3                *(5) Approval requires review by the governing body or its designate under ORS*  
4                *215.296. Uses may be approved only where such uses:*

5                        *(a) Will not force a significant change in accepted farm or forest practices on*  
6                        *surrounding lands devoted to farm or forest use; and*

7                        *(b) Will not significantly increase the cost of accepted farm or forest practices*  
8                        *on surrounding lands devoted to farm or forest use.*

9                OAR 660-033-0130(5) cross-references ORS 215.296, which contains standards for  
10 approval for a use allowed under ORS 215.283(2) that are substantively identical to OAR  
11 660-033-0130(5)(a) and (b). These same approval standards are incorporated in the Umatilla  
12 County zoning ordinance, UCDC Section 152.061, discussed above at page 33. In the  
13 discussion of the ordinance, the Council finds that the proposed Stateline 3 facilities would  
14 not force a significant change in accepted farm practices on surrounding farmland and would  
15 not significantly increase the cost of accepted farm practices. Because the same approval  
16 standards are contained in the land use statute and LCDC rule, the Council finds that the  
17 principal use and access roads would comply with ORS 215.296 and OAR 660-033-0130(5),  
18 for the same reasons given in the discussion of UCDC Section 152.061.

19                OAR 660-033-0130(17)

20                *(17) A power generation facility shall not preclude more than 12 acres from use as*  
21                *a commercial agricultural enterprise unless an exception is taken pursuant to*  
22                *OAR chapter 660, division 4.*

23                OAR 660-033-0130(22)

24                *(22) A power generation facility shall not preclude more than 20 acres from use as*  
25                *a commercial agricultural enterprise unless an exception is taken pursuant to ORS*  
26                *197.732 and OAR chapter 660, division 004.*

27                Under OAR 660-033-0120, the 12-acre limitation described in OAR 660-033-  
28 0130(17) applies to components of a power generation facility located on high-value  
29 farmland. The 20-acre limitation described in OAR 660-033-0130(22) applies on non-high-  
30 value farmland. As shown in Table 4 at page 64 above, the proposed Stateline 3 principal use  
31 and access roads would occupy approximately 54 acres of high-value farmland. In addition,  
32 they would occupy approximately 4 acres of non-high-value farmland. The Stateline 3  
33 components increase the overall size of the SWP. As a whole, the SWP facility would occupy  
34 an estimated 54 acres of high-value and 61 acres of non-high-value farmland, if the Council  
35 approves Amendment #4.<sup>203</sup> The Council finds that the SWP principal use and access roads,  
36 as expanded by Amendment #4, would not comply with OAR 660-033-0130(17) or (22)  
37 because they would preclude more than 12 acres of high-value farmland and more than 20  
38 acres of non-high-value farmland from use “as a commercial agricultural enterprise.” Based  
39 on this finding, the SWP, with the expansion allowed by Amendment #4, would not comply  
40 with the rules implementing Goal 3. We discuss an exception to Goal 3 below at page 77.

1           The New Rules

2           Under the amended LCDC rules that became effective on January 2, 2009, OAR 660-  
3 033-0130(5) and (37) apply to the siting of a wind power generating facility. The analysis of  
4 OAR 660-033-0130(5) has already been addressed above at page 67.

5           OAR 660-033-0130(37) defines a “wind power generating facility” and provides  
6 criteria for the approval of a wind power generating facility sited on farmland. The Council  
7 finds that the Stateline 3 components fit entirely within the definition of “wind power  
8 generating facility” in OAR 660-033-0130(37). The Council finds that the Stateline 3  
9 components meet the approval criteria for a wind power generating facility, for the reasons  
10 discussed below.

11           OAR 660-033-0130(37)

12           *(37) For purposes of this rule a wind power generation facility includes, but is not*  
13 *limited to, the following system components: all wind turbine towers and concrete*  
14 *pads, permanent meteorological towers and wind measurement devices, electrical*  
15 *cable collection systems connecting wind turbine towers with the relevant power*  
16 *substation, new or expanded private roads (whether temporary or permanent)*  
17 *constructed to serve the wind power generation facility, office and operation and*  
18 *maintenance buildings, temporary lay-down areas and all other necessary*  
19 *appurtenances. A proposal for a wind power generation facility shall be subject to*  
20 *the following provisions:*

21           *(a) For high-value farmland soils described at ORS 195.300(10), the*  
22 *governing body or its designate must find that all of the following are*  
23 *satisfied:*

24           *(A) Reasonable alternatives have been considered to show that siting the*  
25 *wind power generation facility or component thereof on high-value*  
26 *farmland soils is necessary for the facility or component to function*  
27 *properly or if a road system or turbine string must be placed on such soils*  
28 *to achieve a reasonably direct route considering the following factors:*

29           *(i) Technical and engineering feasibility;*

30           *(ii) Availability of existing rights of way; and*

31           *(iii) The long term environmental, economic, social and energy*  
32 *consequences of siting the facility or component on alternative sites, as*  
33 *determined under OAR 660-033-0130(37)(a)(B).*

34           *(B) The long-term environmental, economic, social and energy*  
35 *consequences resulting from the wind power generation facility or any*  
36 *components thereof at the proposed site with measures designed to reduce*  
37 *adverse impacts are not significantly more adverse than would typically*  
38 *result from the same proposal being located on other agricultural lands*  
39 *that do not include high-value farmland soils.*

40           *(C) Costs associated with any of the factors listed in OAR 660-033-*  
41 *0130(37)(a)(A) may be considered, but costs alone may not be the only*

1 *consideration in determining that siting any component of a wind power*  
2 *generation facility on high-value farmland soils is necessary.*

3 *(D) The owner of a wind power generation facility approved under OAR*  
4 *660-033-0130(37)(a) shall be responsible for restoring, as nearly as*  
5 *possible, to its former condition any agricultural land and associated*  
6 *improvements that are damaged or otherwise disturbed by the siting,*  
7 *maintenance, repair or reconstruction of the facility. Nothing in this*  
8 *subsection shall prevent the owner of the facility from requiring a bond or*  
9 *other security from a contractor or otherwise imposing on a contractor the*  
10 *responsibility for restoration.*

11 *(E) The criteria of OAR 660-033-0130(37)(b) are satisfied.*

12 *(b) For arable lands, meaning lands that are cultivated or suitable for*  
13 *cultivation, including high-value farmland soils described at ORS*  
14 *195.300(10), the governing body or its designate must find that:*

15 *(A) The proposed wind power facility will not create unnecessary negative*  
16 *impacts on agricultural operations conducted on the subject property.*  
17 *Negative impacts could include, but are not limited to, the unnecessary*  
18 *construction of roads, dividing a field or multiple fields in such a way that*  
19 *creates small or isolated pieces of property that are more difficult to farm,*  
20 *and placing wind farm components such as meteorological towers on lands*  
21 *in a manner that could disrupt common and accepted farming practices;*  
22 *and*

23 *(B) The presence of a proposed wind power facility will not result in*  
24 *unnecessary soil erosion or loss that could limit agricultural productivity*  
25 *on the subject property. This provision may be satisfied by the submittal*  
26 *and county approval of a soil and erosion control plan prepared by an*  
27 *adequately qualified individual, showing how unnecessary soil erosion will*  
28 *be avoided or remedied and how topsoil will be stripped, stockpiled and*  
29 *clearly marked. The approved plan shall be attached to the decision as a*  
30 *condition of approval; and*

31 *(C) Construction or maintenance activities will not result in unnecessary*  
32 *soil compaction that reduces the productivity of soil for crop production.*  
33 *This provision may be satisfied by the submittal and county approval of a*  
34 *plan prepared by an adequately qualified individual, showing how*  
35 *unnecessary soil compaction will be avoided or remedied in a timely*  
36 *manner through deep soil decompaction or other appropriate practices.*  
37 *The approved plan shall be attached to the decision as a condition of*  
38 *approval; and*

39 *(D) Construction or maintenance activities will not result in the unabated*  
40 *introduction or spread of noxious weeds and other undesirable weeds*  
41 *species. This provision may be satisfied by the submittal and county*  
42 *approval of a weed control plan prepared by an adequately qualified*

1 *individual that includes a long-term maintenance agreement. The approved*  
2 *plan shall be attached to the decision as a condition of approval.*

3 *(c) For nonarable lands, meaning lands that are not suitable for cultivation,*  
4 *the governing body or its designate must find that the requirements of OAR*  
5 *660-033-0130(37)(b)(D) are satisfied.*

6 *(d) In the event that a wind power generation facility is proposed on a*  
7 *combination of arable and nonarable lands as described in OAR 660-033-*  
8 *0130(37)(b) and (c) the approval criteria of OAR 660-033-0130(37)(b)*  
9 *shall apply to the entire project.*

10 OAR 660-033-0130(37)(a) provides criteria for locating a wind power generating  
11 facility on high-value farmland soils. The rule references ORS 195.300(10) for the definition  
12 of “high-value farmland soils.” ORS 195.300(10), in turn, references ORS 215.710, which  
13 defines “High Value Farmland” as land “in a tract composed predominantly of soils that  
14 are...[either irrigated or not irrigated and] classified prime, unique, Class I or II” by the  
15 NRCS.<sup>204</sup> “Tract” means one or more contiguous lots or parcels in the same ownership.<sup>205</sup> As  
16 shown in Table 4 at page 64 above, the proposed Stateline 3 principal use and access roads  
17 would occupy approximately 54 acres of high-value farmland.

18 Reasonable alternatives

19 OAR 660-033-0130(37)(a)(A) requires the applicants to consider “reasonable  
20 alternatives” to locating the facility, or components of the facility, on high-value farmland.  
21 The applicants must “show that siting the wind power generation facility or component  
22 thereof on high-value farmland soils is necessary for the facility or component to function  
23 properly.” In the case of access roads and turbine strings, the applicants must show that these  
24 components must be placed on high-value farmland soils “to achieve a reasonably direct  
25 route.” To demonstrate the necessity of using high-value farmland for the facility to “function  
26 properly” or for a road or turbine string to “achieve a reasonably direct route,” the applicants  
27 must consider the factors listed in subsections (i) through (iii).

28 Thus, the rule first requires the applicants to determine whether “reasonable  
29 alternatives” exist on non-high-value soils, and then to analyze whether the facility could  
30 “function properly” in an alternative location. The rule does not, however, contain specific  
31 factors to be considered to determine whether a given alternative is “reasonable.”

32 The first consideration in determining whether an alternate location on non-high-value  
33 farmland is “reasonable” is, of course, whether there is a substantially similar wind resource  
34 comparable to the wind resource at the proposed site. If there is not, the alternative cannot be  
35 determined to be reasonable.

36 In addition, whether an alternative proposed for analysis is “reasonable” will depend  
37 on the design of the proposed facility. In this case, the proposed land use is an expansion of an  
38 existing wind power generating facility (approved before the new rules were adopted by  
39 LCDC). The proposed Stateline 3 components are part of an amendment to a site certificate

1 for an operating energy facility and would expand the boundaries of that facility. It would be  
2 unreasonable to require the applicants to locate the facility expansion at a distant location  
3 remote from the existing facility components. The Council finds that, for an amendment that  
4 enlarges the site of an existing facility, a “reasonable alternative” must be on non-high-value  
5 farmland where there is a substantially similar wind resource, and must be either be  
6 contiguous with, or sufficiently close to, the existing facility to ensure that operation of the  
7 entire facility is practicable. If both prongs of this test cannot be satisfied, there is no  
8 “reasonable alternative,” and the analysis ends there. The facility must be located on high-  
9 value farmland for the facility (or a component of the facility) to function properly.

10 If there is sufficient non-high-value farmland close to the existing facility that might  
11 serve as an alternate location for the expansion, then the applicants may demonstrate that the  
12 expansion must, nevertheless, be located on high-value farmland for reasons of: (i) technical  
13 and engineering feasibility; (ii) availability of existing rights of way; and (iii) the long term  
14 environmental, economic, social and energy consequences of siting the facility or component  
15 on alternative sites.

16 OAR 660-033-0130(37)(a)(B) more fully defines the environmental, economic and  
17 social analysis required by OAR 660-033-0130(37)(a)(A)(iii). OAR 660-033-0130(37)(a)(C)  
18 provides that costs may be considered in the analysis. OAR 660-033-0130(a)(D) imposes an  
19 obligation on the owner of a wind power facility to restore any farmland “damaged or  
20 otherwise disturbed by the siting, maintenance, repair or reconstruction of the facility.”

21 The applicants provided information about the soil characteristics that exist within and  
22 near the proposed Stateline 3 site boundary.<sup>206</sup> Soil maps of the area, based on data from the  
23 NRCS, show a mosaic of soil types. A complex pattern of individual soil types in which high-  
24 value farmland is interspersed with non-high-value farmland is characteristic of northern  
25 Umatilla County (Township 5N Ranges 33E and 34E and Township 6N, Ranges 32E and  
26 33E) where the SWP is located. In response to the Department’s request for further analysis  
27 of the availability of sufficient non-high-value farmland in the vicinity of the existing  
28 Stateline 1&2 components of the SWP, the applicants provided a map showing the site  
29 boundary of the proposed Stateline 3 components and the constraints presented by the high-  
30 value farmland soils in the area.<sup>207</sup> Finding a “reasonable alternative” for the Stateline 3  
31 components is further constrained by the areas occupied by the existing Combine Hills and  
32 Vansycle Ridge wind projects and by the land leased or otherwise committed to the proposed  
33 Helix Wind Power Facility that is currently under Council review. The applicants point out  
34 that they are “hemmed in” to the northeast and west by these other wind energy projects and  
35 that to the south, east and west, “there is more high-value farmland on increasingly  
36 challenging terrain.”<sup>208</sup>

37 In addition, the applicants note that the proposed location of the Stateline 3  
38 components allows efficient use of existing transmission infrastructure and the use, in  
39 common with Stateline 1&2, of existing points of interconnection with the regional power  
40 grid in Washington. The applicants have negotiated transmission service at the proposed  
41 points of interconnection, but they have “no assurance that firm transmission would be

1 available from some new point of interconnection at a new, different Stateline 3 grid-  
2 interconnection substation.”

3 The figures provided by the applicants depict the proposed site boundary of the  
4 Stateline 3 components. The boundary defines an area of approximately 7,055 acres that is the  
5 area required to design, construct and operate the proposed wind energy facility that would  
6 include up to 67 wind turbine towers and related and supporting facilities and infrastructure.  
7 Although the final footprint of the proposed facility would occupy less than 60 acres, a larger  
8 area is necessary to allow sufficient flexibility for micro-siting considerations in the final  
9 design of the facility, to allow sufficient additional area for laydown areas and other  
10 construction zones and to avoid adverse impacts to habitat that is essential or important for  
11 wildlife.

12 Given the diverse mosaic of soil types in the area of northern Umatilla County that is  
13 near or contiguous with the existing SWP and potentially available for locating the proposed  
14 Stateline 3 components, the Council finds the applicants have considered whether “reasonable  
15 alternatives” exist as required by OAR 660-033-0130(37)(a)(A). Based on the information  
16 provided by the applicants, the use of high-value farmland soils for the proposed expansion of  
17 the wind power generation facility is unavoidable. There is no “reasonable alternative” to  
18 locating components of the proposed facility entirely or partially on high-value farmland soils.

19 Any alternative configuration of the Stateline 3 components is likely to affect high-  
20 value farmland to some extent. The anticipated environmental, economic, social and energy  
21 consequences of an alternative facility configuration would be substantially the same as the  
22 proposed configuration. The Council finds that reasonable alternatives to siting the wind  
23 power generating facility on high-value farmland have been considered, that siting the  
24 facility, or a component thereof, on high-value farmland soils is necessary for the facility to  
25 function properly and that siting portions of the road system and turbine strings on high-value  
26 farmland is necessary to achieve a reasonably direct route.

#### 27 Environmental, Economic, Social and Energy Consequences

28 Under OAR 660-033-0130(37)(a)(B), the applicants must show that “the long term  
29 environmental, economic, social and energy consequences” of the facility or its components,  
30 taking mitigation into account, “are not significantly more adverse than would typically result  
31 from the same proposal being located on other agricultural lands that do not include high-  
32 value farmland soils.” The test is similar to that required under ORS 459.504(2)(c)(B) when  
33 the Council determines whether to grant a “reasons” exception to a statewide planning goal:  
34 “The significant environmental, economic, social and energy consequences anticipated as a  
35 result of the proposed facility have been identified and adverse impacts will be mitigated in  
36 accordance with rules of the council applicable to the siting of the proposed facility.” The  
37 environmental, economic, social and energy consequences of the proposed Stateline 3  
38 components are discussed below at page 79 as part of the Goal 3 exception analysis. For the  
39 reasons addressed there, the Council finds that the “consequences” of siting the facility on  
40 high-value farmland are not significantly more adverse than would typically result from  
41 locating the components on non-high-value farmland

42 Siting the wind facility components on high value farmland is likely to be beneficial to  
43 the landowners. The current and proposed site certificate conditions contain mitigation

1 measures designed to minimize any adverse impacts related to the siting of the facility on  
2 high-value farmland. Though the facility components might affect some agricultural routines  
3 of the landowner, the wind turbines will, along with other benefits, provide a significant  
4 source of additional, stable income to the landowner. Expansion of wind energy generation  
5 will take advantage of a clean and available energy source uniquely suited to the large, open  
6 areas often associated with high-value farmland. Therefore, the environmental, economic,  
7 social and energy effects of locating the Stateline 3 components on high-value farmland,  
8 when mitigation measures are taken into account, would not be significantly more adverse  
9 than if the facility were located on non-high-value farmland.

10 Restoration

11 OAR 660-033-0130(37)(a)(D) requires the owner of a wind facility to restore  
12 agricultural land damaged by the wind power facility. Condition 65 requires the certificate  
13 holder to restore all areas disturbed by construction, including farmland, according to the  
14 *Revegetation Plan*. Revision 45 incorporates the Department’s recommended revisions of the  
15 *Revegetation Plan* (Attachment B to the Proposed Order). The Council finds that the  
16 requirements of Condition 65 satisfy the obligation contained in OAR 660-033-  
17 0130(37)(a)(D).

18 Additional Criteria

19 OAR 660-033-0130(37)(a)(E) requires the applicants to demonstrate that the criteria  
20 of OAR 660-033-0130(37)(b) are satisfied when determining whether a facility may be sited  
21 on high-value farmland soils.

22 Arable and Nonarable Lands

23 Subsections (b), (c) and (d) of OAR 660-033-0130(37) provide additional criteria for  
24 wind power generation facilities located on “arable” or “nonarable” land. Subsection (b)  
25 defines “arable land” as “lands that are cultivated or suitable for cultivation, including high-  
26 value farmland soils” and provides criteria for locating a facility on arable land. Subsection  
27 (c) defines “nonarable land” as land “not suitable for cultivation” and identifies the criteria  
28 applicable on nonarable land. Subsection (d) provides that when a proposed wind power  
29 generation facility is located on a combination of arable and nonarable lands, then the criteria  
30 in subsection (b) apply to the entire facility. The proposed Stateline 3 components would be  
31 located on combination of arable and nonarable lands, as shown on Table 8 herein.  
32 Accordingly, the criteria in subsection (b) apply.

33 Impacts on Agricultural Operations

34 OAR 660-033-0130(37)(b)(A) provides that the proposed wind power facility must  
35 not “create unnecessary negative impacts on agricultural operations conducted on the subject  
36 property.” This requirement is substantially similar to the approval standards in the Umatilla  
37 County zoning ordinance, UCDC Section 152.061, discussed above at page 33. For the  
38 reasons discussed there and subject to the site certificate conditions discussed herein, the  
39 Council finds that the Stateline 3 components will not result in unnecessary negative impacts  
40 on agricultural operations.

1           Soil Erosion and Compaction

2           OAR 660-033-0130(37)(b)(B) provides that the proposed wind power facility must  
3 not result in unnecessary soil erosion. OAR 660-033-0130(37)(b)(C) provides that facility  
4 construction or maintenance activities must not result in unnecessary soil compaction.  
5 Potential adverse impacts to soils and measures to avoid or control soil erosion and  
6 compaction are addressed by the Council’s Soil Protection Standard, discussed below at page  
7 80. For the reasons discussed there and subject to site certificate conditions, the Council finds  
8 that construction and operation of the Stateline 3 components would not result in unnecessary  
9 soil erosion.

10           Weed Control

11           OAR 660-033-0130(37)(b)(D) provides that construction or maintenance activities  
12 must not result in the “unabated introduction or spread of noxious weeds and other  
13 undesirable weeds species.” Weed control is addressed by UCDC Section 152.616(HHH),  
14 discussed above at page 40. Specifically, UCDC Section 152.616(HHH)(2)(H) requires a  
15 weed control plan. Condition 68 addresses construction impacts to agricultural land and  
16 requires the certificate holder to implement a *Revegetation Plan*, which includes weed control  
17 measures. Condition 68 requires control of noxious weeds in areas disturbed by construction.  
18 Condition 30 requires the certificate holder to implement a weed control program during the  
19 life of the facility. Condition 92 addresses weed control during operation. The Council finds  
20 that construction and operation of the Stateline 3 components would not result in unabated  
21 introduction of spread of weeds on farmland.

22           The Access Roads

23           The proposed access roads are part of the “wind power generation facility” as defined  
24 by OAR 660-033-0130(37), if the new rules are applicable, and would not require separate  
25 analysis. If the old rules apply, then the proposed Stateline 3 access roads are allowable on  
26 EFU land under ORS 215.283(3). ORS 215.283(3) allows “roads, highways and other  
27 transportation facilities and improvements” that are not otherwise allowed under paragraphs  
28 (1) and (2) of ORS 215.283 to be established in an EFU zone, subject to:

29           (a) *Adoption of an exception to the goal related to agricultural lands and to any*  
30           *other applicable goal with which the facility or improvement does not comply;*  
31           *or*

32           (b) *ORS 215.296 for those uses identified by rule of the Land Conservation and*  
33           *Development Commission as provided in section 3, chapter 529, Oregon Laws*  
34           *1993.*

35           The subparagraphs are conjoined by “or” and so either (a) or (b) applies. In this case,  
36 subparagraph (b) applies because the Stateline 3 access roads are a use identified by the  
37 LCDC. OAR 660-033-0120 identifies uses authorized on agricultural lands. OAR 660-033-  
38 0120 (Table 1) lists “transportation improvements on rural lands allowed by OAR 660-012-  
39 0065” as a type “R” use (“use may be approved, after required review”). OAR 660-012-  
40 0065(2)(d) defines “accessory transportation improvements” as “transportation improvements

1 that are incidental to a land use to provide safe and efficient access to the use.”<sup>209</sup> The  
2 proposed Stateline 3 access roads are incidental to the principal use and would provide safe  
3 and efficient access to the facility.

4 Under OAR 660-012-0065(3)(a), transportation improvements for a use that is  
5 conditionally allowed by ORS 215.283 are consistent with Goal 3, subject to the requirements  
6 of OAR 660-012-0065.<sup>210</sup> The requirements of OAR 660-012-0065(4) are applicable:

7 *(4) Accessory transportation improvements required as a condition of*  
8 *development listed in subsection (3)(a) of this rule shall be subject to the same*  
9 *procedures, standards and requirements applicable to the use to which they are*  
10 *accessory.*

11 The rule language applies specifically to accessory transportation improvements  
12 “required as a condition of development.” Because the Stateline 3 access roads are necessary  
13 for the operation and maintenance of the wind energy facility, they are a necessary condition  
14 of the development of the commercial utility facility. Accordingly, the access roads are  
15 subject to the standards and requirements applicable to the principal use. We have discussed  
16 the standards applicable to the principal use above, beginning at page 67.

17 **Substation and Interconnection Line**

18 The proposed Stateline 3 substation is necessary to convert the voltage from the 34.5-  
19 kV collector system to 230 kV so that electricity generated by the energy facility can be  
20 transmitted efficiently over the transmission interconnection line to public customers. The  
21 proposed substation and 230-kV interconnection line are part of the “wind power generation  
22 facility” as defined by OAR 660-033-0130(37), if the new rules are applicable, and would not  
23 require separate analysis. If the old rules apply, then the substation and the 230-kV  
24 transmission line are within the scope of ORS 215.283(1)(d), which allows “utility facilities  
25 necessary for public service” on EFU land subject to the provisions of ORS 215.275.

26 ***215.275 Utility facilities necessary for public service; criteria; mitigating impact***  
27 ***of facility. (1) A utility facility established under ORS 215.213 (1)(d) or 215.283***  
28 ***(1)(d) is necessary for public service if the facility must be sited in an exclusive***  
29 ***farm use zone in order to provide the service.***

30 *(2) To demonstrate that a utility facility is necessary, an applicant for approval*  
31 *under ORS 215.213 (1)(d) or 215.283 (1)(d) must show that reasonable*  
32 *alternatives have been considered and that the facility must be sited in an*  
33 *exclusive farm use zone due to one or more of the following factors:*

34 *(a) Technical and engineering feasibility;*

35 *(b) The proposed facility is locationally dependent. A utility facility is*  
36 *locationally dependent if it must cross land in one or more areas zoned for*

1                    *exclusive farm use in order to achieve a reasonably direct route or to meet*  
2                    *unique geographical needs that cannot be satisfied on other lands;*

3                    *(c) Lack of available urban and nonresource lands;*

4                    *(d) Availability of existing rights of way;*

5                    *(e) Public health and safety; and*

6                    *(f) Other requirements of state or federal agencies.*

7                    *(3) Costs associated with any of the factors listed in subsection (2) of this*  
8                    *section may be considered, but cost alone may not be the only consideration in*  
9                    *determining that a utility facility is necessary for public service. Land costs shall*  
10                   *not be included when considering alternative locations for substantially similar*  
11                   *utility facilities. The Land Conservation and Development Commission shall*  
12                   *determine by rule how land costs may be considered when evaluating the siting of*  
13                   *utility facilities that are not substantially similar.*

14                   *(4) The owner of a utility facility approved under ORS 215.213 (1)(d) or*  
15                   *215.283 (1)(d) shall be responsible for restoring, as nearly as possible, to its*  
16                   *former condition any agricultural land and associated improvements that are*  
17                   *damaged or otherwise disturbed by the siting, maintenance, repair or*  
18                   *reconstruction of the facility. Nothing in this section shall prevent the owner of the*  
19                   *utility facility from requiring a bond or other security from a contractor or*  
20                   *otherwise imposing on a contractor the responsibility for restoration.*

21                   *(5) The governing body of the county or its designee shall impose clear and*  
22                   *objective conditions on an application for utility facility siting under ORS 215.213*  
23                   *(1)(d) or 215.283 (1)(d) to mitigate and minimize the impacts of the proposed*  
24                   *facility, if any, on surrounding lands devoted to farm use in order to prevent a*  
25                   *significant change in accepted farm practices or a significant increase in the cost*  
26                   *of farm practices on the surrounding farmlands.*

27                   *(6) The provisions of subsections (2) to (5) of this section do not apply to*  
28                   *interstate natural gas pipelines and associated facilities authorized by and subject*  
29                   *to regulation by the Federal Energy Regulatory Commission.*

30                   ORS 215.275(2) lists factors for deciding whether a utility facility is “necessary for  
31                   public service.” The factors are substantially the same as the factors listed in UCDC Section  
32                   152.617(II)(7), discussed above beginning at page 48. The Council finds that the proposed  
33                   230-kV transmission line must be sited in an exclusive farm use zone for the same reasons  
34                   given in the discussion of UCDC Section 152.617(II)(7).

35                   Likewise, the Stateline 3 substation must be located in an EFU zone because there is  
36                   no non-EFU land near the proposed Stateline 3 wind turbines where the substation could be  
37                   located. There are no reasonable alternatives to this location. At least three of the factors listed  
38                   in ORS 215.275(2) apply. “Technical and engineering feasibility” requires that there be a  
39                   substation to accommodate interconnection of the lower-voltage power generated by  
40                   individual Stateline 3 wind turbines with existing Stateline 230-kV transmission line in  
41                   Washington and ultimately to the PacifiCorp system. It is not feasible or technically possible  
42                   to interconnect with the regional transmission grid without a substation to step-up the voltage.

1 Second, the proposed substation is “locationally dependent.” It must be located in proximity  
2 to the proposed wind turbines, because that is where the power would be generated. It must be  
3 located reasonably near existing regional transmission lines so that the power can be  
4 transmitted to customers. Third, there are no “available urban and nonresource lands” on  
5 which to locate the substation where it could serve its purpose. The turbine area (located  
6 where an adequate wind resource for commercial power generation exists) is located on EFU  
7 land. For these reasons, location of the substation on EFU land is “necessary for public  
8 service.” The Council finds that the substation is allowed under ORS 215.283(1)(d) subject to  
9 the other applicable provisions of ORS 215.275.

10 ORS 215.275(3) provides that the costs associated with any of the factors listed in  
11 subsection (2) may be considered but may not be the only consideration in determining that a  
12 utility facility is necessary for public service. The Council finds that the substation and the  
13 230-kV transmission line are utility facilities necessary for public service without  
14 consideration of the costs associated with the factors listed in ORS 215.275(2).

15 ORS 215.275(4) requires that the owner of a utility facility approved under  
16 ORS 215.283(1)(d) be responsible for restoring agricultural land and associated  
17 improvements to their former condition if they are damaged or disturbed by the siting,  
18 maintenance, repair or reconstruction of the facility. The certificate holders would be  
19 responsible for restoring all areas of agricultural land temporarily disturbed during  
20 construction, maintenance or repair of the substation and the 230-kV transmission line  
21 (Conditions 68).

22 ORS 215.275(5) requires the imposition of “clear and objective conditions” on siting a  
23 utility facility under 215.283(1)(d) “to mitigate and minimize the impacts of the proposed  
24 facility, if any, on surrounding lands devoted to farm use in order to prevent a significant  
25 change in accepted farm practices or a significant increase in the cost of farm practices on the  
26 surrounding farmlands.” These objectives are substantially identical to the approval standards  
27 incorporated in UCDC Section 152.061, discussed above at page 33. The Council applies the  
28 site certificate conditions as described in the discussion of UCDC Section 152.061 to mitigate  
29 and minimize potential impacts of the proposed Stateline 3 facilities on farm practices .

### C. Goal 3 Exception

30 As discussed above at page 67, if the Council approves Amendment #4, the SWP  
31 would occupy more than 12 acres of high-value farmland and more than 20 acres of non-high-  
32 value farmland. If the old rules apply, the facility would not comply with OAR 660-033-  
33 0130(17) and (22). Therefore, to find compliance under ORS 469.504(1)(b)(B), the Council  
34 must decide whether an exception to Goal 3 is justified under ORS 469.504(2). Alternatively,  
35 if the new rules apply and Stateline 3 were found not to comply with OAR 660-033-0130(37),  
36 then the Council must make the same determination regarding a Goal 3 exception.

37 ORS 469.504(2)(c) sets out the requirements that must be met for the Council to take  
38 an exception to a statewide planning goal, as follows:

39 *(2) The council may find goal compliance for a facility that does not otherwise*  
40 *comply with one or more statewide planning goals by taking an exception to the*  
41 *applicable goal. Notwithstanding the requirements of ORS 197.732, the statewide*  
42 *planning goal pertaining to the exception process or any rules of the Land*

1           *Conservation and Development Commission pertaining to an exception process*  
2           *goal, the council may take an exception to a goal if the council finds:*

3           \* \* \*

4           (c) *The following standards are met:*

5                   (A) *Reasons justify why the state policy embodied in the applicable goal should*  
6                   *not apply;*

7                   (B) *The significant environmental, economic, social and energy consequences*  
8                   *anticipated as a result of the proposed facility have been identified and*  
9                   *adverse impacts will be mitigated in accordance with rules of the council*  
10                   *applicable to the siting of the proposed facility; and*

11                   (C) *The proposed facility is compatible with other adjacent uses or will be*  
12                   *made compatible through measures designed to reduce adverse impacts.*

13           The Council makes the findings discussed below and concludes that the standards for  
14           an exception to Goal 3 under ORS 469.504(2)(c) are met.

15           Reasons Supporting an Exception

16           The state policy embodied in Goal 3 is the preservation and maintenance of  
17           agricultural land for farm use. The following reasons support an exception to Goal 3.

18           First, although the proposed principal use and access roads would occupy  
19           approximately 59 acres of EFU farmland, the Stateline 3 components would occupy  
20           approximately 1-percent of the farmland within the site boundary that is currently in  
21           agricultural use.<sup>211</sup> It is significant to note that the wind facility structures would not occupy a  
22           single, contiguous area within which no farming activities could occur. Rather, the spacing of  
23           turbines and turbine strings would allow farm use to continue efficiently on most of the land  
24           currently used for grazing and cultivation of crops.

25           Second, facility access roads would be available to landowners for use in farm  
26           operations. As shown in Table 4, of the 54 acres of high-value farmland occupied by the  
27           Stateline 3 components, the access roads would occupy approximately 39 acres. The roads  
28           would be available to the landowners for farming or ranching uses. Facility access roads  
29           would be the minimum size necessary for safe operation and would be located to minimize  
30           conflict with farm uses on surrounding land (Condition 44).

31           Third, approval of the proposed Stateline 3 components furthers the state policy  
32           embodied in Goal 13 (Energy Conservation). The Guidelines for implementing Goal 13 direct  
33           that land use planning utilize renewable energy sources, including wind, “whenever possible.”  
34           EFU land is particularly well suited to the utilization of wind energy, which requires open  
35           land with unobstructed access to consistently strong winds. The areas within Umatilla County  
36           that have sufficient open space and strong winds are within EFU zones.

37           Fourth, the use of farmland for the location of the facility provides efficient access to  
38           the regional transmission system. Less than 13 miles of new transmission line would be

1 needed in Oregon to connect the proposed Stateline 3 components to existing regional power  
2 lines.<sup>212</sup>

3 Environmental, Economic, Social and Energy Consequences

4 The Council's standards address the environmental consequences of the SWP with the  
5 proposed Stateline 3 components. In our discussion of each of the standards, we identify the  
6 potential adverse impacts of the proposed Stateline 3 facilities and explain how those impacts  
7 would be mitigated. We discuss impacts to soils at page 80; to protected areas at page 83; to  
8 scenic resources at page 88; to threatened and endangered species at page 103; to wildlife  
9 habitat at page 105; to ambient noise levels at page 118; to waters of the state at page 123; and  
10 to groundwater at page 124. The facility would have no emissions that would adversely affect  
11 air or water quality. Upon retirement of the facility, the site would be restored to a useful,  
12 non-hazardous condition (see discussion of the Council's Retirement and Financial Assurance  
13 Standard at page 15).

14 The proposed Stateline 3 components would have beneficial economic consequences  
15 and no significant adverse economic consequences. Stateline 3 would offer local employment  
16 opportunities by providing up to 150 jobs during construction and up to eight jobs during  
17 operation.<sup>213</sup> Annual lease payments in the wind facility lease area would supplement  
18 landowner income from other farm operations without significantly reducing the land base  
19 available for farming practices. In addition, the proposed facility would provide property tax  
20 revenue to Umatilla County.

21 The proposed Stateline 3 components would not have significant adverse social  
22 consequences. The proposed expansion of the SWP would not cause any significant adverse  
23 impact on the ability of communities in the local area to provide services such as housing,  
24 health care, schools, police and fire protection, water and sewer, solid waste management,  
25 transportation and traffic safety (see discussion of site certificate conditions related to the  
26 Council's Public Services Standard at page 114). The site certificate would include conditions  
27 to avoid adverse impact to historic, cultural and archaeological resources (see discussion at  
28 page 113). The proposed Stateline 3 facilities would have no adverse impact on important  
29 recreational opportunities in the local area (see discussion of the Council's Recreation  
30 Standard at page 95). We address public safety issues related to the proposed facility at page  
31 96 (Public Health and Safety Standards for Wind Energy Facilities), page 101 (Siting  
32 Standards for Transmission Lines), page 112 (Structural Standard) and page 125 (Public  
33 Health and Safety). During construction and operation of Stateline 3, the certificate holders  
34 would minimize the generation of solid waste and wastewater and would properly dispose or  
35 recycle waste materials (see discussion at page 117).

36 The energy consequences of adding the proposed Stateline 3 components to the SWP  
37 would be the additional generation of up to 33.5 MW of electricity (average electric  
38 generating capacity) that would become available to meet local and regional energy needs.  
39 The expansion of the SWP would increase the overall average electric generating capacity of  
40 the facility to 74.5 MW. The proposed Stateline 3 turbines would generate electricity from a

1 renewable source (wind), which furthers the State’s energy policy “to develop permanently  
2 sustainable energy resources” (ORS 469.010).

3 In 2007, the Oregon Legislature enacted SB 838. This legislation established a  
4 “Renewable Portfolio Standard” (RPS) under which the State’s largest utilities must provide  
5 25 percent of their retail sales of electricity from renewable sources of energy by 2025. The  
6 generation of an additional 33.5 MW of electricity from the proposed Stateline 3 wind  
7 turbines would be a significant new renewable energy source that might help Oregon utilities  
8 meet the RPS goals.

9 Compatibility with Other Adjacent Uses

10 Adjacent uses are primarily dryland wheat farming.<sup>214</sup> The Stateline 3 components are  
11 compatible with farm uses for the reasons discussed above in reference to UCDC Section  
12 152.061 at page 33. Expansion of the SWP to add the Stateline 3 components would not force  
13 a significant change in accepted farm practices on surrounding lands and would not  
14 significantly increase the costs of farm practices. The directly affected landowners are willing  
15 to enter into land leases to allow Stateline 3 to be built. In return, the landowners would  
16 receive annual lease payments. Lease payments would provide a stable, supplemental income  
17 source that would help maintain the land in farm use by increasing the economic viability of  
18 the landowners’ farm operations.

19 Conclusions of Law

20 Based on the foregoing findings of fact, reasoning, proposed conditions and  
21 conclusions, the Council finds that the SWP with the proposed Stateline 3 components would  
22 comply with all applicable substantive criteria from Umatilla County except UCCD Section  
23 152.616(HHH)(2)(J). Accordingly, the Council must proceed with the land use analysis under  
24 ORS 469.504(1)(b)(B).

25 If the old rules apply, the Council finds that the proposed expansion of the SWP as  
26 described in the amendment request does not comply with OAR 660-033-0130(22), if  
27 applicable, and therefore does not comply with the applicable statewide planning goal (Goal  
28 3). If the new rules apply, the Council finds that the proposed expansion of the SWP complies  
29 with OAR 660-033-0130(37) and otherwise complies with all applicable statewide planning  
30 goals.<sup>215</sup> The Council finds that an exception to Goal 3 is justified under ORS 469.504(2)(c).

31 Based on these findings and the site certificate conditions described herein, the  
32 Council concludes that the SWP would comply with the Land Use Standard if Amendment #4  
were approved.

**(b) Soil Protection**

33 **OAR 345-022-0022**

34 *To issue a site certificate, the Council must find that the design, construction and*  
35 *operation of the facility, taking into account mitigation, are not likely to result in a*  
36 *significant adverse impact to soils including, but not limited to, erosion and*

1 *chemical factors such as salt deposition from cooling towers, land application of*  
2 *liquid effluent, and chemical spills.*

### Findings of Fact

3 In the Final Order on the Application and the Final Order on Amendment #1, the  
4 Council found that the design, construction and operation of the Stateline 1&2 components of  
5 the SWP, taking into account mitigation and subject to the conditions stated in the orders,  
6 would not likely cause a significant adverse impact to soils. Amendment #4 would change the  
7 site boundary of the SWP. The Council must decide, therefore, whether the design,  
8 construction and operation of the proposed Stateline 3 components would have a significant  
9 adverse impact to soils.

10 The applicants provided information about soil impacts in Exhibit I of the amendment  
11 request. As shown in Table 8 herein, construction activities for Stateline 3 would potentially  
12 affect approximately 327 acres of land, and the Stateline 3 components would permanently  
13 occupy approximately 59 acres.

14 Adverse impacts to soils can affect crop production on adjacent agricultural lands,  
15 native vegetation, fish and wildlife habitat, and water quality. Construction and operation of  
16 the Stateline 3 components could have soil impacts such as erosion, compaction and chemical  
17 spills. Because a wind facility does not have a cooling tower or liquid effluent, there is no  
18 potential for salt deposition or land application of liquid effluent. Small amounts of lubricant  
19 and herbicide for weed control would be used, but due to the quantities used, there is no  
20 potential for significant spills.

#### A. Potential Impacts During Construction

21 Wind and water erosion may occur during construction of Stateline 3. Construction  
22 would include removal of surface vegetation, grading and leveling operations. Movement of  
23 construction cranes and other heavy equipment would temporarily increase the potential for  
24 soil erosion. Installation of underground communications and power collection systems would  
25 require trenching that could expose the affected areas to increased erosion risk.

26 Heavy equipment movement, car and truck traffic, and component laydown during  
27 construction could cause soil compaction and dust emissions. Transportation and dumping of  
28 gravel and processing aggregate for concrete mixing could cause significant temporary dust  
29 emissions. Soil compaction can reduce agricultural productivity or interfere with revegetation.  
30 Dust emissions can adversely affect air quality. During construction, there is a risk of  
31 chemical spills from fuels, oils and grease associated with operation of construction  
32 equipment.

#### B. Potential Impacts During Operation

33 Operation of the Stateline 3 components would be similar to the operation of Stateline  
34 1&2. Operation of the SWP facility would have little impact on soils. Precipitation could  
35 result in surface water collecting on structures and on concrete or gravel surfaces. Drainage  
36 from those areas could erode nearby soils. In addition, repair or maintenance of underground  
37 communications or power collection lines could expose soils to increased erosion. Operation  
38 of equipment and vehicular traffic for maintenance could result in soil compaction and dust  
39 emissions. Small amounts of chemicals such as lubricating oils and cleaners for the turbines

1 and herbicides for weed control would be used at the facility site and present a risk to soils  
2 from accidental spills.

### C. Control and Impact Mitigation Measures

3 The Council confirms that Condition 60 applies to Stateline 3. Condition 60 requires  
4 that all construction would be subject to the requirements of the NPDES Storm Water  
5 Discharge General Permit #1200-C and associated Erosion and Sediment Control Plan. An  
6 Erosion and Sediment Control Plan describes best management practices for erosion and  
7 sediment control, spill prevention and response procedures, regular maintenance for vehicles  
8 and equipment, employee training on spill prevention and proper disposal procedures. The  
9 applicants described typical “best management practices” that would be implemented to  
10 control erosion during construction of Stateline 3, including use of hay bales, silt fences,  
11 revegetation, sediment-control basins, traps in drainages, revegetation and other erosion  
12 control practices.<sup>216</sup>

13 The Council confirms that Conditions 61 and 92 apply to Stateline 3. These conditions  
14 list measures that would be implemented during construction and operation to reduce or avoid  
15 soil erosion and compaction. Condition 61 includes using water for dust suppression and  
16 covering roads and turbine pads with gravel immediately following exposures to limit wind  
17 and water erosion.

18 Hazardous materials that could be used on-site during construction and operation  
19 include lubricating oils, cleaners, gasoline and pesticides or herbicides.<sup>217</sup> Condition 32  
20 requires the certificate holder to use hazardous materials in a manner that is protective of  
21 human health and the environment to comply with all applicable local, state, and federal  
22 environmental laws and regulations.<sup>218</sup> The condition requires the certificate holder to reduce  
23 the risk of accidental releases of hazardous materials through the proper containment of these  
24 substances during transportation and use on the site. The Council confirms that Condition 32  
25 applies to Stateline 3.

26 The Council confirms that Conditions 20, 65 and 68 apply to Stateline 3. These  
27 conditions require the restoration of temporarily disturbed areas upon completion of  
28 construction as described in the *Revegetation Plan* (Attachment B). The Department’s  
29 recommended modifications to the *Revegetation Plan* are incorporated in Revision 45.

### Conclusions of Law

30 For the reasons discussed above, the Council finds that the design, construction and  
31 operation of the Stateline 3 components, taking mitigation into account, are not likely to result  
32 in a significant adverse impact to soils. Based on these findings and the site certificate  
33 conditions described herein, the Council concludes the SWP would comply with the Council’s  
34 Soil Protection Standard if Amendment #4 were approved.

**(c) Protected Areas**

**OAR 345-022-0040**

*(1) Except as provided in sections (2) and (3), the Council shall not issue a site certificate for a proposed facility located in the areas listed below. To issue a site certificate for a proposed facility located outside the areas listed below, the Council must find that, taking into account mitigation, the design, construction and operation of the facility are not likely to result in significant adverse impact to the areas listed below. References in this rule to protected areas designated under federal or state statutes or regulations are to the designations in effect as of May 11, 2007:*

*(a) National parks, including but not limited to Crater Lake National Park and Fort Clatsop National Memorial;*

*(b) National monuments, including but not limited to John Day Fossil Bed National Monument, Newberry National Volcanic Monument and Oregon Caves National Monument;*

*(c) Wilderness areas established pursuant to The Wilderness Act, 16 U.S.C. 1131 et seq. and areas recommended for designation as wilderness areas pursuant to 43 U.S.C. 1782;*

*(d) National and state wildlife refuges, including but not limited to Ankeny, Bandon Marsh, Baskett Slough, Bear Valley, Cape Meares, Cold Springs, Deer Flat, Hart Mountain, Julia Butler Hansen, Klamath Forest, Lewis and Clark, Lower Klamath, Malheur, McKay Creek, Oregon Islands, Sheldon, Three Arch Rocks, Umatilla, Upper Klamath, and William L. Finley;*

*(e) National coordination areas, including but not limited to Government Island, Ochoco and Summer Lake;*

### Findings of Fact

32                   In the Final Order on the Application and the Final Order on Amendment #1 the  
33                   Council found that the design, construction and operation of the Stateline 1&2 components of  
34                   the SWP, taking mitigation into account and subject to the conditions stated in the orders,  
35                   were not likely to result in significant adverse impact to protected areas. In the Final Order on

1 Amendment #2, the Council found that the design, construction and operation of the old  
2 Stateline 3 configuration would not result in a significant adverse impact to any protected  
3 area. Amendment #4 would change the site boundary of the SWP and authorize the  
4 construction of a new Stateline 3 configuration. The Council must decide, therefore, whether  
5 the design, construction and operation of the proposed Stateline 3 components would have a  
6 significant adverse impact to protected areas.

7 The applicants provided information about potential impacts to protected areas in  
8 Exhibit L of the amendment request. Table 5 shows the protected areas within 20 miles of the  
9 Stateline 3 site, a reference to the applicable subparagraph of OAR 345-022-0040(1), the  
10 approximate distance from the closest edge of the site boundary, the direction of each  
11 protected area from the proposed facility site and the state in which each area is located.<sup>219</sup>  
12 Figure L-1 in the amendment request shows the locations of the protected areas in relation to  
13 the site boundary.<sup>220</sup> In some cases, as shown by comparing Figure L-1 to Figures C-5a and  
14 C-5b, the protected areas are closer to the Stateline 1&2 components of the facility.<sup>221</sup> The  
15 Council has previously analyzed the potential adverse impacts of the Stateline 1&2  
16 components and the previous Stateline 3 configuration on these protected areas.<sup>222</sup>

A. Noise

1 Noise generated by operation of the Stateline 3 components would comply with the  
 2 noise control regulations of the Oregon Department of Environmental Quality (DEQ), and  
 3 would not result in a significant adverse impact to protected areas. At the closest protected  
 4 area (Wallula HMU), noise generated during facility operation would not exceed a 50-dBA  
 5 standard for “quiet areas,” based on the applicant’s noise analysis in Exhibit X of the  
 6 application.<sup>226</sup> Noise produced during construction is exempt from the State noise regulations  
 7 under OAR 340-035-0035(5)(g), but, considering the distance from the protected areas,  
 8 construction noise is not likely to result in any significant adverse impact. The Council finds  
 9 that noise generated during construction and operation of the proposed Stateline 3  
 10 components would not result in a significant adverse impact to any protected area.

B. Traffic

11 Construction traffic would follow a designated transportation route from Interstate 84  
 12 (I-84) to State Route 11 (alternatively from I-84 to State Route 331 to State Route 11), then  
 13 north to State Route 334 and west to Gerking Flat Road.<sup>227</sup> The designated route does not pass  
 14 through any protected areas. Traffic volume on the transportation route would increase during  
 15 the period of construction of the Stateline 3 components, as described below at page 116. The  
 16 Council finds that the temporary increase in traffic would not result in traffic delays affecting  
 17 access to protected areas and would not result in a significant adverse impact to any protected  
 18 area.

1 Trip volume during operations would be significantly lower. The Stateline 3  
2 operations staff would consist of up to eight employees.<sup>228</sup> Road use by employees and road  
3 use for deliveries and operational purposes would not produce a significant traffic impact. The  
4 Council finds that facility-related road use during operation of the proposed Stateline 3  
5 components would not result in a significant adverse impact to any protected area.

#### C. Water Use and Wastewater Disposal

6 Facility water use would be temporary, relatively small in volume and predominantly  
7 limited to the construction period. Up to 120,000 gallons of water per day would be used  
8 during construction.<sup>229</sup> The water would be obtained from the City of Helix under an existing  
9 municipal water right or supplied by a private landowner well under a limited water use  
10 license to be issued by OWRD. The water would be used primarily for dust suppression, road  
11 and earthwork compaction and concrete mixing. No water used on the site would be  
12 discharged into wetlands, streams or other water bodies.<sup>230</sup> Wastewater from washdown of  
13 concrete trucks would be discharged into the foundation excavations at each turbine tower.<sup>231</sup>  
14 Portable toilets would be provided for onsite sewage handling during construction and would  
15 be pumped and cleaned regularly by a licensed contractor. No other wastewater is anticipated  
16 to be generated during construction.

17 During operation of Stateline 3, water use would be primarily for sanitary purposes at  
18 the O&M building. Water use is not expected to exceed 1,000 gallons per day.<sup>232</sup> The water  
19 would be supplied from an on-site well. Wastewater generated at the O&M building would be  
20 discharged to a new on-site septic system.

21 The Council finds that water use and disposal during construction and operation of the  
22 proposed Stateline 3 components would not result in a significant adverse impact on water  
23 quantity or water quality within any protected area.

#### D. Visual Impacts

24 Wind energy facilities have no emissions that would negatively affect air quality or  
25 visibility during facility operation. During construction, dust suppression measures would  
26 reduce the potential for visible dust clouds. The applicants provided a visibility analysis for  
27 the proposed Stateline 3 wind turbines.<sup>233</sup> Based on that analysis, the Whitman Mission  
28 National Historic Site is the only protected area within 10 miles of any proposed turbine  
29 location.

30 Although the applicants estimate that as many as 40 Stateline 3 turbines might be  
31 visible from the Whitman Mission site, the nearest turbine location would be more than nine  
32 miles away. There are Stateline 1&2 turbines closer to the Whitman Mission site (as well as  
33 other wind turbines of the Vansycle Wind Project and the Combine Hills Wind Project). In  
34 the Final Order on Amendment #2, the Council analyzed the visual impact of the old Stateline

1 3 configuration on the Whitman Mission.<sup>234</sup> The Council found: “Some existing Vansycle  
2 Wind Project turbines are visible and some Stateline 3 turbines might be visible from the site.  
3 However, at a distance of 10 miles, the Stateline 3 turbines would be a minor element of the  
4 background and would not result in significant adverse impact to the scenic value of the  
5 historic site.” The turbines that were proposed in the old Stateline 3 configuration had a hub  
6 height of approximately 165 feet and a blade tip height of approximately 242 feet.<sup>235</sup> The  
7 turbines proposed for the new Stateline 3 configuration would have a hub height of  
8 approximately 262 feet and a maximum blade tip height of approximately 415 feet.<sup>236</sup> From a  
9 distance of more than nine miles, a 173-foot difference in the height of the blade tips is  
10 unlikely to be perceived as significant. In addition, although wind turbines might be visible  
11 from the Whitman Mission site, the impact would not significantly affect the purpose of the  
12 Whitman Mission as a protected area.

13 According to the historic site’s General Management Plan, the site is managed, in part,  
14 to “encourage others to assist in the preservation of the cultural and agricultural setting around  
15 Whitman Mission National Historic Site and the historic setting of the Mission area.”<sup>237</sup> In  
16 discussing management of scenic resources, the Plan states: “The scenic resources within  
17 adjacent properties will be protected by the voluntary acquisition of conservation easements,  
18 agricultural easements, and development rights by a nonprofit organization.”<sup>238</sup> No scenic  
19 resource easements or development rights pertain to the areas within the Stateline 3 site  
20 boundary. The Council finds that the “historic setting of the Mission area” refers primarily to  
21 the area immediately adjacent to the Mission and not to distant areas that might be visible  
22 from the Mission.

### Conclusions of Law

23 For the reasons discussed above, the Council finds that the proposed Stateline 3  
24 components are not located in any protected area listed in OAR 345-022-0040 and that the  
25 design, construction and operation of Stateline 3 are not likely to result in significant adverse  
26 impact to any protected area. Based on these findings and the site certificate conditions  
27 described herein, the Council concludes that the SWP would comply with the Council’s  
28 Protected Areas Standard if Amendment #4 were approved.

#### **(d) Scenic Resources**

29 **OAR 345-022-0080**  
30 *(1) Except for facilities described in section (2), to issue a site certificate, the*  
31 *Council must find that the design, construction and operation of the facility, taking*  
32 *into account mitigation, are not likely to result in significant adverse impact to*  
33 *scenic resources and values identified as significant or important in local land use*  
34 *plans, tribal land management plans and federal land management plans for any*

### 3 Findings of Fact

4 In the Final Order on the Application and the Final Order on Amendment #1 the  
5 Council found that the design, construction and operation of the Stateline 1&2 components of  
6 the SWP, taking mitigation into account and subject to the conditions stated in the orders,  
7 were not likely to result in significant adverse impact to scenic and aesthetic values identified  
8 as significant or important in applicable federal land management plans or in local land use  
9 plans in the analysis area. Likewise, in the Final Order on Amendment #2, the Council found  
10 that the design, construction and operation of the old Stateline 3 configuration would not  
11 result in significant adverse impact to identified scenic or aesthetic values. Amendment #4  
12 would change the site boundary of the SWP and authorize the construction of a new Stateline  
13 3 configuration. The Council must decide, therefore, whether the design, construction and  
14 operation of the proposed Stateline 3 components would have a significant adverse impact to  
15 scenic resources and values identified as significant or important in local land use plans, tribal  
16 land management plans and federal land management plans for any lands located within the  
analysis area

17 The applicants provided information about potential impacts to scenic resources in  
18 Exhibit R of the amendment request. The analysis area for the Scenic Resources Standard is  
19 the area within the site boundary and 10 miles from the site boundary, including areas outside  
20 the state. In applying this standard, the Council focuses on the effects of facility structures on  
21 scenic resources described in “local land use plans, tribal land management plans and federal  
22 land management plans for any lands located within the analysis area described in the project  
23 order.”

#### A. Visual Features of the Site and the Proposed Facility

24 The proposed Stateline 3 consists of facility components spread out within an area of  
25 approximately 376 acres. Within the site boundary, the applicants propose to construct up to  
26 43 2.3-MW wind turbines or up to 67 1.5-MW wind turbines. The 2.3-MW turbines have a  
27 hub height of 80 meters (262 feet) and a maximum blade tip height of 126.5 meters (415 feet).  
28 The 1.5-MW turbines also have a hub height of 80 meters (262 feet) and a maximum blade tip  
29 height of 121.25 meters (398 feet).<sup>239</sup> The wind turbines would be arrayed in strings along  
30 ridgetops, with the individual turbines spaced at approximately 3.1 to 4.1 times the turbine  
31 rotor diameter.<sup>240</sup> The proposed Stateline 3 would also include an aboveground 230-kV  
32 transmission line, an O&M building and a substation. The transmission line would be  
33 supported on structures up to 61 feet tall.<sup>241</sup> The tallest proposed Stateline 3 components are  
34 the turbine towers. The turbines are the visual elements of the facility most likely to be visible  
35 from a distance, although the visual impact of the towers diminishes with distance and  
36 changes in topography.

37 Condition 37 requires the SWP turbine towers to be smooth, tubular steel structures  
38 painted a low-reflectivity neutral gray or white color and requires the O&M building to be

1 designed to blend with the surrounding landscape. The modifications to Condition 37 are  
2 described below in Revision 36 at page 145. The Council confirms that Condition 37 applies  
3 to Stateline 3. UCDC Sections 152.545 through 152.548 establish requirements for the types  
4 of signs allowed in the County. Other than signs required for facility safety or required by  
5 law, the applicants propose to use only those signs required for operation and safety or  
6 required by federal, state, or local law.<sup>242</sup> Turbine tower lighting would be visible at night and  
7 would be limited to the minimum required number and intensity to meet Federal Aviation  
8 Administration (FAA) guidelines. Outdoor night lighting of the O&M building and the  
9 substation would be limited to the minimum required for safety and security, and sensors and  
10 switches would be used to keep the lighting turned off when not required. Outdoor night  
11 lighting at the O&M building and substation would be hooded and directed to minimize  
12 backscatter and offsite light trespass.<sup>243</sup>

#### B. Effect on Identified Scenic Values

13 The applicants provided a Zone of Visual Influence (ZVI) analysis using ArcGIS 9.3  
14 software on areas within a 10-mile radius of the proposed turbine locations.<sup>244</sup> The applicants  
15 used the analysis to determine whether Stateline 3 wind turbines might be visible from  
16 important scenic viewpoints within the analysis area.

17 The ZVI analysis is a conservative modeling analysis of line-of-sight visibility. The  
18 computer model does not account for screening from vegetation or structures that might block  
19 the line-of-sight between a viewpoint and the turbine towers. The model does not account for  
20 factors such as weather conditions, haze or background landscape that might obscure  
21 visibility. The analysis considers a turbine to be “visible” if any part of a turbine is within a  
22 line-of-sight, based on the maximum blade tip height. The results of the analysis are  
23 illustrated by color-coded maps, showing the approximate density of turbine towers visible  
24 from any angle in the landscape within 10 miles of the proposed tower locations.<sup>245</sup>

25 The applicants modeled both the 67-turbine layout (121.25-meter blade tip height) and  
26 the 43-turbine layout (126.5-meter blade tip height). The applicants presented the results of  
27 the analysis graphically in Figures R-2a and R-2b. The applicants did not provide a separate  
28 ZVI analysis for the proposed transmission line structures, which are approximately 19 meters  
29 high.

30 To decide whether the proposed Stateline 3 facilities would comply with the Council’s  
31 standard, the Council must first determine whether the applicable land use or land  
32 management plans within the analysis area identify significant or important scenic resources  
33 and values. The Council must then decide whether any Stateline 3 components could be  
34 visible from areas addressed by those plans and, if so, whether their visual impact would  
35 result in significant adverse impact to the identified scenic resources and values. Based on the  
36 line-of-sight ZVI analysis, the applicants determined that some portion of the new Stateline 3  
37 configuration might be visible within managed areas identified in Table 6.

1        Umatilla County, Oregon

2            The proposed Stateline 3 turbines and 12.9 miles of transmission line would be located  
3 within Umatilla County, visible from many locations in the County. The Umatilla County  
4 Comprehensive Plan (UCCP) is the applicable local land use plan for the County. The UCCP  
5 “Open Space, Scenic and Historic Areas, and Natural Resources” element notes that there are  
6 scenic resources within the County:<sup>247</sup>

7            Outstanding Scenic Views and Sites

8            There are areas and views which are commonly recognized as striking in their effect on those  
9 who experience them. Geological features, green vegetation, and water are major scenic  
10 features; human works and dry, shrubsteppe landscape are other attractions. So that areas do  
11 not lose their eye-catching attributes, plans attempt to identify “commonly recognized” scenic  
12 features, and suggest uses for these areas that minimize conflicts with the valuable features.

13            The UCCP makes a general finding (Finding #20) regarding scenic views and includes  
14 policies to protect them. The finding states: “Umatilla County has a number of outstanding  
15 scenic views and pleasant vistas.”<sup>248</sup> The relevant policy language is as follows:

16            20. (a) Developments of potentially high visual impacts shall address and mitigate adverse  
17 visual effects in their permit application, as outlined in the Development Ordinance standards,  
18 (b) It is the position of the County that the Comprehensive Plan designations and zoning  
19 already limit scenic and aesthetic conflicts by limiting land uses or by mitigating conflicts  
20 through ordinance criteria. However, to address any specific, potential conflicts, the County  
21 shall insure special consideration of the following when reviewing a proposed change of land  
22 use:

23            \*\*\*

24            8. Protection [of] vistas and other views which are important to be recognized because of their  
25 limited number and importance to the visual attractiveness of the area.

1 (c) Publicly owned lands which provide outstanding scenic views shall be developed where  
2 appropriate.

3 (d) The “Elephant Rock” site shall be studied to determine if there is any scenic significance.

4 (e) The Wallula Gap has been recognized as a significant scenic (as well as historic and  
5 wildlife) area. The county shall enact special land use measures; i.e., overlay zone to protect  
6 and preserve this area (see Technical Report).

7 In Finding #21, the UCCP notes that there are no designated state or federal scenic  
8 waterways in Umatilla County. In addition, the UCCP includes additional scenic resource  
9 protection policies in the “Multiple Use Plan Policies” section:<sup>249</sup>

10 Policy 34 - It shall be a policy of the county to thoroughly review development as it may  
11 affect historical and scenic values and resources.

12 Policy 35 - The county will adopt regulations and provide encouragements that are reasonable  
13 and enforceable to protect historic, cultural and scenic resources.

14 Elephant Rock is a rock formation near the town of Gibbon on the northeast boundary  
15 of the Umatilla Indian Reservation. It is at least 15 miles from the site boundary. Wallula Gap  
16 is a narrow segment of the Columbia River approximately 16 miles south of Pasco,  
17 Washington. Wallula Gap is dominated by steep, basalt formations rising nearly vertically  
18 from both banks of the river. The County’s Technical Report indicates that Wallula Gap has  
19 value as a scenic site or view because it is enjoyed “to look upon” rather than “to look  
20 from.”<sup>250</sup> The UCCP does not identify other scenic resources as important or significant.

21 Wallula Gap is approximately 10 miles from the proposed Stateline 3 230-kV  
22 transmission line corridor and at least 14 miles from the nearest the proposed Stateline 3  
23 turbines.<sup>251</sup> Although the applicant’s ZVI analysis does not extend to Wallula gap, it is  
24 unlikely that the 61-foot transmission line structures or the turbines from Stateline 3 would be  
25 noticeable. The nearest existing Stateline 1&2 turbines lie approximately 7 miles from  
26 Wallula Gap.<sup>252</sup> In the Final Order on Amendment #1, the Council found that visual impact of  
27 Stateline 1&2 would not adversely affect the scenic value of Wallula Gap that is identified as  
28 significant or important. For the same reasons, the Council finds that the proposed Stateline 3  
29 components would not result in a significant adverse impact to significant or important scenic  
30 resources or values identified in the UCCP.

31 Walla Walla County, Washington

32 Walla Walla County lies to the north of the proposed Stateline 3 turbine locations.  
33 Approximately 3.1 miles of proposed 230-kV Stateline 3 transmission line would lie within  
34 Walla Walla County. The applicable local land use plan is the Walla Walla County  
35 Comprehensive Plan. The Parks and Recreation Element of the Plan identifies the  
36 “spectacular views of the Columbia River” from the Wallula Gap National Natural

1 Landmark.<sup>253</sup> The Stateline 3 components would not interfere with views of the Columbia  
2 River from this location. The Plan does not identify other scenic resources. The Council finds  
3 that the proposed Stateline 3 components of the SWP would not result in a significant adverse  
4 impact to significant or important scenic resources or values identified in the Walla Walla  
5 County Comprehensive Plan.

#### 6 Benton County, Washington

7 Benton County lies to the northwest of the proposed Stateline 3 site, across the  
8 Columbia River. The nearest portion of the proposed Stateline 3 230-kV transmission line  
9 corridor is approximately 9 miles from the Benton County border. The nearest proposed  
10 Stateline 3 turbine locations are at least 14 miles from the Benton County border. The  
11 applicable local land use plan is the Benton County Comprehensive Plan. The only scenic  
12 resource identified in the plan is State Route 14 (SR 14), which is designated as a Scenic  
13 Highway. SR 14 runs along the Columbia River to its eastern terminus at I-82 (near McNary  
14 Dam). At its closest point, SR 14 is more than 20 miles from the Stateline 3 site boundary.  
15 The Council finds that the proposed Stateline 3 components of the SWP would not result in a  
16 significant adverse impact to the scenic resources identified in the Benton County  
17 Comprehensive Plan.

#### 18 Whitman Mission National Historic Site

19 The Whitman Mission National Historic Site is located northeast of the proposed  
20 Stateline 3 components, at least 9 miles from the Stateline 3 site boundary. Based on the ZVI  
21 analysis, the applicants estimate that many of the proposed Stateline 3 turbines would be  
22 visible from the Whitman Mission. The identified scenic resources of the Whitman Mission  
23 site discussed above at page 87. For the reasons discussed there, the Council finds that the  
24 proposed Stateline 3 components of the SWP would not result in a significant adverse impact  
25 to the identified scenic resources of the Whitman Mission National Historic Site.

#### 26 Wallula, Juniper Canyon and Stateline HMUs

27 The Wallula, Juniper Canyon and Stateline HMUs are all at least 5 miles from the  
28 proposed Stateline 3 230-kV transmission line. The nearest proposed Stateline 3 wind turbines  
29 are more than 10 miles away from the HMUs.<sup>254</sup> Management of these areas has been  
30 transferred to the U.S. Fish and Wildlife Service (USFWS) from the U.S. Army Corps of  
31 Engineers (USACE). A management plan for these areas has not been adopted by the  
32 USFWS, but a draft Comprehensive Conservation Plan (CCP) has been issued.<sup>255</sup> The HMUs  
33 are managed primarily for wildlife habitat.<sup>256</sup> Although the draft CCP does not specify

1 significant or important scenic resources, the plan identifies the “visual character” of the  
2 Wallula, Stateline and Juniper Canyon areas as “high.”<sup>257</sup>

3 The nearest turbines would be more than 10 miles from the Wallula HMU, which is  
4 the closest of the 3 HMUs to the turbines.<sup>258</sup> The HMUs are beyond the range of the ZVI  
5 analysis that was done for the turbines, and no ZVI modeling was done for the transmission  
6 line. If any Stateline 3 components were visible from locations within the HMUs, it is  
7 unlikely that the visual effect would be significant, given the distances involved. Considering  
8 that conservation of wildlife habitat is the primary purpose of the HMUs and that public  
9 viewing of wildlife is the identified scenic value, the Council finds that the proposed Stateline  
10 3 components of the SWP would not result in a significant adverse impact.

#### 11 Lake Wallula

12 Lake Wallula is a recreational resource located within the Columbia River west of the  
13 SWP facility. Lake Wallula lies at least 10 miles from the proposed Stateline 3 230-kV  
14 transmission line corridor and approximately 14 miles from the nearest proposed Stateline 3  
15 turbine location.

16 The USACE manages much of the shoreline of Lake Wallula under the guidance of  
17 the *McNary Master Plan*.<sup>259</sup> The Plan refers to the importance of visual and scenic resources,  
18 but the Plan does not contain goals or polices that specifically address visual or scenic  
19 resources. The Plan indicates that Wallula Gap was declared a National Natural Landmark in  
20 1980 and has been approved for inclusion in the National Registry of Natural Landmarks.<sup>260</sup>  
21 The Plan notes that the USACE “has no visual resources control concerning development on  
22 private lands” and mentions existing visual elements that intrude on the scenic quality of Lake  
23 Wallula: “major point sources of visual intrusions are industrial facilities (plants, grain, and  
24 petrochemical storage) and irrigation pump facilities. Levees, utility lines, and railroad  
25 embankments are the major lineal impacts.”<sup>261</sup>

26 The applicants ZVI analysis did not extend as far as Wallula Gap or Lake Wallula, but  
27 it is possible that Stateline 3 components could be visible from some vantage points, but the  
28 Stateline 3 components would not interfere with views toward Wallula Gap. As discussed  
29 above at page 91, the UCCP recognizes Wallula Gap as a scenic resource. In the Final Order  
30 on Amendment #1, the Council found that the nearest existing Stateline 1&2 turbines lie  
31 approximately 7 miles from Wallula Gap and the visual impact of Stateline 1&2 would not  
32 adversely affect its scenic value.<sup>262</sup> The Council finds that the proposed Stateline 3  
33 components would not have a significant adverse visual impact on the Lake Wallula area.

Conclusions of Law

1 For the reasons discussed above, the Council finds that the design, construction and  
2 operation of the proposed Stateline 3 components, taking mitigation into account, are not  
3 likely to result in significant adverse impact to scenic resources and values identified as  
4 significant or important in local land use plans, tribal land management plans and federal land  
5 management plans for any lands located within the analysis area. Based on these findings and  
6 subject to the site certificate conditions described herein, the Council concludes that the SWP  
7 would comply with the Council’s Scenic Resources Standard if Amendment #4 were  
8 approved.

**(e) Recreation**

**OAR 345-022-0100**

9 *(1) Except for facilities described in section (2), to issue a site certificate, the*  
10 *Council must find that the design, construction and operation of a facility, taking*  
11 *into account mitigation, are not likely to result in a significant adverse impact to*  
12 *important recreational opportunities in the analysis area as described in the*  
13 *project order. The Council shall consider the following factors in judging the*  
14 *importance of a recreational opportunity:*

- 15 (a) *Any special designation or management of the location;*
- 16 (b) *The degree of demand;*
- 17 (c) *Outstanding or unusual qualities;*
- 18 (d) *Availability or rareness;*
- 19 (e) *Irreplaceability or irretrievability of the opportunity.*

20 \* \* \*

Findings of Fact

21  
22 In the Final Order on the Application and the Final Order on Amendment #1 the  
23 Council found that the design, construction and operation of the Stateline 1&2 components of  
24 the SWP, taking mitigation into account and subject to the conditions stated in the orders,  
25 were not likely to result in significant adverse impacts to recreational opportunities in the  
26 analysis area. In the Final Order on Amendment #2, the Council found that the design,  
27 construction and operation of the old Stateline 3 configuration would not result in any impacts  
28 to recreational opportunities that had not already been considered by the Council in its  
29 findings on Stateline 1&2. Amendment #4 would change the site boundary of the SWP and  
30 authorize the construction of a new Stateline 3 configuration. The Council must decide,  
31 therefore, whether the design, construction and operation of the proposed Stateline 3  
32 components would have a significant adverse impact to important recreational opportunities  
33 in the analysis area.

34 The applicants provided information about compliance with the Council’s Recreation  
35 Standard in Exhibit T of the amendment request. The analysis area for the Recreation  
36 Standard is the area within the site boundary and five miles from the site boundary, including  
37 areas outside the state.

1 The area within the site boundary is privately owned, and it contains no County, State  
2 or federal recreational facilities. In the analysis area outside the site boundary, there are no  
3 designated recreational lands other than local park and recreation facilities in the  
4 unincorporated community of Touchet, approximately 4 miles north of the proposed Stateline  
5 3 transmission line corridor. In the Final Order on the Application, the Council considered the  
6 impact of the SWP on recreational opportunities in Touchet and found that, although these  
7 opportunities might be important, the SWP would not interfere significantly with the  
8 recreational activities that occur there.<sup>263</sup>

9 Pheasant hunting is allowed seasonally by landowner permission in some areas, both  
10 within the site boundary and within the analysis area outside the site boundary. There are  
11 numerous similar opportunities for pheasant hunting on public and private land throughout  
12 Umatilla County and the rest of the state. Demand for pheasant hunting within the analysis  
13 area is no greater than in other available areas. The Council finds that pheasant hunting is not  
14 an important recreational opportunity according to the factors listed in the Recreation  
15 Standard. Similarly, the Council finds that other recreational activities such as hiking, wildlife  
16 observation and nature photography may occur on private land in the analysis area but would  
17 not be important recreational opportunities under the standard.

#### Conclusions of Law

18 For the reasons discussed above, the Council finds that the design, construction and  
19 operation of the proposed Stateline 3 components are not likely to result in a significant  
20 adverse impact to any important recreational opportunities in the analysis area. Based on these  
21 findings and subject to the site certificate conditions described herein, the Council concludes  
22 that the SWP would comply with the Council's Recreation Standard if Amendment #4 were  
23 approved.

#### **(f) Public Health and Safety Standards for Wind Energy Facilities**

##### **OAR 345-024-0010**

24 *To issue a site certificate for a proposed wind energy facility, the Council must*  
25 *find that the applicant:*  
26

27 *(1) Can design, construct and operate the facility to exclude members of the public*  
28 *from close proximity to the turbine blades and electrical equipment.*

29 *(2) Can design, construct and operate the facility to preclude structural failure of*  
30 *the tower or blades that could endanger the public safety and to have adequate*  
31 *safety devices and testing procedures designed to warn of impending failure and to*  
32 *minimize the consequences of such failure.*

#### Findings of Fact

33 The Council has previously found that the certificate holder could design, construct  
34 and operate the Stateline 1&2 facilities to exclude members of the public from close  
35 proximity to the turbine blades and electrical equipment, to preclude structural failure of the

1 tower or blades that could endanger the public safety and to have adequate safety devices and  
2 testing procedures.<sup>264</sup>

3 Similar public safety considerations would apply to the Stateline 3 components.  
4 Stateline 3 would be located on private property, limiting access by the general public.  
5 Condition 126 would require that wind turbines be at least 1,320 feet from any residence and  
6 at least 428 feet from public roads.<sup>265</sup> During operation, the minimum blade tip clearance  
7 above ground would be 33.5 meters (109.5 feet).<sup>266</sup> The turbine towers would be smooth,  
8 tubular structures that would preclude climbing, and they would have locked access doors.<sup>267</sup>  
9 Pad-mounted transformers located at each turbine would be located inside locked metal  
10 cabinets. The facility's substation would be enclosed by 7-foot-high chain-link fence with a  
11 locked gate.<sup>268</sup>

12 To protect public safety, the Council has adopted site certificate conditions applicable  
13 to Stateline 1&2. The certificate holder must notify the Department of any accidents or  
14 mechanical failures associated with operation of the facility that may result in public health  
15 and safety concerns (Condition 36). The certificate holder must use turbine towers that have  
16 locked access doors (Condition 38). The certificate holder must inspect turbine blades on a  
17 regular basis for signs of wear or potential failure (Condition 95). The certificate holder must  
18 use pad-mounted transformers enclosed in locked cabinets (Condition 103). The Council  
19 confirms that Conditions 36, 38, 95 and 103 are applicable to Stateline 3.

20 The Council previously adopted site certificate conditions applicable to the old  
21 Stateline 3 configuration.<sup>269</sup> These conditions included a requirement that the facility  
22 substation be enclosed by a seven-foot-tall chain link fence with barbed wire at the top  
23 pointing out at a 45-degree angle (Condition 113). The Council confirms that Condition 113 is  
24 applicable to the new configuration of Stateline 3, if the Council approves Amendment #4.

#### Conclusions of Law

25 The Council finds that the applicants can design, construct and operate the Stateline 3  
26 components to exclude members of the public from close proximity to the turbine blades and  
27 electrical equipment. The Council further finds that the applicants can design, construct and  
28 operate the Stateline 3 components to preclude structural failure of the tower or blades that  
29 could endanger the public safety and to have adequate safety devices and testing procedures  
30 designed to warn of impending failure and to minimize the consequences of such failure.  
31 Based on these findings and subject to the site certificate conditions described herein, the  
32 Council concludes that the SWP would comply with the Public Health and Safety Standards  
33 for Wind Energy Facilities if Amendment #4 were approved.

**(g) Siting Standards for Wind Energy Facilities**

**OAR 345-024-0015**

*To issue a site certificate for a proposed wind energy facility, the Council must find that the applicant can design and construct the facility to reduce cumulative adverse environmental effects in the vicinity by practicable measures including, but not limited to, the following:*

*(1) Using existing roads to provide access to the facility site, or if new roads are needed, minimizing the amount of land used for new roads and locating them to reduce adverse environmental impacts.*

*(2) Using underground transmission lines and combining transmission routes.*

*(3) Connecting the facility to existing substations, or if new substations are needed, minimizing the number of new substations.*

*(4) Designing the facility to reduce the risk of injury to raptors or other vulnerable wildlife in areas near turbines or electrical equipment.*

*(5) Designing the components of the facility to minimize adverse visual features.*

*(6) Using the minimum lighting necessary for safety and security purposes and using techniques to prevent casting glare from the site, except as otherwise required by the Federal Aviation Administration or the Oregon Department of Aviation.*

**Findings of Fact**

In the Final Order on the Application and in the Final Order on Amendment #1, the Council found that the certificate holder could design and construct Stateline 1&2 to reduce visual impact, to restrict public access and to reduce cumulative adverse environmental impacts in the vicinity to the extent practicable in accordance with the requirements of OAR 345-024-0015 in effect at that time.

In the Final Order on Amendment #2, the Council found that the certificate holder could design and construct the old Stateline 3 configuration in accordance with the requirements of OAR 345-024-0015.

In May 2007, the Council revised OAR 345-024-0015. Both the earlier version of the standard and the current version require applicants to “reduce cumulative adverse environmental impacts in the vicinity to the extent practicable.” The specific parts of the standard regarding use of existing roads and limiting new roads, combining transmission routes, use of existing substations, raptor protection and minimizing visual impact are substantially unchanged from the previous version of the rule.

Compared to the old Stateline 3 configuration, the new configuration proposed in Amendment #4 would have fewer turbines. The old configuration included up to 279 turbines; the proposed Stateline 3 would have a maximum of 67 turbines (if 1.5-MW turbines are used) or 43 turbines (if 2.3-MW turbines are used). The proposed turbines would be taller structures than the turbines in the old configuration. The proposed Stateline 3 turbines would have a hub height of 80 meters (262 feet) compared to 50 meters (164 feet) for the old Stateline 3 turbines. The old Stateline 3 configuration included construction of approximately 21.5 miles

1 of new access roads; the proposed configuration would have up to approximately 23 miles of  
2 new access roads (if 1.5-MW turbines are used) or approximately 16.6 miles (if 2.3-MW  
3 turbines are used). The old Stateline 3 configuration included about 30.5 miles of  
4 underground collector lines and 17 miles of aboveground collector lines; the proposed  
5 Stateline 3 configuration would include up to 24.4 miles of underground collector lines and no  
6 aboveground collector lines. The old Stateline 3 configuration included an aboveground 115-  
7 kV or 230-kV transmission line approximately 8.5 miles in length (in Oregon); the proposed  
8 configuration would have an aboveground 230-kV transmission line approximately 12.9 miles  
9 in length (in Oregon). Both configurations included a facility substation.

10 The old Stateline 3 components would have had a cumulative permanent footprint of  
11 approximately 75 acres. The proposed Stateline 3 facilities would have a cumulative footprint  
12 of approximately to 57 acres (if 1.5-MW turbines are used) or 35 acres (if 2.3-MW turbines  
13 are used).<sup>270</sup> The old Stateline 3 configuration would have had up to 345 acres of construction  
14 disturbance. The proposed Stateline configuration would have approximately 321 acres of  
15 construction disturbance (if 1.5-MW turbines are used) or approximately 205 acres (if 2.3-  
16 MW turbines are used).

17 The applicants provided a cumulative impact analysis of the proposed new Stateline 3  
18 configuration.<sup>271</sup> The applicants estimated potential avian fatality impacts, assuming the  
19 average fatality rates reported for five wind energy facilities in Umatilla County and the  
20 neighboring Washington counties of Walla Walla and Benton. Based on these rates, the  
21 Stateline 3 facility could result in 211 avian fatalities per year (including 4 raptors) and 163  
22 bat fatalities per year.<sup>272</sup> Compared to the old Stateline 3 configuration, which the Council  
23 approved, the potential avian and bat fatalities would be substantially reduced by the new  
24 configuration. Using the same average fatality rates, the old configuration could have resulted  
25 in 386 avian fatalities (including 8 raptors) and 294 bat fatalities per year.

#### A. Access Roads

26 The Council's standard encourages the use of existing roads to provide access to the  
27 facility site, minimizing the amount of land used for new roads and locating new roads in a  
28 manner that reduces adverse environmental impacts. To minimize the impacts of road  
29 construction, Stateline 3 would be designed to make use of existing county and private roads  
30 to the extent possible.<sup>273</sup> New access roads would be up to 37 feet wide (including shoulders)  
31 during construction but would be reduced to 16 feet wide during operation.<sup>274</sup> Condition 44  
32 requires the certificate holder to locate roads to minimize disturbance and maximize  
33 transportation efficiency and to avoid sensitive resources and unsuitable topography. The  
34 Council confirms that Condition 44 is applicable to Stateline 3. To further reduce the  
35 cumulative effects of new roads, the applicants propose to maintain vegetative buffer strips  
36 between areas of construction impact and any receiving waters.

## B. Transmission Lines and Substations

1 The standard encourages the use of underground transmission lines, combining  
2 transmission routes and minimizing the number of new substations. The collector system for  
3 Stateline 3 would be entirely underground and would follow access roads as much as  
4 possible.<sup>275</sup> An aboveground 230-kV transmission line, approximately 12.9 miles in length in  
5 Oregon (plus approximately 3 miles in Washington), would be necessary to transmit the  
6 facility's electrical output to the regional power grid. A single project substation would be  
7 centrally-located within the Stateline 3 turbine area.<sup>276</sup> The substation would be located within  
8 Category 6 habitat.<sup>277</sup>

## C. Wildlife Protection

9 The standard encourages facility design that reduces the risk of injury to raptors or  
10 other vulnerable wildlife in areas near turbines or electrical equipment. The applicant  
11 proposes to design the transmission lines to minimize raptor injury by conforming to the 2006  
12 Avian Powerline Interaction Committee (APLIC) suggested practices for raptor protection on  
13 power lines.<sup>278</sup> Condition 64 requires the certificate holder to spread gravel on turbine pad  
14 areas to avoid creating habitat for raptor prey and to reduce weed infestation. Conditions 37  
15 and 70 require the use of smooth, tubular towers rather than lattice towers to reduce avian  
16 perching opportunities in proximity to turbine blades. Two unguyed, monopole met towers  
17 would be constructed for Stateline 3. Conditions 114 and 115 require the certificate holder to  
18 design the transmission line support structures to deter perching near turbines and to reduce  
19 the risk of raptor electrocution. In Revision 70, based on discussion with ODFW, the  
20 Department recommends modification of Condition 114 to require anti-perching devices on  
21 transmission line support structures that are located within ½-mile of any wind turbine unless  
22 the top of the support structure is below the base of the turbine tower due to topography. In  
23 Revision 71, the Department recommends modification of Condition 115 to require the  
24 certificate holder to design the transmission lines to conform to the APLIC guidelines. The  
25 Council confirms that Conditions 37, 64, 70, 114 and 115 are applicable to Stateline 3.

26 In addition to the measures to reduce adverse impacts on avian species addressed by  
27 the conditions discussed above, the applicants have designed the new Stateline 3  
28 configuration to avoid direct impacts to Washington ground squirrel (WGS) habitat.<sup>279</sup> The  
29 WGS is a State-listed endangered species, discussed below at page 104. Condition 69 requires  
30 avoidance impacts to WGS colonies. Condition 131 would require the certificate holder to  
31 avoid permanent and temporary disturbance to all Category 1 and Category 2 habitat within  
32 the Stateline 3 site boundary.

## D. Visual Features

33 The standard encourages facility design that minimizes adverse visual features.  
34 Condition 37 requires the certificate holder to reduce the visual impact of the facility.  
35 Measures include painting turbine towers uniformly in a neutral light gray or white color and

1 not allowing any advertising to be used on any part of the facility or on any signs posted at the  
2 facility. Condition 37 requires the certificate holder to design and construct the O&M building  
3 to be generally consistent with the character of similar buildings used by commercial farmers  
4 or ranchers. The Council modifies Condition 37 as described in Revision 36 and confirms that  
5 Condition 37 applies to Stateline 3.

#### E. Lighting

6 The standard requires the use of the minimum lighting necessary for safety and  
7 security purposes and the use of techniques to prevent casting glare from the site but does not  
8 restrict the use of lighting otherwise required by the FAA or the Oregon Department of  
9 Aviation. Condition 37 requires the certificate holder to use only the minimum lighting on  
10 turbines required by the FAA. The condition allows low-impact lighting to be used for  
11 occasional nighttime repairs, maintenance or operations at the substation and requires that  
12 security lighting at the Stateline 3 O&M building and substation be shielded or downward-  
13 directed to reduce glare. The modification of Condition 37 is discussed in Revision 36.

#### Conclusions of Law

14 Based on these findings and subject to the site certificate conditions described herein,  
15 the Council concludes that the SWP would comply with the Council's Siting Standards for  
16 Wind Energy Facilities if Amendment #4 were approved.

#### **(h) Siting Standards for Transmission Lines**

##### **OAR 345-024-0090**

17 *To issue a site certificate for a facility that includes any transmission line under*  
18 *Council jurisdiction, the Council must find that the applicant:*  
19

20 *(1) Can design, construct and operate the proposed transmission line so that*  
21 *alternating current electric fields do not exceed 9 kV per meter at one meter above*  
22 *the ground surface in areas accessible to the public;*

23 *(2) Can design, construct and operate the proposed transmission line so that*  
24 *induced currents resulting from the transmission line and related or supporting*  
25 *facilities will be as low as reasonably achievable.*

#### Findings of Fact

##### A. Electric Fields

26 In the Final Order on the Application and the Final Order on Amendment #1, the  
27 Council found that the certificate holder could design and construct the Stateline 1&2  
28 transmission line components so that electric fields would not exceed 9 kV per meter at one  
29 meter above ground surface in areas accessible to the public and so that induced currents  
30 would be as low as reasonably achievable.

31 The proposed Stateline 3 would include underground 34.5-kV collector lines and an  
32 aboveground 230-kV interconnection transmission line. For the underground lines, the  
33 electric field is totally contained within the insulation of the cable.<sup>280</sup> There would be no

1 measurable electric field at the surface (or at one meter above ground surface). Condition 62  
2 addresses the construction of underground electrical and communications cables. The Council  
3 confirms that Condition 62 is applicable to Stateline 3.

4 The applicants calculated the electric field that would be produced by the aboveground  
5 230-kV transmission line using the Bonneville Power Administration (BPA) Corona and  
6 Field Effect Program (Version 3). The proposed line would consist of one, three-phase circuit  
7 with two conductors per phase.<sup>281</sup> The assumed line loading for the electric field calculation  
8 was 1,506 amperes per phase. The transmission line would be supported by H-frame wooden  
9 poles spaced approximately 500 feet apart. The minimum line clearance above ground was  
10 assumed to be 30 feet. The calculated maximum electric field strength was 3.8 kV per meter  
11 at one meter above ground surface.<sup>282</sup> Condition 113 requires, in part, that the certificate  
12 holder design and construct transmission lines to conform to the 9 kV per meter electric field  
13 standard and to reduce induced voltages. In Revision 69, the Department recommends  
14 modification of Condition 113 to reflect the new Stateline 3 components as described in the  
15 amendment request.

#### B. Induced Current

16 The magnetic and electric fields around alternating current transmission lines can  
17 induce current or voltage in nearby objects. Induced currents are not hazardous to people but  
18 can be a concern for railroad communications and pipeline cathodic protections systems that  
19 parallel transmission lines. An ungrounded fence or metal roof located within an electric field  
20 can carry an induced voltage. If proper precautions are not taken, the induced voltage can  
21 result in an electrical shock when a person or animal touches the object, which allows a  
22 current to flow to the ground. Grounding of potentially charged structures minimizes the  
23 danger by providing an alternative path for the electric current. Passing current through the  
24 grounding wire minimizes the current that would otherwise flow through a person or animal  
25 that comes in contact with the object.

26 Because the underground 34.5-kV cables do not create an electric field at the ground  
27 surface, the SWP collector system does not present an induced voltage risk. The proposed  
28 Stateline 3 230-kV transmission line could cause induced voltage. As required by Condition  
29 6, FPL Stateline proposes to ground fences that are parallel to the transmission line and to  
30 provide grounding for any metal-roofed buildings in proximity to the line.<sup>283</sup> Condition 6  
31 incorporates the language of OAR 345-027-0023(4), which provides standard condition  
32 language to address public safety for transmission lines within the Council's jurisdiction. The  
33 Council confirms that Condition 6 is applicable to Stateline 3.

#### Conclusions of Law

34 Based on these findings and subject to the site certificate conditions described herein,  
35 the Council concludes that the SWP would comply with the Council's Siting Standards for  
36 Transmission Lines if Amendment #4 were approved.

#### 4. Standards to Protect Wildlife

##### (a) Threatened and Endangered Species

1           **OAR 345-022-0070**

2           *To issue a site certificate, the Council, after consultation with appropriate state*  
3           *agencies, must find that:*

4           *(1) For plant species that the Oregon Department of Agriculture has listed as*  
5           *threatened or endangered under ORS 564.105(2), the design, construction and*  
6           *operation of the proposed facility, taking into account mitigation:*

7                 *(a) Are consistent with the protection and conservation program, if any, that*  
8                 *the Oregon Department of Agriculture has adopted under ORS 564.105(3); or*

9                 *(b) If the Oregon Department of Agriculture has not adopted a protection and*  
10                 *conservation program, are not likely to cause a significant reduction in the*  
11                 *likelihood of survival or recovery of the species; and*

12           *(2) For wildlife species that the Oregon Fish and Wildlife Commission has listed*  
13           *as threatened or endangered under ORS 496.172(2), the design, construction and*  
14           *operation of the proposed facility, taking into account mitigation, are not likely to*  
15           *cause a significant reduction in the likelihood of survival or recovery of the*  
16           *species.*

##### Findings of Fact

17           There are no protection and conservation programs adopted under ORS 564.105(3) for  
18           threatened or endangered plant species in the SWP area. In the Final Order on the Application  
19           and the Final Order on Amendment #1, the Council found that the design, construction and  
20           operation of Stateline 1&2, taking mitigation into account and subject to the site certificate  
21           conditions adopted in the orders, did not have the potential to significantly reduce the  
22           likelihood of the survival or recovery of any threatened or endangered plant or wildlife  
23           species listed under Oregon law. In the Final Order on Amendment #2, the Council made the  
24           same finding with regard to the old Stateline 3 components. Amendment #4 would change the  
25           site boundary of the SWP and authorize the construction of a new Stateline 3 configuration.  
26           The Council must decide, therefore, whether the design, construction and operation of the  
27           proposed Stateline 3 components would have the potential to significantly reduce the  
28           likelihood of the survival or recovery of any threatened or endangered plant or wildlife  
29           species listed under Oregon law (State-listed species).

##### A. Plant Species

30           The Council has previously found that one State-listed threatened plant species,  
31           Laurence's milk-vetch (*Astragalus collinus*), potentially occurs in the analysis area for  
32           Stateline 1&2.<sup>284</sup> The species has not been observed during any surveys for rare plants  
33           conducted for Stateline 1&2 or the old Stateline 3 configuration. In 2008, Northwest Wildlife  
34           Consultants (NWC) conducted rare plant surveys within 500 feet of the proposed new  
35           Stateline 3 facilities.<sup>285</sup> No State-listed plant species were observed during these surveys. The

1 Council finds that the design, construction and operation of the proposed new Stateline 3  
2 configuration are not likely to cause a significant reduction in the likelihood of survival or  
3 recovery of the State-listed plant species.

#### B. Fish and Wildlife Species

4 Washington ground squirrel (*Spermophilus washingtoni*) is a mammal species that is  
5 State-listed as endangered. Bald eagle (*Haliaeetus leucocephalus*) is a raptor that is State-  
6 listed as threatened. The Council has previously found that these two State-listed wildlife  
7 species potentially occur within the analysis areas for Stateline 1&2.<sup>286</sup> The Council adopted  
8 Condition 56, which requires pre-construction surveys in construction zones having suitable  
9 habitat for Washington ground squirrel (WGS) and requires no-construction buffers and other  
10 mitigation if WGS activity is found. The Council adopted Condition 69, which requires  
11 avoidance of WGS colonies and requires measures to minimize impacts to potential WGS  
12 habitat.

13 In the Final Order on Amendment #2, the Council found that, in addition to the  
14 Washington ground squirrel (WGS) and bald eagle, a third State-listed species, American  
15 peregrine falcon (*Falco peregrinus anatum*), potentially could occur within the old Stateline 3  
16 analysis area.<sup>287</sup> In 2007, the Oregon Fish and Wildlife Commission removed peregrine falcon  
17 from the State list of threatened and endangered species.

18 In the Final Order on Amendment #2, the Council found that construction and  
19 operation of the old Stateline 3 configuration would directly affect an estimated 12.3 acres of  
20 known WSG habitat.<sup>288</sup> The Council modified Condition 69 and adopted Condition 107,  
21 which required the certificate holder to implement the *Resource Impact Avoidance and*  
22 *Mitigation Plan* to reduce and mitigate the impacts to WGS habitat.<sup>289</sup> Based on the small  
23 area of direct impact on WGS habitat, the existence of the WGS in other suitable habitat  
24 throughout the SWP project area and the mitigation measures required under the *Resource*  
25 *Impact Avoidance and Mitigation Plan*, the Council found that the construction, operation and  
26 retirement of the old Stateline 3 components were not likely to cause a significant reduction in  
27 the likelihood of survival or recovery of the WGS.

28 Amendment #3 addressed, in part, the certificate holder's request to extend the  
29 construction deadlines for the old Stateline 3 configuration. In the amendment request, the  
30 certificate holder indicated that a future modification of the Stateline 3 configuration might  
31 involve changes to the turbine strings proposed to be sited in the area that was classified as  
32 Category 1 at the time of the Council's decision on Amendment #2.<sup>290</sup> The certificate holder  
33 would submit a later amendment request to address the facility modification and, in the  
34 meantime, would avoid disturbance of the previously identified Category 1 habitat. The  
35 Council adopted Condition 121, which required avoidance of the identified Category 1 habitat  
36 pending a future site certificate amendment proceeding.

1 The bald eagle and the WGS are the State-listed species that have potential to occur  
2 within the new Stateline 3 site boundary. Between May and September 2008, NWC  
3 conducted wildlife surveys within the potential disturbance area around the proposed new  
4 Stateline 3 configuration.<sup>291</sup> No individual WGS, burrows or other signs of WGS were  
5 observed within the survey area.<sup>292</sup> The applicants identified three WGS colonies near, but  
6 outside, the survey area. The applicants have designed the turbine locations, access roads,  
7 collector lines and other structures to avoid direct impacts on WGS habitat. The edge of the  
8 closest WGS colony is 790 feet from the proposed 230-kV transmission line.<sup>293</sup> Because the  
9 new Stateline 3 configuration avoids impact to the 12.3 acres of known WGS habitat that  
10 would have been affected by the old configuration, the *Resource Impact Avoidance and*  
11 *Mitigation Plan* is no longer appropriate. In Revisions 46 and 64, the Department  
12 recommends that the Council modify Condition 69 and remove Condition 107 to eliminate the  
13 requirement that the certificate holders implement the *Resource Impact Avoidance and*  
14 *Mitigation Plan*. The modification of Condition 69 would add a requirement for on-site  
15 monitoring of the WGS area during construction, as proposed by the applicants.<sup>294</sup> In  
16 Revision 75, the Department further recommends that the Council remove Condition 121,  
17 which, as described above, required avoidance of impact to Category 1 WGS habitat pending  
18 redesign of Stateline 3. In the request for Amendment #4, the applicants have proposed a new  
19 Stateline 3 configuration and, therefore, Condition 121 is no longer needed.

20 The applicants describe the bald eagle as an “infrequent visitor to the study area” and  
21 note the lack of nest trees or known bald eagle nests in the area.<sup>295</sup> The applicants assessed the  
22 risk to bald eagles as “low” and noted that there have been no reported bald eagle fatalities at  
23 any wind project in the western U.S.

24 The Council finds that the design, construction and operation of the proposed new  
25 Stateline 3 configuration are not likely to cause a significant reduction in the likelihood of  
26 survival or recovery of the State-listed wildlife species.

### Conclusions of Law

27 For the reasons discussed above and subject to the site certificate conditions described  
28 herein, the Council concludes that the SWP would comply with the Council’s Threatened and  
29 Endangered Species Standard if Amendment #4 were approved.

#### **(b) Fish and Wildlife Habitat**

##### **OAR 345-022-0060**

30 *To issue a site certificate, the Council must find that the design, construction and*  
31 *operation of the facility, taking into account mitigation, are consistent with the fish*  
32 *and wildlife habitat mitigation goals and standards of OAR 635-415-0025 in effect*  
33 *as of September 1, 2000.*

## Findings of Fact

### A. Habitat Impacts

1 In the Final Order on the Application and the Final Order on Amendment #1, the  
2 Council found that the Stateline 1&2 components are consistent with the ODFW habitat  
3 mitigation goals and standards. Habitats affected by Stateline 1&2 components are  
4 summarized in Table 7.<sup>296</sup>

5 In the Final Order on Amendment #2, the Council found that the old Stateline 3  
6 configuration was consistent with the ODFW goals and standards except for the potential  
7 impacts on Category 1 habitat used by the WGS (as discussed above at page 104). The  
8 Council found that the old Stateline configuration did not comply with the Council's Fish and  
9 Wildlife Habitat Standard.<sup>297</sup> The Council applied the "balancing analysis" under *former*  
10 OAR 345-022-0000(2).<sup>298</sup> Using the balancing analysis, the Council may issue or amend a  
11 site certificate for a facility that does not meet a siting standard by finding that the overall  
12 public benefits outweigh the damage to the resources protected by the standard.<sup>299</sup> Based on  
13 consideration of the balancing factors described in the rule and considering the  
14 implementation of the *Resource Impact Avoidance and Mitigation Plan* (Attachment C to the  
15 Final Order on Amendment #2), the Council found that the overall public benefits of the  
16 facility outweighed the damage to the resource (WGS habitat) protected by the Council's Fish  
17 and Wildlife Habitat Standard.<sup>300</sup> The Council modified Condition 69 and adopted Condition  
18 107 to require implementation of the *Resource Impact Avoidance and Mitigation Plan*. The  
19 new Stateline 3 configuration would have no direct impact on the Category 1 WGS area that  
20 was at issue when the Council applied the balancing analysis in the Final Order on

1 Amendment #2. The Council modifies Condition 69 and removes Condition 107 from the site  
 2 certificate as described in Revisions 46 and 64.

3 In Exhibit P of the amendment request, the applicants classified the habitat within the  
 4 new Stateline 3 site boundary according to ODFW categories.<sup>301</sup> The habitat categories are  
 5 shown on Figures P-1a through P-1h.<sup>302</sup>

6 The applicants estimated the maximum impacts of the new Stateline 3 components on  
 7 high-value wildlife habitat by using a layout of 1.5-MW turbines (maximum number of  
 8 turbines), including two alternate turbine locations, and placing the components in the highest  
 9 category allowable while maintaining a buildable design.<sup>303</sup> The estimated habitat impacts of  
 10 the Stateline 3 components are shown in Table 8.<sup>304</sup>

1 Category 1 habitat within the site boundary consists of grassland-steppe vegetation  
2 within a 785-foot buffer around WGS colonies located near the transmission line. ODFW  
3 considers the habitat to be essential for WGS survival, and therefore it is considered Category  
4 1.<sup>305</sup> Category 2 habitat within the site boundary includes high quality grassland steppe  
5 vegetation, riparian trees and other riparian habitat, and areas containing recently active raptor  
6 nests and burrowing owl burrows. The applicants have designed the new Stateline 3  
7 configuration to avoid impacts to all Category 1 and Category 2 habitat within the site  
8 boundary. In Revision 85, the Department recommends that the Council adopt Condition 131,  
9 which would require the certificate holder to avoid impacts on Category 1 and Category 2  
10 habitat within the Stateline 3 site boundary.

11 Category 3 habitat within the site boundary includes moderate quality grassland steppe  
12 and shrub-steppe vegetation types as well as revegetated CRP areas.<sup>306</sup> Category 4 and 5  
13 habitat within the site boundary consists of low quality grassland steppe areas. The applicants  
14 rated “agricultural areas” within the site boundary as Category 6.

#### B. Proposed Habitat Mitigation Area

15 The applicants proposed to establish a Habitat Mitigation Area (HMA) to address the  
16 permanent and temporal impacts of the new Stateline 3 components on wildlife habitat. At a  
17 minimum, the HMA must be large enough to achieve, within a reasonable time, the habitat  
18 mitigation goals and standards of ODFW’s Fish and Wildlife Habitat Mitigation Policy  
19 described in OAR 635-415-0025. The ODFW goals require mitigation to achieve “no net  
20 loss” of habitat in Categories 3 and 4 (acre-for-acre mitigation). For Category 5 impacts,  
21 mitigation is achieved by a “net benefit in habitat quantity or quality.” In addition, to address  
22 the temporal loss of habitat quality during the recovery of Category 3 and Category 5 shrub-  
23 steppe (SS) and grassland shrub-steppe (GSS) habitat temporarily disturbed during  
24 construction (outside the footprint), the HMA must include ½ acre for every acre of shrub-  
25 steppe habitat affected (a 0.5:1 ratio).

26 Based on the maximum habitat impacts shown in Table 8, the Department calculated  
27 the maximum mitigation area requirement to be 11 acres of predominantly Category 3  
28 habitat.<sup>307</sup> The actual Stateline 3 footprint and construction disturbance areas cannot be  
29 determined until the final design layout of the facility is known. The Council modifies  
30 Condition 112, as discussed in Revision 68. As modified, Condition 112 requires the  
31 certificate holder to provide to the Department and ODFW a map showing the final design  
32 configuration of Stateline 3 and a table showing the acres of impacts on wildlife habitat,

1 similar to Table 8. The habitat impacts of the final design layout would determine the final  
2 size of the mitigation area.

3 The applicants proposed a 50-acre HMA and identified two possible sites for the  
4 HMA.<sup>308</sup> According to the applicant's preliminary assessment, each parcel includes  
5 approximately 50 acres of native grassland steppe vegetation. Each of the possible sites  
6 contains grassland currently used periodically for domestic livestock (sheep and cattle)  
7 grazing. ODFW has visited both sites and agrees that either one would be suitable for the  
8 Stateline 3 HMA.

9 Proposed Area A has been studied previously.<sup>309</sup> In the Request for Amendment #2,  
10 Area A encompassed proposed turbine string BG-C and its associated survey corridor. The  
11 turbines were never built, and Area A would not contain any new wind turbines if the area  
12 were selected as the HMA. Area A contains mostly Category 1 habitat associated with an  
13 historic WGS colony. The northeast portion of Area A is Category 2 habitat. If Area A were  
14 selected, it would ensure conservation of regionally scarce habitat containing vegetation and  
15 soil characteristics that could support WGS. Grasshopper sparrows (a State Sensitive -  
16 Vulnerable species) were observed in the area during the breeding season of 2002.<sup>310</sup>

17 Area B is located to the east of adjacent land that was investigated during the 2002  
18 survey referenced above. Area B is similar in vegetation, structure and slope aspect as the  
19 studied area. The area contains habitat suitable for WGS, grasshopper sparrows and  
20 burrowing owls. The applicant estimates that approximately 75-percent of Area B is Category  
21 1 due to the presence of WGS. Small patches of weeds are present, due to past livestock  
22 grazing pressure.

### C. Mitigation Measures

23 In the Final Order on the Application and the Final Order on Amendment #1, the  
24 Council adopted Conditions 52, 53, 54, 56, 63, 64, 65, 66, 67, 68, 69, 70, 89, 90, 91, 93, 94,  
25 101 and 104, which address mitigation for the potential impacts of Stateline 1&2 on wildlife  
26 and wildlife habitat. In the Final Order on Amendment #2, the Council applied all of these  
27 conditions to the old Stateline 3 configuration, except Conditions 66, 67, 101 and 104, which  
28 relate specifically to Stateline 1&2 components. In the Final Order on Amendment #2 and the  
29 Final Order on Amendment 3, the Council adopted Conditions 107, 112, 114, 115, 116, 117  
30 and 121, which address mitigation for the potential impacts of the old Stateline 3  
31 configuration on wildlife and wildlife habitat. The Council applies or modifies the following  
32 site certificate conditions to address the potential impacts of the new Stateline 3 configuration  
33 on wildlife and wildlife habitat:

- 34 • Conditions 52 and 70: These conditions relate to the design (Condition 52) and  
35 construction (Condition 70) of the facility to reduce risk to avian species (for example,  
36 by not locating turbines in narrow ridge saddles).

- 1       • Condition 53: This condition requires pre-construction survey of known Swainson’s  
2       hawk nests in the vicinity of proposed construction and measures to avoid nest  
3       disturbance during the sensitive season if occupied nests are found.
- 4       • Condition 54: This condition is similar to Condition 53 but applies to burrowing owls.
- 5       • Condition 56: This condition requires pre-construction survey for the presence of  
6       WGS in constructions zones that have suitable habitat and requires no-construction  
7       buffers and other mitigation if WGS activity is found. The condition defines  
8       “construction zones” as the areas of permanent or temporary construction disturbance  
9       plus a 175-foot surrounding buffer.
- 10      • Conditions 63 and 90: These conditions list measures to be implemented during  
11      construction (Condition 63) and operation (Condition 90) to reduce or avoid impacts  
12      to wildlife.
- 13      • Condition 64: This condition requires the use of gravel on turbine pad areas to avoid  
14      creating artificial habitat for raptor prey and to reduce the potential for weed  
15      infestation.
- 16      • Conditions 65 and 91: These conditions list measures to be implemented during  
17      construction (Condition 65) and operation (Condition 91) to reduce or avoid impacts  
18      to wildlife habitat. Condition 65 includes the requirement to restore temporarily  
19      disturbed areas as described in the *Revegetation Plan*.
- 20      • Condition 68: This condition lists measures to be implemented to avoid impacts on  
21      temporarily disturbed Category 6 habitat. This condition also includes the requirement  
22      to restore temporarily disturbed areas as described in the *Revegetation Plan*.
- 23      • Condition 69: This condition requires avoidance impacts to WGS colonies. The  
24      Council modifies Condition 69 to eliminate the requirement that the certificate holders  
25      implement the *Resource Impact Avoidance and Mitigation Plan*. The modification  
26      would require an on-site wildlife monitor, who would flag the habitat required for  
27      WGS survival as a no-entry area during construction, as proposed by the applicants.<sup>311</sup>  
28      The wildlife monitor would survey the area for WGS activity before and after  
29      construction.
- 30      • Condition 89: This condition requires avoidance of impacts to new nesting or denning  
31      sites that are found during facility operation.
- 32      • Condition 93: This condition requires implementation of wildlife monitoring as  
33      described in the *Oregon Wildlife Monitoring Plan*.
- 34      • Condition 94: This condition requires additional mitigation if the analysis of  
35      monitoring data indicates impacts to wildlife or wildlife habitat that the certificate  
36      holder has not adequately addressed by other mitigation measures.
- 37      • Condition 112: This condition addresses mitigation for the permanent impacts of  
38      Stateline 3 on wildlife habitat. The Council modifies Condition 112 to require

1 implementation of the *Stateline 3 Habitat Mitigation Plan* as described in Revision 68  
2 and Attachment C.

- 3 • Condition 114: This condition requires installation of anti-perching devices on  
4 transmission line support structures within one mile of any turbine. In Revision 70, the  
5 Department recommends that the Council modify this condition to reduce the distance  
6 to one-half mile, unless the top of the support structure is below the base of the turbine  
7 tower, due to topography.<sup>312</sup>
- 8 • Condition 115: This condition requires the certificate holder to design the electrical  
9 conductors of aboveground transmission lines with sufficient spacing to reduce the  
10 risk of bird electrocution. The Council modifies the condition to require design of  
11 transmission line support structures to conform to the avian protection practices  
12 recommended by the Avian Power Line Interaction Committee.
- 13 • Condition 117: This condition requires mitigation measures to avoid construction  
14 disturbance during the sensitive season if known ferruginous hawk nests are occupied.
- 15 • Condition 131: This condition requires the certificate holder to avoid permanent and  
16 temporary disturbance to all Category 1 and Category 2 habitat within the Stateline 3  
17 site boundary.
- 18 • Condition 135: This condition mitigates possible disturbance to nesting Swainson’s  
19 hawks during construction of Stateline 3 by requiring that transmission line support  
20 structures be located at least 800 feet from active nest sites.

#### Conclusions of Law

21 For the reasons discussed above and subject to the site certificate conditions described  
22 herein, the Council concludes that the SWP would comply with the Council’s Fish and  
23 Wildlife Habitat Standard if Amendment #4 were approved.

#### **5. Standards Not Applicable to Site Certificate Eligibility**

24 Under ORS 469.501(4), the Council may issue a site certificate without making the  
25 findings required by the standards discussed in this section (Structural Standard, Historic,  
26 Cultural and Archaeological Resources Standard, Public Services Standard and Waste  
27 Minimization Standard).<sup>313</sup> Nevertheless, the Council may impose site certificate conditions  
28 based on the requirements of these standards.

**(a) Structural Standard**

**OAR 345-022-0020**

*(1) Except for facilities described in sections (2) and (3), to issue a site certificate, the Council must find that:*

*(a) The applicant, through appropriate site-specific study, has adequately characterized the site as to Maximum Considered Earthquake Ground Motion identified at International Building Code (2003 Edition) Section 1615 and maximum probable ground motion, taking into account ground failure and amplification for the site specific soil profile under the maximum credible and maximum probable seismic events; and*

*(b) The applicant can design, engineer, and construct the facility to avoid dangers to human safety presented by seismic hazards affecting the site that are expected to result from maximum probable ground motion events. As used in this rule “seismic hazard” includes ground shaking, ground failure, landslide, liquefaction, lateral spreading, tsunami inundation, fault displacement, and subsidence;*

*(c) The applicant, through appropriate site-specific study, has adequately characterized the potential geological and soils hazards of the site and its vicinity that could, in the absence of a seismic event, adversely affect, or be aggravated by, the construction and operation of the proposed facility; and*

*(d) The applicant can design, engineer and construct the facility to avoid dangers to human safety presented by the hazards identified in subsection (c).*

*(2) The Council may issue a site certificate for a facility that would produce power from wind, solar or geothermal energy without making the findings described in section (1). However, the Council may apply the requirements of section (1) to impose conditions on a site certificate issued for such a facility.*

\* \* \*

Proposed Conditions

In the Final Order on the Application and the Final Order on Amendment #1, the Council made findings regarding the seismic, geological and soil hazards in the area of the Stateline 1&2 components. In the Final Order on Amendment #2, the Council made findings on the area of the old Stateline 3 configuration. The site certificate includes conditions addressing structural safety (Conditions 16, 17, 18, 49, 50, 51 and 59).

The applicants provided information regarding the seismic characteristics of the site and possible seismic and geological hazards in Exhibit H of the amendment request. The new Stateline 3 configuration that is proposed by the applicants in Amendment #4 lies largely within the area of the old Stateline 3 configuration.<sup>314</sup> The geological conditions of the proposed Stateline 3 site are similar to the geological conditions of Stateline 1&2: wind-blown sandy silt of variable thickness covers basalt bedrock.<sup>315</sup> FPL Vansycle conducted soil

1 borings and test pits at several locations throughout the old Stateline 3 area.<sup>316</sup> There are  
2 several proposed new Stateline 3 turbine locations that lie outside, but within a mile, of the  
3 old Stateline 3 turbine locations.

4 Conditions 16, 17 and 18 incorporate mandatory conditions required under OAR 345-  
5 027-0020(12), (13) and (14). Condition 49 requires the certificate holder to design the facility  
6 in accordance with seismic design provisions of the Oregon Building Code. In comments on  
7 the amendment request, DOGAMI advised that the facilities should be designed to meet the  
8 current Oregon Structural Specialty Code (OSSC 2007) and the 2006 International Building  
9 Code.<sup>317</sup> In Revision 41, the Department recommends that the Council modify Condition 49  
10 to incorporate the building code requirements recommended by DOGAMI. Conditions 50 and  
11 51 contain turbine foundation design specifications recommended by DOGAMI in 2001.  
12 Condition 59 requires inspection of excavations to confirm that geologic conditions are  
13 appropriate for supporting turbines and other facilities. The Council confirms that Conditions  
14 16, 17, 18, 49, 50, 51 and 59 apply to Stateline 3.

15 The applicants propose to conduct a detailed site-specific investigation of the Stateline  
16 3 site before construction begins.<sup>318</sup> In Revision 86, the Department recommends that the  
17 Council adopt Condition 132, which would require a pre-construction geotechnical  
18 investigation and consultation with DOGAMI.

## **(b) Historic, Cultural and Archaeological Resources**

### **OAR 345-022-0090**

19 *(1) Except for facilities described in sections (2) and (3), to issue a site certificate,*  
20 *the Council must find that the construction and operation of the facility, taking*  
21 *into account mitigation, are not likely to result in significant adverse impacts to:*  
22

23 *(a) Historic, cultural or archaeological resources that have been listed on, or*  
24 *would likely be listed on the National Register of Historic Places;*

25 *(b) For a facility on private land, archaeological objects, as defined in ORS*  
26 *358.905(1)(a), or archaeological sites, as defined in ORS 358.905(1)(c); and*

27 *(c) For a facility on public land, archaeological sites, as defined in ORS*  
28 *358.905(1)(c).*

29 *(2) The Council may issue a site certificate for a facility that would produce power*  
30 *from wind, solar or geothermal energy without making the findings described in*  
31 *section (1). However, the Council may apply the requirements of section (1) to*  
32 *impose conditions on a site certificate issued for such a facility.*

33 \* \* \*

### Proposed Conditions

34 In the Final Order on the Application, the Final Order on Amendment #1 and the Final  
35 Order on Amendment #2, the Council reviewed cultural resource surveys of the areas where

1 the Stateline 1&2 and old Stateline 3 components would be located. These surveys were  
2 conducted in consultation with the CTUIR. The Council adopted Conditions 75 and 76 to  
3 safeguard cultural resources.

4 The site boundary for the proposed new Stateline 3 configuration includes some areas  
5 that were not surveyed for the old Stateline 3 configuration. The CTUIR Cultural Resources  
6 Protection Program conducted pedestrian surveys in the summer and fall of 2008 in the areas  
7 that had not previously been surveyed for archaeological resources. These surveys identified  
8 three prehistoric sites, two historic era sites and one isolated artifact.<sup>319</sup>

9 The applicants agreed to implement the measures recommended by CTUIR to protect  
10 cultural and archaeological sites.<sup>320</sup> In Revision 47, the Department recommends that the  
11 Council adopt modify Conditions 75 and 76 to incorporate the recommended measures. The  
12 Council confirms that Conditions 75 and 76 are applicable to the proposed Stateline 3.

### (c) Public Services

#### **OAR 345-022-0110**

13 *(1) Except for facilities described in sections (2) and (3), to issue a site certificate,*  
14 *the Council must find that the construction and operation of the facility, taking*  
15 *into account mitigation, are not likely to result in significant adverse impact to the*  
16 *ability of public and private providers within the analysis area described in the*  
17 *project order to provide: sewers and sewage treatment, water, storm water*  
18 *drainage, solid waste management, housing, traffic safety, police and fire*  
19 *protection, health care and schools.*

21 *(2) The Council may issue a site certificate for a facility that would produce power*  
22 *from wind, solar or geothermal energy without making the findings described in*  
23 *section (1). However, the Council may apply the requirements of section (1) to*  
24 *impose conditions on a site certificate issued for such a facility.*

25 \* \* \*

### Proposed Conditions

26 In the Final Order on the Application and the Final Order on Amendment #1, the  
27 Council addressed the potential impacts of construction and operation of Stateline 1&2 on the  
28 ability of public and private providers within the analysis area to provide public services.<sup>321</sup>  
29 The analysis area that was addressed by the Council incorporated communities within 30  
30 miles of the Stateline 1&2 site boundary. The Council found that operation of Stateline 1&2  
31 would have no significant adverse impact on the ability of communities to provide public  
32 services.<sup>322</sup> In the Final Order on Amendment #2, the Council considered the potential

1 impacts of the old Stateline 3 configuration on public services within a 30-mile radius of the  
2 site boundary. The Council determined that Conditions 31, 32, 33, 34, 35, 45, 48, 58, 60, 61,  
3 71, 72, 73, 74, 77, 81, 85, 86, 87, 88, 96 and 103 should apply to the old Stateline 3 facilities.

4 The applicants provided information about the impacts of the new Stateline 3  
5 configuration on public services in Exhibit U of the amendment request. The analysis area for  
6 the new Stateline 3 configuration is the area within the new Stateline 3 site boundary and the  
7 area within 10 miles from the site boundary.<sup>323</sup> The analysis area for the new Stateline 3  
8 configuration lies entirely within the analysis area addressed by the Council for the old  
9 Stateline 3 configuration.<sup>324</sup>

10 In the request for Amendment #4, the applicants have proposed a new configuration  
11 for Stateline 3. The maximum number of turbines proposed in the new configuration is 67,  
12 which is substantially fewer than the 279 turbines approved by the Council for the old  
13 configuration. Because of the smaller size of the new Stateline 3 configuration, the potential  
14 public service impacts of construction and operation of the new Stateline 3 configuration  
15 would be reduced compared with the impacts of the old Stateline 3 configuration, as discussed  
16 further below. The Council finds that no new conditions related to public services are needed  
17 under the proposed amendment. The Council confirms that the conditions listed above (except  
18 Condition 87) apply to the new Stateline 3 configuration, subject to the recommended  
19 revisions discussed below beginning at page 128.

#### A. Sewage, Storm Water and Solid Waste

20 During construction and operation of Stateline 3, the impact on sewage treatment  
21 would be minimal. Wastewater from washdown of concrete trucks would be discharged into  
22 the foundation excavations at each turbine tower (Condition 72). Portable toilets would be  
23 provided for onsite sewage handling during construction and would be pumped and cleaned  
24 regularly by a licensed contractor (Condition 73). No other wastewater is anticipated to be  
25 generated during construction. During operation, wastewater generated at the O&M building  
26 would be discharged to an on-site septic system.

27 With the exception of minimal stormwater drainage facilities associated with public  
28 roads, there are no public stormwater services within the Stateline 3 site boundary. Condition  
29 60 requires the certificate holder to conduct construction activities in accordance with the  
30 NPDES Storm Water Discharge General Permit #1200-C, which would ensure appropriate  
31 on-site handling of storm water.

32 There are no solid waste management services that serve the Stateline 3 site. Solid  
33 waste generated during construction and operation would be recycled to the extent practical.  
34 Conditions 73 and 86 require the certificate holder to recycle solid waste generated during  
35 construction and operation of the facility as much as feasible and to collect non-recyclable  
36 waste and transport it to a local landfill.

## B. Water

1 For uses during construction, the new Stateline 3 configuration would require up to 8.7  
2 million gallons of water, compared to an estimated maximum of 17 million gallons for  
3 construction of the old Stateline 3 configuration.<sup>325</sup> As discussed below at page 124, water for  
4 construction purposes would be provided subject to appropriate water rights and would not  
5 have an adverse impact on other water users in the area. During operation, water use would be  
6 primarily for sanitary purposes at the O&M building. Water use is not expected to exceed  
7 1,000 gallons per day.<sup>326</sup> The water would be supplied from an on-site well and would have  
8 no adverse impact on public water services.

## C. Housing, Police and Fire Protection, Health Care and Schools

9 Increases in population due to a temporary influx of construction workers potentially  
10 affect police and fire protection services, housing availability, health care services and  
11 schools. The applicants estimate that a maximum of 133 to 200 temporary new residents  
12 might be associated with construction of the new Stateline 3 configuration.<sup>327</sup> In contrast,  
13 construction of the old Stateline 3 configuration was anticipated to bring a maximum of 250  
14 temporary new residents to the area.<sup>328</sup> The Council considered the potential impacts of  
15 temporary population increases during construction of the old Stateline 3 configuration and  
16 concluded that the impact to the ability of communities to provide housing, police and fire  
17 protection, health care and schools was not likely to be significant. Permanent population  
18 increases (for operational staff hired from outside the area) would not be significant under  
19 either the new or old Stateline 3 configurations.

## D. Traffic Safety

20 Potential traffic safety impacts during construction are related to the estimated number  
21 of vehicle trips anticipated. To estimate the traffic impacts due to construction of Stateline 1,  
22 FPL Vansycle performed a complex, detailed analysis of the anticipated volume of  
23 construction vehicles of all types.<sup>329</sup> Based on this analysis, FPL Vansycle estimated that  
24 construction of the Stateline 1 facilities in Oregon would generate a total of 12,707 vehicle  
25 trips.<sup>330</sup> The analysis was based on assumptions regarding the quantities of materials or trips  
26 required for each turbine.

27 In assessing the potential traffic impacts for construction of the old Stateline 3  
28 configuration, the Council assumed that the total number of vehicle trips would be in direct  
29 proportion to the number of turbines being built. Based on this assumption, the Council  
30 estimated that construction of the old Stateline 3 configuration would require 27,915 vehicle  
31 trips. Using the same analysis, construction of the new Stateline 3 configuration would require  
32 6,704 vehicle trips and the potential traffic safety impacts would be greatly reduced. The  
33 applicants discussed the proposed transportation route with the Umatilla County Public Works  
34 Director and the Oregon Department of Transportation (ODOT). ODOT determined that no

1 significant alterations or improvements would be needed to State roadways or to areas outside  
2 of the right-of-way.<sup>331</sup> Condition 124 would require the certificate holder to use a  
3 transportation route approved by the County Public Works Director for all oversized and  
4 heavy load transport vehicles.

5 During operation, the anticipated permanent staff of up to eight employees would not  
6 significantly increase traffic in the analysis area. The use of area highways and local roads by  
7 employees during operation is not likely to result in a significant adverse impact on traffic  
8 safety.

#### (d) Waste Minimization

##### **OAR 345-022-0120**

9 (1) Except for facilities described in sections (2) and (3), to issue a site certificate,  
10 the Council must find that, to the extent reasonably practicable:

11  
12 (a) The applicant's solid waste and wastewater plans are likely to minimize  
13 generation of solid waste and wastewater in the construction and operation of the  
14 facility, and when solid waste or wastewater is generated, to result in recycling  
15 and reuse of such wastes;

16 (b) The applicant's plans to manage the accumulation, storage, disposal and  
17 transportation of waste generated by the construction and operation of the facility  
18 are likely to result in minimal adverse impact on surrounding and adjacent areas.

19 (2) The Council may issue a site certificate for a facility that would produce power  
20 from wind, solar or geothermal energy without making the findings described in  
21 section (1). However, the Council may apply the requirements of section (1) to  
22 impose conditions on a site certificate issued for such a facility.

#### Proposed Conditions

23 In the Final Order on the Application, the Council made findings and adopted site  
24 certificate conditions regarding the solid waste and wastewater likely to be generated during  
25 the construction, operation and retirement of Stateline 1 and the impact on surrounding  
26 communities.<sup>332</sup> In the Final Order on Amendment #1, the Council applied the same  
27 conditions to Stateline 2.<sup>333</sup> In the Final Order on Amendment #2, the Council found that the  
28 type of waste generated by construction and operation of the old Stateline 3 configuration  
29 would be similar but proportionally greater in volume than the waste generated by  
30 construction and operation of Stateline 1&2, due to the greater number of wind turbines that  
31 would be built plus construction of a substation and aboveground transmission lines.<sup>334</sup> The  
32 Council applied Conditions 32, 71, 72, 73, 74, 83, 86 and 98 to the old Stateline 3  
33 configuration.

34 Solid waste and wastewater generated by construction, operation and retirement of the  
35 new Stateline 3 configuration are likely to be similar in type to that generated by Stateline 1&

1 2 and lower in volume than the Council anticipated for the old Stateline 3 configuration. The  
2 Council confirms that the conditions listed above (except Condition 98) apply to the new  
3 Stateline 3 configuration, subject to the recommended modifications discussed below  
4 beginning at page 128.

## V. OTHER APPLICABLE REGULATORY REQUIREMENTS: FINDINGS AND CONCLUSIONS

### 1. Requirements under Council Jurisdiction

5 Under ORS 469.503(3) and under the Council’s General Standard of Review (OAR  
6 345-022-0000, the Council must determine that a facility complies with “all other Oregon  
7 statutes and administrative rules identified in the project order, as amended, as applicable to  
8 the issuance of a site certificate for the proposed facility.” Other Oregon statutes and  
9 administrative rules that are applicable to the changes requested in Amendment #4 include the  
10 DEQ noise control regulations, the regulations adopted by the Department of State Lands  
11 (DSL) for removal or fill of material affecting waters of the state, the Water Resources  
12 Department’s (WRD) regulations for appropriating ground water and the Council’s statutory  
13 authority to consider protection of public health and safety.

#### (a) Noise Control Regulations

14 The applicable noise control regulations are as follows:

##### **OAR 340-035-0035**

##### **Noise Control Regulations for Industry and Commerce**

##### *(1) Standards and Regulations:*

18 \* \* \*

##### *(b) New Noise Sources:*

20 \* \* \*

##### *(B) New Sources Located on Previously Unused Site:*

22 *(i) No person owning or controlling a new industrial or commercial noise source*  
23 *located on a previously unused industrial or commercial site shall cause or permit*  
24 *the operation of that noise source if the noise levels generated or indirectly caused*  
25 *by that noise source increase the ambient statistical noise levels, L10 or L50, by*  
26 *more than 10 dBA in any one hour, or exceed the levels specified in Table 8, as*  
27 *measured at an appropriate measurement point, as specified in subsection (3)(b)*  
28 *of this rule, except as specified in subparagraph (1)(b)(B)(iii).*

29 *(ii) The ambient statistical noise level of a new industrial or commercial noise*  
30 *source on a previously unused industrial or commercial site shall include all*  
31 *noises generated or indirectly caused by or attributable to that source including*  
32 *all of its related activities. Sources exempted from the requirements of section (1)*  
33 *of this rule, which are identified in subsections (5)(b) - (f), (j), and (k) of this rule,*  
34 *shall not be excluded from this ambient measurement.*

35 *(iii) For noise levels generated or caused by a wind energy facility:*

1           (I) *The increase in ambient statistical noise levels is based on an assumed*  
2 *background L50 ambient noise level of 26 dBA or the actual ambient background*  
3 *level. The person owning the wind energy facility may conduct measurements to*  
4 *determine the actual ambient L10 and L50 background level.*

5           (II) *The “actual ambient background level” is the measured noise level at the*  
6 *appropriate measurement point as specified in subsection (3)(b) of this rule using*  
7 *generally accepted noise engineering measurement practices. Background noise*  
8 *measurements shall be obtained at the appropriate measurement point,*  
9 *synchronized with windspeed measurements of hub height conditions at the*  
10 *nearest wind turbine location. “Actual ambient background level” does not*  
11 *include noise generated or caused by the wind energy facility.*

12           (III) *The noise levels from a wind energy facility may increase the ambient*  
13 *statistical noise levels L10 and L50 by more than 10 dBA (but not above the limits*  
14 *specified in Table 8), if the person who owns the noise sensitive property executes*  
15 *a legally effective easement or real covenant that benefits the property on which*  
16 *the wind energy facility is located. The easement or covenant must authorize the*  
17 *wind energy facility to increase the ambient statistical noise levels, L10 or L50 on*  
18 *the sensitive property by more than 10 dBA at the appropriate measurement point.*

19           (IV) *For purposes of determining whether a proposed wind energy facility*  
20 *would satisfy the ambient noise standard where a landowner has not waived the*  
21 *standard, noise levels at the appropriate measurement point are predicted*  
22 *assuming that all of the proposed wind facility’s turbines are operating between*  
23 *cut-in speed and the wind speed corresponding to the maximum sound power level*  
24 *established by IEC 61400-11 (version 2002-12). These predictions must be*  
25 *compared to the highest of either the assumed ambient noise level of 26 dBA or to*  
26 *the actual ambient background L10 and L50 noise level, if measured. The facility*  
27 *complies with the noise ambient background standard if this comparison shows*  
28 *that the increase in noise is not more than 10 dBA over this entire range of wind*  
29 *speeds.*

30           (V) *For purposes of determining whether an operating wind energy facility*  
31 *complies with the ambient noise standard where a landowner has not waived the*  
32 *standard, noise levels at the appropriate measurement point are measured when*  
33 *the facility’s nearest wind turbine is operating over the entire range of wind*  
34 *speeds between cut-in speed and the windspeed corresponding to the maximum*  
35 *sound power level and no turbine that could contribute to the noise level is*  
36 *disabled. The facility complies with the noise ambient background standard if the*  
37 *increase in noise over either the assumed ambient noise level of 26 dBA or to the*  
38 *actual ambient background L10 and L50 noise level, if measured, is not more than*  
39 *10 dBA over this entire range of wind speeds.*

40           (VI) *For purposes of determining whether a proposed wind energy facility*  
41 *would satisfy the Table 8 standards, noise levels at the appropriate measurement*  
42 *point are predicted by using the turbine’s maximum sound power level following*  
43 *procedures established by IEC 61400-11 (version 2002-12), and assuming that all*

1 *of the proposed wind facility’s turbines are operating at the maximum sound*  
2 *power level.*

3 *(VII) For purposes of determining whether an operating wind energy facility*  
4 *satisfies the Table 8 standards, noise generated by the energy facility is measured*  
5 *at the appropriate measurement point when the facility’s nearest wind turbine is*  
6 *operating at the windspeed corresponding to the maximum sound power level and*  
7 *no turbine that could contribute to the noise level is disabled.*

8 \* \* \*

### Findings of Fact

9 In the Final Order on the Application and the Final Order on Amendment #1, the  
10 Council concluded that Stateline 1&2 would comply with the State noise control regulations.  
11 The Department has received no complaints about noise produced by the operation of  
12 Stateline 1&2 wind turbines. Amendment #4 would change the site boundary of the SWP and  
13 authorize the construction of a new Stateline 3 configuration. The Council must decide,  
14 therefore, whether the noise generated by the operation of the SWP with the proposed  
15 Stateline 3 components would comply with the noise control regulations.<sup>335</sup> In Oregon, noise  
16 is subject to regulation “to provide protection of the health, safety and welfare of Oregon  
17 citizens from the hazards and deterioration of the quality of life imposed by excessive noise  
18 emissions.”<sup>336</sup> The applicable noise standard is OAR 340-035-0035(1)(b)(B), which applies to  
19 a new industrial or commercial noise source located on a previously unused site.

20 In 2004, after the Council’s decision on Amendment #2 approving the old Stateline 3  
21 configuration, the Oregon Environmental Quality Commission adopted amendments to OAR  
22 340-035-0035(1)(b)(B) that changed how the noise regulations apply to wind facilities. Under  
23 the amended regulations, the noise from the facility must comply with two tests. The noise  
24 must not exceed the maximum allowable limit of 50 dBA (the maximum allowable test) and  
25 must not increase ambient noise levels by more than 10 dBA at any noise sensitive property  
26 (the ambient degradation test).<sup>337</sup> OAR 340-035-0035(1)(b)(B)(iii)(III) relieves the applicant  
27 from having to show compliance with the ambient degradation test “if the person who owns  
28 the noise sensitive property executes a legally effective easement or real covenant that  
29 benefits the property on which the wind energy facility is located” (a “noise waiver”).

30 The applicants provided information regarding compliance with the noise regulations  
31 in Exhibit X of the amendment request. The applicants hired Tetra Tech EC (TETRA TECH)  
32 to perform an acoustical analysis and interpret the results.<sup>338</sup> The analysis evaluated the noise  
33 generated by a 46-turbine layout (the proposed 43 turbine locations plus 3 alternative turbine  
34 locations) using Siemens SWT 2.3 MW turbine noise specifications and a 70-turbine layout  
35 (the proposed 67 turbine locations plus 3 alternative turbine locations) using GE 1.5 MW SLE  
36 turbine noise specifications.<sup>339</sup> TETRA TECH also considered noise generated by

transformers on the Stateline 3 site, but concluded that transformers located at the base of the turbines “likely will be inaudible at residential receptor locations given current Facility setback requirements.”<sup>340</sup> The analysis did not include noise generated by the proposed substation transformer. The applicants stated that substation transformers “will be reviewed by the Construction Engineer as the Facility enters the detailed design phase” and “noise mitigation measures such as the use of NEMA low noise transformers may be required to meet the ODEQ environmental noise regulations.”<sup>341</sup>

TETRA TECH performed noise modeling using Datakustic GmbH’s CadnaA (v. 3.7) and presented the results of noise predictions for 23 noise sensitive receivers in Tables X-6 and X-7 and in Figures X-2a and X-2b of the amendment request. The Department consulted with Kerrie Standlee of Daly Standlee and Associates to review and confirm TETRA TECH’s findings. The predicted levels are shown in Table 9 below.

1 The applicants considered the effect of the existing Stateline 1&2 wind turbines on the  
2 noise sensitive properties listed in the table, but because the nearest Stateline 1&2 turbines are  
3 more than two miles from these properties, no cumulative adverse noise effects are  
4 expected.<sup>342</sup> Likewise, the Stateline 3 wind turbines are not expected to have cumulative noise  
5 effects on noise sensitive properties previously analyzed for impacts from Stateline 1&2.

6 Based on the data shown in Table 9, noise generated by the SWP including the  
7 proposed Stateline 3 components, would comply with the maximum-allowable test at all noise  
8 sensitive properties that would be affected by noise from Stateline 3. That is, the noise  
9 generated by operation of the facility would not exceed the night-time L<sub>50</sub> noise limit of 50  
10 dBA at any noise sensitive receptor.

11 In assessing the predicted noise levels relative to the ambient degradation test, the  
12 applicant elected to use the 26-dBA ambient noise level for all receptors, as allowed in OAR  
13 340-035-0035(1)(b)(B)(iii)(I). Based on the data shown in Table 9, noise generated by the  
14 SWP, including the proposed Stateline 3 components, would exceed the 10-dBA ambient  
15 degradation test at four noise sensitive properties (indicated by underscore in the table) if the  
16 GE 1.5-MW SLE or XLE turbine layout is used or at two noise sensitive properties if the  
17 Siemens SWT 2.3-MW turbine layout is used. TETRA TECH analyzed compliance with the  
18 ambient-degradation test using a “worst-case” approach, which included additional wind  
19 turbines in alternative locations, as stated above.<sup>343</sup> The facility could comply with the noise  
20 control regulations if the certificate holders obtained noise waivers from the property owners  
21 of the affected properties.

22 To ensure that the SWP would comply with the noise control regulations if the  
23 Stateline 3 components are built, the Council adopts Condition 133. This condition would  
24 require the certificate holders to provide information about the turbines selected and about the  
25 final design layout for Stateline 3 to the Department before beginning construction of  
26 Stateline 3 components. The condition requires the certificate holder to demonstrate to the  
27 satisfaction of the Department that the facility, with the Stateline 3 components built  
28 according to the final design layout, would comply with the applicable noise control  
29 regulations.

30 Condition 78 requires the certificate holder to confine the noisiest construction  
31 activities to the daylight hours. In Revision 74, the Department recommends modification of  
32 Condition 120 to require verification that the actual sound output of the Stateline 3 wind  
33 turbines meets the manufacturer’s warranty. The Council confirms that Conditions 78 and 120  
34 apply to Stateline 3.

35 Under OAR 340-035-0035(4)(a), DEQ has authority to require the owner of an  
36 operating noise source to monitor and record the statistical noise levels upon written  
37 notification. In the event of a complaint regarding noise levels during operation of the SWP,

1 the Council has the authority to act in the place of DEQ to enforce this provision to verify that  
2 the certificate holder is operating the facility in compliance with the noise control regulations.  
3 Under Condition 2, the certificate holders are required to operate the facility in accordance  
4 with all applicable state laws and administrative rules. The Council adopts Condition 134,  
5 which requires the certificate holder to notify the Department of any complaints received  
6 about noise from the facility as well as the actions taken to address them.

### Conclusions of Law

7 For the reasons discussed above and subject to the conditions described herein, the  
8 Council concludes that the SWP would comply with the applicable noise control regulations  
9 in OAR 340-035-0035 if Amendment #4 were approved.

### **(b) Removal-Fill Law**

10 The Oregon Removal-Fill Law (ORS 196.800 through .990) and DSL regulations  
11 (OAR 141-085-0005 through 141-085-0090) require a Removal/Fill Permit if 50 cubic yards  
12 or more of material is removed, filled or altered within any “waters of the state” at the  
13 proposed site.<sup>344</sup> The USACE administers Section 404 of the Clean Water Act, which  
14 regulates the discharge of fill into waters of the United States, and determines whether a  
15 Nationwide or Individual Section 404 fill permit is required.

### Findings of Fact

16 In the Final Order on the Application and the Final Order on Amendment #1, the  
17 Council found that a Removal/Fill Permit was not needed for construction of the Stateline  
18 1&2 components. In Exhibit J of the amendment request, the applicants provided information  
19 about waters of the state potentially affected by construction of the new Stateline 3  
20 components. A delineation report was prepared for the applicants by TETRA TECH.<sup>345</sup> The  
21 report was submitted to DSL for review.

22 TETRA TECH evaluated the site for presence of federal or State jurisdictional waters.  
23 After identifying potential wetlands and waters based on mapping evidence, TETRA TECH  
24 conducted on-site delineation surveys on August 6-8, August 20-22 and October 14-16, 2008,  
25 following the procedures in the USACE *Wetland Delineation Manual* (Environmental  
26 Laboratory, 1987) and the *Interim Regional Supplement to the Corps of Engineers Wetland  
27 Delineation Manual: Arid West Region* (USACE 2006).

28 TETRA TECH did not find any wetlands within the project area.<sup>346</sup> TETRA TECH  
29 delineated two unnamed perennial streams and one intermittent stream and determined that  
30 these three streams are potentially jurisdictional under both State and federal regulations.<sup>347</sup>  
31 The potentially jurisdictional streams are listed in Table J-1 of the amendment request.

32 The proposed 230-kV transmission line would cross the three potentially-jurisdictional  
33 streams, but the applicants propose to avoid impacts by spanning the transmission line over

1 the streams.<sup>348</sup> No removal or fill within the stream channels would be needed. The applicants  
2 would construct transmission line access roads and support structures no closer than the top of  
3 bank on each side of the jurisdictional streams. In Revision 73, the Department recommends  
4 modification of Condition 118 to clarify the limitation of removal or fill allowed without a  
5 permit and to ensure that potentially-jurisdictional streams are avoided as described herein.  
6 DSL has reviewed the amendment request and has expressed no concerns to the  
7 Department.<sup>349</sup>

#### Conclusions of Law

8 For the reasons discussed above, the Council concludes that a Removal/Fill Permit  
9 would not be required for the SWP, subject to the site certificate conditions described herein,  
10 if Amendment #4 were approved.

#### **(c) Ground Water Act**

11 Through the provisions of the Ground Water Act of 1955, ORS 537.505 to ORS  
12 537.796, and OAR Chapter 690, the Oregon Water Resources Commission administers the  
13 rights of appropriation and use of the ground water resources of the state. Under OAR 345-  
14 022-0000(1), the Council must determine whether the proposed Stateline 3 complies with  
15 these statutes and administrative rules.

#### Findings of Fact

16 In the Final Order on the Application and the Final Order on Amendment #1, the  
17 Council found that a new or transferred water right was not needed for construction or  
18 operation of the Stateline 1&2 components of the SWP facility.

19 OWRD has reviewed the amendment request and expressed no concerns to the  
20 Department. The applicants estimate that up to 8.7 million gallons of water would be needed  
21 for road and earthwork compaction, dust suppression and concrete mixing during construction  
22 of the proposed Stateline 3 components.<sup>350</sup> Construction could consume up to 120,000 gallons  
23 of water per day, but the average usage would be approximately 60,000 gallons per day. The  
24 primary source of water is expected to be the City of Helix. The amendment request includes  
25 a letter from the Mayor of Helix indicating the City's willingness to supply up to 120,000  
26 gallons of water per day for the proposed Stateline 3 facility under the City's existing  
27 municipal water right.<sup>351</sup>

28 The applicants propose to obtain water from a private landowner as an alternate source  
29 of water for construction of Stateline 3. The applicants' contractor has applied for a Limited  
30 License to use this water.<sup>352</sup>

31 During operation of the proposed Stateline 3, water would be used at the O&M  
32 building, primarily for domestic purposes in the restrooms, kitchen and utility sinks. The  
33 applicants do not expect water use to exceed 1,000 gallons per day.<sup>353</sup> Water would be

1 supplied from a new on-site well. ORS 537.545(1)(f) provides that a new water right is not  
2 required for industrial and commercial uses of up to 5,000 gallons per day. The Council  
3 adopts Condition 130, which addresses the use of water from the proposed new on-site well.

#### Conclusions of Law

4 Based on the findings discussed above and subject to the site certificate conditions  
5 discussed herein, the Council concludes that the SWP would comply with applicable  
6 regulations pertaining to water rights if Amendment #4 were approved.

#### **(d) Public Health and Safety**

7 Under ORS 469.310, the Council is charged with ensuring that the “siting,  
8 construction and operation of energy facilities shall be accomplished in a manner consistent  
9 with protection of the public health and safety....” State law further provides that “the site  
10 certificate shall contain conditions for the protection of the public health and safety....” ORS  
11 469.401(2).

#### Findings of Fact

12 We discuss the Council’s Public Health and Safety Standards for wind energy  
13 facilities above at page 96. In this section below, we discuss the issues of fire protection,  
14 magnetic fields and coordination with the Oregon Public Utility Commission.

##### A. Fire Protection

15 In the Final Order on the Application, the Final Order on Amendment #1 and the Final  
16 Order on Amendment #2, the Council made findings and adopted conditions regarding fire  
17 prevention and response for Stateline 1&2.<sup>354</sup> In the Final Order on Amendment #2, the  
18 Council made findings regarding fire protection measures and site certificate conditions  
19 applicable to the old Stateline 3 configuration.<sup>355</sup> The fire risks for the new Stateline 3  
20 configuration are similar to the risks previously considered by the Council. The Council  
21 confirms that site certificate conditions addressing fire protection and response apply to  
22 Stateline 3. Applicable conditions include Conditions 31, 33, 34, 58, 96 and 103.

23 The applicants consulted with Rick Saager, Chief of the Milton-Freewater Rural Fire  
24 Department regarding fire and ambulance services. Based on his recommendations, the  
25 applicants agreed to position a 3,000-gallon water truck on-site during construction.<sup>356</sup>  
26 Revision 82 incorporates this agreement.

##### B. Magnetic Fields

27 Electric transmission lines create both electric and magnetic fields. The electric fields  
28 associated with the proposed transmission lines are addressed above at page 101.

29 In the Final Order on the Application and the Final Order on Amendment #1, the  
30 Council concluded that there would be no significant risk to public health and safety from the  
31 magnetic field generated by the underground 34.5-kV collector system based on a calculated

1 magnetic field strength of 60 milligauss (mG).<sup>357</sup> The applicants estimated the magnetic field  
2 that would be produced by the underground collector lines for the proposed Stateline 3 using  
3 BPA’s Corona and Field Effects Program (Version 3).<sup>358</sup> The analysis provided calculated  
4 magnetic fields for two cases: the field produced by an isolated single cable and the field  
5 produced by three parallel 34.5-kV circuits. The calculated magnetic field strength is at its  
6 maximum directly over the buried cable. For the isolated cable, maximum calculated field  
7 strength is 22.8 mG; for the parallel cables, the maximum calculated field strength is 31.8  
8 mG.

9 The Stateline 1&2 facilities do not include any aboveground transmission lines. The  
10 proposed Stateline 3 facilities include an aboveground 230-kV transmission line. The  
11 calculated magnetic field strength is 304 mG.<sup>359</sup>

12 Due to the absence of scientific consensus regarding the possible health effects of  
13 exposure to magnetic fields, there is no Oregon standard limiting the allowable magnetic field  
14 strength associated with transmission lines.<sup>360</sup> The Council has encouraged applicants to  
15 practice “prudent avoidance” and to propose low-cost ways to reduce or manage public  
16 exposure to magnetic fields from transmission lines under the Council’s jurisdiction.

17 Condition 108 addresses prudent avoidance measures to reduce human exposure to  
18 magnetic fields. The Council confirms that Condition 108 is applicable to Stateline 3.

### C. Coordination with the PUC

19 The Oregon Public Utility Commission Safety and Reliability Section (PUC) has  
20 requested that the Council ensure that certificate holders coordinate with PUC staff on the  
21 design and specifications of electrical transmission lines and the natural gas pipelines. The  
22 PUC has explained that others in the past have made inadvertent, but costly, mistakes in the  
23 design and specifications of power lines and pipelines that could have easily been corrected  
24 early if the developer had consulted with the PUC staff responsible for the safety codes and  
25 standards. Condition 110 requires the certificate holder to coordinate the design of electric  
26 transmission lines with the PUC. The Council confirms that Condition 110 is applicable to  
27 Stateline 3.

### Conclusions of Law

28 Based on the findings discussed above and subject to the site certificate conditions  
29 discussed herein, the Council concludes that the SWP would comply with requirements to  
30 protect public health and safety if Amendment #4 were approved.

## **2. Requirements That Are Not Under Council Jurisdiction**

### **(a) Federally-Delegated Programs**

1 Under ORS 469.503(3), the Council does not have jurisdiction for determining  
2 compliance with statutes and rules for which the federal government has delegated the  
3 decision on compliance to a state agency other than the Council. Nevertheless, the Council  
4 may rely on the determinations of compliance and the conditions in the federally-delegated  
5 permits issued by these state agencies in deciding whether the proposed facility meets other  
6 standards and requirements under its jurisdiction.

7 As required under Condition 60, the certificate holder would conduct all construction  
8 work in compliance with an Erosion and Sediment Control Plan satisfactory to the Oregon  
9 Department of Environmental Quality and as required under the federally-delegated National  
10 Pollutant Discharge Elimination System Storm Water Discharge General Permit #1200-C.  
11 The Council confirms that Condition 60 applies to Stateline 3.

### **(b) Requirements That Do Not Relate to Siting**

12 Under ORS 469.401(4), the Council does not have authority to preempt the  
13 jurisdiction of any state agency or local government over matters that are not included in and  
14 governed by the site certificate or amended site certificate. Such matters include  
15 design-specific construction or operating standards and practices that do not relate to siting.  
16 Nevertheless, the Council may rely on the determinations of compliance and the conditions in  
17 the permits issued by these state agencies and local governments in deciding whether the  
18 facility meets other standards and requirements under its jurisdiction.

## **VI. GENERAL APPLICATION OF CONDITIONS**

19 The conditions referenced in this order include conditions that are specifically required  
20 by OAR 345-027-0020 (Mandatory Conditions in Site Certificates), OAR 345-027-0023 (Site  
21 Specific Conditions), OAR 345-027-0028 (Monitoring Conditions) or OAR Chapter 345,  
22 Division 26 (Construction and Operation Rules for Facilities). The conditions referenced in  
23 this order include conditions based on representations in the request for amendment and the  
24 supporting record. The Council deems these representations to be binding commitments made  
25 by the applicants. This order also includes conditions that the Council finds necessary to  
26 ensure compliance with the siting standards of OAR Chapter 345, Divisions 22 and 24, or to  
27 protect public health and safety.

28 In addition to all other conditions referenced or included in this order, the site  
29 certificate holder is subject to all conditions and requirements contained in the rules of the  
30 Council and in local ordinances and state law in effect on the date the amended site certificate  
31 is executed.<sup>361</sup> Under ORS 469.401(2), upon a clear showing of a significant threat to the  
32 public health, safety or the environment that requires application of later-adopted laws or  
33 rules, the Council may require compliance with such later-adopted laws or rules.

1 The Department recognizes that many specific tasks related to the design,  
2 construction, operation and retirement of the facility will be undertaken by the certificate  
3 holder's agents or contractors. Nevertheless, the certificate holder is responsible for ensuring  
4 that all agents and contractors comply with all provisions of the site certificate.

## VII. GENERAL CONCLUSION

5 The proposed amendment would authorize a reconfigured third phase of construction  
6 (Stateline 3) and would partially transfer the Site Certificate from the current certificate holder  
7 (FPL Vansycle) to FPL Stateline. The Council adopts revisions to the Site Certificate as  
8 described in the section that follows. The Council's findings regarding a reasonable estimate  
9 of the cost to restore Stateline 1&2 to a useful, non-hazardous condition (Condition 80) and a  
10 reasonable estimate of the cost to restore Stateline 3 to a useful, non-hazardous condition  
11 (Condition 109) are stated on page 174 of this order.

12 Based on the findings and conclusions discussed above regarding the proposed  
13 amendment, the Council makes the following findings:

- 14 1. The transferee, FPL Stateline, complies with the standards described in OAR 345-  
15 022-0010 and OAR 345-022-0050 and is lawfully entitled to possession or control  
16 of Stateline 3 as described in the site certificate as amended by this order.
- 17 2. The proposed Amendment #4 complies with the requirements of the Oregon  
18 Energy Facility Siting statutes, ORS 469.300 to ORS 469.570 and 469.590 to  
19 469.619.
- 20 3. The proposed Amendment #4 complies with the applicable standards adopted by  
21 the Council pursuant to ORS 469.501.
- 22 4. The proposed Amendment #4 complies with all other Oregon statutes and  
23 administrative rules applicable to the amendment of the site certificate for the  
24 SWP that are within the Council's jurisdiction.

25 Accordingly, the Council finds that the facility complies with the General Standard of  
26 Review (OAR 345-022-0000). The Council concludes, based on a preponderance of the  
27 evidence on the record, that the site certificate may be amended as requested by the certificate  
28 holder, subject to the revisions recommended by the Department and set forth below.

### 1. The Department's Recommended Revisions

14 110-percent of maximum blade tip height, measured from the centerline of the turbine  
15 tower to the nearest edge of any public road right-of-way. The certificate holder shall  
16 assume a minimum right-of-way width of 60 feet.

17 (c) Where (a) does not apply, the certificate holder shall maintain a minimum distance of  
18 1,320 feet, measured from the centerline of the turbine tower to the center of the nearest  
19 residence existing at the time of tower construction.

20 (d) Where (a) does not apply, the certificate holder shall maintain a minimum distance of  
21 110-percent of maximum blade tip height, measured from the centerline of the turbine  
22 tower to the nearest boundary of the certificate holder’s lease area.

23 (e) The certificate holder shall not locate equipment associated with the temporary batch  
24 plant within 50 feet of a public road, county road or utility right of way.

25 [Amendment #4]

Explanation

26 This revision incorporates the residential setback distance required under UCDC  
27 Section 152.616(HHH)(5) and the safety setback distances that the Council has adopted in  
28 recent site certificates for wind energy facilities. In subsection (e), the proposed condition  
29 incorporates a setback for batch plant equipment, which is required under UCDC Section  
30 152.617(I)(K)(2).

Revision 81

31 *Page 29, following Revision 80:*

32 (127) The certificate holder shall deliver a copy of the annual report required under Condition  
33 8 to the Umatilla County Planning Commission on an annual basis unless specifically  
34 discontinued by the County. [Amendment #4]

Explanation

1 This revision adds a condition requested by Umatilla County.

Revision 82

2 *Page 29, following Revision 81:*

3 (128) During construction, the certificate holder shall position a 3,000-gallon water truck on-  
4 site while personnel are present and actively working. [Amendment #4]

Explanation

5 This revision incorporates an agreement between the applicants and the Chief of the  
6 Milton-Freewater Rural Fire Department.

Revision 83

7 *Page 29, following Revision 82:*

8 (129) During operation, the certificate holder shall discharge sanitary wastewater generated at  
9 the Stateline 3 O&M building to a licensed on-site septic system in compliance with  
10 county permit requirements. The certificate holder shall locate the septic system more than  
11 100 feet from any streams, lakes or wetlands. The certificate holder shall design the septic  
12 system for a discharge capacity of less than 2,500 gallons per day. [Amendment #4]

Explanation

13 This revision provides location and design requirements for the Stateline 3 septic  
14 system. The new condition incorporates the setback requirements of UCDC Section  
15 152.063(E).

Revision 84

16 *Page 29, following Revision 83:*

17 (130) During operation, the certificate holder shall obtain water for on-site uses from a wells  
18 located at the Stateline 3 O&M building, subject to compliance with applicable permit  
19 requirements. The certificate holder shall not use more than 5,000 gallons of water per day  
20 from the on-site well. [Amendment #4]

Explanation

21 This revision provides for an on-site well for operational purposes at the O&M  
22 building. The new condition limits the water use to 5,000 gallons per day.

Revision 85

23 *Page 29, following Revision 84:*

24 (131) The certificate holder shall avoid permanent and temporary disturbance to all Category 1  
25 and Category 2 habitat within the Stateline 3 site boundary. [Amendment #4]

Explanation

26 This revision ensures that construction of Stateline 3 would have no permanent or  
27 temporary impact on Category 1 or Category 2 habitat within the Stateline 3 site boundary.



Revision 86

Page 29, following Revision 85:

(132) Before beginning construction, the certificate holder shall conduct a site-specific geotechnical investigation and shall report its findings to the Oregon Department of Geology & Mineral Industries (DOGAMI) and the Department. The certificate holder shall conduct the geotechnical investigation after consultation with DOGAMI and in general accordance with DOGAMI open file report 00-04 "Guidelines for Engineering Geologic Reports and Site-Specific Seismic Hazard Reports." [Amendment #4]

Explanation

This revision requires the certificate holder to conduct a pre-construction, site-specific geotechnical investigation and to report the results to DOGAMI and the Department.

Revision 87

Page 29, following Revision 86:

(133) Before beginning construction, the certificate holder shall provide to the Department:

(a) Information that identifies the final design locations of all Stateline 3 wind turbines to be built.

(b) The maximum sound power level for the Stateline 3 substation transformers and the maximum sound power level and octave band data for the turbines selected for the Stateline 3 based on manufacturers' warranties or confirmed by other means acceptable to the Department.

(c) The results of noise analysis of the facility, including the Stateline 3 components to be built according to the final design, performed in a manner consistent with the requirements of OAR 340-035-0035(1)(b)(B)(iii)(IV) and (VI) demonstrating to the satisfaction of the Department that the total noise generated by the facility (including the noise from turbines and substation transformers) would meet the ambient degradation test and maximum allowable test at the appropriate measurement point for all potentially-affected noise sensitive properties.

(d) For each noise-sensitive property where the certificate holder relies on a noise waiver to demonstrate compliance in accordance with OAR 340-035-0035 (1)(b)(B)(iii)(III), a copy of the a legally effective easement or real covenant pursuant to which the owner of the property authorizes the certificate holder's operation of the facility to increase ambient statistical noise levels L10 and L50 by more than 10 dBA at the appropriate measurement point. The legally-effective easement or real covenant must: include a legal description of the burdened property (the noise sensitive property); be recorded in the real property records of the county; expressly benefit the certificate holder; expressly run with the land and bind all future owners, lessees or holders of any interest in the burdened property; and not be subject to revocation without the certificate holder's written approval.

[Amendment #4]

Explanation

This revision adds Condition 133, which ensures that the SWP, including the Stateline 3 components in their final design locations, would comply with the DEQ Noise Control Regulations.

Revision 88

1 *Page 29, following Revision 87:*

2 (134) During operation, the certificate holder shall maintain a complaint response system to  
3 address noise complaints. The certificate holder shall promptly notify the Department of  
4 any complaints received regarding facility noise and of any actions taken by the certificate  
5 holder to address those complaints. In response to a complaint from the owner of a noise  
6 sensitive property regarding noise levels during operation of the facility, the Council may  
7 require the certificate holder to monitor and record the statistical noise levels to verify that  
8 the certificate holder is operating the facility in compliance with the noise control  
9 regulations. [Amendment #4]

Explanation

10 This revision adds Condition 134, which requires the certificate holder to maintain a  
11 complaint response system to address any complaints about noise from the facility during  
12 operation. The condition provides for verification that the facility is operated in compliance  
13 with the applicable noise limits.

Revision 89

14 *Page 29, following Revision 88:*

15 (135) During construction, the certificate holder shall not install any transmission line support  
16 structures within 800 feet of any active Swainson’s hawk nest identified in 2008 or later.  
17 [Amendment #4]

Explanation

18 This revision adds Condition 135, which would mitigate possible disturbance to  
19 nesting Swainson’s hawks during construction of Stateline 3.

Revision 90

20 *Page 29, following Revision 89:*

21 (136) This condition applies to all phases of the Stateline Wind Project. When any third-party  
22 lien or security interest in the facility’s wind turbines or turbine towers is created, the  
23 certificate holder shall notify such third party in writing that the wind turbines and towers  
24 are components an energy facility that is subject to the terms and conditions of a Site  
25 Certificate and subject to the rules of the Oregon Energy Facility Siting Council. The  
26 certificate holder shall provide to the Department a copy of each written notification  
27 required under this condition and the name and contact information for each third party so  
28 notified. [Amendment #4]

Explanation

29 This revision ensures that any third party having an interest in the facility’s wind  
30 turbines or turbine towers has notice of the existence of the Site Certificate and that any  
31 disposition of the turbines and towers would be subject to Council rules. The condition  
32 requires the certificate holder to identify any third party having a lien or security interest in  
33 the turbines or towers so that the Department can notify those parties if termination of the Site  
34 Certificate is initiated under OAR 345-027-0110.

## VIII. ORDER

1 The Council approves Amendment #4 and issues an amended site certificate for the  
2 Stateline Wind Project, subject to the terms and conditions set forth above and subject to the  
3 following decision regarding financial assurance (as indicated by the initials of the Council  
4 Chair).

5 \_\_\_\_\_ The Council finds that \$3.962 million (1<sup>st</sup> Quarter, 2009 dollars) is a reasonable  
6 estimate of the cost to restore Stateline 1&2 to a useful, non-hazardous condition  
7 and that \$3.976 million (1<sup>st</sup> Quarter, 2009 dollars) is a reasonable estimate of the  
8 cost to restore Stateline 3 to a useful, non-hazardous condition. The Council adopts  
9 Condition 80, Alternative A, and Condition 109, Alternative A, as described  
10 herein.

11 RS The Council finds that \$6.160 million (1<sup>st</sup> Quarter, 2009 dollars) is a reasonable  
12 estimate of the cost to restore Stateline 1&2 to a useful, non-hazardous condition  
13 and that \$5.911 million (1<sup>st</sup> Quarter, 2009 dollars) is a reasonable estimate of the  
14 cost to restore Stateline 3 to a useful, non-hazardous condition. The Council adopts  
15 Condition 80, Alternative B, and Condition 109, Alternative B, as described  
16 herein.
