Executive Summary

As required by law, this implementation status report is produced by the Wildfire Programs Director every two months for the Governor, the Presiding Officers of the Oregon Legislature, and the chairs of relevant legislative committees.

Wildfire Program Highlights:

- 1. Oregon's Fire Adapted Community Programs:** [OSFM: Wildfire in Oregon](#). The implementation of SB 82 (2023) is taking us on a pathway to partner with Oregon's insurance industry to seek long-term solutions on this challenging issue. Over 600 Oregonians have requested on-site visits to assess their home's defensible space. Homeowners can then share these assessments with insurers, showcasing that Oregonians are taking action to reduce wildfire risk around their homes.
- 2. Oregon Youth Conservation Corps:** This wildfire grant program remains active with 146 youth employed to reduce hazardous fuels around our most vulnerable communities. In this biennium, over 1300 acres across 39 zip codes have been treated. [Oregon-Youth-Works](#)
- 3. Electric Utility Wildfire Readiness:** As we prepare for 2024 wildfire season, the PUC will continue to convene workshops to help utilities and first responders share best practices regarding risk-based wildfire protection and mitigation. Annual Wildfire Mitigation Plans continue to be filed with PUC. Where the utility uses public safety power shutoffs, those plans include implementation details. [Wildfire Mitigation Plans](#). Many of the utilities are expanding their use of situational awareness tools and, in many cases, making that information available to the public. This includes weather monitoring functions such as interactive maps (see Pacific Power example [here](#)), as well as investing and collaborating on Oregon's wildfire camera detection system.
- 4. Wildfire Hazard Mapping:** The next iteration of the State's Wildfire Hazard Map is underway. ODF has established a Rules Advisory Committee and



town hall meetings are being scheduled around the state. The next iteration of the map will consider adjustments directed by SB 80 (2023).

- 5. 20-Year Landscape Resiliency Strategy:** This effort is critical to mitigating the catastrophic risk of wildfire across our landscapes: [ODF: 20-Year Landscape Resiliency Strategy](#). Key federal partners from the US Forest Service and Bureau of Land Management will continue to engage with the WPAC on this effort.
- 6. Durable Wildfire Funding Questions Remain:** Strategies that preserve Oregon's adequate wildfire response capacity and advance wildfire mitigation to address the increasing threat of wildfire remain unresolved. This durable and equitable wildfire funding question has been tasked to ODF and OSFM, through SB 5701 Budget Reconciliation Measure Budget Note # 5. The Agencies are currently coordinating to begin the formation of a workgroup to take on this complex funding challenge. This effort will essentially be a modern look at recommendation #37 (p.102-107) of the 2019 Governor's Council on Wildfire Response Report: [Governors Wildfire Council Report](#)
- 7. WPAC Transitions:** The Wildfire Programs are guided by the 19 - member WPAC: [Wildfire Programs Advisory Council](#). The WPAC is appointed by the Presiding Officers and 2024 marks the first rotation to half of the membership on this Council. The Wildfire Programs Director will work with Presiding Officers to assist in these transitions, which are slated for September 2024.

Duties of the Wildfire Programs Director

- Oversee implementation of the Wildfire Programs.
- Coordinate activities across all wildfire implementation agencies.
- Ensure compliance with deadlines.
- Monitor and assess the equity of any financial impacts from implementation activities on local jurisdictions.
- Supervise council staff and develop director reports every two months.
- Explore current and future opportunities to reduce wildfire risk.



Roles of the Wildfire Programs Advisory Council

- Advise and assist the Wildfire Programs Director.
- Monitor Wildfire Programs implementation and evaluate agency reports.
- Advise on changes necessary to dramatically reduce wildfire risk and ensure regional defensible space, building codes and land use applications are appropriate.
- Strengthen intergovernmental and multiparty collaboration including government, stakeholders and the public.
- Assess how Oregon's wildfire risk map may inform building codes and land use laws, rules and decisions in a regionally appropriate manner.
- Assess the application of defensible space requirements to vineyards, crops and other cultivated vegetation.
- Review the findings and recommendations in the DLCD's October 2022 report and make additional recommendations to land use planning, local comprehensive plans, and zoning codes to minimize wildfire risk.
- Report every October to the Governor and appropriate committees or interim committees of the Oregon Legislative Assembly.
