## **February Agency Update:**

Strategic Roadmap: Oregon's Strategic Roadmap for Postsecondary Education and Training was finalized in 2021 after an extensive public engagement and development process. The Roadmap sets an ambitious path forward by describing how postsecondary systems, policies, and practices need to change in order to achieve Oregon's goals for educational attainment and equity. The HECC is now in the process of developing and seeking input from partners on potential funding and policy proposals for 2023-25 aimed to advance the Strategic Roadmap, and invites input from Tribes and other partners.

Agency Report to the Legislative Commission on Indian Services: In December 2021, HECC provided its Annual Report to the Legislative Commission on Indian Services, 2021 summarizing HECC actions and initiatives the HECC in 2021 to foster postsecondary education and training opportunities and pathways for tribal students and learners in Oregon.

<u>Future Tribal Access Grant Would Significantly Increase Supports for Enrolled Members of Oregon-Based Tribes</u>: We are pleased to be working with Oregon's Tribal leadership and the Governor's Office on the development of a \$19 million package creating new grants targeted to students who are members of one of Oregon's nine federally recognized tribes, and look forward to continued conversations. The Tribal Access Grant would fund most undergraduate and graduate higher education expenses of enrolled members of Oregon-based Tribes. If approved, this would be a historically significant investment to support recognized members of Oregon-based Tribes, regardless of current state of residency, as they work toward their first associates, bachelor's, and master's degrees at eligible Oregon colleges and universities. The Tribal Access Grant would ensure that the most significant educational expenses are eliminated, improving affordable access to Oregon public and non-profit institutions of higher education for Tribal students. The HECC looks forward to conversations on this proposal, and we will implement the grant in time for the 2022-2023 academic year through the Office of Student Access and Completion if it is approved. Due to the nature of the legislative appropriation, the program will need to be reauthorized in 2023 in order to continue on a permanent basis. Future Ready: Addressing Oregon's Workforce Needs with an Equity Lens: One of Governor Kate Brown's major proposals for the 2022 Legislative Session is Future Ready Oregon 2022 (SB 1545), a \$200 million package of investments to give people the education, training, and resources they need to get into good-paying jobs. Focused on equitable prosperity, this funding would focus on realizing the full potential of Oregon's workforce, and meeting the needs of Oregon's employers today and into the future. In particular, Future Ready Oregon 2022 focuses on advancing opportunities for historically underserved communities, including adult learners, dislocated workers, and youth. Investments emphasize recruitment, retention, and career advancement opportunities, while prioritizing key populations, including people of color, women, people with low incomes, rural communities, veterans, and Oregonians who are incarcerated and formerly incarcerated. If approved, many of the funds would be administered through the HECC, working with state and local workforce boards, community-based and culturally-specific organizations, education & training providers, employers, and other partners, and bolstering current HECC statewide workforce strategies.

HECC Proposes Doubling Oregon Promise Grant Amount for Low-Income Students: As in prior Sessions, the HECC continues to advocate for an increased focus on equity in state financial aid program design. This Legislative Session, we have proposed modifying the Oregon Promise Grant to distribute more funds to low-income students. Currently designed, the award amount for low-income students has not changed as college costs have increased. To better support low-income students struggling with the increasing costs of college, HECC has proposed doubling the minimum award amount from \$1,000 to \$2,000, and indexing future increases to the increase with the average community college tuition rate. We have also proposed removing the \$50 per term copay, reducing the grade-point-average (GPA) requirement from 2.5 to 2.0, and eliminating the first-year experience. See recent testimony here.

HECC Encourages Participation in the Legislature's Joint Task Force On Student Success for Underrepresented Students in Higher Education: The HECC encourages postsecondary students and community members to participate in public meetings of the Oregon Legislature's Joint Task Force On Student Success for Underrepresented Students in Higher Education (HB 2590, 2021), which has commenced a historic statewide public engagement process. In recognition of the deep disparities in access to and success in Oregon postsecondary education, Oregon established this task force, charged with visiting postsecondary institutions and meeting with students and other stakeholders to examine issues of access, retention, graduation, and entry into the workforce. ## **Recent Research and Reports:**

New Equity Briefs Highlight Comprehensive Data on Students of Color in Higher Education and Training: The HECC Office of Research and Data is pleased to announce a new series of research publications, Equity Briefs, providing an in-depth look at data on the challenges and successes of public college or university students of color. Each Equity Brief focuses on the challenges of success—from high school through college and into the workplace—and where progress in reducing gaps has or has not been made for each racial/ethnic group. There are separate analyses for Asian American/Asian learners, Black/African American learners, Latino/a/x/Hispanic learners, Native American/Alaska Native learners, and Native Hawaiian/Pacific Islander learners.

Recommendations for Adults in Custody to Access Federal Aid: HECC recently submitted a report to the Oregon Legislature from the SB 234 Workgroup, Postsecondary Education for Adults in Custody. The report offers recommendations on how to establish a coordinated, statewide approach to best serve Oregon adults currently in custody who will become eligible soon for federal Pell grants due to 2020 changes in federal law. The report is the result of more than 5 public meetings of the SB 234 Workgroup, which was convened in fall 2021 as directed by SB 234 (2021).

#### **Affordability and Financial Aid:**

The HECC Office of Student Access and Completion (OSAC) continues to encourage Oregonians to pursue grants and scholarships at OregonStudentAid.gov.

OSAC Grant Applications for 2022-23 School Year: To be eligible for most types of financial aid, students must complete the Free Application for Federal Student Aid (FAFSA) or the Oregon Student Aid Application (ORSAA). These applications compile financial information and other details about students and families, which the US Department of Education and the State of Oregon use to determine financial need and eligibility for various financial aid opportunities. OSAC continues to encourage Oregonians to complete the FAFSA or ORSAA and to apply for the, Oregon Promise Grant, the Oregon Child Care Grant, and other state grant programs. <u>Webinars on Financial Aid Applications</u> - OSAC is hosting numerous webinars this month for practitioners, students, and families looking for financial aid application assistance. Topics include: the Free Application for Federal Student Aid (FAFSA), the Oregon Student Aid Application (ORSAA), grants and FAFSA Plus+.

OSAC offers the FAFSA Plus+ program for schools, community-based organizations, and other sites that work with a specific student population. Becoming a FAFSA Plus+ site allows an organization to upload a roster of students and then be able to see the FAFSA filing status for those students. <u>Tribal Access to Oregon Foster Youth Tuition and Fee Waiver:</u> HECC-OSAC continues to be available to ensure Tribal foster youth have access to the Oregon Foster Youth Tuition and Fee Waiver program, which waives tuition and fees for the equivalent of 4 years of undergraduate studies after other public grants and any school aid are applied. ### **Supporting Pathways and Student Success**

<u>Transfer Council Focused on Streamlining Transfer Pathways:</u> The <u>Transfer Council</u>—convened in October 2021, and comprised of representatives from Oregon public universities, community colleges, and high schools— is working to develop and advance work to streamline student transfer pathways between institutions. The HECC recently submitted to the Oregon Legislature a <u>report on the progress of the Transfer Council work to date</u>. This work is intended to simplify transfer and reduce the time and cost of earning a degree. All meetings are public, with details on the <u>HECC website here.</u>

<u>Equity Lens Updated with a Focus on Postsecondary Education and Training</u>: In December 2021, the Commission adopted an updated version of the Equity Lens, now titled the <u>Oregon HECC Equity Lens</u> with a renewed focus on application in postsecondary education and training. The Oregon HECC Equity Lens is

a cornerstone to the State's approach to postsecondary education and training policy and funding, with a focus on Oregonians who are currently and historically underserved in access to and success in postsecondary education and training. The HECC adopted the original Oregon Equity Lens in 2014, and has applied the Lens as a cornerstone to postsecondary education and training policy and funding since its first year as an agency. This update draws on the State of <u>Oregon Diversity</u>, <u>Equity</u>, <u>and Inclusion</u> (DEI) <u>Action Plan: A Roadmap to Racial Equity and Belonging for the State of Oregon</u> published by the Governor's Office in Fall, 2021, as well as the 2021 <u>Strategic Roadmap for Postsecondary Education and Training</u>.

Academic Program Approvals: At its February public meeting, the Commission approved the following new academic programs—Columbia Gorge Community College (CC): AAS in Advanced Manufacturing and Fabrication; AAS in Construction Technology; Lane CC: AAS in Aviation Unmanned Aircraft Systems; Certificate of Completion in Wildland Fire Management; Oregon Coast CC: Certificate of Completion in Shipbuilding and Repair Level II; Eastern Oregon University: BA/BS, Public Relations; Master of Public Administration; Oregon State University: BA/BS, Contemporary Music Industry; MA/MS Communication; Western Oregon University: BA/Bachelor of Arts and Science, Data Analytics. At its October Commission meeting, the HECC approved the following new academic programs—Portland CC, AAS, Video Production and Emerging Media; Western Oregon University, Doctorate in Physical Therapy.

<u>Applied Baccalaureate Program Proposals Advance to Third Phase</u>: At its February public meeting, the Commission received program proposals for new bachelors of applied science degrees at Chemeketa CC BAS, Management and Leadership, and Mt Hood CC: BAS, Cybersecurity. These programs were both approved to move into Phase Three of the <u>program approval process for applied baccalaureate degrees at community colleges</u>.

In 2019, the HECC and the WTDB convened an Adult Learner Advisory Committee (ALAC) to advise staff in these efforts. In 2021, the HECC and WTDB released the Adult Learner Advisory Committee (ALAC) Report, a comprehensive report designed to inform state strategies to increase credential completion among Oregon working-age adults, including an in-depth overview of adult learners in Oregon today, and identification of "Credentials that Work" for high wage-high demand fields.

#### **Other Updates**

Commission to Expand Membership with 2021 Legislation: Senate Confirms New Commissioners Appointed by the Governor. With the passage of SB 712 in 2021, several changes were made to the membership of the Higher Education Coordinating Commission which take effect with appointments confirmed after January 1, 2022. The bill adds a member to the Commission who is currently a graduate student, and converts positions that are currently nonvoting positions to voting positions. Once all positions are converted, the Commission will have 15 voting member slots. On February 10, the Oregon Senate confirmed Governor Brown's appointments of new Commissioners to the HECC for terms that beginning March 1, 2022. Former State Senator Richard Devlin will serve in the position currently held by Commissioner Larry Roper, whose term will expire; Motutama Sipelli will serve in the new graduate student position; and Aislyn Matias will serve in the position currently held by Enrique Farrera, whose term will expire. In addition, we are delighted to announce that on November 17, 2021, the Oregon Senate confirmed the Governor's appointment of Rukaiyah Adams as a voting member of the HECC.
