Dear Ms. Gaines:

The above-mentioned Special Local Need (SLN) registrations issued under Section 24(c) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, have been voluntarily cancelled by the registrant. All seven SLNs were issued to Dow AgroSciences, LLC (now Corteva Agriscience, LLC) to authorize additional uses of Lorsban Advanced (EPA Reg. No. 62719-591, chlorpyrifos). The uses that were authorized under these SLNs are summarized below:

The federal registration for Lorsban Advanced (EPA Reg. No. 62719-591) was voluntarily cancelled on May 4, 2023 (88 FR 28541). The purpose of this letter is to cancel all Oregon SLNs for Lorsban Advanced. As a result of this action, there are no longer any chlorpyrifos SLNs active in the State of Oregon.

All seven SLNs were non-food/non-feed uses and were therefore not affected by the expiration of chlorpyrifos tolerances on February 28, 2022. The uses on crops grown for seed were considered non-food/non-feed due to Oregon Administrative Rule 603-057-0535 Pesticide Use on Crops Grown for Seed. The Special Crop Use Restrictions section on the SLN labels was reflective of this rule and its requirements. These labels were initially set to expire on December 31, 2023, in accordance with OAR 603-057-0545 Limitations on Pesticide Products Containing Chlorpyrifos. However, these SLNs are now cancelled as of the date of this letter.
