Programs that are included with the Office of Education, Innovation, and Improvement are:

The Integrated Guidance is aligning the following programs:

- High School Success (HSS)
- Student Investment Account (SIA)
- Continuous Improvement Planning (CIP)
- Career and Technical Education - Perkins (CTE)
- Every Day Matters (EDM)
- Early Indicator & Intervention Systems (EIIS)

The guidance was released on February 8, 2022 and ODE has been engaging with communities since then. There will be increased support from ODE for districts in how to implement this alignment in the coming fall. Districts will be submitting applications in March 2023.

The goal of the alignment is to improve outcomes and learning conditions for Oregon's students. The common elements of all the initiatives are:

- Authentic Engagement Processes
- Equity Based Decision Making
- Focus on historically marginalized students
- Comprehensive Needs Assessment
- Continuous Improvement Cycle

A Community Engagement Toolkit has been created to support this alignment and the efforts of school districts.

	<p>Q: How did the plans get rolled out to districts to ensure that they understand ODE’s work and the expectations placed on districts?  A: This is the main work of Appendix F. The outline presented there will greatly help districts in outlining their work. ODE is currently trying to establish accountability measures for districts, and also for ODE, that will be most effective. Work done by this advisory group and the Latino/a/x &amp; Indigenous Student Success Plan is being elevated to the Education Service Districts (ESD’s) across the state. Those ESD’s are responsible for communicating the work to districts, but districts are not currently required by law/statute to implement strategies.</p> <p>Q: Will districts be applying to all six of the programs/initiatives or individual ones?  A: To date, the programs have been separate with separate applications, funding streams, and reporting requirements. This is creating a single pathway/application for all 6 initiatives and aligning the funding and reporting as well. This will replace the separate applications and processes currently being used by the programs.</p>
