2.0 Approval of April 7, 2020, minutes

4.0 Indian Education Office Updates

ODE has shared multiple K-12 guidance documents on Distance Learning for all and are currently discussing 8.5% potential budget reductions. We don't know how much impact this will have on our programs but have already identified some possible reductions. Our hope is to limit how these reductions will affect our districts and students. Family Advocates are stepping in to help teachers reach students who have been difficult to contact. Director Colt Gill will be virtually meeting with Title VI Directors, TAPP Family Advocates, and TAPP Directors regarding Distance Learning For All guidance and to answer program or district specific questions.

5.0 AI/AN Education Plan

5.1 Recommendation to move state plan to Government to Government (G2G) Education Cluster for approval

Deleana OtherBull reviewed the edits and changes to the AI/AN State Plan. The G2G Education Cluster is scheduled to review the plan on May 5. If the plan is approved, it will go before the State Board of Education for adoption on May 21, 2020. Deleana OtherBull recommends the plan move forward. Robin Butterfield moved to approve the plan as

presented, seconded by Angie Morrill. No discussion. After a vote, motion passes with a vote of 10-0-1 (ayes, no, abstain).

6.0 AI/AN Administrative Rules

6.1 Recommendation for approval

There is \$3.2M budgeted for grants for the Native Student Success Plan. These grants are funded as part of the Student Success Act, which is dependent on tax dollars. With the current budget downfall, there may be some adjustments in available grant money. We will know more after the state budget forecast in May.

Robin Butterfield moved and Chris Mansayon seconded to approve the rules as presented. Discussion included that the rules had adequate clarification of authority and implementation details to get the grants launched as soon as possible. Often more than one year is needed to get a program running smoothly, so we are hoping for continuation of funds. No further discussion.

After a vote, the motion carries with a vote of 10-1-0 (Ayes, no, abstain)
