

Beginning in January 2022, ODOT's Intermodal Disadvantaged Business Enterprise (DBE) reporting is incorporated into the OPTIS Agency Periodic Report (APR). This replaces the semi-annual DBE report. This document provides instructions for the new fields and contact information for the Office of Civil Rights.
