#### **First Notification**

- **▶ Definition 00110.20**
- ➤ First Notification Written acknowledgment by the Engineer of the date on which workers employed by the Contractor or a Subcontractor have begun performance of the Contract, including Aggregate source development or erection of a plant, but not including installation of covered temporary signs according to Section 00225

# First Notification Date on which the erection of a sign or plant, the development of Aggregate sources, or the performance of a Contract construction operation began. Oregon Department of Transportation



#### **Second Notification**

- ➤ Definition 00110.20
- ➤ Second Notification Written acknowledgment by the Engineer of the end of Contract Time according to 00180.50(g)
- √ This represents the date that the Contractor Completed the Project work and Stops any Contract Time Charges from further accrual. This initiates the beginning of the Project Closeout Process

## 00180.50(g) - End of Contract Time

When the Engineer determines that the On-Site Work has been completed, except for the items listed below, the Engineer will issue a Second Notification

#### Second Notification will list:

- The date the time charges stopped;
- Final trimming and cleanup tasks (see 00140.90)
- Equipment to be removed from the Project Site;
- · Minor corrective work not involving additional payment to be completed; and
- Submittals, including, without limitation, all required certifications, bills, forms, warranties, certificate of insurance coverage, (00170.70(b)), and other documents, required to be provided to the Engineer before Third Notification will issue.
- ☐ Failure to Complete all tasks could result in Rescinding 2<sup>nd</sup> Note and resuming Time Charges



# Specified Completion Date(s) - SCD's

- Initially set in the Special Provisions of the Project according to Section 00180.50(h)
- Some Projects will include multiple SCD's (00180.50(h)(1), 00180.50(h)(2), 00180.50(h)(3)....and so on). The last date listed under the "(h)(#)" subsection will be the "Ultimate" Specified Completion Date for the Project.
- SCD's can only be modified by Contract Change Order.
- ✓ Note: For each SCD specified only the most recent modified SCD is applicable to the Contract. The préviously established date becomes irrelevant.

#### **Weekly Statement** of Contract Time Charges (form 734-3483)

#### Submit per Section 00180.50 (d):

- For calendar days, weekly showing the number of Calendar Days counted for the preceding week and Days remaining to Specified Completion Date (SCD).
- •For specified completion date, immediately after each specified completion date.
- •Continue submitting until Second Notification is issued.

### - Second Notification Example


- 00180.50(h) included 3 separate Contract Times on this Project
- Each SCD was further modified by CCO04.
- The Contractor completed the work according to (h)(1) prior to the modified SCD therefore, no "Days were Charged beyond the SCD.
- The Contractor failed to complete the work according to (h)(2) & (h)(3) therefore, the days were counted between the modified SCD's and the corresponding dates the Contractor completed the Work

# **Transmitting 2nd Notification**

- Statewide CAU Position Paper was distributed January 30, 2024
- ■00170.08 requires the RE to issue 2<sup>nd</sup> Note through Doc Express
- ☐ This requires the RE to sign and Approve the document (preferably by transitioning the Document to "Approved by Project RE" however, wet signing is ok)
- ■2<sup>nd</sup> Note does not go through the RAS assigned to the project.
- □ It is entirely up to the RE Office to publish 2<sup>nd</sup> Notification to the ZO7 Contract Documents Drawer!!
- ☐ The Final Step of the Doc Express Workflow is considered the official transmittal to the Contractor.

# What about emailing 2<sup>nd</sup> Note to the Contractor??

- As interpreted by the Department of Justice (DOJ), email delivery <u>DOES</u> <u>NOT</u> meet the requirements of the Contract according to 00170.08, nor any of the delivery requirements given in 00150.30
- Can you still email 2<sup>nd</sup> Notification to the Contactor?
  - Technically yes however, CAU recommends it should be limited to an explanation or indication that 2<sup>nd</sup> Notification has been issued through Doc Express.
  - To avoid accidental transmission of an incomplete or incorrect version of 2<sup>nd</sup> Note, consider including a link to the document rather than an attachment.
  - Regardless, the 45-day claim period as specified in 00199.30(b), cannot be based on the date of delivery of 2<sup>nd</sup> Notification by email.





#### **Third Notification**

- ➤ Definition 00110.20
- > Third Notification Written acknowledgment by the Engineer, subject to Final Acceptance, that as of the date of the notification the Contractor has completed the Project according to the Contract, including without limitation, completion of all minor corrective work, Equipment and Plant removal, site clean-up, and submittal of all certifications, bills, forms and documents required under the Contract.

#### **Third Notification**



Enter the date on which all contract work was completed including corrective work, equipment and plant removal, site cleanup, and Project Manager's receipt of all certifications, bills and other documents required under the contract.

√This initiates the preparation of the Semi Final Documentation Package.
