

EXTERNAL CIVIL RIGHTS COMPLAINT

Purpose

This form is for Oregon Department of Transportation (ODOT) contractors, and their employees and subcontractors, to submit Equal Employment Opportunity (EEO) complaints reporting alleged discrimination or harassment to ODOT. The listed complaint may pertain to a contractor or subcontractor working on an ODOT project, an applicant or employee of the contractor or subcontractor, or an employee or agent of ODOT.

Process

ODOT accepts EEO complaints related to ODOT projects from contractors, their employees and applicants, their subcontractors, and their subcontractors' employees and applicants. Complaints should be submitted and addressed as soon as possible after the alleged incident or incidents.

ODOT encourages complainants to work with their ODOT Resident Engineer (RE) first. A Project Manager (PM) can help the complainant contact the RE if needed. If the RE is unable to resolve a complaint within three days of receiving the complaint, the RE will forward it to the ODOT Office of Equity and Civil Rights (OECR) EEO Compliance Officer to begin an investigation. OECR may also choose to begin an investigation immediately in certain cases.

It is also acceptable to submit an EEO complaint to ODOT without using this form. Include contact information and sufficient detail about what happened to support the complaint investigation.
