Use this form to request a review of ADA need status to verify if the ramp positions in question are not needed. Obstructed (OB), Unmarked Leg (UL), and Driveway (D) need status categories have been phased out. Ramps must have a need status of In Place (IP); Missing (MS), Closed (CL) or Not Needed (NN).

Definitions:

In Place (IP): Ramps that have been built.

Missing (MS): Ramp positions in which a ramp needs to be built or position closed by STRE approval.

Closed (CL): Ramp position has been closed by official action as a part of a crosswalk closure. Ramp positions are never closed individually. Crosswalk closures require STRE approval.

Not Needed (NN): No ramp is needed, provided ramp position fits one of three criteria listed on page two of this document.

Instructions:

Fill in the location information below in the first three columns. Use the drop down menu to enter Corner, Ramp and Not Needed Condition.

Use location information found on FACS-STIP or TransGIS

Select the Not Needed Condition below. In order for the ramp position to be considered for Need Status = Not Needed, it must meet one of the three listed criteria.

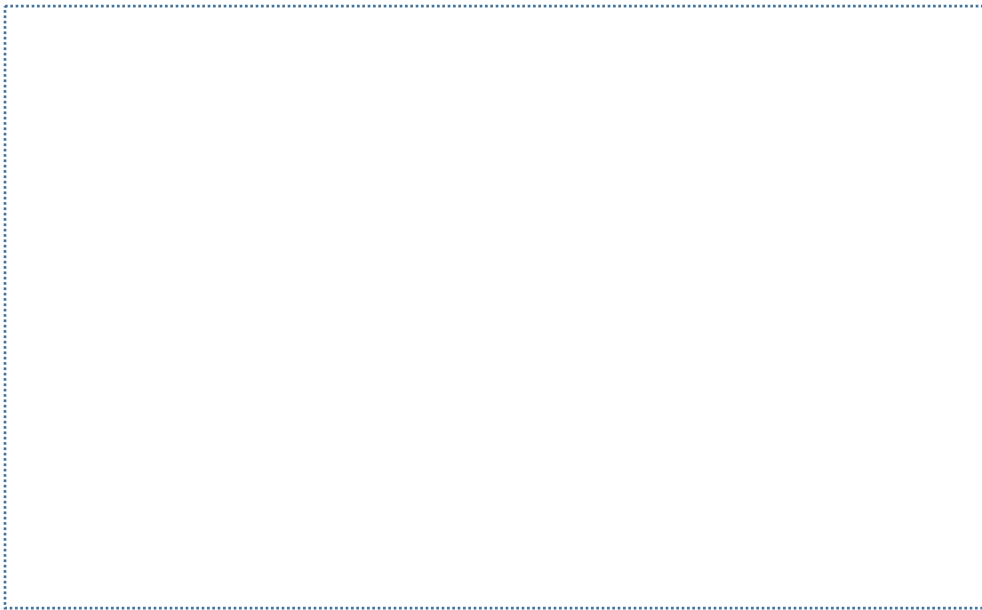
Not Needed Criteria:

1. No pedestrian facilities opposite the ramp position (aligning position is not intended for pedestrian use; bridge structure < 32" curb/concrete that is part of the structure and not intended to be used by pedestrians)
2. Location where the shoulder takes the place of the pedestrian facility. May or may not have drainage curb present.
3. Location where there is a sidewalk and curb present but there are coincident crossings. Most common for intersections with more than four corners. Locations where there is no need for a crosswalk closure or a built ramp.
