# QC Process for Stormwater Management Plans (SWMPs)

#### **Definitions**:

"WRPC" means Water Resources Program Coordinator.

"DRAFT SWMP" means consultant-prepared draft SWMPs submitted to regions as a contract deliverable as required by their statements of work; it doesn't refer to a preliminary version of SWMPs that region prepares.

"Region" generally means the region staff preparing SWMPs (water resources specialists, biologists, etc.), but when referring to the reviewer, it could be any ODOT employee whose position qualifies them in 401 matters, such as a peer in another region or the WRPC.

## NOTE: The process described below is not intended to substitute for centralized document tracking through submittal to the NRU-Trans mailbox.
