Upcoming Utility Work in Front of Your Residence

Pre-construction activities are underway for Phase 2 of the Oregon Department of Transportation's (ODOT) **Outer Powell Transportation Safety Project**. When completed, the project will help people travel Outer SE Powell Boulevard more safely by adding a center turn lane, sidewalks, bike lanes and other safety improvements. Before roadway construction begins along the corridor, pre-construction activities, such as utility pole relocations, tree trimming or tree removal must occur. Early utility relocation work ensures services such as power and communications are in place prior to roadway construction starting in late summer/early fall 2023.

Between **April 2023** and the end of this summer, expect a representative from PGE or NW Natural utility companies to visit your home with details about the utility-related work needed at your property. This work includes PGE pole relocation, gas line relocation, vegetation removal or fence panel removal on part of the property ODOT purchased. If you own property along SE Powell Boulevard in these areas, a right of way agent has already been in contact with you to discuss changes to your property. These activities are occurring Monday through Saturday, from 7 a.m. to 6 p.m. and at night from 9 p.m. to 5 a.m.

Schedule is subject to change based on weather and site conditions.
