Mobile Health Unit Pilot Program Update

Ongoing and regular updates on the Mobile Health Unit Pilot Program will be provided. Along with general Program updates, there is future work to include Grantee highlights, progress on HB 4052 legislative reports, and Mobile Health Advisory Committee (MHAC) workstreams.

In this month’s digest, Central City Concern shared an initial impact of receiving grant funding for their Mobile Health program.

Since their service delivery launch in September:

- 50 individuals received comprehensive medical care. Over half of the individuals who received care were new intakes and scheduled follow-up care after initial visits with the Mobile Health team.

On Friday, September 15, Program Staff had the opportunity to connect with Central City Concern at their service delivery launch at Clinton Triangle, one of three City of Portland’s Temporary Alternative Shelter Sites. The service delivery launch was a co-branded dental and primary care clinic event with Medical Teams International (MTI).

Members were asked to confirm their interest to continue as part of the MHAC. Current committee membership will be identified to determine recruitment needs for a fully staffed committee.

HB 4052 Community Update

Grantees have been invited to speak about their Mobile Health Unit Program during the House Bill (HB) 4052 (2022) Equity Action Group Zoom virtual meeting space. This group meets bimonthly from 1 – 2pm to act on health equity recommendations.

Central City Concern presented at the meeting on Tuesday, October 31. Raíces De Bienestar are scheduled to present on Tuesday, November 14. The Confederated Tribes of Grand Ronde will be scheduled to present at a future date.
