**Met afeiengawan?** Iteiten wiik, ina epwe 5 chon Oregon re maano ren an kon nuunuuno ar aea drug, ika overdose. Non ei fansoun, mei wor ekkewe tipitipin opioid safei mei nofit ngeni fentanyl mei cheufetan non Oregon. Ekkei tipitipin safei mei fokkun afeiengaw. Efou chok safei mei tongeni fori an emon epwe overdose.

**Met ei opioid?** Opioid, ekkewe safei mei ammwauenno an aramas ngasangas me fori met repwe mochen mour ren. Ekkei opioid mei pachenong morphine, oxycodone, dilaudid, me heroin. Fentanyl pwan ew sokkun opioid mei pochokkun: ekis chok, nonnon fitu foun ppi, mei tongneni nieno emon aramas.

**Pota aramas re aea opioid?** Opioid mei tongeni kawor ren safeian metek. Ekkoch aat me nengin, re sossot drug pwe re mochen sinei ika epwe feter. Ekkoch aramas, re aea drug ren ar resapw mefi osukosuken netipar. En mei tongeni mwochuno won opioid.

**Met ei naloxone? Naloxone (pwan itan Narcan) ew sokkun safei si fiienong non pwot ika me non oppos ren an epwe fetaneoch sefan ngasangas** ren emon ika pwe a ammwauenno ika kouno an ngasangas mwirimwirin an overdose won fentanyl, opioid safei ika heroin. Naloxone mei popwuta ne fori angangan non chok 2-3 minich, mei tongeni tori 30-90 minich angangan. Fan ekkoch, oruwen aean naloxone epwe namwot ika pwe esisinnen overdose a niwin sefan. Ika en mei sinei emon mei aea opioid, kose mochen ekieki omw kopwe kkut Narcan pwe kopwe onomwu ngonuk me epwe wor non imwomw. 

