# License to Sell Tobacco Required in Oregon

## **Tobacco Retail License Information and Support**

Since Jan. 1, 2022, any retailer in Oregon who sells tobacco, or inhalant delivery system (IDS) products, also known as e-cigarettes or vaping products must have a license.



## **Tobacco retail licenses protect youth**

Since Jan. 1, 2022, any retailer in Oregon who sells tobacco, or inhalant delivery system (IDS) products, also known as e-cigarettes or vaping products must have a license.

It's too easy for kids in Oregon to get tobacco and IDS products. In 2023, in a review by the Oregon Health Authority (OHA), nearly one in four tobacco retailers inspected by OHA sold tobacco products to people under 21. That is against the law.



## The tobacco retail license law can help

Tobacco retail licensing holds all retailers to the same standards. The state can then:



- Track where tobacco is sold
- --- Enforce tobacco sales laws, and
- Support retail owners and staff with education and training.



### What the license covers

#### **Products**



The law requires a tobacco retail license to sell any tobacco or IDS product, such as:

- Cigarettes
- Cigars
- Chewing tobacco
- --- E-cigarettes and vape products, and
- Any other item designed for tobacco product consumption, use or preparation.

#### Retailers

Anyone who sells tobacco or IDS products directly to consumers is a tobacco retailer. Those who must have a tobacco retail license to sell tobacco include:

- Retail stores
- Cigar and hookah lounges
- •— Vape shops, and
- •— Bars.



The law does **not** apply to:

- Retailers on tribal lands
- Oregon Liquor and Cannabis Commission (OLCC)-licensed marijuana retailers, or
- OHA-licensed marijuana dispensaries that don't sell IDS products that contain nicotine.



#### Retailer license

Retailers must post the license in a location visible to customers.

Retailers in some counties operate under their county tobacco retail license program. The Oregon Department of Revenue (DOR) has a list of local program websites on their <u>Statewide Tobacco Retail License web page</u>.

The DOR and OHA together regulate the statewide tobacco retail license. Below are the roles of each.



#### DOR:

- Administers tobacco and cigarette taxes
- Issues licenses
- Collects fees
- Enforces licensing requirements, and
- Suspends or revokes licenses if needed.



- •— Educates retailers on tobacco sales laws
- Conducts compliance checks, and
- •— Issues penalties for violations of tobacco sales laws.



## **Requirements and resources for retailers**

Retailers apply for a tobacco retail license at the Department of Revenue's Tobacco Retail License webpage





Retailers pay an annual fee of \$ Retailers with multiple locations need a license for each location. The license fee covers the costs of administering the program.

#### **OHA** enforcement

Conducts two inspections per year to make sure retailers:

- Do not sell to people under 21, and
- •— Follow all tobacco retail sales laws.
