# **Description:**

Staff requests approval for awarding a procurement contract exceeding \$500,000. The contract will be to purchase specialized Wave Attenuators and hardware to be installed at the Cove Palisades Marina. These units are specialized pieces that are designed and built for this specific location and as such take a significant amount of time to produce. Staff are recommending proceeding with this project award as we are experiencing an ever-increasing amount of damage within the marina due to wave action from weather events and/or an increase in large wake boats traversing the area. This wave action has caused significant damage and wear on the dock facilities within the marina and staff have even started to see damage to boats moored within the marina from these high wave events. Staff have been in consultation with the Oregon State Marine Board over the last several years regarding this issue as well and they had recommended installation of No Wake buoys 200 feet out from our facilities and installing some sort of wave breaker or attenuator floats similar to what we are proposing.

This procurement will include the following:

- 14 Sections of 36-inch diameter HDPE Wave Attenuators
- 10 Sections of 24-inch diameter HDPE Wave Attenuators
- Light Stands for attachment to Attenuators
- Hardware and Accessories for Attenuator Attachments
- Delivery and Off-Loading of units on-site at the Cove Palisades

Preliminary estimates for this project ranged to \$450,000. Upon completing the procurement process, OPRD had one qualified bidder from a fabrication company and that bid came in at \$605,000. This project will be funded via FIP Funds.

# 1.0 **PROCUREMENT DESCRIPTION**

### 1.1 PURPOSE AND SCOPE

The Oregon Parks and Recreation Department (OPRD) is seeking bids for the purchase of wave attenuators for use at The Cove Palisades State Park Marina.

As a result of this solicitation process, OPRD intends to award one contract for the goods described in this Solicitation Document. The awarded contract will be in the form of a standard State of Oregon purchase order. The general provisions of the awarded contract(s) are included in **Attachment 4 (Standard Terms and Conditions for the Purchase of Goods).** 

Unless OPRD specifies otherwise, the selected contractor is required to meet the highest standards prevalent in the industry or business most closely involved in providing the appropriate goods or services.

### 1.2 SPECIFICATIONS

Detailed specifications and requirements for the goods are described in **Attachment 3** (Detailed Specifications).

For "Or Equal" requests, see section 2.6.4.

### 1.3 ADDITIONAL INFORMATION

**1.3.1 Tobacco Free Properties.** Bidders need to be aware that Executive Order 12-13 established statewide policy that properties wholly owned or leased by the State of Oregon shall be tobacco free. If Bidder is selected for contract award, Bidder, and its employees, agents and subcontractors will be expected to comply with established smoking restrictions while performing services on State property.

# 2.0 SOLICITATION PROCESS

### 2.1 PROCUREMENT AUTHORITY AND METHOD

OPRD is conducting this Procurement under the authority granted in ORS 279A.050(6)(d), which gives the State Parks and Recreation Department authority to procure or supervise the procurement of all goods, services, public improvements and personal services relating to state parks in accordance with the Public Contracting Code.

OPRD is conducting this Procurement in accordance with OAR 137-047-0255, Competitive Sealed Bidding.

### 2.2 GENERAL DEFINITIONS

Capitalized terms in the Solicitation Document have the meaning set forth below, and if not defined below, the meaning set forth in the Attorney General's Model Public Contract Rules (OAR Chapter 137), and if not defined there, the meaning set forth in the Public Contracting Code (ORS Chapters 279A, 279B and 279C). Other capitalized terms may be defined in the section in which they appear.

- **2.2.1** "Addendum" or "Addenda" means an addition to, deletion from, a material change in, or general interest explanation of this Solicitation Document.
- **2.2.2** "Bid" or "Offer" means the Bidder's written offer submitted in response to this Invitation to Bid, including all necessary attachments.

- 2.2.3 "Bidder" or "Offeror" means a Person that submits a Bid in response to this Invitation to Bid.
- **2.2.4** "Closing" means the date and time specified in this Solicitation Document as the deadline for submitting Bids.
- **2.2.5** "Contractor" means the Person with whom OPRD enters into a contract pursuant to this Invitation to Bid.
- **2.2.6 "Goods"** means all supplies, equipment, materials, and personal property, including any tangible, intangible and intellectual property and rights and licenses in relation thereto, required to be delivered under the Contract resulting from this Solicitation Document.
- 2.2.7 "OPRD" means the Oregon Parks and Recreation Department.
- **2.2.8** "**Person**" means any of the following with legal capacity to enter into a Contract: individual, corporation, business trust, estate, trust, partnership, limited liability company, association, joint venture, governmental agency, public corporation or any other legal or commercial entity.
- **2.2.9** "**Responsive**" means having the characteristic of substantial compliance in all material respects with the applicable requirements of this Solicitation Document.
- **2.2.10** "Services" means all work required to be performed under the Contract resulting from this Solicitation Document.
- 2.2.11 "Solicitation Document" or "Invitation to Bid (ITB)" means this document, and all its attachments, which is issued to invite offers from prospective contractors pursuant to ORS Chapter 279B.

- **2.6.2 Requests for Clarification.** A prospective Bidder may request clarification of any provision contained in this Solicitation Document. Any request for clarification **must**:
  - Be submitted in writing via e-mail to the Single Point of Contact, and
  - Be received by the deadline for inquiries designated in **section 2.3** Procurement Schedule, or as changed by Addenda.

At its sole discretion, OPRD will respond to such requests received by direct response to the requestor, by issuing clarification(s) in the form of Questions and Answers posted on ORPIN, or by issuing changes in the form of Addenda posted on ORPIN. OPRD's clarification to a Bidder's request, whether orally or in writing, does not change this Solicitation Document and is not binding on OPRD unless the Solicitation Document is amended by Addendum in accordance with **section 2.6.5** below.

- **2.6.3 Protests of Procurement Process or Solicitation Document.** A prospective Bidder who believes that this procurement process is contrary to law or that this Solicitation Document is unnecessarily restrictive, legally flawed, or improperly specifies a brand name may protest the procurement process or Solicitation Document in accordance with OAR 137-047-0730. Any protest **must:**

OPRD will consider such protests received and issue a written response in accordance with OAR 137-047-0730. OPRD's response to a protest does not change this Solicitation Document and is not binding on OPRD unless the Solicitation Document is amended by Addendum in accordance with **section 2.6.5** below.

- 2.6.4 Requests for "Or Equal" Product. A prospective Bidder may request approval of a manufacturer/brand as an "Or Equal" of the manufacturer/brand specified in this Solicitation Document. Any request for brand approval **must**:
  - Be submitted with Bidders Bid response by the Closing date listed in Section 2.3 and must include all relevant information as shown on the Or Equal Form, Attachment 7 concerning how the requested brand meets or exceeds the specifications of the brand specified in this Solicitation Document.

OPRD will review requests for "or equal" submitted in accordance with this section and, at its sole discretion, will determine whether the requested brand is approved or not. OPRD will respond to the requestor with its determination in a timely manner.

- **2.6.5** Changes to Solicitation Document. Changes to the Solicitation Document will be made only by Addenda issued by OPRD and posted on ORPIN.
- **2.6.6 Protest of Addendum.** A prospective Bidder may submit a protest of the Addendum by the close of the next business day after the issuance of the Addendum, or no later than the due date for Protests of ITB identified in Section 2.3 of this ITB, whichever is later. Unless otherwise specified in the Addendum, a protest must be submitted in the same manner as a protest of the ITB under Section 2.6.3.

### 2.7 BID REQUIREMENTS

### 2.7.1 Bid Format

Bids must be submitted on the forms and in the format required by this Solicitation Document. Any specific forms required for Bid submittal are included as attachments to this Solicitation Document.

### 2.7.2 Bid Content

The Bid must be complete in all respects, including necessary signatures, certifications, documentation, and responses to any other information required by this Solicitation Document, including but not limited to the following:

## A. Bidder Information and Certification Form

The Bid must contain a completed **Bidder Information and Certification Form** (Attachment 1) including an original or electronic signature of the Bidder or a representative of the Bidder who is authorized to commit the Bidder to legal contracts. The person signing the Bid shall initial any alterations or erasures in ink. By submitting its Bid, a Bidder agrees to be bound by the terms and conditions contained in this Solicitation Document. A Bidder shall **not** make a Bid conditional upon OPRD's acceptance of terms or conditions that conflict with or are in addition to those contained in this Solicitation Document.

### **B.** Pricing Proposal

The Bid must contain **a completed Pricing Proposal Form** (Attachment 2). All Pricing Proposals must be valid for 30 days from Closing.

### C. Specifications; Minimum Requirements

The Bid must comply with all specifications and minimum requirements described in **Attachment 3 (Detailed Specifications)**.

### **D.** References

The Bid must include a **Bidder Reference Form (Attachment 6)** and must contain three (3) references including valid contact information for each, from separate firms or clients that may be contacted to verify Bidder's abilities and experience with respect to goods and/or services provided within the past ten (10) years that are similar in size and scope to those described in this Solicitation Document. References from Oregon Parks and Recreation Department will not be accepted.

### E. Welder Qualifications / Certifications

The Bid must include the names and certifications of Bidder's welder(s) it intends to use in the manufacture of the wave attenuators as described in the **Detailed Specifications** (Attachment 3).

### 2.7.3 Bid Submission

Bidder is solely responsible for ensuring its Bid is received by the SPC before Closing. OPRD is not responsible for any delays in mail or by common carriers, or for any mis-delivery for any reason, including electronic transmission error.

A Bid submitted by any means not authorized below may be rejected. The following delivery options are permitted for this ITB:

- A. Delivery in Person. A Bid may be hand-delivered. A Bid submitted in this manner MUST:
  - be delivered to the attention of the SPC at the address on the Cover Page and received prior to Closing;
  - be submitted in a sealed envelope, package or box; and
  - be clearly labeled on the outside of the sealed submission with Bidder's name and the Bid number.

Hand-delivered Bids will be accepted, one hour prior to Closing or during OPRD's front desk COVID business hours of 8:00 a.m. to 5:00 p.m. Pacific Time, Mondays, Wednesdays, and Fridays, except during State of Oregon holidays.

- **B.** Delivery through Mail or Parcel Carrier. A Bid may be submitted through the U. S. mail or via parcel carrier. A Bid submitted in this manner MUST:
  - be sent to the attention of the SPC at the address listed on the Cover Page and received prior to Closing;
  - be submitted in a sealed envelope, package or box; and
  - be clearly labeled on the outside of the sealed submission with Bidder's name and the ITB number.
- **C. Delivery by Email.** A Bid may be submitted by email. A Bid submitted in this manner MUST:
  - be submitted to <u>Contract.OPRD@oregon.gov</u> and received prior to Closing, and
  - identify the ITB number in the email subject line.

Attached files must be in PDF format or file formats compatible with MS Office 10 applications. Files may not be in .zip, .exe or .com format. The combined size of all attachments may not exceed 20 Megabytes. Multiple emails may be submitted such that no single email contains attachments that exceed 20 Megabytes combined.

- **D. Unacceptable Delivery and Receipt.** OPRD will **not** accept or consider Bids that are:
  - Submitted orally, by FAX, the World Wide Web, or some other Internet protocol;
  - Received at a physical location other than the address specified in **section 2.6.1** Single Point of Contact; or
  - Received after the Closing.
- **2.7.4 Bid Modification.** A Bid submitted in response to this Invitation to Bid may be modified, in writing, by the Bidder prior to Closing. Bid modifications submitted must be clearly marked as a modification and must comply with all Bid requirements in **section 2.7.** Bidder shall prepare modifications on Bidder's letterhead. Each Bid modification must be signed by an authorized representative and state that the modifications amend and supersede the identified portions of the Bid.
- 2.7.5 Bid Withdrawal. A Bid submitted in response to this Invitation to Bid may be withdrawn by the Bidder prior to Closing. To withdraw a Bid, Bidder must submit a written notice on company letterhead signed by an authorized representative to the Single Point of Contact listed in section 2.6.1. The written notice may be delivered by mail or in person. If delivered in person, OPRD will require appropriate identification before releasing the Bid.
- **2.7.6 Bid Costs.** All costs associated with preparation, submission, modification and withdrawal of a Bid are the sole responsibility of the Bidder and will not be borne by OPRD.
- 2.7.7 Public Records; Trade Secrets. This Solicitation Document and one copy of each original Bid received in response to it will be kept by OPRD and made a part of a file or record which shall be open to public inspection. If a Bidder believes that its Bid contains any information that is considered a trade secret under ORS 192.501(2) or otherwise exempt from disclosure under the Oregon Public Records Law, ORS 192.410 through 192.505, each sheet of such information must be marked as follows:

"This data is exempt from disclosure under the Oregon Public Records Law pursuant to ORS 192, and is not to be disclosed except in accordance with the Oregon Public Records Law, ORS 192.410 through 192.505."

Bidders are cautioned that cost information submitted in response to a Solicitation is generally not considered a trade secret under the Oregon Public Records Law. Further, information submitted by a Bidder that is already in the public domain is not protected as a trade secret. Go to: <u>https://www.oregonlegislature.gov/bills\_laws/ors/ors192.html</u> for the definition of trade secret and information on what is exempt from disclosure.

OPRD shall not be liable for disclosure or release of any information when authorized or required by law or court order to do so. OPRD shall also be immune from liability for disclosure or release of information under the circumstances set out in ORS 646.473(3).

By submitting a response to this ITB, Bidder grants the State of Oregon a non-exclusive, perpetual, irrevocable, royalty-free, worldwide license for the rights to copy, distribute, display, prepare derivative works of, and transmit the response for the purpose of conducting this procurement and to fulfill obligations under Oregon Public Records Laws.

# 2.8 BID OPENING

Bids will be opened by the Single Point of Contact at the Closing date and time designated in **section 2.3** Procurement Schedule or as changed by Addendum. Only the names of the Bidders and the total price bid, if applicable, will be made available at time of opening.

# 3.0 EVALUATION PROCESS

Bids received prior to Closing will be evaluated in accordance with the evaluation process described below and any other applicable rules and statutes, including but not limited to OAR 137-047-0255.

### 3.1 CLARIFICATION OF BIDS

During the evaluation process, OPRD may request clarification from any Bidder regarding any portion of their Bid. Bidders should remain available during the evaluation period to respond to any such requests for clarification. Bidders should respond to requests for Bid clarification in the format and timeframe required by OPRD. If OPRD is unable to contact or receive a requested clarification from a Bidder, that Bidder's Bid may be rejected according to OPRD's interpretation of the Bid without clarification.

## 3.2 DISQUALIFICATION OF BIDS

Any attempt by a Bidder to improperly influence the evaluation process will result in the disqualification of that Bidder's Bid from consideration.

## 3.3 CANCELLATION OF SOLICITATION

Any time during the Solicitation Process, OPRD may cancel this Solicitation or reject any and all Bids in accordance with ORS 279B.100.

## 3.4 ADMINISTRATIVE REVIEW

Bids will be evaluated for compliance with the Bid requirements identified in **section 2.7**. Bids deemed nonresponsive will be rejected. Bids deemed Responsive will be further evaluated as described in **section 3.5** below.

### 3.5 SPECIFICATIONS; MINIMUM REQUIREMENTS

Responsive Bids will be evaluated for compliance with the specifications and/or minimum requirements described in **section 2.7.2.C**. Bids deemed nonresponsive to the specifications and/or minimum requirements will be rejected. Bids deemed Responsive to the specifications and/or minimum requirements will be further evaluated as described in **section 3.6** below.

### 3.6 PRICING

For all Responsive Bids, Pricing submitted in accordance with the requirements described in **section 2.7.2.B** Pricing Proposals will be evaluated to determine the lowest total Bid for the items selected for award.

### 3.7 METHOD OF AWARD

Only Responsive Bids will be considered for award. Award will be based on the lowest total Bid determined in the Pricing section above.

OPRD reserves the right to award a Contract to the Bidder submitting a Bid with guaranteed delivery of all Goods elected for award by June 30, 2021, regardless of price, so long as the total Bid is within OPRD's budget.

If OPRD awards a Contract, OPRD will award the Contract in accordance with ORS 279B.055(10) and OAR 137-047-0600(4).

### 3.8 APPLICABLE PREFERENCES

In accordance with ORS 279A.120 and 125, OPRD must:

- (a) Give preference to goods or services that have been manufactured or produced in Oregon if price, fitness, availability and quality are otherwise equal,
- (b) Add a percent increase to the Bid of a nonresident Bidder equal to the percent, if any, of the preference given to the Bidder in the state in which the Bidder resides, and
- (c) Give preference to the procurement of goods manufactured from recycled materials.

For purposes of applying (a) and (b) above, Bidder must identify on the **Bidder Information** and **Certification Form (Attachment 1)** whether Bidder is a "Resident Bidder" as defined in ORS 279A120(1)(a).

### 3.9 BIDDER REFERENCES

OPRD may contact any or all of the references provided by Bidder in response to **section 2.7.2.D** to verify Bidder's qualifications, abilities, and experience. OPRD reserves the right to reject a Bidder if the references fail to support Bidder's ability to provide the Goods or Services described in this Solicitation Document.

### 3.10 BIDDER RESPONSIBILITY

In accordance ORS 279B.110, OPRD may contact any references (whether or not provided by Bidder) and request any additional information deemed necessary to determine the Responsibility of the Bidder to provide the Goods or Services.

### 4.0 AWARD PROCESS

### 4.1 METHOD OF AWARD

If an award is made, OPRD intends to award a contract to the Bidder submitting the lowest total bid for the Bid items selected for award per Attachment 2 – Pricing Proposal Form.

### 4.2 INTENT TO AWARD

OPRD will notify all Bidders via Notice on ORPIN of the selected Bidder. This announcement will serve as notice to all Bidders that OPRD intends to award a contract to the selected Bidder subject to the successful negotiation of any negotiable provisions.

# 4.3 PROTEST OF AWARD

If OPRD receives only one Bid, OPRD may dispense with the intent to award protest period described in this section and proceed with Contract award.

- **4.3.1 Protest Eligibility.** A Bidder may protest OPRD's intent to award a contract in accordance with OAR 137-047-0740 **if** the Bidder is adversely affected because the Bidder would be eligible to be awarded the Contract in the event that the protest were successful **and** the reason for the protest is that:
  - All lower Bids are nonresponsive;
  - OPRD has failed to conduct the evaluation of Bids in accordance with the criteria or processes described in the solicitation materials;
  - OPRD has abused its discretion in rejecting the protestor's Bid as nonresponsive; or
  - OPRD's evaluation of Bids or OPRD's subsequent determination of award is otherwise in violation of ORS chapter 279B or ORS chapter 279A.

A Bidder's protest must be submitted to OPRD in writing and must specify the grounds for the protest in order to be considered by OPRD.

- **4.3.2 Protest Submission.** The written protest must be received at the delivery address identified in **section 2.6.1** within three (3) calendar days of OPRD's Notice of Intent to Award. The protest MUST be marked PROTEST and MUST identify the Solicitation number.
- **4.3.3 Response to Protest.** OPRD will consider any protest received by the deadline and respond in writing in a timely manner.

### 4.4 CONTRACT REQUIREMENTS

**4.4.1 Contract Form.** The Bid is an offer to enter into a contract that, if accepted for award, binds the Bidder to a contract and the terms and conditions contained in this Solicitation Document.

The form of contract will be a standard State of Oregon Purchase Order that incorporates the terms and conditions contained in **Attachment 4 (Standard Terms and Conditions for the Purchase of Goods).** 

A Bidder shall not make a Bid contingent upon OPRD's acceptance of terms or conditions that conflict with or are in addition to those contained in this Solicitation Document. The process for requesting changes to the Contract terms and conditions is described in section 2.6 of this Solicitation Document.

- **4.4.2 Recyclable Products.** Contractors shall use recyclable products to the maximum extent economically feasible in the performance of the contract work set forth in this document.
- **4.4.3 Insurance.** If the selected Bidder uses owned or leased vehicles to deliver Goods (not common carrier), Bidder shall provide to OPRD certificates and additional insured endorsements of the insurance coverages identified in **Attachment 5 (Insurance Requirements)** or as otherwise specified in this Solicitation Document.

# 3.0 NEED

The Oregon Parks and Recreation Department (OPRD) wishes to purchase 1,200 feet of wave attenuator comprised of 700 feet of 36-inch SDR 32.5 HDPE and 500 feet of 24-inch SDR 32.5 HDPE, including all related hardware, anchor points, and connections identified in these specifications.

# 3.1 QUANTITY

OPRD anticipates purchasing 1200 feet of wave attenuator However, OPRD reserves the right to reduce the quantity of wave attenuator purchased if necessary due to budget restraints.

# **3.2 MATERIAL SPECIFICATIONS**

# 3.2.1 General

- a. Wave Attenuator shall be multi-function wave attenuation boom ("Attenuator") furnished by Pacific Netting Products, Inc. 25993 United Rd. NE, Kingston, WA. (1.360.297.0858) or Equal.
- b. Each Attenuator section shall be 50-feet in length.
- c. Attenuators shall have a 1-inch thick by 8-inch tall HDPE top splashguard, color Fed Std 13655 Safety Yellow, extending the length of the Attenuator that shall be extrusion welded at 22.5 degrees from top center, built as an integral part of the Attenuator. Manufacturer must provide supporting documents to meet a 20-year minimum life span without color fade.
- d. Attenuator sections shall bolt through the Attenuator end caps to other Attenuator sections using metal steel backing rings and grade 5 or A325 structural bolts.
- e. All steel metal components connecting or anchoring the wave attenuator shall be hot dipped galvanized

# 3.2.2 36-inch Diameter Attenuator (700 feet total length, all sections)


- a. Attenuator shall be 36-inch diameter, 32.5 SDR HDPE pipe with at least 1-inch thick water tight fusion welded HDPE end caps.
- b. Flanges connecting 36-inch Attenuator section to Attenuator section: Shall be 20, 1-inch A325 structural galvanized bolts.
- c. Attenuator skirt and keel shall be continuous length, built of 12-inch SDR 32.5 HDPE vertical pipes and 18-inch SDR 32.5 HDPE lower ballastable pipes with1/2-inch thick HDPE rigid sheet with a total skirt/keel depth of 48-inches, permanently welded in-between pipes and to bottom of 36-inch Attenuator. Lower ballast shall be 100lb/ft.

# 3.2.3 24-inch Diameter Attenuator (500 feet total length, all sections)

- a. Attenuator shall be 24-inch diameter 32.5 SDR HDPE pipe with at least 1-inch thick water tight fusion welded HDPE end caps.
- Flanges connecting 24-inch Attenuator section to Attenuator section: Shall be connected using 16, 3/4" A325 structural galvanized bolts
- c. Attenuator skirt shall be continuous length; built of heavy duty 4-ply poly-nylon with a depth of 48-inches, adequately bolted to the Attenuator. Keel shall be welded to bottom of 24-inch Attenuator. The skirt shall be resistant to impacts, tearing, and abrasion, flexible and weighted with ballast minimum of 20lbs per foot required.





# 3.2.4 Anchor Points and Connections

a. Lake Anchor Points. Steel anchor points shall be available at Attenuator section ends. Anchor points shall be on both sides at or just below water level; shore and lake anchor design, adequate for securing Attenuator in place.

b. Lake Anchor Connections. Flange bolted assembly shall include steel mooring ring built of 1inch ASTM A572 g50 steel material.

c. **Shore Anchor Connections.** Shore anchor connections shall include steel end plate with 1-1/4-inch wide mouth mooring pad bolted to HDPE end plate.

# 3.2.5 Hardware and Accessories

- a. All metal hardware or accessories shall be galvanized steel.
- b. All nut and bolt hardware shall have locking mechanisms.

# 3.3 MINIMUM REQUIREMENTS

a. Bidder shall provide, with its Bid, references from at least three (3) customer's that Bidder provided goods and services most comparable to those requested in this ITB within the last ten years.

# **3.4 PRE-MANUFACTURE SUBMITTALS**

Contractor shall provide shop drawings for Attenuator, Attenuator section connections, Attenuation skirts/keel and/or panels and anchor connections including materials lists to OPRD for review prior to fabrication.

# 3.5 DELIVERY

a. All materials shall be delivered to The Cove Palisades State Park, Crooked River Day Use Area located at 7300 SW Jordan Rd. Culver, OR 97734 no later than June 30, 2021.

OPRD *may* consider accepting a partial delivery before June 30, 2021 and the remaining Attenuator's after June 30, 2021. Bidder shall state, in its Bid, the earliest date all product will be delivered or, the date(s) Bidder will make deliveries (if multiple dates), keeping in mind it is OPRD's desire to receive as many Attenuator's as possible prior to June 30, 2021.

b. OPRD desires off-loading and placement services at time of delivery (see Optional Services below).

c. Goods will be inspected by OPRD for damage upon delivery and off-loading.

# 3.6 MANUALS / INSTALLATION SUPPORT

# 3.7 WARRANTY

# a. Attenuator Warranty.

- a. Light Stand and Light. Include the cost to affix manufacturer's standard light stand, with light, to Attenuator.

# 3.8.2 Services

Bidder shall include, in the space(s) provided on the Pricing sheet (Attachment 2), the cost for the following Services:

- b. Cost for installation of Attenuators at The Cove Palisades State Park, Crooked River Day Use Area Marina located at 7300 SW Jordan Rd. Culver, OR 97734. Installation costs shall include all travel, labor, tools, equipment and materials necessary to install the purchased Wave Attenuators, including both lake and shore anchoring. (Note: installation is anticipated to occur during September 2021.)

# 3.9 PAYMENT

OPRD will make payment as follows:

**3.9.1 Cost of Materials.** OPRD will make payment for materials purchased for the manufacture of the wave attenuators upon receipt of an invoice from Contractor showing a detailed list of materials purchased and received by Contractor for the manufacture of the 24-inch and 36-inch Attenuators and receipt of Pre-Manufacture Submittals per Attachment 3 – Detailed Specifications section 3.4.

**3.9.2. Attenuators.** OPRD will make payment for the remaining balance of the awarded Contract price of the 24-inch and 36-inch Attenuators upon delivery and acceptance of the 24-inch and 36-inch Attenuators by OPRD.

**3.9.3 Off-Loading.** OPRD will make payment for Services (if awarded) to off-load Attenuators at The Cove Palisades State Park Marina upon completion of Services and acceptance by OPRD.

**3.9.4 Installation.** OPRD will make payment for Installation Services (if awarded) upon completion of Installation Services and acceptance by OPRD.

# STANDARD TERMS AND CONDITIONS FOR THE PURCHASE OF GOODS

# STANDARD TERMS AND CONDITIONS

- 1. DELIVERY: Deliveries will be F.O.B destination. Contractor shall pay all transportation and handling charges. Contractor is responsible and liable for loss or damage until final inspection and acceptance of the Goods. Contractor remains liable for latent defects, fraud, and warranties.
- 2. INSPECTIONS: OPRD may inspect and test the Goods and related Services (collectively, Goods). OPRD may reject non-conforming Goods and require Contractor to correct them without charge or deliver them at a reduced price, as negotiated. If Contractor does not cure any defects within a reasonable time, OPRD may reject the Goods and cancel this Purchase Order (PO) in whole or in part. This paragraph does not affect or limit OPRD's rights, including its rights under the Uniform Commercial Code, ORS chapter 72 (UCC).
- 3. GOODS PAYMENT OBLIGATION: OPRD will pay only for Goods that meet the specifications and performance standards specified in this Solicitation Document. If OPRD determines that any Goods do not meet these specifications or performance standards, OPRD will notify Contractor of OPRD's rejection of the Goods. Upon receipt of notice of non-acceptance, Contractor shall, remove and replace rejected Goods at Contractor's sole expense within 10 calendar days to ensure the Goods meet such specifications or performance standards, and shall notify OPRD in writing that it has completed such modifications or replacements and re-tender them to OPRD.

OPRD will thereafter examine the modified or replaced Goods within 5 business days of receipt of Contractor's delivery. Failure of the Goods to meet the specifications and performance standards after the re-tender following OPRD's initial rejection of the Goods shall constitute a default by Contractor. Upon such default, OPRD may either (i) notify Contractor of such default and instruct Contractor to modify or replace the Goods or (ii) notify Contractor of such default and instruct Contractor to cease work, in which case Contractor shall refund to OPRD all amounts paid by OPRD related to such Goods. Such refund is in addition to, and not in lieu of, any other remedies OPRD may have for Contractor's default.

OPRD will pay Contractor within 30 days from (i) the date the Goods are delivered and accepted, in accordance with the preceding paragraphs, or (ii) the date the invoice is received, whichever is later. If OPRD fails to pay within 45 days of such date, Contractor may assess overdue account charges up to a rate of 2/3% per month (8% APR) or the maximum rate allowed by law on the outstanding balance.

- 4. STATE PAYMENT OF CONTRACTOR CLAIMS: If Contractor does not pay promptly any claim that is due for Goods or Services furnished to the Contractor by any subcontractor in connection with this PO, the State may pay such claim and charge that payment against any payment due to the Contractor under this PO. The State's payment of a claim does not relieve the Contractor or its surety, if any, from their obligations for any unpaid claims.
- 5. WARRANTIES: Contractor represents and warrants that the Goods are new, current, and fully warranted by the manufacturer. Delivered Goods will comply with specifications and be free from defects in labor, material and manufacture. All UCC implied and expressed warranties are incorporated in this PO. Contractor shall transfer all warranties to the State.
- 6. **TERMINATION:** (i) The parties may terminate this PO by mutual agreement. (ii) OPRD may terminate this PO at any time with written notice to Contractor. Upon receipt of the written notice, Contractor shall stop performance, and OPRD shall pay Contractor for Goods delivered and accepted. (iii) OPRD may terminate this PO at any time if OPRD fails to receive funding, appropriations, or other expenditure authority. (iv) If Contractor breaches any PO provision or is declared insolvent, OPRD may terminate this PO for cause with written notice to Contractor shall be liable for all incidental and consequential damages resulting from its breach, including all damages as provided in the UCC.
- 7. HOLD HARMLESS: Contractor shall indemnify, defend and hold harmless the State and its agencies, their divisions, officers, employees, and agents, from all claims, suits or actions of any nature arising out of or related to the activities of Contractor, its officers, subcontractors, agents or employees under this PO.

- 8. GOVERNING LAW, JURISDICTION, VENUE: This PO is governed by Oregon law, without resort to any other jurisdiction's laws. Any claim, action, suit, or proceeding between the State and the Contractor that relates to this PO (Claim) must be heard exclusively in the Circuit Court of Marion County for the State of Oregon. If the Claim must be brought in a federal forum, then it must be heard exclusively in the US District Court for the District of Oregon. Contractor consents to the in personam jurisdiction of these courts. *Neither this Section nor any other provision of this PO is a waiver by the State of any form of defense, sovereign immunity, governmental immunity, immunity based on the Eleventh Amendment to the US Constitution, or other immunity, from any Claim or from the jurisdiction of any court.*
- **9.** FORCE MAJEURE: Neither party is responsible for delay or default caused by an event beyond its reasonable control. OPRD may terminate this PO without liability to Contractor upon written notice after determining the delay or default reasonably prevents performance of this PO.
- 10. ASSIGNMENT/SUBCONTRACT/SUCCESSORS: Contractor shall not assign, transfer, or subcontract rights (Subcontract) or delegate responsibilities under this PO in whole or in part, without the prior written approval of OPRD. This PO's provisions are binding upon and inure to the benefit of the parties to the PO and their respective successors and assigns.
- 11. ACCESS TO RECORDS: Contractor shall maintain all accounting records relating to this PO according to GAAP and any other records relating to Contractor's performance ("Records") for six (6) years from termination or as otherwise required. Contractor shall grant the State and its agencies, the Secretary of State Audits Division, the federal government, and their duly authorized representatives access to the Records, including reviewing, auditing, copying, and making transcripts.
- 12. Thank you for the opportunity to offer a proposal for the design, manufacturing, and installation of a PNP wave attenuator for the Cove Palisades site. We have reviewed the bid specifications and are confident that we will be able to meet or exceed your expectations for this project. PNP has manufactured several Wave Attenuation Systems that are nearly identical to what you are requesting, all of which are performing well for their intended purpose.

Some of the key factors in wave attenuation effectiveness are the overall mass of the boom to control/dampen its motion; it is also the, depth, of the wall/skirt to reduce wave energy passage. For your site location, we feel that the combination of the 24" and 36" wave attenuation booms will be well suited to greatly reduce wave action that is created by passing boats and wind driven wave action.








#### In water anchoring:

There was limited information regarding anchoring of the wave attenuation system. Based on experience with our designs, we have chosen to offer a system using a series of concrete blocks and anchor cables to hold the boom in place and help resist wave loading effects. This design will be further reviewed and confirmed during design phase.

Anchor Blocks: *Custom Manufactured by Hooker Creek Construction Materials – Bend Oregon* We are recommending pre-cast anchor blocks, like the sketch below but finished size of 2x2x6' with a weight of 3,600lbs dry weight. A 1.25-inch diameter galvanized bent rod will be placed within the block during the pour process for connection of the anchor cable.

60 each anchor blocks have been provided in our proposal. Spaced at 50' intervals on each side of the boom, will provide adequate holding power.





#### Anchor Lines:

Currently, we are recommending the use of <sup>3</sup>/<sub>4</sub>" IWRC galvanized wire rope for the anchor lines. The cable provides adequate strength and residue long term service life. Alternatively, stainless steel could be offered but not currently included in this proposal due to cost considerations.

Anchor materials quoted consist of:

60 each concrete anchor blocks 2x2x6'
3/4"" 6x19 galvanized wire x 8,000'
<sup>3</sup>/4" galv. Drop forged wire rope clips (3 per eye splice)
<sup>3</sup>/4" galv. Thimbles for each eye
1" galvanized safety anchor shackles to attach anchor cable to block and boom.
2 each 1-1/4" x 10' galvanized open link chain to attach boom end to shore anchors.
1-1/4" galvanized safety anchor shackles to attach boom to chain/boom to shore anchors.

Final anchor line design will be detailed out during design phase of project.




#### Shore anchors:

Limited information was provided within the RFP to fully vet best alternatives for anchor to shore. PNP has been involved on past projects around Lake Billy Chinook and realize there is a couple types of shore anchors that can be considered.

- Pour in place concrete blocks Site access is limited and may reduce the possibility of land-based equipment from reaching location. Shore grubbing and rock scaling to provide proper base for forming block will need to be performed/accessed from water. However, concrete could be pumped from land-based operation. Estimated concrete block size is 4x4x6'.
- 2) Drill and grout rock anchors Again, site access is limited but good bedrock might be attainable to drill and epoxy grout anchor rods for attachment of a grouted galvanized steel pad eye base plate (shown below). Land based air supply could be provided for hand drill equipment.

Other considerations such as permitting, land ownership, environmental requirements will need to be discussed early in design phase to determine best approach moving forward.

PNP took into consideration, these two anchor options and captured the average costs within the installation portion of the proposal.

#### **Shipping**

11 each 48' flatbed trucks will be required to ship all attenuator boom sections, ballast weight chain and anchoring hardware. In addition, 5 each 48' flatbed trucks will be required to ship the 60 concrete anchor blocks. A 12K telehandler will be onsite for offloading equipment. It is assumed that material delivery will be located at final project site. Minimum laydown area requirement is 20,000 sq.ft



### **Delivery/Work Schedule:**

Due to current project scheduling and long material lead times, PNP will have substantial portion of boom sections ready to ship prior to June 30. Remaining sections will be ready to ship on or before July 30.

PNP has been staying in close contact with it's suppliers and believes that it is a short term issue, however, due to recent political changes, causing concern within the oil and natural gas sectors, is leading to a trend of higher prices.

PNP factored in the most recent price increases as of March 1. We anticipate the chance of further price increases but are committed to holding this proposal price schedule for 30 days.
