Pursuant to a duly adopted delegation order, and acting in accordance therewith, the Director, or her designee, has approved the following actions on behalf of the Oregon Parks & Recreation Commission:

SCENIC WATERWAYS NOTIFICATION

On February 21, 2023, Notification of Intent #2A-290-23 was approved to allow the construction of a new single-family dwelling in the Middle Deschutes Scenic Waterway at 20052 Beaver Lane, Tumalo. The project was approved because it complies with all relevant Middle Deschutes Scenic River Area rules. Construction will occur outside of the 100' setback, will remain below the 30' height limit, will be finished in materials/colors that blend in with the natural surroundings, and the landowners will use additional vegetation to screen house from the river upon project completion.

On February 22, 2023, Notification of Intent #2A-291-23 was approved to allow the construction of a bedroom addition to an existing single-family dwelling in the Middle Deschutes Scenic Waterway at 7770 NW Grubstake Way, Redmond. The project was approved because it complies with all relevant Middle Deschutes Scenic River Area rules, will be constructed to blend in with the natural landscape, and will be screened from view of the river in this section by both topography and vegetation.

On March 1st, 2023, Notification of Intent NOI #14-29-23 was approved to allow the construction of a temporary fish trap and haul facility at the spawning channel below Trail Bridge Dam within the McKenzie State Scenic Waterway. The project was approved because it complies with all relevant McKenzie River Scenic Waterway Scenic River Area rules, will be subordinate to existing approved structures at the location, and will be screened from the main river channel.

On March 1, 2023, Notification of Intent #2B-1105-23 was approved to allow the renovation of an existing single-family dwelling in the Upper Deschutes Scenic Waterway at 56940 River Road, Sunriver. The project was approved because it complies with all relevant Upper Deschutes

Recreational River Area rules, will take place outside of the setback and below the height limit, will be constructed to blend in with the natural landscape, and will maintain existing vegetation screening on site.

On March 2, 2023, Notification of Intent (NOI 07-741-23) was approved to allow the Oregon Department of Forestry to conduct post-fire timber salvage operations on the Maple Gulch parcel owned by the Department of State Lands in the Lower Rogue River State Scenic Waterway, near the community of Galice in Josephine County. This area burned during the Rum Creek wildfire in August 2022. The project was approved because the proposed activities comply with all relevant Lower Rogue River State Scenic Waterway rules, specifically those related to timber harvesting following wildlife.

On March 14, 2023, Notification of Intent #2B-1106-23 was approved to allow the construction of a new single-family dwelling, shed, and replacement pumphouse in the Upper Deschutes Scenic Waterway at 54665 Silver Fox Drive, Bend. The project was approved because it complies with all relevant Upper Deschutes Scenic River Area rules, will take place outside of the setback and below the height limit, will be constructed to blend in with the natural landscape, and will both maintain and add vegetation screening on site.
