


Water Right Transaction Fees

- Supports staff who process water right transactions from application to certification and provide customer service
 - Front desk customer service
 - Water right related transactions
 - Protests and contested case participation
 - Data processing and mapping
- Supports 14.93 FTE / 18 positions



Water Right Transaction Fee History


- Fees increased every 4 years
- 2009: 50/50 General Fund Fee Funded split
- 2021: Fees were increased, but positions were still cut
- History of inadequate increases to cover work





Water Right Transactions Expenditures


Water Right Related Spending (in millions)




2021-2023: ARPA Influx, Fee FTE Reduction in 2021-23




















Workload and Fee Drivers

- Increased cost of services
- Increasing complexity due to water scarcity, legal challenges, and public interest
 - Re-reviews, mitigation discussions, repeated engagement with applicants, contested cases
- Backlog accumulation
- Staffing uncertainty funding, temporary/limited duration staff, training
- Additional tasks not covered by fees



Water Right Transaction Fee Shortfalls and Impacts

Shortfalls: Projected \$3.6 million - \$4.8 million shortfall by 2027-2029

- Equivalent to resources for 8-10 FTE
- 64-86% increase to fill shortfall with fees alone

Transaction	Current Fee (2021-25)	64%-86% Fee Increase (2025-2029)
Water Right Application – Surface Water	\$1,090	\$1,788-\$2,028
Transfer	\$1,360	\$2,231-\$2,530
Claim of Beneficial Use	\$230	\$377-\$428
Protest (non-applicant)	\$950	\$1,558-\$1,767



Well Construction



Well Construction Program

Protect public health, safety and groundwater resources by preventing wells from serving as a conduit for groundwater contamination or draining of aquifers

- Licensing and permitting
- Continuing Education
- Start Card program
- Well Report program
- Well identification program
- Well inspection and regulation
- Special standard implementation
- General customer service
- Geotechnical hole program





Well Construction Licensing and Landowner Permit Fees

- Cost of staff to operate licensing and renewal program, administer continuing education program and process landowner permit applications
- Supports: 0.57 FTE / 1 position
- Four fees are combined
 - Licensing Exam
 - License Fee / Renewal
 - Late renewal fee
 - Continuing Education (Online exam)
 - Landowner permit





Fee Name	Current Fee	Year Established	Last Increase
License Exam Fee	\$20	1981	N/A
Driller License Fee / Renewal	\$150 (+\$100 late fee)	1981	2001
Continuing Education Fee	\$40/credit hour	2007	N/A
Landowner Permit	\$500	1981	2017

Well Construction Licensing and Landowner Permit Fee Shortfalls

Shortfalls: Projected \$26,000 - \$51,000 shortfall by 2025-2029


- Equivalent to resources for 0.25 FTE
- 12-23% increase to fill shortfall with fees alone

Fee Name	Current Fee	Projected Fee 2025-2029 (12% - 23%)
License Exam Fee	\$20	\$23-\$25
Driller License Fee / Renewal	\$150 (+\$100 late fee)	\$168-\$185 (+\$112-\$123 late fee)
Continuing Education Fee	\$40/credit hour	\$45-\$50
Landowner Permit	\$500	\$560-\$615




Start Card Fee Background

- Costs of staff to inspect wells and well construction and ensure compliance with standards
- Current Fee: \$350
- Supports: 9.87 FTE / 15 positions






Historic Start Card Expenditures and Use





Historic Well Program Expenses


Well Program Expenses





Historic Well Program FTE


Well Program Staffing

Start Card Fee Shortfalls and Impacts

Shortfalls: Projected \$210,000 - \$975,000 shortfall by 2027-2029

- Equivalent to resources for 0.5-2.25 FTE
- 5-22% increase to fill shortfall with fees alone

Current Fee (2021-25)	5%-22% Fee Increase (2025-2029)
\$350	\$368-\$427
