ORS 192.440(4)(a). For a breakdown of the calculation of fees please refer to DAS statewide policy, number 107-001-030, Exhibit B: Statewide Standardized Fee-Schedule. https://www.oregon.gov/das/Policies/107-001-030.pdf A public body has the authority to charge a fee in excess of \$25 only if it first provides a written cost estimate to the requestor and receives confirmation that the requestor wants the public body to proceed with responding to the request. ORS 192.440(4)(c). A public body may require payment of the estimated cost prior to issuance of the records requested.
