Background

State-owned forests are sustainably managed to provide environmental, social and economic benefits to all Oregonians. ODF is revising the Western Oregon State Forests Management Plan (FMP) and developing new Implementation Plans to prepare the necessary policy framework to implement draft Habitat Conservation Plan strategies and to support the achievement of Greatest Permanent Value. ODF is in the final phase of developing the Habitat Conservation Plan for Western Oregon State Forests which is a holistic and cost-effective way to comply with the Endangered Species Act. The HCP is currently undergoing environmental review under the federally required National Environmental Policy Act (NEPA) process. It is important that the HCP, FMP and IPs complement one another. As ODF updates the FMP and continues the HCP development process, a key goal of ODF is to provide information and engage in dialogue with all Oregonians who want to weigh in on these important planning efforts.
